Moved by Alderman McMillan, seconded by Alderman A. Stewart that the above requests be granted. Carried.

From the Kinsmen Club of North Vancouver requesting permission to display a banner on the City street at the foot of Lonsdale Ave. for a period of 14 days, and to display the usual banner on the City Ferries. Moved by Alderman Walker, seconded by Alderman A. Stewart that permission be granted to the Kinsmen Club to display banners as requested. Carried.

FINANCE COMMITTEE

Alderman Stewart reported progress on behalf of the Labor Relations Committee. With regard to masters and mates they had reached the point where the Committee had offered an increase of \$15.00 which is standard with other shipping firms and the Guild had refused this. They will meet once more in an endeavour to reach an agreement.

The Assessor submitted a Progress Report on the field survey which was authorized by the Council on March 17th. The Assessor was present and 5 answered questions in connection with the survey. Mr.Jellis was thanked for his report.

Alderman A.M.Stewart reported that he had received several offers from various firms to change the securities held by the City and he recommended that no change be made in the City's investments at the present time.

BOARD OF WORKS COMMITTEE

Re application of St. Andrews United Church for culvert.

FERRY COMMITTEE

Alderman McMillan reported that No.4 Ferry is now on the dock and alterations are under way and the annual overhaul is also being done.

FIRE AND LIGHT COMMITTEE

Alderman Goldsworthy reported he hopes to have a report at the next meeting regarding wages for the Fire Department.

The Ambulance matter has been held up and it is hoped to have this cleared away by next meeting.

PARKS COMMITTEE

Alderman Walker reported that painting is proceeding at the Horticultural Hall and the first coat is on. Alderman Walker suggested that, owing to the fact that there is a Confederation Park in Vancouver as well as in North Vancouver, the name of Confederation Park be changed; also the name of the Horticultural grounds.

RECOMMEND that Confederation Park change of name be taken under consideration.

RECOMMEND that in view of the fact that the Horticultural grounds and Hall have been developed as a public park and that some people, particularly visitors, do not realize that it is a park, the name of this park be "LONSDALE PARK" and that, if required, a bylaw be prepared to cover this,

AND FURTHER, that a sign be placed on the Hall naming it the "LONSDALE HALL" and a sign at the gates - "LONSDALE PARK - VISITORS WELCOME".

RECOMMEND that the Treasurer ascertain the total amount of the salaries payable for the month of May for the Health Unit and then apportion each Municipality's share and the School Board's share according to the regular manner in which we have apportioned expenses in previous months and when these amounts are received from the District of North Vancouver, District of West Vancouver and the School Board, that the City put in its proportion and pay the salary cheques only, this without prejudice to the City's position.

He particularly wants records of the officials and as many photographs as possible and he suggested that an album for North Vancouver be prepared.
