FINANCE COMMITTEE

Alderman A. M. Stewart reported that there was a great divergence of opinion on the assessing of machinery under the School Act and he advised that representatives of the Corporation would attend the Taxation Commission's meeting in Vancouver on 11th December 1947 in order that they may be fully conversant with the situation.

RECOMMEND that the Mayor and City Clerk be authorized to sign a new agreement for a period of one year, with the Seafarers' International Union of North America covering the unlicensed ratings in the deck of the North Vancouver Ferries, the Agreement to be effective from April 16th 1947 and to include the following changes:

(1) A new clause providing for the settlement of grievances or disputes without stoppage of work.

(2) Periods of sickness extending over the 12 days set out in the agreement, may be taken up with the Ferry Committee and the latter will consider each case on its merit.

(3) Employee may receive seven days holiday after completing six months' service, provided that such holidays must be taken at a time approved by the Ferry Superintendent.

(4) Employees to receive time off in lieu of nine Statutory Holidays, as set out in the agreement.

(5) Deckhands to receive an increase of \$20.00 per month and deckhands collecting vehicle fares to receive an additional amount of \$15.00 per month(or a total of \$35.00).

(6) Clothing supplied to the Deckhands by the Corporation must be approved by the Ferry Committee.

> Moved by Alderman A. M. Stewart, seconded by Alderman McMillan that the above report and recommendation of the Finance Committee be adopted. Carried.

BOARD OF WORKS COMMITTEE

RECOMMEND that the second and third recommendations of the Board of Works Committee adopted on November 3rd 1947, be rescinded and the following substituted therefor:

His Worship advised that the question of increased fares had been brought up but the representatives of the Cities present advised Mr. Wismer that such a matter would have to be placed before the respective Councils. As far as the City of North Vancouver is concerned any question of increased fares would have to be considered fully by the Council should the Company make such an application.

His Worship further pointed out that there was no understanding as to increased fares between either the Company or the Union representatives and the Municipalities involved.
