I am proud to be the Mayor of this City for in all its history no other Mayor has had such an outstanding group of Aldermen, all of different occupations and training. This is a splendid cross-section and it is very gratifying to have men who are civic-conscious, energetic and with a vital interest to see North Vancouver prosper.

I would request all members of the 1948 Council to re-read the Procedure By-law No. 308 and to familiarize themselves with this bylaw to regulate the proceedings of the Municipal Council. In view of the vast amount of work and the many problems facing us I would suggest setting the Wednesday evening preceding the regular Council meeting as a regular meeting night for all Standing Committees, and such meeting to be held at 7 p.m. in the City Hall. Present at Committee meetings should be all Department Heads, with the City Clerk and the Assistant City Clerk, whose duty it will be to record all committee minutes and prepare all proposed by-laws, resolutions, reports, etc., as expressed by the Committees. All technical and legal matters to be checked by the City Solicitor as to the correct and legal wording before being mailed on Friday evening to all Council members.

By this procedure all Council members would receive, not later than Saturday, copies and information on all matters to be brought up at Monday's regular Council Meeting, with sufficient time for study.

Due to the investment in the growth of our City in the past, this year's Council must watch our financial position very closely making it necessary to co-operate wholeheartedly with the School Board, Health Unit, Provincial and Federal Governments and with other local organizations in order that we may all have a thorough understanding of each others problems. With this understanding and the assistance of our local and federal members, together with the help of the U. B. C. M., I feel certain we shall receive such financial assistance as we require in order that we may maintain our present tax rate and carry out the essential development work so necessary for our success."
