Mr. Harbottle said that considerable pressure had been brought to bear on merchants in the North Shopping area to sign the petition. Briefly this means that the south shore Ticket Office will be closed entirely, the North Vancouver Ticket Office will be open for three hours during the morning and evening rush period - the remaining time, tickets will be sold by the turnstile operators. As arranged through agreement with the deckhands, the latter will take over the collection of vehicle fares, using the approved fare-boxes.

RECOMMEND that plans be prepared and submitted to the Ferry Committee, covering the proposed new locations of the ticket collector and seller booths at the Ferry Teminals.

## FIRE & LIGHT COMMITTEE

Alderman Gostick reported that a meeting will be held shortly between the Fire and Light Committee, the Chairman of the Labour Relations Committee and members of the Fire Department regarding salaries, etc.

#### HEALTH COMMITTEE

Alderman Gostick reported that members of the North Shore Health Unit had met Dr. Amyot this afternoon at 2 p.m. and the operation and financing of the Unit had been discussed. He said that it was generally agreed that the operation of the Unit was not functioning as well as it could, there being only a loose gentlemen's agreement governing the operation. He said that the Government hopes in the not too distant future, to put forward a satisfactory plan of financing but that for the current year some assistance would be forthcoming in the form of a Grant.

His Worship asked if the Finance Committee had made any decision on the Five Day week in the City Hall.

Alderman Stewart said his Committee would be making a recommendation on this matter shortly.

Moved by Alderman Gostick, seconded by Alderman Copping that a letter of appreciation be forwarded to Captain J. H. Cates, M. L. A., thanking him for his interest and attendance at the meeting recently held with Dr. Amyot regarding Health matters. Carried

Moved by Alderman Gostick, seconded by Alderman A.M. Stewart that the Metropolitan Health Committee be written to asking whether they consider the City of North Vancouver is a member of the Metropolitan Health Committee or not. Carried

Mayor Goldsworthy reported that he had visited Victoria and while there had interviewed Public Utilities officials. They had advised him that they would give the City any reports they have on any subject which they be deal with and the Commission will send over their staff report on the application of the B. C. E. R. Company for an increase in fares.

His Worship advised that he had met with Premier Johnson and they had discussed Hospital, Education and Social Welfare matters. He had been advised by the Premier that something concrete will be forthcoming at the next session of the Legislature in regard to the above matter.

Alderman A.M. Stewart reported that Superintendent Greenwood had been investigating the various water agreements between the City and District and he asked for confirmation of the Superintendent's action in this regard.

Moved by Alderman A.M. Stewart, seconded by Alderman Gostick that Superintendent Greenwood be authorized to investigate the conditions of delivery and sale of water to the District of North Vancouver as set out in the various Agreements now in effect.
