CORRESPONDENCE

From North Vancouver School District No. 44, thanking the Council for the Gift of an Electric Clock for the new Vocational Training School. Moved by Alderman A. M. Stewart, seconded by Alderman Gostick that this letter be received and filed. Carried

From L. & K. Lumber (North Shore) Limited, requesting that the Corporation clean out the ditch on the north side of the Low Level Road opposite their property.

Superintendent Greenwood reported that the work had been carried out as requested but he asked for a ruling whether the Corporation should be responsible for the upkeep of culverts on National Harbour Board property south of the Low Level Road.

Moved by Alderman Copping, seconded by Alderman Gostick that the L. & K. Lumber (North Shore) Limited be advised that the necessary work has been carried out in this regard and further that the Solicitor be asked for a ruling as to the Corporation's responsibility for the upkeep of culverts on the south side of the highway. From North Vancouver School District No. 44, requesting that the City Council transfer Lots 1 to 6 inclusive and 22 to 24 inclusive, Resub. 2, Block 207, D.L. 545 to the Board for the purpose of erecting thereon a Gymnasium-Cafeteria for School purposes.

Referred to Finance Committee report.

From the B. C. Fire Chief's Association, advising of the Annual Fire College to be held in Kelowna during the coming year and inviting the Fire Chief Members of the Department and the Chairman of the Fire 3 Committee to attend.

Referred by the Mayor to the Fire and Light and Finance Committees for report.

From R. F. Macnaghten, asking if the Corporation would agree to the erection by Mr. T. W. Armstrong of a Taxi office on skids, to be located at the rear of Lot 6, Block 38, D.L. 548/9.

Moved by Alderman Copping, seconded by Alderman Gostick that this request be referred to the Building Committee and Taxi Committee for report and that Mr. Macnaghten be advised accordingly. Carried

From the Victorian Order of Nurses, requesting an increase of \$485.00 in their 1948 Grant because of the considerable growth in the work of the nurses.

FERRY COMMITTEE

RECOMMEND that North Shore Marine Basin be advised that at the present time the Council has no intention of leasing the Chesterfield Avenue 7 wharf.

RECOMMEND that the City and District Property Owners' Association be advised that when the present turnstiles at the ferry are altered, it is anticipated that the present rest rooms will be made available to the public without charge, but that it further be pointed out that the g present ferry patrons may use the rest room facilities on payment of the usual fare.

RECOMMEND that 14th Street and 16th Street for 200 feet west of Lonsdale be used for diagonal Parking on both sides of the Street and that the work be undertaken as soon as the weather is favourable and when funds permit.

Alderman Copping reported that his Committee along with the Superintendent will be bringing in a recommendation at a future meeting as to the policy w to be followed in the financing and construction of new sidewalks, sewers, lânes, etc.

RECOMMEND that the lane running East and West between 16th and 17th Street and between St. Andrew's and the Boulevard be graded and opened to traffic as soon as the Superintendent has equipment available to do the work.

RECOMMEND that the Superintendent be instructed to clear brush from rim to rim of the ravine lying adjacent to Rufus Street, from the lane South of 19th Street to 16th Street and further that he install a wooden flume to take care of drainage for the area.

Moved by Alderman Copping, seconded by Alderman Gostick that the above recommendations and report of the Board of Works Committee be adopted. Carried

WATERWORKS COMMITTEE

RECOMMEND that the City Solicitor be asked to give his opinion in writing with regard to the Registrar, Land Registry Office, allowing the division of Lot "A", Block 22, D.L. 273 into the North and South a laves, and that the owner of the North half of Lot "A" be supplied with a copy of the Solicitor's opinion.

Moved by Alderman Gostick, seconded by Alderman A. Stewart that the above recommendation of the Waterworks Committee be adopted. Carried

PARKS & CEMETERY COMMITTEE

RECOMMEND that the Cemetery By-law be amended increasing the cost of digging graves from \$15.00 to \$20.00.

Moved by Alderman A. Stewart, seconded by Alderman Gostick that the above recommendation of the Parks & Cemetery Committee be adopted. Carried

At this point Alderman E. N. Copping reported that he had attended on behalf of the Council, a meeting of the Metropolitan Parks Planning Committee in Vancouver on February 26th 1948.

A proposal had been introduced at the meeting asking that Garibaldi Park be turned over to the Dominion Government. However, a resolution in this connection was turned down and an emendment was passed requesting that Garibaldi Park remain under Provincial jurisdiction.

Alderman Copping reported that a Committee had been formed by the Metropolitan Parks Planning group to interview the Indians with a view to purchasing for Park purposes, the area on the North Shore opposite Stanley & Park with a view to making an attractive entrance to the Harbour.

The Mayor thanked Alderman Copping for his report.

FIRE & LIGHT COMMITTEE

Alderman A. Stewart reported that his Committee will have a recommendation to make in the near future with regard to the application of R. F. Gardiner concerning the location of Street lights on the Boulevard.

LABOUR RELATIONS COMMITTEE

Alderman A. M. Stewart reported that his Committee had reached an agreement on wages and salaries with the North Vancouver Civic Employees Association but that he did not wish to make any specific recommendation at this time until certain clauses in the working agreement have been drafted and approved by both parties.

Alderman A. M. Stewart reported that it is the intention of the Labour Relations Committee and the Fire and Light Committee to meet with members 9 of the Fire Department in the near future to discuss the working agreement of the employees in that Department.

TRANSPORTATION COMMITTEE

THAT provided service to the public is adequately maintained by local taxi operators, we recommend that licences be not granted to taxi operators in to other Municipalities unless a reciprocable arrangement exists so that North Vancouver Taxi operators can be licensed in such other Municipalities.

THAT WHEREAS it would appear from President Grauer's letter of January 19th 1948 that the Company's present deficit below cost of service for North Vancouver bus system local and inter-City is running at the rate of about \$145,000.00 per year, and that revised figures computed by P. U. C. would show an increase of about \$7,500.00, making an annual deficit of approximately \$152,500.00.

AND WHEREAS in computing such deficit the revised Company's figures including depreciation show a total operating cost per mile of 41.07 cents as against 28.16 cents per mile for the Municipal system

of West Vancouver,

AND WHEREAS consideration must be given to the fact that the cost of operation in North Vancouver on account of more burdensome grades is greater than in West Vancouver which may qualify the figures compar-

ing cost of operation in those municipalities,

THEREFORE BE IT RESOLVED that in view of the City Treasurer's report and after interviews with the Public Utilities Commission and Officials of the Company, the Council requests that the P. U. C. consider a modification of the proposed increased rates; provided that this resolution shall not be taken as an admission on the part of the City of the accuracy of any figures or financial statements made on incomplete audits and provided further that this resolution shall be taken to be made Without Prejudice to the City's rights.

RECOMMEND that a copy of the above resolution be forwarded to Commissioner Sowden

Alderman Cates reported progress in this matter advising that the Fire Chief has further information yet to secure.

MOTIONS

Moved by Alderman Gostick, seconded by Alderman A. M. Stewart that a Special Committee be appointed to ascertain if it is possible to secure additional revenue from Trade Licences as early as possible.

Mayor Goldsworthy appointed Alderman Gostick, White & A. Stewart as a Special Committee to investigate this matter.

NEW BUSINESS

The Clerk reported that By-laws No. 1838, 1842 and 1843 were now q registered in the County Court.

Ordered received and filed.

The Clerk reported that 8 notices of appeal had been received by him against the assessment of certain lands on Lonsdale Avenue.

Moved by Alderman Copping, seconded by Alderman A. Stewart that Mr. Donaghy, City Solicitor, be authorized to defend the Corporation in the matter of the above appeals and that every assistance be given him by the various Corporation officials. Carried

The Clerk submitted a report on the Wednesday Closing Petition received at the Council meeting on February 2nd 1948.

Moved by Alderman Copping, seconded by Alderman Cates that a copy of this report be forwarded to the Retail Merchants Bureau of the Board of Trade for consideration with other information previously submitted by the Council in this regard. Carried

Moved by Alderman A. M. Stewart, seconded by Alderman Gostick and resolved that the Mayor and Clerk of the City of North Vancouver be and are hereby authorized to execute and sign a Certificate detailing the following persons permanent employees of the Corporation under the "Unemployment Insurance Act, 1940."

Henry Lord - effective November 1st 1945 Stephen Morris - effective May 1st 1946. Alderman White brought up the matter of the issuance of a Beer Licence to the Olympic Estates Limited.

His Worship Mayor Goldsworthy reported that the Company had obtained a Building Permit for alterations to their premises and the Company had estimated the cost of alterations at \$25,000.00. The work to be carried out would place the building back into the same lay out as was in effect approximately 20 years ago and this would appear to be out of line with previous promises made by the Company both before and after the Beer Plebiscite was held in the City.

His Worship also reported that he had talked the matter over with Mr. Kennedy of the Liquor Control Board when he was in Victoria on February 27th as there might be a possibility that the Beer licence would be 2 granted to the Company on March 1st 1948. He said that Mr. Kennedy had assured him that the beer licence would not be granted against the wishes of the City Council.

Alderman White stated that at the time of the Plebiscite certain promises were made for a new Hotel in the City of North Vancouver and as the City Council has a duty to protect the citizens at large he did not 3 feel that the present plans of the Company met the requirements of the City in providing suitable hotel accommodation.

All members of the Council expressed themselves in accord with Alderman White's remarks.

It was particularly pointed out that it is the intention of the Council to follow a policy of opposing the granting of any Beer Licence to premises which do not meet the requirements of the City with respect to suitable Hotel accommodation.

Moved by Alderman White, seconded by Alderman Gostick that in view of the promises made for a first class Hotel to meet the demands of the Community by the applicant to the City Council IT IS RESOLVED that the Liquor Control Board be respectfully requested to postpone granting of a beer licence to Olympic Estates Limited until such time as the promises have been implemented and further that a copy of this resolution be forwarded to Captain J. H. Cates, M. L. A.

BY-LAWS

Moved by Alderman Gostick, seconded by Alderman A. Stewart that "The City of North Vancouver Tax Lands Sale By-law 1948, No. 5" be reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal.

Whereupon the By-law was reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal and numbered 1844.

& All the members of the Council voted for this By-law.

Moved by Alderman A. M. Stewart, seconded by Alderman Cates that "The City of North Vancouver Highways Dedication By-law No. 1, 1948" be reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal.

Whereupon the By-law was reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal and numbered 1845.

UNFINISHED BUSINESS

The Clerk reported that the Town Planning Commission advised that they would not agree to the subdivision of any Lot in the City of North Vancouver into a less frontage than 50 feet and accordingly were not in favour of granting the request for subdivision by W. A. Dewey, Jr.

Moved by Alderman Copping, seconded by Alderman A. Stewart that Mr. W. A. Dewey, Jr. be advised that in view of the Town Planning Commission's recommendation, this City cannot grant his request for subdivision as stated in his letter of January 29th 1948. Carried

A letter was received from the International Woodworkers of America, Local 217, advising that their Union is pleased that the Gouncil is taking action to improve the Ambulance Service in the City of North Vancouver.

Moved by Alderman Gostick, seconded by Alderman White that this letter be received and filed. Carried

Alderman Copping reported that the matter of the proposed easement between the National Harbours Board and the Corporation for a watermain along the Low Level Road is being discussed with the Superintendent of Works and he would report at a subsequent meeting on this matter.

Alderman A. M. Stewart requested the Clerk to bring up the matter of the leasing of Fell Avenue extension to the M. B. King Lumber Company at the next Finance Committee meeting.

ANY OTHER COMPETENT BUSINESS

Letter was received from the North Vancouver Board of Trade Special Transportation Committee, suggesting that the Lonsdale Avenue Bus runs be altered to Trolley Bus operation as the Committee felt that the cost of operation of such vehicles would be considerably cheaper than operation of gasoline or diesel buses.

Mayor Goldsworthy reported that this matter had been discussed with the B. C. Electric Railway officials and a report would be made soon on this matter.

Moved by Alderman A. M. Stewart, seconded by Alderman Gostick that this Council do now adjourn. Whereupon the Council adjourned at 9:30 p.m.

From William Angus on behalf of Seylynn Recreations, asking permission to construct a snowman on the West side of the North Vancouver Ferry Dock, 30 feet South of the bus terminal, this display to be used in connection with the Seylynn Recreations drive for funds for playground purposes.

REPORTS OF COMMITTEES

FINANCE COMMITTEE

RECOMMEND that the North Vancouver School District No. 44 be advised that the Council now accepts the Ordinary Estimates of the Board as submitted in their letter and attached statements addressed to the City Clerk under date of March 8th 1948.

Moved by Alderman A. M. Stewart, seconded by Alderman Gostick that the above Recommendation of the Finance Committee be adopted. Carried

Alderman A. M. Stewart then gave an outline of the manner in which the 1948 Estimates of the City of North Vancouver had been prepared. He advised that the expenditures in the budget were those of strictest necessity. If the financial position of the Municipality improved during the coming year as a result of the sale of Tax Sale Lands or any other source, it might be possible to carry out additional work. He pointed out that the City of North Vancouver was adequately equipped with schools, 2 especially Junior Highschools, but that since the amalgamation with the District of North Vancouver it had become necessary to build additional accommodation. He contended that the District of North Vancouver should pay a larger share of school building costs, and might reasonably be expected to pay the full cost of the proposed Junior Highschool. The Estimates as now approved would call for the imposition of 55 mill tax levy, the same as last year.

RECOMMEND that the 1948 Estimates of the City of North Vancouver be prepared as approved by the various Committees, forwarded to the Minister of Municipal Affairs, and when approved by the latter, the Clerk authorized to prepare a By-law setting the tax rate for 1948 in accordance with the estimates so approved.

Moved by Alderman A. M. Stewart, seconded by Alderman Cates, that the above Recommendation of the Finance Committee be adopted. Carried

RECOMMEND that the Minister of Education and the Minister of Municipal Affairs be advised that this Council has been forced to reject the Extraordinary Estimates of the School Board, the main item being a Junior Highschool, which building is urgently needed in North Vancouver, and that it be pointed out that if there is any way that additional revenue can be provided that will enable this Municipality to accept the Extraordinary Estimates of the School Board, the Council is willing to do so, and that a copy of this Laccommendation be forwarded to J. H. Cates, M. L. A., and to the North Vancouver School Board, suggesting that the Board endorse the stand taken by the Council.

Herdman, and had discussed the allocation of the Policing costs of the North Shore, and it was now intended to hold a meeting with Commissioner Sowden to discuss the matter. A fuller report will be made at a future meeting.

RECOMMEND that the Resolution of the Council passed on December 17th 1945, setting aside in a special Bank account the sum of \$20,000.00 for New School Construction and the Resolution of the Council passed on December 15th 1947 setting aside the sum of \$18,832.00 for New School Construction be now reconsidered by this Council.

Moved by Alderman A. M. Stewart, seconded by Alderman White, that the above Recommendation of the Finance Committee be adopted. Carried

Moved by Alderman A. M. Stewart, seconded by Alderman Gostick that the sum of \$20,399.38, being balance now on hand in the special Bank account for New School Construction be and the same is hereby authorized to be spent for ordinary School Expenses. Carried

The Solicitor advised that National Harbours Board is liable to maintain at its own cost and expense, and keep in good condition and repair, all storm sewers and stream outlets in and over the property owned by the Board South of the Low Level Road. He suggested that if the Corporation has spent any monies on the maintenance of such sewers it might be possible to obtain reimbursement from the Board, if they were approached by the Superintendent of Works.

This matter was left in Mr. Greenwood's hands.

The Clerk advised the Labour Relations Committee that the North Vancouver Civic Employees Association wished to have a meeting with the Committee before the next monthly meeting of the Association, which is to be held on March 29th.
