& FINANCE COMMITTEE

Alderman A.M. Stewart reported that his Committee had met with the City Auditors and had discussed the recent arrangement made with the Provincial Government whereby certain City bonds held by the Provincial Government were cancelled in order to clean up a Relief Loan owed by the City to the Province.

Alderman Stewart pointed out that the cancellation of these Refunding Debentures was in addition to the Statutory amount required to be bought in and cancelled by the Board of Debt Retirement Trustees.

.RECOMMEND that the matter of the cancellation of the above debentures be referred to the Solicitor, Auditors and the City Treasurer for discussion and report.

LABOUR RELATIONS COMMITTEE

(1) Salary adjustments during the year, providing they are within the specified range and are recommended by the responsible Department head and approved by the Council.

(2) New clause provides for a probationery period when an employee is promoted or awarded a new position.

(3) Changes in the sickness and leave clauses, the main alteration providing for an accrual of 50% of unused sick pay up to a maximum of 30 days.

(4) New clause providing for 30 days' notice to permanent salaried employees and two weeks notice to permanent hourly employees when they are relieved of their position for reasons other than cause.

(5) A change in the hours of work clause, setting out the hours of work of the inside staff as 8:30 a.m. to 5:00 p.m. on Mondays, Tuesdays, Wednesdays, Thursdays and Fridays.

(6) A change in the overtime clause providing that in consideration of the granting of a five-day work week to the inside staff the Association agrees that no employee shall be entitled to overtime pay for work performed on any Saturday morning.

(7) A change in the salary schedule to provide for increases in the salaries of the inside staff of approximately \$20.00 per month, and increases to the hourly workers on the outside staff of approximately 13 cents per hour - retroactive to January 1st 1948.

Alderman A.M. Stewart reported that his Committee had been considering the setting up of a special representative group composed of representatives from the Council and the various Unions, to discuss the setting up of a Medical and Health plan for Corporation employees but that this matter had been left in abeyance until his Committee has studied the proposed Provincial Health Plan.

RECOMMEND that the salaries of those employees not covered by Union Agreements be increased in accordance with the Schedule agreed to by the Council in Committee, retroactive to January 1st 1948.

Moved by Alderman A.M. Stewart, seconded by Alderman Copping that the above report and recommendation of the Labour Relations Committee be adopted. Carried

FERRY COMMITTEE

- Nalderman Cates reported that the Boathouse owned by F. Griffiths was now properly moored at the foot of Chesterfield Avenue in accordance with the arrangements made.
- RECOMMEND that the North Shore Marine Basin Limited be advised that the Corporation is not considering the leasing of the Chesterfield Avenue Dock to anyone at this time.

BOARD OF WORKS COMMITTEE

RECOMMEND that the application of the Indian Agent to subdivide Lots 8 & 9, Block 71, D.L. 271 be not granted, as the Council's policy is similar to the policy of the Town Planning Commission, which is that no property shall be subdivided into less than 50 ft. lots in residential areas.

RECOMMEND that the application of Mr. Paul R. Brun for lane in the 300 Block West between 24th and 25th Streets, cannot be granted as it is the Council's policy not to open lanes of less than 20 feet in width, and that Mr. Brun be advised that property owners in this area have already been canvassed to dedicate the necessary extra width but they have refused.

Blacktop sidewalks shall not be permitted on the following streets:21st, 14th, 15th, 16th & 13th - for one block East & West of
Lonsdale;

1st, 2nd, 3rd, 4th and 15th - from boundary to boundary: and Keith Road from Marine Drive to Queensbury.

On all other streets the property owner shall have the choice of concrete, blacktop or sand, under the following conditions:-

- 1. Where 75% or more of the property in the Block is privately owned.
- 2. Where 100% of the privately owned property owners petition the Council for a sidewalk.
- 3. If the Petition is for concrete, that they shall deposit with the City Treesurer \$1.40 for every front foot of sidewalk required.
- 4. If the Petition is for blacktop, that they shall deposit with the City Treasurer, 70 cents for every front foot of sidewalk required.
- 5. Sand sidewalks to be put in at the discretion of the Council, and where not less than 75% of the property is privately owned.
- 6. Where a sidewalk has been petitioned and granted and built fronting City owned property, the cost of same shall be added to the sale price of the property.
- 7. The City shall decide what width of sidewalk is necessary for the area to be served, and shall bear the cost of anything over \$1.40, and if the property owner wishes a wider walk than the City is prepared to put in, he shall bear any additional cost.
 - 8. Before any work is undertaken by the City 100% of private property owners must pay their portion of the cost to the City Treasurer.

Moved by Alderman Copping, seconded by Alderman Gostick that the above recommendation of the Board of Works Committee be adopted. Carried

WATERWORKS COMMITTEE

RECOMMEND that water pumped by the District of North Vancouver from the Rice Lake line be charged for at the rate charged by the Greater Vancouver Water Board to the City of Vancouver, plus 20%.

Moved by Alderman A. Stewart, seconded by Alderman Copping that the above recommendation of the Parks Committee be adopted. Carried

A discussion followed on the advisability of floodlighting Mahon Park. RECOMMEND that the Superintendent of Works be authorized to erect the necessary poles to floodlight Mahon Park.

Alderman A.M. Stewart pointed out that he felt the Council was in favour of putting up flood lights in Mahon Park as soon as possible in order to get the whole scheme started, but if in the future the lights had to be changed to another location, those responsible for asking that they be located in Mahon Park should be responsible for looking after their transfer.

Alderman A. Stewart reported that the Grandstand in Confederation Park had been seriously damaged by fire at about midnight on April 17th, the 4 loss being well covered by Insurance. Alderman Copping reported that his Committee had met with a Special Committee of the Board of Trade and had discussed the possibility of operating Trolley Busses on Lonsdale Avenue; the desirability of a Bus connection at the Vancouver terminal and the present inadequate Bus connection between the City of North Vancouver and the District of West Vancouver.

SPECIAL COMMITTEE (All-day Wednesday Closing)

4 Alderman Copping reported that this Special Committee had held one meeting and was reporting progress.

NEW BUSINESS

Alderman White brought up the matter of Freight Rates to the North Shore. He said that the Burrard Rivet and Forge Co., which had formerly employed 75 men had moved to Marpole and was now employing 200 men. He said the Company had moved on account of the increase in tariffs west of Lonsdale Avenue. He stated that the local Board of Trade has been working on this matter with a view to getting a reduction in local freight rates and he asked the Council to get behind the Board of Trade in their attempt to get a lower tariff.

His Worship advised that the Burrard Rivet and Forge Co. Ltd., had supplied rivets to the Shipyards during the War and was subsidized by the Government and the Company had moved to Marpole because there was no further need for such a business as was required during the war years, and further he stated that the Company was not able to buy the land on which their premises were situated.

6 Mr. Jardine, President of the Board of Trade, was present and discussed the matter briefly with the Council.

Moved by Alderman Gostick, seconded by Alderman White that the Industrial Committee be instructed to work in conjunction with the Committee of the Board of Trade and attempt to get a solution to the inequality existing in freight rates between Vancouver and the North Shore, and to arrange if felt necessary, a meeting between interested groups. Carried

The Clerk submitted the Police Report for the month of March 1948. Ordered received and filed.

Application was received from Messrs. Drew, Zielke & Wilson to operate an additional Taxi.
