Minutes of a Special Meeting of the City Council held in the Council Chamber, City Hall, on Tuesday, May 25th 1948, at 8:00 p.m.

Present His Worship Mayor F. R. Goldsworthy, Alderman C. W. Cates, Alderman E. N. Copping, Alder-

man K. H. Gostick, Alderman A. Stewart and Alderman P. A. White.

The Clerk reported that this meeting had been posted for twenty-four hours and had been called for the purpose of discussing the following matters:

North Shore Union Board of Health All Day Wednesday Closing By-Laws Any Other Competent Business.

NORTH SHORE UNION BOARD OF HEALTH

Alderman Gostick submitted a summary of the history of the North Shore Health Unit. and this was read by the Clerk.

Discussion then followed on the proposal that the City enter into a Union Board of Health covering the North Shore.

Moved by Alderman Gostick, seconded by Alderman A. Stewart that the Clerk be authorized to write to the Deputy Minister of Health advising him that the City of North Vancouver is willing to enter into a Union Board of Health on the understanding that there must be a hard and fast method of sharing expenses and a hard and fast agreement for the method of operation, or, alternatively, the City would enter into a Union Board of Health set-up where the costs of operation would be shared on a per capita grant basis, and further that copies of this Resolution and the report of the Health Committee chairman be forwarded to the Deputy Minister of Health, Commissioner Sowden, Reeve Brown of West Vancouver, and the School Districts of North Vancouver and West Vancouver. Carried

Alderman Gostick drew attention to recent press announcements which gave the impression that the new Provincial Hospital Insurance would have the effect of interfering with the formation of a Union Board of Health. He pointed out that this was not the case, as generally speaking, the function of the Health Unit is in the main preventative, while the Hospitalization plan of the Government is of course an operation covering the curative side of sickness.

ALL DAY WEDNESDAY CLOSING

Alderman Copping read the report of the special Committee appointed to deal with the Petition received from certain merchants for All Day Wednesday Closing. The Committee report recommended that no action be taken with the Petition.

Alderman Cates advised that he wished to be recorded as being in favour of the Committee report as submitted, and Alderman White, the third member of the Committee, also supported the recommendation.

Moved by Alderman Copping, seconded by Alderman Cates, that the recommendation and report of the special Committee on All Day Wednesday Closing be adopted and minuted.

### -REPORT OF COMMITTEE ON ALL-DAY WEDNESDAY CLOSING-

The committee has given much thought to this question, a question to which the interested parties themselves have failed to find an answer. It concerns a form of legislation affording protection or benefit to a certain section of the public as distinct from the public as a whole. Apart from whether it may prove an inconvenience to those whom the merchants claim to serve, and whether it might prove detrimental to the economic life of the City, especially with no such regulations in the District, the Committee considers that the rights of a monority, when those rights are not hurtful to the public interests, should be respected.

The problem is not clear cut like the closing of the barber shops where the wishes of only one class were concerned. All Day Closing as required by this petition would regulate stores and shops of many categories, and it might well be that the merchants of one category would have to close against their will because of the wishes of merchants of another and possibly larger category. At the same time, some shops would be exempt altogether. And the issue is further aggravated in that certain stores compelled to close, sell merchandise similar to that handled by shops not compelled to close - such as drug stores.

It is not a question of hours of labour and benefit to the employee. That is a matter of Provincial government concern. The proposed All-Day Closing would not benefit the employees in food and drug stores. And it need hardly be pointed out that there is nothing to prevent a merchant voluntarily giving his employees a five day or a forty hour week - some do this.

We know of no law prohibiting a merchant from closing his store at any time. It is true that the Council has the power to legislate for this All-Day Closing without any petition being presented. But in view of all the circumstances, the Committee would be reluctant to recommend that this power be invoked. Indeed, we view with some concern the growing tendency in this day and age, of organizations and groups of individuals calling on government to legislate on questions of no special benefit to the citizens as a whole, which questions can often be solved just as efficiently and just as effectively by community or individual effort.

We therefore invite the merchants to get together and work out some agreement amoung themselves - possibly some arrangement of "staggered" closing days, as the gas stations have done. And if that idea is altogether too Utopian, then we would point out that there are plenty of capable middle aged persons desirous of part time employment during the hours when regular employees are on holiday.

The committee therefore, with all due regard for the problems of the merchants, recommends that no action be taken on this matter at this time.

Moved by Alderman Gostick, seconded by Alderman A. Stewart that this letter from Town Planning Commission be laid on the table for the time being until the Council have had an opportunity of studying the plan. Carried

Letter was received from the Town Planning Commission enclosing two copies of the zoning report and one copy of the Parks and Schools report, and Major Streets report. The Commission asked that additional copies be typed for the Commission members.

Moved by Alderman Copping, seconded by Alderman A. Stewart that the Clerk be authorized to make sufficient copies of the Bartholomew report for the members of the Council and the Town Planning Commission. Carried

Letter was received from the United Emergency Fund for Britain asking for grant.

Moved by Alderman A. Stewart, seconded by Alderman White that this matter be referred to the Finance Committee for recommendation. Carried

From the Pacific National Exhibition, extending an invitation to attend the Annual Director's Golf Tournament to be held at Exhibition Park on Thursday, May 27th, 1948.

May or Goldsworthy asked Alderman A. Stewart to attend this function.

Letter was received from the Kinsmen Club of North Vancouver asking permission to display a banner at the foot of Lonsdale Avenue, and on the City Ferries, to advertise the Carnival and Board of Trade Exhibition on June 23rd, 24th, 25th and 26th next.

Moved by Alderman Copping, seconded by Alderman White, that permission be granted to the Kinsmen Club to place a banner at the foot of Lonsdale Avenue for a period not exceeding fourteen days, providing the banner complies with the provisions of the Sign By-Law, and further that the Kinsmen Club be given permission to place the usual banner on the City Ferries. Carried

Application was received from Mr. W. D. Garriock, 2012 Cortell Avenue, applying to rent a vacant cabin in the City owned Rogers Block, West 2nd Street.

Moved by Alderman Gostick, seconded by Alderman Copping, that this request be referred to the Clerk and Treasurer to deal with, and further that the Building Committee be asked to bring in a recommendation covering the responsibility for the leasing, repair and collection of rent, etc., from the City owned dwellings. Carried

The Clerk recommended that a Labour Relations Committee meeting be held in the near future to deal with matters that have been pending.

It was decided to hold a special meeting of the Committee on May 31st, 1948, at 7:30 p.m.

Alderman A. Stewart, Alderman White and Alderman Cates then spoke of their meeting with the Indians to discuss the possibility of securing the Indian Reserve property on the North Shore near the First Narrows Bridge for Park purposes.

The matter was still being negotiated.

Moved by Alderman Copping, seconded by Alderman Gostick that this Council now adjourn.

Whereupon the Council adjourned at 9:45 p. m.

Minutes of Special Meeting of the Council, held in the Council Chamber, City Hall, on Monday, May 31st 1948 at 7 p.m.

His Worship Mayor F. R. Goldsworthy, Alderman C.W. Cates, Alderman E.N. Copping, Alderman K.H. Gostick, Alderman A. Stewart and Alderman P.A. White.

The meeting had been advertised for 24 hours as required by the "Municipal Act" and had been called for the purpose of transacting the following business:-

New Business By-laws Any other competent business.

NEW BUSINESS (SCHOOL SITE)

Dr. H. C. Graham, Chairman of School District No. 44 and Trustee C. H. Malcolm were present representing the School Board.

A discussion followed on the need for additional school accommodation. Mayor Goldsworthy expressed the opinion that the need for more School accommodation could be met by building more and smaller Primary or Elementary Schools.

Trustee Malcolm said that the Board would give serious consideration to the Mayor's suggestion but asked that the City Council endorse the Bartholomew recommendation for a new Junior High School possibly on Boulevard Park.

Dr. Graham felt that the Mayor's suggestion, that more and smaller Elementary Schools be built, was uneconomical from the standpoint of administration.

Alderman Gostick felt that in view of the endorsation of the Boulevard Park site by the Town Planning Commission and the School Board that the Council should approve of the proposed site at Boulevard Park in principle, provided that the School Board finds that the Mayor's suggestion for more and smaller Schools is not practical.

Moved by Alderman Copping, seconded by Alderman A. Stewart that the School Board and Special Committee of the Council appointed to investigate possible School sites, give further study to the Mayor's suggestion of smaller Schools and submit their recommendations in this regard and in the meantime a meeting be held by Mayor Goldsworthy, Dr. H. C. Graham and a representative of the Town Planning Commission with officials of the North Vancouver Land and Improvement Company to ascertain if the Company will allow Boulevard Park to be used for a School Site. Carried Dr. Graham & Trustee Malcolm then left.

POST OFFICE SITE

The Council then discussed possible sites for the new Post Office.

Moved by Alderman Copping, seconded by Alderman White that this
Council request the Federal Government to expedite the erection of a
Federal Building to be used as a Post Office on the present site
with a view to using the new building for other Federal purposes should
the need arise in the future for a new Post Office in another location
and further that this Council urgently request the Federal Government to
include a Customs service in the proposed new building. Carried

Flood Situation

Discussion followed on the B. C. Flood situation.

Mayor Goldsworthy reported that he had attended a meeting in Vancouver with other Municipal, Provincial and Federal officials to discuss the Flood Relief question.

The local Board of Trade has been asked to set up the machinery for collection of monies for flood relief, in accordance with instructions contained in telegrams to the Board from Mr. Austin Taylor, Chairman of the Flood Relief Fund.

His Worship advised that Mr. Norman Brown, Manager of the Bank of Montreal, had been appointed Treasurer of the Local Fund and other Bank Managers are authorized to receive donations.

His Worship advised that Superintendent Greenwood had taken two trucks and 15 men out to the flooded area and Mayor Mott of New Westminster had expressed appreciation for their services.

The Council then discussed the question of making a grant to the Flood Relief Fund.

It was decided to leave the matter over for consideration to the next regular meeting of the Council on Tuesday, June 8th and in the w meantime Mayor Goldsworthy was to take action sooner if necessary, upon confirmation of Council members.

The Council agreed that Lonsdale Hall would be made available to the Red Cross for use for flood relief purposes as soon as it is possible to do so.

### B.C.E.R. RATE HEARINGS

A report was received from the City Treasurer dealing with the Brief submitted to the Public Utilities Commission by the B. C. Electric Railway Co. Ltd., and Associated Companies with reference to proposed Rate Hearings.

The Treasurer reported that the application could be opposed by the Corporation on several grounds. He suggested that other affected Municipalities (exclusive of Vancouver) get together and see if they would be willing to retain one firm to prepare the necessary Brief on behalf of the Municipalities concerned.

Moved by Alderman Gostick, seconded by Alderman A. Stewart that the Treasurer ascertain if surrounding Municipalities would consider preparation of a Joint Brief to present to the Public Utilities Compression at the B. C. Electric Railway Rate Hearings, the cost of preparation to be shared on a per capita basis and if the Municipalities are interested in such a plan that they authorize their Finance Chairman and Treasurer to attend a joint meeting to discuss the matter. Carried

A request was received from St. John's Church for permission to have their Picnic Vessel pick up passengers at the Ferry Wharf on Wednesday, June 30th at 1 p.m.

The Clerk advised that the Ferry Superintendent approved of the equest.

Moved by Alderman Cates, seconded by Alderman White that permission be granted to St. John's Church to dock their picnic vessel as requested.

11 Carried

A letter was received from the Kinsmen Club, asking the City to enter a float in the Kinsmen Parade on June 26th 1948.

Moved by Alderman Gostick, seconded by Alderman Copping that the City venter a float as requested, in the Kinsmen Parade on June 26th and that the Publicity Committee be authorized to go ahead with the preparation of the Float. Carried

Letter was received from the Kiwanis Club of North Vancouver asking that Blocks 15 and 16 in D.L. 616 be reserved from sale for future use as a site for housing for elder citizens.

Moved by Alderman Gostick, seconded by Alderman White that the Kiwanis Club be advised that the Blocks of land referred to will be kept under the present Reserve from sale that is now placed on them. Carried

A letter and accompanying plan was submitted from Clelia Gallia, 120 West 2nd Street, asking the Council to approve the granting of a beer licence at this location.

Moved by Alderman Copping, seconded by Alderman Cates that this request be referred to the Building Committee for report to Committee of the Whole Council. Carried

Letter and accompanying plans were received from Mr. A. G. Gaunt, Manager of Montrose Hotel, 170 West Esplanade, asking the Council to approve of his plans for a new wing on the Hotel to be used as a Beer parlour.

Moved by Alderman Copping, seconded by Alderman Cates that this request be referred to the Building Committee for report to Committee of the Whole Council. Carried

A letter of complaint was received from Mr. Alex. Gaunt, Manager, Montrose Hotel, 170 Esplanade West, concerning the condition of the ditch along the north side of Esplanade, near his premises.

Referred to the Board of Works Committee for recommendation.

Letter was received from Dr. W. H. Inkster, requesting permission to open the South  $\frac{1}{2}$  of Lane between 10th and 11th Streets on the East side of the Grand Boulevard.

Moved by Alderman Gostick, seconded by Alderman A. Stewart that this request be referred to the Board of Works Committee with power to act. Carried

BY-LAWS

Moved by Alderman A. Stewart, seconded by Alderman Gostick that the "Central Mortgage and Housing Corporation Conveyance By-law, 1948" be reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal. Carried Whereupon the By-law was reconsidered, finally adopted, and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal and numbered 1861.

Moved by Alderman Gostick, seconded by Alderman A. Stewart that the "City of North Vancouver Tax Lands Sale By-law 1948, No. 11" be introduced and read a first time. Carried

Whereupon the By-law was read a first time.

Moved by Alderman Gostick, seconded by Alderman A. Stewart that the "City of North Vancouver Tax Lands Sale By-law 1948, No. 11" be now fread a second time. Carried

Whereupon the By-law was read a second time.

Moved by Alderman A. Stewart, seconded by Alderman Gostick that the Committee proceedings be dispensed with and that "The City of North Vancouver Tax Lands Sale By-law 1948, No. 11" be read a third time. Carried

Whereupon the By-law was read a third time.

Moved by Alderman A. Stewart, seconded by Alderman Gostick that the "City of North Vancouver Tax Lands Sale By-law 1948, No. 11" be passed by the Council, subject to reconsideration. Carried

ANY OTHER COMPETENT BUSINESS

The Finance Committee agreed to meet with the Directors of ANVA on Wednesday, June 2nd 1948 at 7 p.m. to discuss the operation of the ANVA Veterans Apartments.

The Clerk reported that the Solicitor required authority to proceed against Tom Mills to recover possession of the City owned premises he now occupies.

Moved by Alderman Gostick, seconded by Alderman White and resolved that the Solicitor be instructed to issue a writ against Tom Mills to recover possession of Lot 5, Block 153, D.L. 274.

An offer was received from Ernest G. Silverton on behalf of A. R. Leland, to pay an additional sum of \$50.00 together with his Lot 32, Block 8, D.L. 272 in exchange for City Lot 16, Block 116, D.L. 274.

Moved by Alderman Copping, seconded by Alderman A; Stewart that provided Mr. A. R. Leland pays the sum of \$50.00 principal and is willing to convey his Lot 32, Block 8, D.L. 272 to the Corporation that an exchange By-law be prepared authorizing the Corporation to convey to Mr. Leland in exchange Lot 16, Block 116, D.L. 274. Carried

Alderman Cates reported that his Committee had considered with the Ferry Superintendent, the advisability of constructing a new lead at the Vancouver Ferry dock but it was felt that due to the cost that the work be not proceeded with this year. Accordingly he moved as follows:

Moved by Alderman Cates, seconded by Alderman White that W.Greenlees and the Vancouver Pile Driving and Contracting Co. Ltd. be notified that the Council have decided not to accept any of the tenders for the construction and installation of a lead at the Vancouver Ferry Dock at this time. Carried

A Certified copy of an Order of the Board of Transport Commissioners No. 70786 dated May 25th 1948 was received, covering the approval by the Board of the issuance of certain Capital Shares of the B.C. P Telephone Company.

Moved by Alderman Gostick, seconded by Alderman Copping that this information be received and filed. Carried

The Council deferred consideration of the application of Mr. J. Crowell to purchase Lots 68 and 69, Resub. 4, Block 4, D.L. 547-8 until the next Committee meeting.

Alderman A. Stewart reported progress in the matter of the replacing of the Confederation Park Grandstand facilities.

In view of Superintendent Greenwood's absence on Flood Relief duties no action was taken on the proposed "Road and Lane Policy" by the Council.

The Clerk was instructed to supply copies of same to all members of the Council as soon as possible.

Alderman Gostick reported that the Special Trade License Committee had referred the proposed "Trade License By-law" to the City Solicitor and it is possible that the new By-law may be ready for the next meeting on Tuesday, June 8th.

Moved by Alderman Copping, seconded by Alderman Gostick that this Council do now adjourn.
