From the North Vancouver Public Library Association asking if the Council would continue the usual Grant for the current year. Moved by Alderman A. M. Stewart, seconded by Alderman White

that the usual Grant of \$240.00 be made to the North Vancouver Public Library Association and that a cheque be forwarded in this amount as soon as possible. Carried

The Clerk reported that he had received two letters of a similar anature requesting water connections, one being from Mr. C. R. Pærkes and the other from Mr. R. S. Alexander.

A report was submitted from the Superintendent of Works concerning the above applications. The Superintendent advised that it has been found possible to give the parties in question, water connection although the pressure and volume may not be all that it should be.' The Superintendent recommended that some warning should be issued to

people who buy lots privately, to the effect that they should check up at the City Hall to see if the lot can be serviced by the City.

Moved by Alderman A. M. Stewart, seconded by Alderman Copping that the Superintendent be authorized to make the necessary water connections to Lot 6, Resub. 6/ 2/1&2/ 2/23 & 24/ 547, owner C. R. Parkes, and to R. S. Alexander - Lot 11/ 34/ 552. Carried

The Press was asked to give suitable prominence to the Superintendent's recommendation regarding purchasers buying unserviced private lots.

Letter was received from K. Warford, 344 East 21st Street, complaining of the condition of the sidewalk on 21st Street East of St. Andrew's Ave.

The Superintendent advised that the old Board sidewalk will be removed and a gravel one constructed as soon as possible. The Clerk was instructed to advise the complainant accordingly.

A letter was received from Reeve R. M. Grauer of the Township of Richmond, expressing appreciation of the services of Mr. J. M. Greenwood and his crews during the recent flood crisis. Ordered received and filed.

From Marian A. Barclay, 227 West 6th Street, complaining of the

condition of the roads and Boulevards in Ottawa Gardens.

A report was attached from the Superintendent of Works advising of the work which had been done in the area complained of. He pointed out that the small Parks budget had been seriously overspent and that the area should be graded and levelled and planted in lawn some time in the future. He advised that 6th Street had not been paved from Sutherland to Chesterfield but had been given a surface treatment because the condition of the sub grade was such that this work could be done. Drainage and subgrade in Ottawa Gardens is not suitable at this time for any form of surface treatment without considerable preliminary work being done. He recommended that the corners at Chesterfield Avenue be rounded off to make the gardens oval in shape. Moved by Alderman Copping, seconded by Alderman White that Mrs. Barcley be advised of the reasons why the roads on both sides of Ottawa

Gardens had not been surfaced in the same manner as the remainder of 6th Street, and that she be advised also of the intention of the Board of Works with regard to the improvement of this area. Carried. The matter of creating rounded entrances into Ottawa Gardens was

referred to the Board of Works Committee for consideration.

A letter and attached agreement was received from the Superannuation Branch, advising that the Corporation may include over-age employees in the Superannuation Fund providing the necessary agreement is entered into between the Department and the Corporation.

REPORTS OF COMMITTEES

FINANCE COMMITTEE

Alderman A. M. Stewart reported that the matter of granting financial 5 aid to the B. C. Cancer Foundation was being given further study by the Committee and a recommendation would be made at a later meeting.

Alderman A. M. Stewart reported that his Committee had met with a delegation of the Grand Boulevard Property Owners Association, the latter Association being concerned with the maintaining of certain Building Restrictions on the Boulevard, the present values in the

Private Act being now out of date and it being required that a renewal of the Act must be made at the end of the current year. Alderman A. M. Stewart reported that his Committee might have

a definite recommendation to make in this regard in the near future.

Alderman A. M. Stewart reported that approximately \$44,000.00 was collected on the 17th being the last day for payment of taxes without penalty.

Between January and July 17/47 approximately \$292,000.00 had been collected and during the same period this year a total of \$317,000.00 had been collected. 85.3% had been collected of the gross levy in 1947 as compared with 80.5% in 1948.

Alderman A. M. Stewart advised that figures had been obtained comparing the Park expenditures for 1946, 1947 and 1948 and this showed that on comparison the Parks Committee had been very well treated financially during the current year.

### LABOUR RELATIONS COMMITTEE

RECOMMEND that the Mayor and Clerk be authorized to amend the present agreement with the Canadian Merchant Service Guild, effective April 1st 1948, providing for a salary increase of \$20.00 per month to Masters and Mates employed on the City Ferries.

Moved by Alderman A. M. Stewart, seconded by Alderman White that the above recommendation of the Labour Relations Committee be adopted. Carried

Alderman A. M. Stewart advised that the question of granting 3 weeks holideys after 15 years service was still under consideration and if it could be worked out without disorganizing the Ferry service, the Committee would be willing to recommend it. 5

RECOMMEND that a Council Committee be appointed to meet with a representative from each of the Employee Unions, to discuss the possibility of instituting a Medical and Hospital plan to cover employees of the Corporation.

RECOMMEND that the Canadian Merchant Service Guild be invited to submit any suggestions for improving the Ferry service that might be received by the Guild from time to time from personnel y under its jurisdiction.

The Mayor appointed the Labour Relations Committee to meet with the employee representatives to discuss the possible Medical and Hospital plan.

The Mayor appointed the Ferry Committee to deal with any suggestions \* received from the Canadian Merchants Service Guild.

The Finance Chairman then drew to the attention of the Council that Bill Parnell and Miss Kay McNamee, residing on the North Shore had been selected as members of Canada's Olympic Team and he felt that the Council should make some official recognition of their success in this regard.

Moved by Alderman Copping, seconded by Alderman A. M. Stewart that a letter of congratulation be forwarded to the parents of both Mr. Parnell and Miss McNamee and further that a wire of congratulations and good wishes be sent on behalf of the Council to both participants at the Olympic games in London. Carried

### BOARD OF WORKS COMMITTEE

RECOMMEND that the Petitioners signing the petition dated May 18th 1948 to the City Council asking for a road connection from Yorkshire Crescent to Hamilton Avenue, be advised that the Council has investigated their request and find that there is not sufficient justification for building an outlet as requested, but that in the mean-
