Electric Railway Company Limited advising that they are prepared to delete the clause from the Overhead Street Lighting (Agreement with the City under which the Corporation agreed to pay half the cost of repair or replacement of lamps and other street lighting equipment of the Company wilfully damaged by any person or persons.

Petition was received from Irwin and Billings Company Limited, Larson Holdings and Jack Loutet and Company Limited, asking for a One-Way Traffic By-Law covering the lane between Lots 15, 16, 17, 18, 20A, 21A, Block 165, District Lots 271 - 274, and also requesting that the lane surface be constructed so that the surface water will drain East to Lonsdale Avenue.

The Superintendent drew the attention of the Council to the lane policy which was adopted in June 1948, wherein the suggestion was made that possibly the merchants or property owners in the downtown section should be approached with a view to their bearing the cost of paving the lanes adjacent to their property as was done in the lane between 2nd and 3rd Streets East of Lonsdale Avenue.

Stewart, seconded by Alderman White that the Superintendent be authorized to interview the owners in the above Petition, and also Mr. William Craig, 113 Lonsdale Avenue, with a view to ascertaining if they would bear the cost of paving the lanes referred to in their applications. REPORTS OF COMMITTEES

FINANCE COMMITTEE

Alderman A. M. Stewart reported that an examination of the financial position of the Ferries as at June 30th showed that the revenue was \$10,000.00 to \$11,000.00 behind the estimated revenue, and if such deficit continued at the same rate the amount of revenue received by December 31st would be down by approximately \$21,000.00 from the estimated revenue for the year. The Alderman advised that passenger figures showed a considerable drop for the first six months of this year, compared with the first six months of last year, being approximately \$1,336,000.00 for the first six months of 1948, as compared with \$1,493,000.00 for the first six months of 1947. The comparison of the vehicles carried during the same period showed that 54,876 were carried in 1948 as compared with 60,869 in 1947 for the same period last year.

BOARD OF WORKS COMMITTEE

RECOMMEND that the Superintendent be authorized to proceed immediately with the following construction:

(1) The widening of Forbes Avenue from Esplanade to 3rd Street at an estimated cost of \$3,000.00.

(2) The alteration of curves at the intersection of Queensbury and Keith Road - estimate \$1,000.00.

(3) The opening up of Jones Avenue and rough grading from 23rd to 20th Street. Estimate \$3,500.00 - and that the necessary By-Law be prepared to expend the above sums from reserve funds under 50/C.

Alderman Cates reported that he had given the matter of coffee bars on the Ferries careful consideration, but as the Ferry Superintendent is on holiday, he felt it wise to leave this matter over until the next meeting when he will bring in a recommendation.

BUILDING COMMITTEE

Applications were received from E. F. Pacey to build the following:

Triplex building on Lot "F", Block 32, D.L. 549 at a cost of \$11,500.00

Duplex building on Lot "G", Block 32, D.L. 549 at a cost of \$9,500.00

Duplex building on Lot "A", Block 32, D.L. 549 at a cost of \$9,000.00

Alderman White reported that in buildings of this nature it was necessary for the Building Inspector to submit same for the approval of the Council. He stated that Mr. Pacey was prepared to meet the requirements of the Building and Sanitary Inspector by making a fill to take care of the drainage and installing septic tanks.

Moved by Alderman White, seconded by Alderman Cates that the above applications be approved by this Council. Carried

RECOMMEND that the Clerk advise the Montrose Hotel Co. and the Liquor Commissioner that the Council is in accord with the whole general plan and proposed development of the Company's property as submitted on August 2, 1948 and would waive any objections to the granting of a beer license upon the completion by the Company of the alterations and additions to their premises in accordance with the blueprints submitted on the above date, on the understanding that the balance of the Company's plans and proposals as contained in their letter of August 2nd, 1948 be completed within one year from the granting of the said license and providing that the necessary detailed plans are submitted to the Building Inspector and approved by him.

BOARD OF WORKS COMMITTEE

Alderman Copping reported that the matter of the One-Way lane is still waiting for replies from two of the applicants.

RECOMMEND that Mr. Turner be advised that the City cannot install the sidewalk asked for on 5th Street East at the present time, but the matter will receive attention with other locations as the Sidewalk Policy of the City is carried out in the future.

Moved by Alderman Copping, seconded by Alderman Gostick that the above recommendation of the Board of Works Committee be adopted. Carried

Alderman Copping reported that 13th Street, which they had paved and erected "SLOW" Signs on, was being used as a Speedway.

RECOMMEND that the Police Department be asked to prosecute people breaking the speed limits in this area.

WATERWORKS COMMITTEE

RECOMMEND that a Hydrauger, Model L.2 be purchased for the Waterworks Department at an estimated cost of \$1,914.00 and that the necessary By-law be prepared to have the money taken out of proceeds of the sale of tex sale lands.

Moved by Alderman Gostick, seconded by Alderman Copping that the above recommendation of the Waterworks Committee be adopted. Carried

Alderman Gostick reported that a meeting had been held with the Harbour Commissioners the other day regarding watermain on the Low Level Road, and Easement.

After discussion it was obvious that the City Council was responsible for the laying of that pipe, and the matter was left at that.

It was decided not to have the Easement at the present time, and if it was decided to lay a main, we would lay it on the road allowance. However, the matter was left open so that if any future Council should require the Easement it would be obtainable.

The complaint of the tenants was for water for more Fire Protection, and we will have to discuss with them some solution for this problem.

The Mayor explained that the first Agreement was entered into in 1926, and the Easement was requested by the Commissioner in 1940 to have the main laid on the South side of the Railway track, but now it is found more economical to have the main South of the road.

FIRE AND LIGHT COMMITTEE

RECOMMEND that Mr. H. G. Robertson be and he is hereby appointed permanent City Electrician and Electrical Inspector to carry out the duties as such, under By-law #738 passed May 17th, 1926, to regulate and authorize the inspection of the installation, arrangement, alteration, repair, use and operation of electric wiring, connections, fixtures and apparatus in the City of North Vancouver, together with the amendment #1812 to the above By-law passed July 4th, 1947.

Moved by Alderman A. Stewart, seconded by Alderman Gostick that the above recommendation of the Fire and Light Committee be adopted. Carried

Moved by Alderman A. Stewart, seconded by Alderman Gostick and resolved that the Mayor and Clerk of the City of North Vancouver be and are hereby authorized to execute and sign a Certificate detailing the following person a permanent employee of the Corporation under the "Unemployment Insurance Act, 1940" effective August 1st 1948:

Harry Govan Robertson.

Moved by Alderman A. Stewart, seconded by Alderman Gostick that Harry Govan Robertson be included in the Employees Group Life Insurance Scheme. Carried

Semi-annual Reports were received from the Fire Chief, covering the number of Alarms, total risk, insurance and loss in both the City and the District, also the Fire Warden's Report for the same period.

Alderman A. Stewart read the proposed recommendation, and the Mayor reported that after comparing our Fire Department with those of other Cities of equal size in British Columbia we find our staff is far in excess of other Cities of comparative size.

RECOMMEND that the strength of the North Vancouver Fire Department be altered to a total of twenty-one (21) men comprising:

The Department Chief 18 officers and men 1 Holiday relief man 1 Fire Warden,

and that all other recommendations as submitted be left to the Chief to carry out at his own discretion.

Moved by Alderman A. Stewart, seconded by Alderman Gostick that the above recommendation of the Fire and Light Committee be adopted. Carried

Moved by Alderman Gostick, seconded by Alderman Copping, that the Chief be instructed to give a monthly report to the Council. Carried

At this point Mayor Goldsworthy asked Alderman A. Stewart to take the chair.

RE FERRIES

Mayor Goldsworthy then suggested that the changes in Ferry services be considered. The Mayor stated that it had been very difficult to obtain information from the Canadian Beaver Company of Toronto as to just when the automatic turnstiles would be delivered, and he suggested that Proposal "A" be put into effect.

Moved by Alderman Copping, seconded by Alderman Gostick that Proposal "D" be adopted as soon as the necessary arrangements can be made. Carried, with Alderman Cates voting against.

Mayor Goldsworthy asked that members of Council voting against resolutions give their reasons for so doing.

Whereupon Alderman Cates stated that he considered that the Ferry services are being jeopardized by cutting off the evening service, and he suggested that the P:U.C. be asked to grant a raise in fares to three (3) passenger tickets for twenty-five cents (25ϕ) and six (6) car tickets for One Dollar (\$1.00), this to include the driver.

PROPOSAL "D"

<u>SECTION A</u> - Change in Ferry Service

Proposed:

(1) That first Ferry leave North Vencouver at 6:20 a.m. daily, to coincide with first morning busses arriving at Ferry wharf. The 6:00 a.m. trip which would be eliminated, now carries a daily average of 6.28 passengers, and connects with no busses.

This would make the first trip from Vancouver at 6:40 in the morning. The first trip which at present leaves Vancouver at 6:20 a.m. would be eliminated. This 6:20 a.m. trip now carries a daily average of 23.2 passengers, with a low of 12 during the trial period.

- A 40 minute service from Vancouver from 6:40 p.m. to 1:20 a.m. inclusive.

SECTION B

The adoption of this proposal would give eleven evening trips from North Vancouver, commencing at 6:20 p.m. The present schedule gives seventeen trips, so that in the evening, service would be reduced by a total of only six round trips.

SECTION D - Annual Passenger Revenue Loss Through Elimination of Six Evening Trips

CANADIAN FEDERATION OF MAYORS

Halifax, Nova Scotia.

June 22nd - 26th, 1948.

Gentlemen:

It is a time-honoured tradition for the Mayor to report on the above conference, but before I proceed with this report, I would like to first take advantage of this opportunity to express again my deep sense of the honour which has been mine of serving you, in the office of Mayor. I realize today, even more than I did six months ago, that being the Mayor of the City of North Vancouver carries with it a high responsibility as well as wide opportunity for service. In attempting to discharge that responsibility and take full advantage of the opportunity of service, within the limits of my ability, I have learned a great deal concerning the vision, the energy, the courage and the capacity which characterize the members of our city council, our Board of Trade and other service organizations in their approach to their individual problems, and in their co-operative relationship to the economic progress of our North Shore.

In accordance with the tradition, I shall not attempt to traverse the whole territory covered at this Conference, but rather be as brief as possible covering the more important factors, which may influence our future development.

The purpose of the Canadian Federation of Mayors is to increase the efficiency and raise the standard of municipal administration throughout the Dominion. To act as a clearing house for the collection, exchange and dissemination of statistics and general information on all manner of municipal practices and procedures. Such information as is gathered is made available to all members. Further to organize annual and, where necessary, other meetings of mayors and civic officials for the discussions and study of municipal problems and matters of interest to municipalities. To act as a research organization in the interest of local government in Canada and publish such results as an aid toward betterment of administration. To represent the interests of Canadian Cities before our Federal Government, and to work towards uniformity in municipal practice and co-ordination in the presentation of statistics, with a higher degree of efficiency.

The Executive Director of the Federation is charged with the responsibility of managing the Federation's office in Montreal, under the supervision of the Executive Committee, formulating policies and planning projects for submission to the Executive Committee, and for the execution of such projects and the pursuance of such policies as approved.

The eleventh annual conference was formally opened at 9:40 a.m., June 22, 1948 in the Ballroom of the Nova Scotian Hotel with an excellent address of welcome by Mayor J.E. Ahern of the City of Halifax. Followed by a very timely address by Federation President, Mayor Ray T. Forbes of Fredericton, New Brunswick.

A report of the special committee on <u>Dominion-Provincial-Municipal</u> Relations was read with the main points as follows:

Some Provinces have made certain adjustments involving grants-in-aid to municipalities or by relieving them of a larger portion of the costs of either education or social services. But, in no instance, has such relief been commensurate with the new burden added to its narrow revenue base of municipal governments consequent upon the emergence or expansion of such services to the people of Canada. Responsible municipal administrators are in accord in stating that the costs of services rendered to people as against the costs of services rendered to property are mounting in disproportionate relationship with no corresponding new source of tax income or other municipal revenue sufficient to enable municipalities to adequately discharge the obligations involved.

Nonetheless, it is true, municipal finances, by and large, are in a better shape today than they were when the Federation presented its brief to the Rowell-Sirois Commission in 1938. But the improved financial position of municipalities has not been brought about because of the correction of

the anomalies in inter-governmental fiscal and administrative relations which then, as now, characterize the governmental structure of Canada.

Rather, the general prosperity engendered by the war, has served to increase current tax revenues and to permit the liquidation of long-standing local tax default. These circumstances are the primary reasons which have enabled municipalities to restore their present financial affairs to a relatively sound basis. But given even a short period of business recession, most municipalities would, once again, be facing a difficult financial position, which might very easily be repeated unless the financial base of municipal government is under-pinned by the assurance of more adequate revenue resources than presently are available.

The costs of local government, like all other costs, have greatly increased during recent years, and they are not likely to grow less. The main source of municipal revenue is taxation of real estate, and, although the value of real estate has risen, it has not kept pace with the increased value of other types of wealth, such as that represented by industrial and commercial enterprise; nor has the enhanced value of real estate found a parallel increase on the tax rolls of the municipal assessor. If the functions of local government are not to be reduced or impaired, it is obvious that some method for supplementary municipal revenues, other than increased taxation of real estate must be found.

Alternative methods have been put to use in some provinces, but nowhere is there a uniform pattern with respect thereto, and, in no province, is there any assurance that the practice of 1948 with respect to such assistance will be continued in future years.

The federation is continuing with its efforts to improve the Dominion-Provincial-Municipal relations in this important matter.

Committee report on Tax Exemption of Crown Properties was heard along the following lines: That the Federal and Provincial Governments must pay Municipal taxes, or grants in lieu thereof, and local improvement or betterment charges, on all Crown lands within Municipal Corporations. A brief was submitted on behalf of the Federation to the Minister of Finance in June 1947, strongly urging the Dominion Government to establish a policy of payments in lieu of taxation on all Crown Properties. Many meetings have been held since that date between the Government and the Federation. On June 2, 1948, the Minister replied in answer to a request for an announcement of policy as follows: To his great regret it would not be possible, at that time, to announce the definite policy which the Government will eventually adopt in this matter. He stated that the question was one which was involving profound study and that study was still in process. He said he could do no more than to assure the Federation that the Government recognizes the necessity to arrive at a reasonable solution to this problem, to which end, for several months past, every effort had been made and would be continued, to gather and complete the necessary information required before a decision could be arrived at.

Special Committee on Low Cost Housing summed up their year's work as follows:

Inadequate housing has brought widespread conditions of substandard living, disease, family breakdown, morel and spiritual deterioration to a large segment of our Canadian people, creating Canada's most serious social problem. The critical need of housing for low income families has been acknowledged by Dominion, Provincial and Municipal Governments. Continued postponement of co-ordinated housing action by the three levels of Government, in the face of their acknowledgment of the critical need, is weakening our Canadian democracy and providing fertile fields for the seeds of disunity. The costs of labour and materials make it impossible to provide housing at rentals within the reach of low income families. Our people cannot afford any further delay in co-ordinated measures to provide low rental housing without ever-increasing danger to the Canadian way of life.

The Housing Committee requested the Federation to urge upon the Federal, Provincial and Municipal Governments the immediate necessity of a clear definition of their respective responsibilities and their

immediate co-operation in providing housing for low income families through the establishment of a national long-term low rental housing program in keeping with the financial needs and abilities of the Canadian people and the availability of labor and materials.

The Resolution Committee submitted to the converence thirty-two resolutions. Twelve resolutions or redrafts were approved by the Federation. The resolutions were along the following topics:

- 1. Modernization and standardization of municipal building by Laws, particularly in the housing field, using the National Building Code as a guide. This would make for greater efficiency and reduced construction costs.
- 2. Request the Dominions Government to exempt municipalities from the payment of the Excise Tax and the eight percent sales tax, now payable on goods and equipment required for municipal purposes.
- 3. Recognition by the Federal Government of full responsibility for the relief of Unemployed Employables, whom by their rights as citizens are permitted to move freely across Canada, in search of employment opportunities, which very from time to time. Such influx of employment seekers, is beyond the control of the communities, and beyond the responsibility and financial capacity of the local tax payers to assume the unequal burden of caring for unemployed citizens.
- 4. The sharing of costs of construction and maintenance of municipal airports as was the prewar policy under which the Federal and Provincial Government contributed an equal share with the municipalities.
- 5. Municipal relief from the costs of Social Services. The basis for this discussion was the care of neglected children being in part the responsibility of the provincial government.
- 6. Dominion Government rescind as soon as reasonably possible the zoning regulations in urban municipalities which had temporarily suspended (as a war measure) bylaws and building restrictions by an Order in Council #200.
- 7. The conference endorsed the principle that War Disability Compensation for Canada's fighting men and women should be fixed with due recognition of the economic conditions under which they must suffer lifelong disabilities.
- 8. Increased payments to the recipients of old age pensions, such pensions be payable to all, irrespective of their means, and that Old Age Pensions be set up on a contributory basis.
- 9. The study for the prevention of Sex Crimes be intensified by the Minister of Justice of Canada and the Attorney-Generals of the Provinces, with a view to remedial action as soon as possible.
- 10. The Convention is to make representation to the proper authorities in Ottawa, drawing their attention to the large number of undesirable publications dealing with crime, sex and many forms of law breaking periodicals.
- 11. The appointment of a Trans-Canada Highway Commission was recommended to the Federal Government.
- 12. The Federal Government will be strongly urged to protect The Canadian standard of living by re-establishing Price Controls on all essential goods.

In addition the conference referred to special committees for study and appropriate action all resolutions dealing with the problems of:

In nearly all the addresses so ably given at the Junior Chamber of Commerce Convention in Winnipeg and The Mayor's Conference in Halifax, by such speakers as Mr. Graham Towers, Governor of the Bank of Canada; Mr. J.S. Duncan, President Massey-Harris Co.; Honorable Stuart Garson, Premier of Manitoba; Honorable D.L. MacLaren, Lt. Governor of New Brunswick. A note of warning was sounded regarding the intensification of Communist propaganda and infiltrative action in Canada. Many of the speakers made no apology for bringing the matter prominently to our attention. Pointing out to us that, there are too many people who take the attitude of "It can't happen here" when any unpleasant possibility is being discussed. If Canadians generally could be made to realize how much they owe to free enterprise, and what it has yet to contribute to our national progress, there would be few of our people who would be content to accept the doctrines of communism as a substitute for a system resting upon free choice and free endeavour.

The menace of Communism, I believe, is a challenge to our patriotism, to our capacity for co-operation, and to the maintenance of free institutions of our democratic country. In striving to promote closer co-operation and understanding, we are actively helping to meet the challenge of Communism in its most subtle and insidious forms. Any dislocation of productive effort is hailed as a victory by those who, because of their adherence to idealogies foreign to our way of life, seek to undermine all democratic institutions, and to sabotage our free enterprise system.

History of the past centuries has taught us that after great wars, invariably conflict of politics, divergent idealogies, continue long after the battles have been fought. During this period of re-adjustment is always a time of activity on the part of secret enemies, who seek to foment dissension and unrest. Always ready, waiting for an opportunity to capitalize upon circumstance to the disadvantage of those who are working and doing their best for democracy.

After listening to many addresses along the subject of Communism, we must not underrate this threat of destruction to our Canadian way of life. We of the City Council, the Leaders of the Board of Trade, the Junior Chamber of Commerce, the Service Clubs, and all such organizations must undertake to the best of our ability, to interpret our free enterprise system, in all its aspects and implications to the people of our community, in order to maintain a spirit of confidence, of mutual understanding and trust.

On my return from Halifax I spent three days in Ottawa. Through the kindness of Mr. James Sinclair our member of Parliament for Vancouver North, I had the honour of a private twenty minute interview with our Prime Minister, Right Honourable MacKenzie King.

Later I met with the Right Honourable J. T. Ilsley, Minister of Justice and Attorney-General, Honourable Brook Claxton, Minister of National Defence; Honourable Paul Martin, Minister of Health and Welfare; Honourable D.C. Abbott, Minister of Finance; Honourable Alphonse Fournier, Minister of Public Works, and Senator S. MacKeen of Vancouver.

During my interview with the Honourable A. Fournier, Minister of Public Works, I was assured that tenders would be called for very shortly for the construction of a new modern (3) three story Federal Building on the site of our present Post Office. This new building would cost between \$150,00 - \$200,000 and would be used as a Post Office, Unemployment Insurance Office and for other Federal uses. The Minister and his deputy, Mr. Murphy, promised that construction of this building would be started early this autumn.

In submitting this report, I have attempted only to cover the more important subjects of the Conference. Such information gathered on Health, Schooling, Fire and Ferry matters etc. will be dealt with in additional reports as required.

Alderman Gostick reported that a meeting had been held between the Council and the Health Unit Committee on Tuesday evening, and it had been agreed to form a Union Board of Health.

Moved by Alderman Copping, seconded by Alderman A. Stewart that the City of North Vancouver join with the District of North Vencouver, the District of West Vancouver and the School Boards in forming a Union Board of Health: a clause being inserted in the Agreement whereby the City can withdraw if necessary on giving six months' notice. Carried, with Alderman Gostick voting against.

Alderman Gostick gave as his reasons that he felt the responsibility of Health is not one for the local Government but should be borne by the Provincial Government. At the present time the Government only gives a Grant and has no particular way of arriving at the amount, and with no assurance that it will be carried out. With this new Health Insurance plan the work of the Unit is growing and working to the benefit of young people. He feels that with the Government assuming responsibility, in the matter of Health Insurance they should assume responsibility in this regard. For four years the Council has been fighting for relief in costs of the Health Unit, and we are not getting relief as any increased grants will be used up by giving additional services under the Union Board of Health. We are assuming extra costs without any assurance that the Government is paying any part of the increased costs.

Alderman Gostick states that the costs will go up each year by \$200.00 or \$300.00 and we will not pull out for \$200.00 or \$300.00.

The Mayor stated that we would still continue to fight for relief of costs.

Alderman A. Stewart asked that we refer back to Parks Committee. Alderman A. Stewart reported progress on the applications received 2 for the use of Lonsdale and Scout Halls.

ANY OTHER COMPETENT BUSINESS

Alderman Copping reported that he had heard there is danger of the Airport project on the North Shore being sbendoned, and he feels that is we let this site go there will be no other available.

Moved by Alderman Copping, seconded by Alderman Gostick that the City Clerk write to the Commissioner of the District of North Vancouver asking 3 for a meeting between the City Council and himself with regard to the development of a Municipal Airport to be undertaken jointly by the City, District and West Vancouver, or by some other method. Proposed area to hale be developed is situated in District Lot 264. Carried

> Moved by Alderman Gostick, seconded by Alderman A. Stewart that the Council do now adjourn.

Whereupon the Council adjourned at 11:30 p.m.

REPORTS OF COMMITTEES

May or Goldsworthy asked that before the Committees' report he be allowed to make a statement on the press reports of his remarks made at Gibsons Landing recently concerning the North Vancouver Ferries.

His Worship advised that he was at Gibsons Landing with the Associated Boards of Trade, and although he was not a scheduled speaker on the programme, he had discussed the possibilities with the other representatives there of a road from Gibsons Landing to Horseshoe Bay.

He had suggested that it would be a long time before the road would be built, and that possibly what they require would be a ferry between Gibsons Landing and Horseshoe Bay. If they considered this suggestion, he advised them that the City of North Vancouver's Ferry No. 3 could possibly be leased for a period of, say, ten months in the year.

The Mayor reported that although the Council and he had discussed the reduction of ferry services from time to time, there had been no suggestion on his part at least of any discontinuance of the ferry system, and he advised that he was making this statement in order to clear up any misunderstanding that might have arisen from the story in the Press purporting to report his remarks at Gibsons Landing.

FINANCE COMMITTEE

Alderman A. M. Stewart reported progress on the following matters referred to his Committee:

Request of the B. C. Cander Foundation for financial aid.

Proposed Agreement of the Superannuation Committee to cover employees over the age of forty.

Request of the Memorial Community Centre for financial aid.

The Clerk reported that the Director of the Memorial Community Centre has inquired as to whether the Council would allow renovations to the Scout Hall as requested by the Boxing Club, which is affiliated with the Centre.

Alderman A. Stewart advised that this matter had been referred to the Building Inspector to report to him, and would be dealt with when the report from Mr. Peers is received.

The Clerk reported that the City was now in receipt of Certificates of Title Nos. 19497-L, 19498-L and 19499-L, in the name of The Corporation of the City of North Vancouver, and covering the ownership of the property known as Low Level Road.

He advised that the Agreement between the Corporation and the Harbours Board provided that the City on transfer of the Title of the Road to the Corporation would carry out the necessary dedication by By-law to make the Road a Public Highway.

The Clerk was instructed to notify the Council members in due course that a special meeting of the Council would be held on September 13th 1948 at 8:00 p. m., in view of the fact that it will not be possible to hold the regular meeting on September 6th or 7th.

Alderman A. M. Stewart reported that the Treasurer had attended the Public Utilities Commission hearings on the B. C. Electric rate structure and that certain things had been brought out at the hearing relating to the primary rate of electric light, and he suggested that a brief should be prepared in view of this information which had been obtained, especially after comparing the costs of service in the City of North Vencouver with

that in surrounding Municipalities and the City of Vancouver.

Moved by Alderman A. M. Stewart, seconded by Alderman Gostick that the Tressurer be empowered to proceed further with his studies of the B. C. Electric rate application, and prepare a brief and application for submission to the Public Utilities Commission with a view to requesting a reduction of the primary rate charged in the City of North Vancouver for domestic electrical energy. Carried

May or Goldsworthy reported that, press comments to the contrary, there would be no less firemen attending fires in the District of North Vancouver than heretofore, and that at the present time there are five men on some shifts at the Fire Hall, and this number will be maintained on the 5 new schedule adopted at the Council meeting on the 16th of this month.

Alderman Gostick pointed out also that the City Council would heartily endorse the idea of having a contract between the City and District fixing costs and operation of the City's Fire Department in the District of North Vancouver.

> Moved by Alderman A. Stewart, seconded by Alderman Copping that this Council now adjourn. Carried
