CORRESPONDENCE

From the U. B. C. M. enclosing copy of the Speech of the Hon. R. C. MacDoneld, given at the 1948 Convention and also advising of a meeting of the Community Plenning Association of Canada, to be held in Vancouver on October 28th and 29th.

Mayor Goldsworthy asked the members of the Council to keep the latter dates in mind in the event that they are able to attend. Moved by Alderman A. Stewart, seconded by Alderman Gostick that the letter from the U. B. C. M. be received and filed and copies of Mr. MacDonald's address supplied to the members of the Council. Carried.

From the Canadian Legion, North Vancouver, asking permission to solicit on Poppy Day.

Moved by Alderman A. Stewart, seconded by Alderman Copping that the usual permission be given to the North Vancouver Branch of the Canadian Legion to hold their Annual Poppy Day on November 6th, 1948, and such permission to extend to the Ferries of the City as in previous years. Carried.

From the Kinsmen Club, North Vancouver, requesting Grant for their Hallow-e'en parties.

Moved by Alderman Copping, seconded by Alderman Gostick that this request be referred to the Finance Committee with power to act. Carried.

From School District No. 44, advising that the Board is agreeable to accepting the proposed agreement setting up the method of operation of the Union Board of Health if same is acceptable to the Council.

5 Moved by Alderman Gostick, seconded by Alderman A. M. Stewart that this letter be referred to the Health Committee report later on in the evening. Carried.

From Heywood Community Centre and North Vancouver Memorial Community Centre re Heywood Community Centre building and grounds.

Moved by Alderman A. M. Stewart, seconded by Alderman Gostick that subject to the approval of the Solicitor, a lease be entered into with 6 the North Vancouver Memorial Community Centre covering the leasing to the Centre for a period of one year from November 1st, 1948 for the sum of one dollar; the premises known as the Heywood Community Centre on Lots 1 to 6 inclusive, Block "H", District Lots 265/552, Provided the less ee covenants to maintain, repair and use the same premises for the purpose of a community Recreational Centre during the said term. Carried.

From Staff Sergeant Herdman, enclosing letter from Lonsdale P. T. A. which recommended that a School Zone be established at 23rd and Chesterfield.

Mr. Greenwood reported that there was now in existence a "15 Mile per 1 hour School Z"one" in the area referred to, that is at Chesterfield Avenue between 21st and 23rd Streets.

Carried.

From Fred A. Bradley, 1014 Robson Street, applying to be appointed and Agent to buy and sell City Tax Sale land.

Moved by Alderman A. M. Stewart, seconded by Alderman Gostick that Mr. Bradley be advised that the Council will consider his application to be appointed an Agent to sell City Lands upon his being able to comply with the Council's regulations governing such appointments. Carried.

From Leonard S. Churchill, Local Manager, Vancouver Sun, requesting removal of Boulevard trees obstructing the front of his new building at 340 Lonsdale Avenue.

Moved by Alderman Copping, seconded by Alderman A. Stewart that the Superintendent be authorized to remove the Boulevard trees on both sides of Lonsdale Avenue between 3rd and 4th Streets. Carried.

"The Party of the First Part, the Party of the Second Part and the Party of the Third Part agree that the monies required to meet the expenditures of the said Union Board of Health shall be provided by them and paid over to the said Union Board of Health in the

following proportions, namely:

The percentage that the amount each Municipality receives as its share of the SOCIAL SECURITY AND MUNICIPAL AID TAX bears to the total amount paid to the three Municipalities from the said tax."

The said Agreement to be amended further by adding the following as clauses four (4), five (5) and six (6):

"Clause #4

The Party of the Fourth Part agrees to pay fifty percent of the amount paid to the Union Board of Health by the Party of the First Part."

Clause #5

The Party of the Fourth Part agrees to pay fifty percent of the amount paid to the Union Board of Health by the Party of the Second Part."

"Clause #6

The Party of the Fifth Part agrees to pay fifty percent of the amount paid to the Union Board of Health by the Party of the Third Part."

With regard to the letter from School District No. 44 which has been referred to Health Committee report, the following recommendation was submitted:-

RECOMMEND that the District of North Vancouver, the District of West Vancouver and School Districts Numbers 44 and 45 be advised that the Council of The Corporation of the City of North Vancouver will pass the recommended by-law, setting up the Union Board of Health and sign the amended agreement if the changes made meet with the approval of all parties concerned.

Moved by Alderman Gostick, seconded by Alderman Cates that the above recommendation of the Health Committee be adopted. Carried.

FIRE & LIGHT COMMITTEE

RECOMMEND that the B. C. Underwriters' Association be asked to re-survey the City of North Vancouver as soon as possible and at the same time that the Board be asked the following questions:

(1) What effect would there be on the fire insurance rates in the City of North Vancouver with a minimum of 4 men per shift at the fire hall.

(2) What effect would there be on the fire insurance rates in the City of North Vancouver with a minimum of 6 men per shift at the fire hall.

(3) What effect there would be on the City fire insurance rates if three firemen answered fire calls in the District of North Vancouver.

C. E. R. Company in regard to their inter-city service.

The Company advised in their letter that the Larson Road "Cut-off" was much more desirable from an operative standpoint than the former narrow highway down 23rd Street and south on Larson and advised that due to this and other operating difficulties they could not make a revision, in the routing as suggested by the petitioners.

Moved by Alderman Copping, seconded by Alderman A. Stewart that the letter from the Company be received and filed. Carried.

Letter was received from the B. C. E. R. Company, advising that they were unable to alter their Bus schedules to meet the new Ferry times on September 12th as the Bus Schedules are changed by-monthly and this particular change missed the regular change date on September 1st. The Company advised however, that they s would survey the present Schedules in conjunction with the Ferry

Schedules with a view to rebuilding the schedules which will be introduced on November 1st.

Moved by Alderman A. Stewart, seconded by Alderman Copping that the above letter be received and filed. Carried.

The Clerk advised that the Bill of Sale of the Ferry Coal Scow had been signed by the Mayor and Clerk and he asked for confirmation of this action.

Moved by Alderman A. M. Stewart, seconded by Alderman Gostick 6 that the signing and sealing by the Mayor and City Clerk of the Bill of Sale conveying the Ferry Coal Scow N.V.S.l. to Gilley Bros. Limited in accordance with the sale provision in the Charter Party of August 15th, 1947, be confirmed subject to the approval of the Minister of Municipal Affairs.

The Clerk asked for authority to sign and seal a Lease with the M. B. King Lumber Company (North Shore) Limited covering the property known as Fell Avenue extension, negotiations having reached a position satisfactory to both parties.

FINANCE COMMITTEE:

Alderman Cates reported that the Finance Committee had met with Teen Town Council and had discussed the operation of the Saturday night dances by Teen Town. The Committee felt that inasmuch as Lonsdale Hall was booked for a considerable number of nights for such purposes that consideration should be given in reduction of rent and the committee recommended as follows:

RECOMMEND that Teen Town Council be charged a rental of \$12.50 per night for the use of Lonsdale Hall for their weekly dances, on the understanding that such rental is based on the use of the Hall for a minimum of 25 dances during the Calendar year and that Teen Town will release any of their nights for special occasions, upon one week's notice from the Corporation;

AND FURTHER if the above proposal is agreeable to Teen Town, then the balance of the 1948 rentals be charged at the rate of \$12.50 per night, it being understood that any damages to the Hall will be borne by Teen Town and the Hall left in a cleanly condition.

Moved by Alderman Cates, seconded by Alderman White that the above recommendation of the Finance Committee be adopted. Carried.

Alderman Cates reported that the Finance Committee had been authorized to act in the matter of a Grant for the Kinsman Club Halloween Party and had agreed to give a Grant of \$100.00 for such purpose.
