Referred to the Transportation Committee report this evening.

From V. A. Glenn, requesting permission to store explosives in the City of North Vancouver.

Referred to Board of Works Committee report.

From George and Florence Sebastian, complaining of drainage water in front of their premises at 1723 Lonsdale Avenue.

Referred to Board of Works Committee report.

From Montrose Hotel Co. Ltd., 170 West Esplanade, submitting plans of proposed alterations and additions to their premises and advising that they intend to abide by former commitments given to the Council with regard to the development of the area around the present building, etc.

Referred to the Building Committee report.

From the Commissioner, B. C. Police, advising that he would meet with representatives of the City and District as soon as he has received notification from the District of North Vancouver. Referred to Finance Committee report.

From School District No. 44, advising that the Board is pleased to accept the Council's invitation to attend the Stewardship meeting to be held on December 13th, at 8 p.m.

Moved by Alderman A. M. Stewart, seconded by Alderman White that this letter be received and filed. Carried.

From North Vancouver School District No. 44, advising that the Board has decided to place the new Junior High School Building and other extraordinary requirements in the 1949 Estimates rather than now request a supplemental estimate for the 1948 portion.

Referred to Finance Committee Report.

From School District No. 44, requesting permission to proceed immediately with clearing a portion of the Junior High School site bounded by 18th and 20th Streets, Sutherland & Williams.

Referred to Finance Committee report.

From Spracklin Realty Company, advising they will be opening a Real Estate Insurance office in January, 1949, at 1414 Lonsdale Avenue and asking if the Council would consider, appointing his office as a sub-payment office for tax and water rate accounts for the City of North Vancouver.

Moved by Alderman A. M. Stewart, seconded by Alderman White that the Spracklin Realty Company be thanked for their offer and advised that in the opinion of the Council the City of North Vancouver is not of sufficient size as to warrant the opening of a sub-office in their premises, and that the present City Treasurer's office is deemed adequate to serve the taxpayers. Carried.

Letters were received from the North Vancouver Memorial Community Centre and North Vancouver Joint Swimming Pool Committee, asking if the Council would release reserve funds amounting to \$10,000.00 plus interest now earmarked for Gymnasium purposes, so that the same can be used to build a swimming pool and it was suggested this money be turned over to a Committee and the monies disbursed by three signing officers from such Committee being one from the Council, one from the Kinsmen Club and one from the Community Centre.

The Solicitor had advised that the Council could not turn over the funds as requested but could construct the pool itself and if the Kinsmen Club or any others wish to give money to the City to be kept in a trust fund for swimming pool purposes this could be legally carried out.

Moved by Alderman A. Stewart, seconded by Alderman Gostick that the Superintendent be instructed to prepare estimates and a report of the cost of constructing a swimming pool in Mahon Park in accordance with the plans prepared by Mr. F. C. Stewart, Consulting Engineer. Carried.

From North Vancouver Civic Labour Association, advising that they will present a petition concerning Bus and Ferry Schedules to the Council this evening.

A delegation was present.

Moved by Alderman Gostick, seconded by Alderman Copping that the petition be now received and that the spokesmen on behalf of the Association be heard. Carried.

Mr., Edward Murphy, President of the North Vancouver Civic Labour Association then introduced Mr. Damon Eisenman and Mr. James Hall.

Mr. Eisenman read a brief summary of the reasons for submitting the petition and Mr. Hall corroborated Mr. Eisenman's remarks.

Alderman A. M. Stewart outlined the Council's reasons for cutting the Ferry service, pointing out that the expenditures were being reduced in an effort to operate the system without loss, which for the year 1948 would be approximately \$20,000.00. He could not see how the system could be returned to the former 20 minute operation without a very great increase in costs of operation.

Alderman A. M. Stewart pointed out that it was not fair for all the taxpayers to have to pay for the operating loss of the system. He suggested that the only proper solution to the situation might be to revert to the 20 minute schedule and increase the fares, as everything else had gone up in cost with the exception of the ferry tariff.

Mayor Goldsworthy suggested that the petition be referred to a Committee of the Whole Council to discuss with representatives of the Association and invited members of the press to be present at such meeting.

Moved by Alderman Copping, seconded by Alderman A. Stewart that the Council meet in Committee with representatives of the Civic Labour Association and the press and that copies of Mr. Eisenman's report and brief be furnished to the Council for consideration at a suitable date after the proposed brief of the Association is completed. Carried.

A delegation was present and on motion was allowed to speak. Mr. G. K. Van then addressed the Council pointing out that the re-routing of the buses from 15th to 13th Street had resulted in a considerable loss of business to merchants in his Block.

Superintendent Greenwood advised that the shoulders of 15th Street were not in condition for heavy bus traffic and could not be placed in proper condition until next May.

Moved by Alderman Copping, Seconded by Alderman Gostick that the petitioners be advised that the Council are not prepared to change the Bus routes back to 15th Street at this time as requested as it does not consider 15th Street is yet in a safe condition for such operation. Carried.

Discussion followed on the desirability of providing covered benches or shelters at certain bus stops in the City and also the possibility of re-routing certain buses along 15th Street from Lonsdale and south on St. George's to 14th.

Moved by Alderman A. M. Stewart, seconded by Alderman Gostick that the suggestions brought forward by the petitioners at to-nights meeting be referred to the Transportation Committee and if it is possible to re-route the buses as suggested that action be taken and further that the suggestion of covered seats at certain bus stops be left to the discretion of the Transportation Committee to take the necessary action. Carried.

FINANCE COMMITTEE.

RECOMMEND that this Council approve of a plan of Police and Fire protection in conjunction with the District of North Vancouver along the following lines:-

POLICE PROTECTION.

The City's policing contract cost and the District policing contract cost to be added together plus all other costs incidental to policing such as maintenance of lock-up, Court room, office, etc., and plus the cost of any extraordinary expenditures and the total cost thus derived apportioned between the two Municipalities in the same manner as School costs, so that the whole detachment of Provincial Police on the North Shore will operate as one force in the two Municipalities under the present N. C. O. and the men may then be used to best advantage in either Municipality as required,

And further that a copy of this recommendation be forwarded to Commissioner Sowden and Commissioner Shirras of the Provincial Police.

FIRE PROTECTION.

Whereas the Council is willing to continue the present arrangement whereby the District pays for services rendered by the Department in the District, it is proposed that after ascertaining the total estimated cost of operating the Fire Department in 1949 and in succeeding years, an agreement be negotiated with the District of North Vancouver providing for such operation in both Municipalities outlining the services to be given and establishing the basis of the apportionment of the total estimated cost between the two Municipalities on the basis of assessed value of improvements,

And further that a copy of this recommendation be forwarded to Commissioner Sowden asking for a meeting to discuss these

matters with him at the earliest opportunity.

Moved by Alderman A. M. Stewart, seconded by Alderman White that the recommendation of the Finance Committee be adopted. Carried.

RECOMMEND that Whereas the School Board of School District #44 (North Vancouver) will require from this City in 1949 the sum of approximately \$99,424.50 as its share of the School Board's Extraordinary requirements for that year.

And Whereas the City has, at the present time, certain funds set aside in its Tax Sale Lands Reserve Account, Therefore be it resolved that this Council set aside the sum of \$49,712.25 of such reserve for use by the School Board in 1949 to meet a part of the City's share of the Board's extraordinary requirements in that year. Moved by Alderman A. M. Stewart, seconded by Alderman White that the above recommendation of the Finance Committee be adopted. Carried.

RECOMMEND that School District #44 be granted permission to proceed immediately with the clearing of the proposed Junior High School site on 18th Street East.

Moved by Alderman A.M. Stewart, seconded by Alderman Copping that the above recommendation of the Finance Committee be adopted. Carried.

RECOMMEND that the present regulations governing the appointment of Agents to receive applications to purchase City tax sale lands be amended to provide that such applicant must first of all be licensed and in operation in the City of North Vancouver as a Real Estate Agent for a period of at least six months prior to such application for appointment as Agent by the City and that no commission shall be paid to any agent on any land in which he is directly or indirectly interested as a purchaser and further that the previous regulations governing the appointment of agents be amended to provide that such agents are authorized to receive applications to purchase City tax sale lands but are not authorized to receive monies from prospective purchasers on behalf of the Corporation.

Moved by Alderman A. M. Stewart, seconded by Alderman White that the above recommendation of the Finance Committee be adopted. Carried.

RECOMMEND that the Treasurer be now authorized to pay to the North Vancouver General Hospital Board the sum of \$3,333.33 as the City's share of enlarging the third floor of the Hospital in accordance with plans approved by the Provincial Architect, and that the necessary By-law be prepared to expend such sum from the Tax Sale lands Reserve Account.

And that the Mayor and Clerk be authorized to sign the necessary contract, etc., on behalf of the Corporation providing the plans and specifications are signed by an Architect, approved by the Provincial Architect and the Fire Warden.

Moved by Alderman A. M. Stewart, seconded by Alderman White that the above recommendation of the Finance Committee be adopted. Carried.

RECOMMEND that any resolution or resolutions now on the Minutes earmarking funds for Auditorium or gymnasium purposes be rescinded and that these funds be held for the construction of a Swimming Pool in Mahon Park providing the Superintendent of Works report on this matter shows that the plans and costs of construction are satisfactory to the Council.

Moved by Alderman A. M. Stewart, seconded by Alderman Gostick that the above recommendation of the Finance Committee be adopted. Carried.

RECOMMEND that Mr. Glenn be advised that it is against the Council's policy to grant permission to store explosives in the City of North Vancouver.

Carried.

Moved by Alderman Copping, seconded by Alderman Gostick that the above recommendation of the Board of Works Committee be adopted. Carried.

TRANSPORTATION COMMITTEE:

RECOMMEND that the License Inspector be authorized to issue a Taxi License to Mr. George Pare as requested, but that Mr. Pare be advised that it is against the Council's policy to issue further taxi stands in the City.

Moved by Alderman Copping, seconded by Alderman White that the above recommendation of the Transportation Committee be adopted. Carried.

RECOMMEND that Christie & MacLeod Agencies Ltd., and Irwin & Billings Co. Ltd., be advised that the Council are of the opinion that it is not desirable to allow Bus seats at Bus stops containing commercial advertising material thereon and their request therefore cannot be granted.

Moved by Alderman Copping, seconded by Alderman White that the above recommendation of the Transportation Committee be adopted. Carried.

RECOMMEND that the Junior Chamber of Commerce be thanked for their offer to provide benches at Bus stops in the City and advised that they must be placed at locations approved by the d Superintendent of Works.

Moved by Alderman Copping, seconded by Alderman White that the above recommendation of the Transportation Committee be adopted. Carried.

RECOMMEND that Mrs. C. P. Harvey be advised that the Joint Transportation Committee has taken up her request with the B. C. Electric Railway Co., and that she be informed that experience has shown a very light traffic count on the route in question and during the same period the traffic has become increasingly heavy on the 15th and Lonsdale route, so that it has become necessary therefore to revert to the old arrangement for the time being.

Moved by Alderman Copping, seconded by Alderman White that the above recommendation of the Transportation Committee be adopted. Carried. Alderman Copping advised that he would check the original routing of the Tempe Crescent Bus and submit a fuller report at a later meeting.

BUILDING COMMITTEE.

RECOMMEND that Mr. Gaunt be advised that the plans for altering and adding to the Montrose Hotel as now submitted meet with the Council's approval and the Council will drop any objection it has to the issuance of a Beer-parlour license to the premises upon the 2 completion of such plans, it being understood that the remainder of the development plans of the Company will be carried out.

Moved by Alderman White, seconded by Alderman A. M. Stewart that the above recommendation of the Building Committee be adopted. Carried.

FERRY COMMITTEE.

Alderman Cates reported that Ferry No. 5 is now off the run on account of its annual overhaul and that a Coffee Bar is being installed on this vessel.

Alderman Cates reported that on November 27th a passenger jumped overboard off one of the ferries and the report of the Skipper of the vessel showed that this man had been rescued from the water and the vessel put underway again in the short time of five minutes and he felt that this was very commendable on the part of the crew concerned.

RECOMMEND that the Clerk be instructed to apply to the Provincial Secretary for a renewal of the Ferry License covering the North Vancouver City Ferries, pursuant to the requirements of the Ferries Act of the Province of British Columbia.

Moved by Alderman Cates, seconded by Alderman A. M. Stewart that the above recommendation of the Ferry Committee be adopted. Carried.

FIRE & LIGHT COMMITTEE.

Alderman A. Stewart reported that a demonstration of two-way radio equipment would be carried out to-morrow Lat 1.30 p.m. and members of the Council are invited to participate.

Alderman A. Stewart reported that the old La France Pumper engine had broken down during Underwriter tests but he would be making a full report on this matter at a later date.

NEW BUSINESS.

The Clerk submitted report of the Fire Department for g the month of October, 1948. Ordered received and filed.

The Clerk reported that certified copies of By-laws No. 1893 and 1898 has been registered in the County 9 Court, Vancouver.

Ordered received and filed.

BY-LAWS.

Gostick that the "City of North Vancouver Ferry Reserve Expenditure By-law 1948, No. 1" be now reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal. Carried.

Whereupon the By-law was reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal and numbered 1899.

Moved by Alderman A. M. Stewart, seconded by Alderman White that "The City of North Vancouver Tax Lands Sale By-law 1948, No. 23" be now reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal. Carried.

Whereupon the By-law was reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk and sealed with the Corporate Seal and numbered 1900.

All the members of the Council present voted for this By-law.

UNFINISHED BUSINESS.

The Clerk reported that he had received a letter from the Vancouver News Herald giving further details of the locations of the proposed honour boxes of the Company.

Moved by Alderman Copping, seconded by Alderman A. Stewart that this information be referred to the Board of Works Committee for consideration. Carried.

Letter was received from the Department of Health advising that they have received the Council's copy of the Union Board of Health Agreement and that as soon as all parties to the agreement have submitted their copies, his Department will submit the entire group for approval of the Lieutenant-Governor-in-Council.

Ordered received and filed.

Discussion followed on the question as to whether Candidates at the coming Election would be allowed to speak after the Stewardship meeting or whether it would be possible to hold a separate meeting at which Candidates could express their views.

Mayor Goldsworthy reported that the City and District Ratepayers Association and the Junior Chamber of Commerce were willing to make arrangements to Chair such a meeting.

After discussion it was agreed that upon the termination of the Stewardship meeting on December 13th the Junior Chamber of Commerce be allowed to arrange for a meeting where the Candidates at the coming election would be allowed to express their views.

Members of the Junior Chamber of Commerce were present at the meeting and agreed to the Council's suggestion.

Moved by Alderman Copping, seconded by Alderman A. M. Stewart that this Council do now adjourn. Whereupon the Council adjourned at 10.45 p.m.

FINANCE COMMITTEE.

Alderman A. M. Stewart reported that a survey of the City's Insurance had been made by an outside broker and the Finance Committee had studied same and it came to the conclusion that no change should be made in the present method of insurance except for a few minor alterations which could be carried out by the Treasurer. He pointed out that the present broker service had been satisfactory and that in one instance pending claim by the Canadian Pacific Railway against the City had been settled by the City's brokers who had done more than they would normally be required to do so that the claim could be settled amicably.

Alderman A. M. Stewart considered that it would be possible to get cheaper premiums but he felt that the City being a public Corporation that the insurance coverage should not be endangered by cutting premium costs. He suggested that the 1949 Finance Committee of the Council review the survey made by the independent broker together with all other information on hand and meet with the said broker if they so desire.

Alderman A. M. Stewart advised that the Labour Relations Committee may have a definite recommendation to make at the next meeting of the Council with regard to wage requests of the North Vancouver Civic Employees Association. RECOMMEND that the matter of replotting certain areas of the City North West of the Grand Boulevard be referred to the 1949 Council for consideration.

FERRY COMMITTEE.

Alderman Gostick advised that although his Committee has power to deal with the request of Solvex Limited to operate a plant at the foot of St. Andrew's Avenue, nevertheless he felt that the Council should be familiar with the information the Committee has received to date.

He advised that the Committee had met with the Company representatives and the latter had described the process used to extract oil, etc., from the raw material. Advice had been received from the City of Victoria to the effect that since the Company had installed their new process at the end of 1941 no further complaints had been received.

A report had been received from a plant adjacent to the Solvex Plant in Long Beach, California, advising that there had been no complaints of undue odors.

Alderman Gostick advised further that Dr. Stewart Murray felt that no trouble could be anticipated by the proposed operation of the Company locally. He suggested that an agreement might be entered into with them to the effect that the plant would be shut down if it caused odors.

Alderman Gostick stated that the Company had already given this undertaking in writing.

BOARD OF WORKS COMMITTEE.
