From Royal Canadian Air Cadets regarding the use of the Lonsdale Hall basement by the local Squadron.

A delegation was present.

Mr. J. B. Currie then introduced Mr. C. O. Robinson, who is the Officer in charge of the Squadron and he then submitted a plan of the basement showing the present area being used by the Squadron and the additional space they would like to secure. Mr. Robinson pointed out that the Squadron has about

\$20,000.00 worth of equipment stored in the basement and they would like to have a definite understanding of the actual area they will be using so that they can take the necessary steps to protect it.

and therefore no charge was made. Ordered received and filed.

From North Shore Neighbourhood House asking if their organization dould secure the use of one of the Staff Houses located on East 3rd Street for use on the community work now being carried on in the Neighbourhood House on East First Street.

Discussion followed.

Mayor Goldsworthy thought that there were quite a number of advantages and disadvantages to setting up of a Mutual Insurance scheme operated by the Municipalities.

- (5) RECOMMEND that the report and recommendations of the Superintendent, covering the operation, regulations and tariffs at the Mahon Park Pool, dated July 15th 1949 and attached hereto, be approved by the Council.
