REPORTS OF COMMITTEES

FINANCE COMMITTEE

Alderman Gostick advised that although his Committee had not had a meeting, nevertheless he felt that the Council could deal with the letter from the Canadian Federation of Mayors and Municipalities concerning the establishment of a Federation Fund. He recommended as follows:

RECOMMEND that the City subscribe the sum of \$250.00 as its share towards the establishment of a Research Fund to be set up by the Canadian Federation of Mayors and Municipalities.

Moved by Alderman Gostick, seconded by Alderman Copping that the above Recommendation of the Finance Committee be adopted. Carried

Alderman Gostick reported that the Financial Statement for the month of June was now in the hands of the Council, and he pointed out that the financial condition of the City was good, except for the deficits on the Ferry System for the month of June. This amounted to \$7,352.49, or a six months' deficit of \$22,811.82. He said it would be interesting to see how the July figures will compare with the same month last year, as the increases in fares only came into effect on July 1st.

Alderman Gostick reported that the Treasurer had made a traffic check on the Second Narrows Bridge, and if any of the Aldermen 3 cared to see same it was on file.

Alderman Gostick advised that the matter of the Ferry Advertising Contract had been receiving considerable thought, and he felt that the present Contract with Mr. Parsons should be terminated, and he was agreeable to entering into a Contract with the firm known as the Pacific Advertising and Publicity Company, provided that the latter furnish a Bond to the effect that the revenue received by the City for the period from the date of Contract to the end of the year would not be less than for the same period last 4 year. Alderman Gostick felt that a new Agreement should be negotiated at that time.

RECOMMEND that the Ferry Advertising Agreement between The Corporation and Alan H. Parson dated March 1st 1933 be terminated as of September 6th 1949, and the Clerk authorized to send a notice of termination in a form approved by the Solicitor to the said Alan H. Parson.

# PUBLICITY COMMITTEE

Alderman McDevitt said that he wished to draw the attention of the Council to the efficient manner in which the staff at the Swimming Pool is carrying on its duties, and made special refer-5 ence to Mrs. Irene Berry, one of its Lifeguards. He felt that Mr. Greenwood was to be complimented on his choice of staff.

#### FERRY COMMITTEE

Alderman Cates reported that the Superintendent had advised him that Mrs. Firth, an employee of long service on the Ferries was now 6 in hospital seriously ill. This matter was left in the hands of Mayor Goldsworthy.

#### NEW BUSINESS

The Clerk submitted an application from Spracklin Realty and Insurance Agencies to be appointed Agent for the City in Real Estate and Insurance matters.

<sup>10</sup> "His Majesty or the Company shall cause the houses comprised in Clauses (c) (d) and (e) above to be painted on the outside before September 30th 1950, and to be painted again on the outside before December 31st 1954."

Moved by Alderman Gostick, seconded by Alderman Copping that the Central Mortgage and Housing Corporation be advised that the last suggested Clause is acceptable to the Council and will be incorporated in the new Agreement which will now be submitted to the Department of Municipal Affairs for approval by the Lieutenant-Governor in Council. Carried Letter was received from the Canadian Pacific Railway Company advising with respect to the application of Gulf Lines Limited to allow Howe Sound Lines to use their float at the Vancouver Ferry Terminal that the Railway Company cannot agree to any modification of the Lease issued to the City in this respect on Aptil 1st 1949.

Moved by Alderman Gostick, seconded by Alderman Cates that Gulf Lines Limited be advised that under the terms of our Agreement with Canadian Pacific Railway Company we are not able to grant their request to allow Howe Sound Lines the use of facilities at the Vancouver Ferry Terminal. Carried

Letter was received from the North Shore Council of Women advising that the matter of civic vote for spouses of property owners will be submitted by the Kelowna Council of Women to the 1949 Convention 2 of the Union of B. C. Municipalities.

Moved by Alderman Copping, seconded by Alderman McDevitt that this letter be received and filed. Carried

Letter was received from Alan H. Parson, Advertising Manager of the Ferry Department, drawing attention to the fact that Press reports were incorrect in stating that the Advertising Contract between the City and himself was on a 60-40 basis, with the City getting the 40%. He pointed out that actually the municipality received 60%.

Alderman Gostick said that he thought that most of the Council knew that the present Contract was on a 60-40 basis, with the larger amount going to the City.

larger amount going to the City. Alderman McDevitt pointed out that although the proposed Contract would be on a 50-50 basis, actual book work will be done by the Advertising Company instead of at the City Hall as at the present time, and he felt that this warranted a bigger commission to the new Company.

Letter was received from Commissioner Sowden advising that he would be quite willing to meet with the City's representatives to discuss at an early date the matter of trespassing in the watershed areas, and also proper apportionment of the School Debt.

Alderman Gostick said he was very pleased to hear the Commissioner was agreeable to discussing the Debt question, and no doubt both matters could be considered as suggested by the Commissioner. It was proposed that a meeting be held with Commissioner Sowden to-morrow afternoon at 4:00 p. m.

# ANY OTHER COMPETENT BUSINESS

A letter from the Regional Planning Division of the Department of Municipal Affairs which was tabled at the last meeting of the Council was then considered. In view of the fact that this dealt with the matters under the Town Planning Act, His Worship referred this matter to the Zoning Committee for recommendation.

Mayor Goldsworthy drew the attention of the Council to the recent successes of the North Shore United Football Club, who are now playing Edmonton for the Western championship, and the right to meet the Eastern finalist at Calgary in the Dominion Final.

Alderman Gostick suggested that the Clerk wire the best wishes of the Council to the team, and he thought it desirable that Mayor Goldsworthy should be in Calgary for the Dominion Final if possible. The suggestions of Alderman Gostick in this regard were agreed

to by the Council.

Alderman McDevitt advised that his Committee was making arrangements to have a rousing reception for the team on its return to North Vancouver, and he was trying to dissipate the current incorrect impression in the minds of the Press and radio that the North Shore United Football Team is from Vancouver and not from North Vancouver.
