Moved by Alderman Cates, seconded by Alderman Copping that the Kinsmen Club of North Vancouver be granted the usual permission to hold their Apple Day on September 24th and that such permission extend to the approaches to the North Vancouver Ferry system both in North Vancouver and in Vancouver but does not extend to the vessels. Carried

From North Vancouver Business Association requesting information in regard to the legal side of the proposal to change the name of the City of North Vancouver.

Referred to the Finance Committee for consideration and report.

From North Vancouver Board of Trade inviting the members of the Council to attend a Banquet in honour of John H. Cates, Minister of Labour on September 15th 1949 at the Olympic Club.

The Clerk was instructed to thank the Board of Trade and advise them that as many of the Council as possible will attend.

From North Shore Parent Teacher Council, asking if the City Council would send a representative to the Library meeting on September 23rd to discuss the formation of a Children's Library.

His Worship appointed Alderman McDevitt.

An application for license to operate an Apartment house was read by the Clerk.

The applicant was Xenia Viola Hoff, 718 Chesterfield Avenue.

He also reported that he had inspected the Mahon Park Pool and found that great use is being made of these facilities. He also mentioned the Open Air concerts being staged in Victoria Park by the National Film Society.

BOARD OF WORKS COMMITTEE

Alderman Stewart advised that due to the absence of the Superintendent there would be no report from the Board of Works Committee at this meeting.

FERRY & TRANSPORTATION COMMITTEE
Alderman Cates brought to the attention of the Council a news item
which had appeared in the morning paper to the effect that one of the North Vancouver Ferries had broken down because of clutch q failure and it is not known when the vessel will be back in operation.

Alderman Cates pointed out that this article was most misleading because the repairs were carried out to the vessel and completed and the Ferry was back in operation in less than one hour's time.

Alderman Cates advised that he had attended the opening of the Oak Ridge Transit Centre of the B. C. Electric Railway Company on Sunday last and he said they certainly had a fine and efficient plant.

Alderman Gostick asked if the Transportation Committee would consider the feasibility of having the West Vancouver bus operate on a route closer to the Hospital at least during visiting hours, so that residents of West Vancouver would be able to visit their friends in the Hospital more easily.

Alderman Cates promised to take this matter up with the

Pacific Stages Transportation Department.

Alderman Cates advised that he had received a report from the License Inspector on the matter of installing meters in the local taxis and copies of this report will be given to the Council and a recommendation made at a later date.

PUBLICITY COMMITTEE

Alderman McDevitt rose in defence of the morning paper referred to by Alderman Cates under Ferry Committee report. He said that the report of the Ferry breaking down emanated from two North Vancouver men who were on the paper's editorial staff and who had not been able to take the 9:20 Ferry to Vancouver. They had reached their office via the First Narrows Bridge and reported the situation upon arrival.

Alderman McDevitt pointed out that he was in no way responsi-

ble for the news item referred to by Alderman Cates.

Alderman McDevitt advised that he has sent photographs of the w new Ambulance and Mahon Park Pool to the magazine "Civic Administration."

LABOUR RELATIONS COMMITTEE

Alderman McDevitt reported that a meeting will be arranged shortly with representatives of the Civic Employees Association to discuss matters proposed by the Association recently.

NEW BUSINESS

In the discussion on the foregoing resolution Alderman Gostick advised that in his opinion the information should be secured from the Underwriters as to what additional manpower and equipment would be necessary to maintain the present key rates and also continue to serve the District with our Fire Department. He was interested in learning also what the comparison would be between the cost of increased insurance rates as against the cost of additional equipment which the Underwriters say is necessary to maintain the present rates. He felt that the City could not afford more equipment at this time.

Alderman Copping was of the mind that we should not agree to the idea of increased rates. He thought that discussions should be held with the District Authorities and in view of the increase in population on the North Shore we should be prepared to spend more money on fire protection.

Mayor Goldsworthy pointed out that one of the recommendations of the Underwriters was that two pumpers and a ladder truck should attend fires in the mercantile area and that these vehicles should be manned by 23 men in addition to the Executive Officers. He pointed out that this would require a minimum of 110 men on the Firehall payroll and this was absolutely out of the question.

An application was received from the North Shore Realty to re-zone Lots 2 and 3, Block 4, D. L. 273 from residential classification to commercial classification.

The Clerk reported that the application to purchase these lots is being held in abeyance until the re-zoning application has been dealt with.

## REPORTS OF COMMITTEES

FINANCE COMMITTEE

Alderman Gostick advised that his Committee would require more time in which to deal with the request of the North Vancouver Business Association in connection with the change of the name of the City of North Vancouver.

LEGAL COMMITTEE

Alderman Copping reported that 87 resolutions were dealt with at the 1949 Convention of the Union of B. C. Municipalities. A great many of the resolutions were similar in character dealing with the per diem Hospital Grants and the costs of education. He reported that the two resolutions submitted by the City of North Vancouver had been adopted by the Convention.

Alderman Cates commented that a lot of earnest work was done 3 at the U. B. C. M. Convention and that the attendance had been very good at all the sessions.

Alderman Copping said that it was very unfortunate that there was such a poor vote at the recent By-election in the City. He felt that if one week between nomination and election day was allowed and if cards were mailed to each voter, that a better turn out would result.

Alderman Copping suggested that consideration be given to enlarging the numbers of the Council personnel and also that the Mayor be elected annually instead of for two year terms.

Union Board of Health Report

Alderman Copping advised that he had taken up with the Board the request of the V. O. N. for additional office space. This was considered at the Board's meeting last Tuesday when a letter was sent to the Hospital Board asking that the East 10 feet of the Assembly Room in the Health Unit building be partitioned for V. O. N. office space. It was suggested that the cost of alterations should be taken out of the rentals of the building.

Alderman Copping advised with regard to the letter from the Board in connection with the condemnation of buildings, that there are two officials authorized to use these cards, that is, the Building Inspector and the Sanitary Inspector. In the case of the latter the one Inspector may be working in the three Municipalities and a uniform notice of condemnation should be used and a copy sent to the Clerk of the pertinent Municipality in each case.

Alderman Gostick said that in his opinion the Union Board of Health is authorized to carry out the Health By-laws of the three North Shore Municipalities and need not consult the Council in any way, although he admitted that it would be appreciated if the Board would give notice to the Clerk of the Municipality when a building is condemned.

Moved by Alderman Copping, seconded by Alderman McDevitt that a Uniform sign be used by all three North Shore Municipalities for use by the Sanitary Inspector and that this official advise the applicable Clerk after affixing a sign and give reasons for so fixing. Carried

PARKS COMMITTEE

RECOMMEND that the application of the School Board for the use of Lonsdale and Scout Halls be granted on same conditions as last year. The question of heating to be left with the Parks Committee with power to act.

Moved by Alderman A. Stewart, seconded by Alderman Cates that the above recommendation of the Parks Committee be adopted. Carried

Alderman Stewart reported progress on the matter of the letter from N. C. Dorward who had suggested the construction of a "Fairyland" in North Vancouver.
