CORRESPONDENCE

From the North Shore Night Patrol, suggesting a method of providing a burglary and fire patrol of business establish-

ments at a cost of \$6,120.00.

Moved by Alderman Gostick, seconded by Alderman McDevitt that this matter be referred to the Police Committee for study and a recommendation. Carried

From the North Vancouver Memorial Community Centre, requesting the Council to appoint two members to act on the Centre's Board of Directors.

The Clerk was instructed to advise the Centre that Alderman Cates and Alderman Templeton have been appointed to act and the Treasurer was authorized to forward the necessary membership fees.

From the North Vancouver General Hospital, advising that in the opinion of the Board of Management it would be more economical if the Fire Department would continue to operate the Ambulance instead of the Hospital Board.

His Worship asked the Ambulance Committee to take this matter under study again in view of the fact that figures now indicate that there is no great increase in the use being made of the new Ambulance, and the additional revenue resulting from the new vehicle is not very substantial. He pointed out that the District of West Vancouver is very much interested in again joining in and sharing the costs of the Ambulance service.

Alderman Stewart promised to investigate this matter as soon as possible.

Alderman Gostick said he could not understand why it would be more economical for the Fire Department to operate the Ambulance than the Hospital.

From the Town Planning Commission enclosing copy of Minutes of their meeting held on December 21st 1949.

Moved by Alderman A. Stewart, seconded by Alderman Suttis that this letter be received and filed. Carried

### REPORTS OF COMMITTEES

### FINANCE COMMITTEE

Alderman Gostick advised that his Committee did not feel that the Corporation should enter into a new contract with the Provincial Police at least not for the present. He suggested that the City should carry on with the terms of the 1949 contract on a month to month basis. He advised that discussions have been held with representatives of the District of West Vancouver and the District of North Vancouver and preliminary figures have been worked out with a view to ascertaining the cost of using Municipal Police rather than Provincial Police and said that his Committee would like to have authority to continue negotiations with other North Shore Municipalities as the preliminary discussions had indicated favourable reactions to the possibility of forming a North Shore Police Force.

RECOMMEND that the Police Committee be authorized to discuss

RECOMMEND that the Police Committee be authorized to discuss with the District of West Vancouver and the District of North Vancouver the possibility of the formation of a North Shore Police Force.

Moved by Alderman Gostick, seconded by Alderman McDevitt that the above recommendation of the Finance Committee be adopted. Carried

Alderman Gostick said that there had been criticism in the Press presumably made by members of the School Board, who had criticised the 1949 City Council for not agreeing to the use of the Extra-ordinary surplus of the Board. He pointed out that the City Solicitor was quite emphatic that the 1949 Council could not bind the 1950 Council on expenditures to be incurred in 1950.

Alderman Gostick pointed out that the School Board could have called for tenders for certain construction they wished to proceed with and could have had the tenders ready for acceptance by the end of 1949 but they had not done so. He felt that the Board and Dr. Graham in particular was asking the City Council to take action along certain lines when the Board itself was not prepared to take similar action with regard to the calling for tenders.

Alderman Gostick said that members of the Board had stated that because of the fact that the 1949 Council had not approved of certain expenditures to be made in 1950 that increased costs would result.

The Clerk was instructed to ask the School Board in what manner increased costs would result by reason of the 1949 Council's inability to approve of certain capital expenditures of the 1950 Board.

Alderman Gostick advised that inasmuch as the District of North Vancouver had failed to pass concurrently with the City, the School Debt Apportionment By-law, the Council should now go on record as agreeing to the basis of such apportionment.

He said that there had been certain criticism of the Mayor regarding this matter but that such criticism was unwarranted as the whole Council were in agreement with the steps taken by His Worship in trying to finalize the situation.

Alderman Gostick advised that the Finance Committee had asked His Worship early in the year to carry on negotiations with the District and with the Government in order to reach a satisfactory agreement and that the Council approved of the proposed agreement and the basis for reaching such agreement. He thought that the public should have all the facts regarding this matter and he suggested that the Publicity Committee should draw up a suitable Press release outlining the method of reaching the agreement and the basis for such agreement.

Moved by Alderman Gostick, seconded by Alderman Suttis that WHEREAS an agreement was made in the presence of the Deputy Minister of Municipal Affairs on the 10th day of November 1949, whereby Commissioner M. E. Sowden, acting for and on behalf of the Corporation of the District of North Vancouver and Mayor Frank Goldsworthy, acting on behalf of the Corporation of the City of North Vancouver agreed that:-

(1) The City of North Vancouver is entitled to include as school debt carrying charges, 14.414% of the annual refunding charges and

(2) That the District of North Vancouver is entitled to include as school debt charges, 4.590% of the annual refunding charges.

RESOLVED that the Agreement made by the Mayor as above stated is hereby ratified, confirmed and declared to be binding between the parties, and a copy be forwarded to Commissioner Sowden.

Alderman Gostick advised that the Police Committee when considering the 1950 Policing contract will also take into consideration the proposal of the North Shore Night Patrol to operate a burglary and fire patrol in the business area.

LEGAL COMMITTEE

Alderman McDevitt reported progress on matters referred to his Committee.

PUBLICITY COMMITTEE

Alderman McDevitt reported that he had inquired into the proposal submitted by Mr. H. F. Spracklin for the construction of a Radio Station on the North Shore and it was felt that the Council should not back any particular person or group in this matter but should go on record as being in favour of having such a broadcasting station in North Vancouver.

RECOMMEND that in the interest of progress in the Community the City Council approves the installation in North Vancouver of a Radio Broadcasting Station.

Moved by Alderman McDevitt, seconded by Alderman Gostick that the above recommendation of the Publicity Committee be adopted. Carried

#### FIRE & LIGHT COMMITTEE

Alderman Stewart reported that the Fire and Light Committee had held a meeting with the B.C. Underwriters and that Com-

missioner Sowden of the District of North Vancouver had also been in attendance.

A very friendly discussion had taken place on the Board's requirements in order that the City of North Vancouver should retain its present classification for fire insurance purposes. He said that the Committee had agreed to practically all of the Board's recommendations except the purchase of a new Pumper and the Committee promised to give the purchase of such a vehicle consideration during the current year.

Alderman Stewart said his Committee would bring in a recommendation on this matter before the next Council meeting.

BOARD OF WORKS COMMITTEE

Alderman Suttis advised that the Board of Works Department p was carrying on with routine work as well as emergency work required because of the unfavourable weather conditions.

RECOMMEND that the following streets be barricaded for sleighriding and that vehicular traffic be asked not to use them from 4 p.m. to 11 p.m. week days and all day on Saturday and Sunday during the period that sleighing is possible:-

27th St. - Mahon to Larson 17th St. - Moody to St. Andrew's View Street - 22nd to Larson 16th Street - West of Bewicke Mahon Ave. - 3rd to 1st

and further that this be adopted as Council policy during such periods.

Moved by Alderman Suttis, seconded by Alderman Stewart that the above recommendation of the Board of Works Committee be adopted. Carried

TRANSPORTATION COMMITTEE

Alderman Cates advised that on New Year's Eve the Buses and Ferry schedules were not running in conjunction with one another. Mr. Sigmundson of the B. C. Electric Railway Company had been contacted and shortly afterwards both transportation systems were co-ordinated so that proper connections were made.

Alderman Cates reported that the vehicular traffic on the Ferries for the month of December was 2280 over December of last year.

Alderman Gostick said that he understood the Council was being criticised for not taking any action on the application of the B.C. Telephone Company for increased rates. He pointed out that the cost of preparing a brief on this matter was beyond the financial ability of the City so the Corporation had joined in with the District of West Vancouver and the District of North Vancouver in discussing the application and at such meeting it was agreed that any brief that could be prepared by the Municipalities would only be duplicating what the Board of Transport Commissioners should do, that is investigate the request of the Company and ascertain all facts and figures necessary to adjudicate on such application. He pointed out that the three North Shore Municipalities had agreed on a common stand and this was embodied in a resolution which had been sent to the Board of Railway Commissioners and to the Union of B.C. Municipalities, such resolution being in the following form:-

"WHEREAS the B.C. Telephone Company claims that present rates are inadequate to meet the necessary cost of maintaining property and furnishing service to its subscribers, to maintain the credit of the applicants and enable them to procure additional funds for expansion and improvement of their facilities, and

WHEREAS their present rate of earnings should be maintained or increased by the expansion of their system, and WHEREAS there is a possibility of a decrease in the cost of providing these services in the next five years; THEREFORE BE IT RESOLVED that the North Shore Municipalities recommend to the Board of Railway Commissioners that any increases granted to the B. C. Telephone Company on its present

application be interim increases subject to review after a period of two years from the date of their taking effect."

In view of the foregoing Alderman Gostick felt that any criticism of the Council was quite unfounded.

Moved by Alderman McDevitt, seconded by Alderman Stewart that Alderman Gostick be appointed Acting Mayor.

Moved by Alderman McDevitt, seconded by Alderman Stewart that the Mayor and Clerk be authorized to execute the necessary Bank 2 resolution to authorize Alderman Gostick to sign cheques and other documents in place of Mayor Goldsworthy. Carried

Moved by Alderman Gostick, seconded by Alderman Suttis that 3 this Council act as a Court of Revision of the 1950 Assessment Roll and the first sitting of said Court be held on Wednesday, February 8th 1950 at 9.00 a.m. Carried

CORRESPONDENCE

From A. R. Chadburn, 2641 Mahon Avenue, protesting against the placing of barricades across 27th Street at Mahon Avenue for sleigh riding purposes.

Alderman McDevitt thought that the majority of the citizens agreed with the action of the Council in blocking off certain streets for use by the children for sleigh riding and other Aldermen agreed on this point.

Mayor Goldsworthy pointed out that the City of Vancouver

follows the same policy.

Moved by Alderman Cates, seconded by Alderman McDevitt that the policy of the Council regarding the blocking off of certain streets for sleigh riding for children, as adopted at the meeting on January 3rd 1950 be confirmed.

From Mrs. J. B. McKenzie, 2370 Western Avenue, applying for a Street Light between 23rd and 25th Streets.

Alderman Stewart pointed out that this was the third application for a street light in this location. POLICE COMMITTEE

Alderman Gostick reported that his Committee had met in West Vancouver with representatives of that Municipality and the District of North Vancouver and had discussed the possibility of forming a North Shore Police Force. No decision had been reached at the meeting but he asked that the matter be given further consideration after the Council meeting adjourned tonight.

LEGAL COMMITTEE

Alderman McDevitt reported progress on the application of the North Shore Packing Company to lease the St. Andrew's Avenue Waterlot.

RECOMMEND that Central Mortgage and Housing Corporation be advised that it is the understanding of the City Council that the houses referred to in paragraphs (a) and (b) of Clause 2 of Amending Agreement No. 3, may be removed at any time, provided they must all be removed on or before June 30th 1951 (and further that the houses referred to in paragraphs (c) (d) and (e) are not to be removed prior to December 31st 1955 but must be removed on or before June 30th 1956 - such understanding being confirmed by a letter from Central Mortgage and Housing Corporation dated July 12th 1949.

FIRE & LIGHT COMMITTEE

Alderman Stewart advised that he had been confined to bed during the past week and so had not been able to do any Committee work. He advised however, that the Fire Department had done a magnificent job at the fire which had occurred on Thursday, January 12th. He reported also that there had been very good work done at this blaze by the Police Department in controlling traffic and helping generally.

He advised that the Radio communication equipment had helped considerably keeping the Chief in contact with his Headquarters at all times.

Mayor Goldsworthy also commended the Fire and Police Departments for the fine co-operation at the Fire. He said he had dropped into the Fire Hall and had listened to the various two way conversations which took place during the blaze and he was very pleased that this equipment was being put to good use.

PARKS COMMITTEE

Alderman Stewart advised that the Fire Department had made arrangements to flood the Lacrosse Box at Mahon Park so that children may have skating facilities.

Alderman Stewart advised that the Electrical Inspector had 2 submitted a report to him covering the work done in that Department during the year 1949.

BOARD OF WORKS COMMITTEE
Alderman Suttis advised that the unusual weather had given his Department considerable extra work but he thought that everyone would agree that a good job was being done by the Superintendent and his staff. He pointed out that some people are being inconvenienced by having snow placed so that it blocks their driveways but generally the method of handling the snow clearance is benefitting the majority of our citi-He said that considerable work had been done in clearing sidewalks with the small equipment which had been pur-

chased recently.
In the first 15 days of January the snow clearance had cost \$3300.00 for labour plus \$360.00 for material..

RECOMMEND that A.J. Chilcott be advised that the surface treatment of Maitland Avenue from Tempe Crescent to Somerset has been included in the Board of Works preliminary Estimates for the year 1950, and providing such Estimates are approved 4 by the Council, such work will be carried out during the

current year.
Moved by Alderman Suttis, seconded by Alderman Stewart that the above recommendation of the Board of Works Committee be adopted. Carried

RECOMMEND that the petition of ratepayers dated December 2nd 1949 requesting lane improvements in the vicinity of the 300 Block West 15th Street, be advised that the lane in question 5 has been gravelled as requested and will be checked again in the Spring to see if any further work is necessary.

that the above recommendation of the Board of Works Committee be adopted. Carried

WATERWORKS COMMITTEE

Alderman Suttis reported that the Waterworks Department had had a lot of emergency work during the cold spell, such as 6 fighting ice conditions at the Intake in order to keep the water flowing to the distribution system. In the first 15 days of January this work had cost \$1200.00.

Alderman Suttis advised that the Waterworks Department were now in a position to order the necessary pipe to construct the water main along the North side of the Low Level Road. The tenants in this area had guaranteed to contribute the sum of \$10,000.00 towards the cost of the construction of such main and would pay this amount to the City when the material is on the ground and the work commenced. RECOMMEND that the Superintendent of Works be authorized to order the following: -

2400 ft. of 8 inch. cast iron watermain - Class D. at a cost of \$5640.00 plus fittings at a cost of \$2180.50, making a total of \$7,820.50 for the construction of a watermain along the north side of the Low Level Road from Kennard Avenue on the East to a point 2400 feet west thereof. Moved by Alderman Suttis, seconded by Alderman Gostick that the above recommendation of the Waterworks Committee be adopted. Carried

FERRY & TRANSPORTATION COMMITTEE

Alderman Cates reported that a meeting is being held next Wednesday with the Official Traffic Commission of the City of Vancouver with a view to obtaining better bus connections with the Ferry System on the Vancouver side.

Alderman Cates reported that he had two meetings with Mr. Sigmundson of the B. C. Electric Railway Company, regarding the possibility of improving the bus service between West Vancouver and North Vancouver improving the bus service between West Vancouver and North Vancouver and the Company will be submitting a report on this matter in due course.

Alderman Cates reported that a meeting will be held on Thursday of this week with representatives of the Greater Vancouver area to consider the possibility of instituting a Metropolitan Taxi Commission.

Moved by Alderman Gostick, seconded by Alderman McDevitt that the Committee proceedings be dispensed with and that the "Central Mortgage and Housing Corporation Conveyance By-law 1950" be now read a third time. Carried Whereupon the By-law was read a third time.

The Clerk submitted a letter from the North Vancouver Civic Labour Association pointing out the need for action to remedy the Unemployment situation which they say exists on the North Shore.

/3 Mayor Goldsworthy advised that he had taken this matter up with the Federal Member and also with the Federation of Mayors and Municipalities and he suggested that the matter should not be dropped but that new representation should be made to the above Federation.

ANY OTHER COMPETENT BUSINESS
The Clerk asked for instructions concerning the issuance of Garden permits for the year 1950 pointing out that only twenty of these had been issued during 1949.

Alderman Gostick felt that the City might be losing some sales of tax sale lands by reason of the cultivation and 2 fencing of lots used by citizens under the authority of a garden permit.

Moved by Alderman Gostick, seconded by Alderman Stewart that the policy of issuing garden permits be discontinued forthwith. Carried.

The Clerk advised that it was desirable to hold a short meeting next Monday in order to pass warrants.

Alderman Stewart advised that he would like to have a meeting of his Committee before the next meeting of the Council.

Minutes of Special Meeting of the Council, held in the Council Chamber, City Hall, on Monday, January 23rd 1950 at 7 p.m. Present

His Worship Mayor F.R. Goldsworthy, Alderman C.W. Cates, Alderman J.C. McDevitt, Alderman A.Stewart, Alderman J.A.S. Suttis and Alderman W.L. Templeton.

The Mayor advised that this meeting had been called for the purpose of passing warrants, By-laws and also considering any other competent business, and had been advertised as required by Statute.

MINUTES

Moved by Alderman Stewart, seconded by Alderman Suttis that the Minutes of the meeting held January 16th 1950 be taken as read 2 and adopted, copies of same having been given to all members of the Council. Carried

Moved by Alderman Stewart, seconded by Alderman Suttis that the Order of Business be suspended and that the letter from the North Shore Parent Teacher Council be now read. Carried

The Clerk then read the above letter in which the Parent Teacher Council advised that its members were against any re-division of School District No. 44 as they felt that the present method of administering the School District jointly between the City and District was to the best advantage of all concerned.

A delegation was present and on motion Mrs. W. Hawkes addressed the Council.

Mrs. Hawkes advised that the Parent Teacher Council had not had a regular meeting since hearing of the possibility of breaking up of School District No. 44 but the members of the Council's Executive had expressed themselves as being against any such split up. Mrs Hawkes said that the Parent Teacher Council felt that the present joint administration was much better than having both Municipalities operating separate School Boards. She said that her organization desired to get more information on the matter of School Debts which apparently was the basis for the City considering breaking away from the present School District.

Mayor Goldsworthy advised that a split up of the School District was the last thing that was to be desired but the Council was adamant in its stand that a correct apportionment of the School Debt between the two Municipalities must be agreed upon if the present School District was to continue in operation.

He then outlined the negotiations between the City and the District on this matter which had taken place over the past two years. He advised that as far as the City was concerned an agreement had been reached with the District of North Vancouver but that the latter had repudiated such agreement.

His Worship advised that the matter was now in the hands of the Minister of Education and no doubt word would be received from him shortly as to the next step to take.

His Worship expressed appreciation to the delegation for their interest in this matter and also pointed out that if the City broke away from School District No. 44 the City School children would have more than sufficient school rooms but the District of North Vancouver would have to construct more accommodation at its own expense instead of having such cost shared with the City.

Other members of the delegation expressed themselves along similar lines as that outlined by Mrs. Hawkes, that is, they felt there should be no split up of the present School District as they felt that the schooling of the children would be affected.

The Order of Business was then resumed.

At this point Alderman Gostick entered the Council Chamber and took his seat.

Commissioner Sowden advised that in his opinion it was quite apparent that the only solution to the matter would be as 2 set out in a letter from the District to the Minister of Education dated January 23rd, a copy of which was attached.

In the letter to the Minister, the Clerk of the District advised that the two Municipalities could not agree upon the adjustment of School Debt and suggested that the dispute be settled by Arbitration and also advised that in fact the District of North Vancouver intends to apply for such a Board of Arbitration.

Mayor Goldsworthy pointed out that there was nothing to arbitrate as an Agreement had been reached by the City and District on the correct apportionment of the School Debt. The only matter which had not been settled was that the Commissioner refused to sign a By-law implementing such agreement.

Alderman Templeton thought the whole matter should have more consideration. He suggested that possibly a Committee of three persons outside of the Council of the City and officials of the District should meet under the Chairmanship of say the Solicitor with a view to bringing in a recommendation at an early date.

Alderman Gostick said that he was inclined to feel it would be better to have the Arbitration and that such Arbitration be dealt with by one representative from the City, one from the District and a Chairman to be selected by the first two.

Alderman Stewart said he agreed with Alderman Templeton's suggestion. He said that the Finance Committee is aware of all the facts on the matter but the rest of the Council have not had sufficient information.

Alderman Cates suggested that the Council should wait until the Minister of Education has considered the matter and Mayor Goldsworthy agreed that this would be desirable.

Alderman Suttis suggested that the matter had been discussed sufficiently and given a little more time it would work itself out.

Alderman McDevitt said that he resented the suggestion of Alderman Templeton that the City representatives are not qualified to look after the interests of the Corporation, and he did not agree that outside representatives should be appointed to deal with the matter.

Moved by Alderman Stewart, seconded by Alderman Gostick that the letter from Commissioner Sowden be left in the hands of the Finance Committee and the Mayor to deal with. AND WHEREAS such costs were shared equally in the year 1949.

NOW THEREFORE BE IT RESOLVED that this Corporation in conjunction with the District of North and West Vancouver, make application to the Provincial Government for a grant of 50% of the cost of operating the Union Board in 1950.

Alderman McDevitt submitted the following recommendation of the Legal Committee:-

RECOMMEND that the Mayor and Clerk be authorized to sign and seal with the Corporate Seal, a lease in favor of the North Shore Packing Company, covering the City's waterlot which subtends St. Andrew's Avenue, such lease to include the following specific terms and conditions:

(1) The period of the lease to commence on February 1st 1950 and extend for 10 years.

(2) The rental to be \$30.00 per month for the first 5 years of the term and thereafter at a rate to be agreed upon, or failing agreement, then such rate as is set by arbitration under the provisions of the "Arbitration Act."

tration under the provisions of the "Arbitration Act."

(3) The Company shall pay in the year 1950 a sum in lieu of but equal to what normal taxes would be if the premises were taxable, and in following years shall pay all taxes as they become due.

(4) The Corporation may cancel the lease after it has been in effect for two years, by giving 6 months notice, if the same is required for municipal purposes.

(5) If the Corporation terminates the lease by giving the notice referred to in (4) above, the Corporation shall reimburse the Company for the cost of any buildings or wharves constructed on the premises during the term, less depreciation. In the event of non-agreement on the cost, such cost shall be fixed by arbitration.

(6) The Company shall allow the officers and servants of the Corporation access to the premises to carry out when necessary, any work required to be done to keep the storm sewer on the premises in proper condition or to replace same.

Moved by Alderman McDevitt, seconded by Alderman Gostick that the above recommendation of the Legal Committee be adopted. Carried

Alderman Cates submitted the following recommendation of the Transportation Committee:
