#### MINUTES

#### CORRESPONDENCE

From the Volunteer Ambulance Corps advising that if the City will provide a separate room under the Grand Stand at Mahon Park, the Corps would endeavour to have a qualified First Aid attendant available during sports and games.

Moved by Alderman Stewart, seconded by Alderman Suttis that the Volunteer Ambulance Corps be thanked for its offer and advised that the Parks Committee has been requested to study same and report its findings to Council. Carried.

From the Town Planning Commission advising that the Commission approves of the diversion of the East and West Boulevard roads to the Lynn Valley highway as shown on sketch No. 3 proposed by the Engineering Department and suggesting that some of the adjacent area should be resubdivided.

Moved by Alderman Suttis, seconded by Alderman Cates that this matter be referred to the Superintendent of Works to submit a report as to the estimated cost of such diversion. Carried.

From the Town Planning Commission requesting the Council to hold on reserve for possible resubdivision Blocks 9, 10, and 15, in D.L. 265.

Moved by Alderman Stewart, seconded by Alderman Gostick that Blocks 9, 10 and 15, in D.L. 265 be placed on reserve for possible resubdivision and the Town Planning Commission requested to submit a sketch of their suggestions of such resubdivisions and at the same time that consideration be given by the Commission to other areas in the City which require resubdivision in order to make better use of the land. Carried.

From the North Vancouver Business Association, asking if the Council will get together with the other North Shore Municipalities with the object of making uniform store closing bylaws.

Alderman Gostick pointed out that the hours of closing

may be altered by Bylaw on a petition by certain classes of business or the Council could initiate certain closing hours by Bylaw if they are of the opinion that such a method would be desirable. He felt that the Business Association wanted if possible, the same hours throughout the North Shore.

Mayor Goldsworthy suggested that possibly the merchants on the North Shore might get together and submit their ideas as to desirable hours for closing.

Alderman Gostick advised that the North Vancouver Business Association and the West Vancouver Business Association are working along the same lines and with similar objectives.

His Worship referred this request to the Legal and Policy Committee to discuss with the pertinent groups and submit a recommendation to Council.

From Blanche M. Cardinal, 247 East 15th Street, requesting permission to connect her property on the north west corner of 29th and Lonsdale, to the City sewerage system.

Moved by Alderman McDevitt, seconded by Alderman Gostick that this request be referred to the Board of Works and Building Committees for a recommendation. Carried.

From the City of Vancouver, enclosing copies of the Minutes of the Vancouver Street Naming Committee meeting held on November 22nd 1950. The Committee had recommended that a Metropolitan Street Naming Committee be set up and asked for the appointment of delegates from adjacent municipalities.

Moved by Alderman Gostick, seconded by Alderman McDevitt that the above Committee be thanked for its work in attempting to consolidate and clarify the list of street names in the Metropolitan area and that the City Clerk be appointed this Council's delegate to the meetings of such committee. Carried.

From J. A. Porterfield, 452 West 25th Street, complaining of drainage conditions in his area.

Mr. Greenwood reported that certain improvement work had been carried out since receipt of the letter.

His Worship referred this letter to the Board of Works Committee with power to act.

From Helicopter Exploration Co. Ltd., 844 West Hastings Street, asking if there would be any difficulties in commencing mining operations at certain zinc claims in the Lynn Creek Watershed.

Alderman Suttis pointed out that the Council's only desire is to protect the City's water supply which is considered to be a much greater asset than the development of any mining property but advised however that his committee would be prepared to meet with the above Company's representatives to discuss the matter.

Moved by Alderman Suttis, seconded by Alderman Gostick that the letter from the Helicopter Exploration Co. Ltd., be referred to the Waterworks Committee to discuss with the Company's representative and advise of the Council's feelings concerning their request. Carried.

From Heywood Community Council asking for permission to place a woodshed on the community centre property on & Marine Drive.

Moved by Alderman Gostick, seconded by Alderman Stewart that this letter be referred to the Building Committee for consideration and report. Carried.

APPLICATIONS TO PURCHASE TAX SALE PROPERTY

**PETITIONS**

The Petitioners stated that the firm of Bartholomew and Associates recommended keeping the ferries and they feel that this opinion should be heeded.

Alderman Gostick stated that Harland Bartholomew and Associates did not make any recommendations as to keeping or discontinuing the ferry service and made very little reference to its operation in its Town

Planning Reports.

Mayor Goldsworthy pointed out that many people seem to have the impression that the Council desires to discontinue the Ferry service and this was not true, the Council only desires to have an expression of opinion from the people as to their wishes on the future operation of the system.

Moved by Alderman Gostick, seconded by Alderman Cates that the above petition be acknowledged and that the petitioners be advised that same has been referred to the Ferry Committee of the Council for its inform-

ation and guidance. Carried.

Alderman Gostick advised that there was sufficient

Letter was received from the Seafarers International Union of North America giving notice that it wishes to reopen its agreement covering unlicenced personnel 2 on the City Ferries.

The Clerk submitted an application for a taxi license from Herbert K. Myland and a further application from Lillian Annie Armstrong and Thomas William Armstrong for a licence to operate as Bert's taxi from 15th and Lonsdale.

AND THAT the application of H. K. Myland, operating as "North Vancouver Taxi" be approved. Carried.

The Clerk submitted Order-in-Council No. 2687 covering the "City of North Vancouver Tax Sale Properties Reserve Expenditure Bylaw 1950, No. 3".

Received and filed.

The Clerk submitted certificates from the County Court covering Bylaws No. 2002, 2003, 2004, 2005, and 2006. Ordered received and filed.

Alderman McDevitt advised that he had had a visit from the Committee handling the North Vancouver Day Celebration at Callister Park on December 9th. He reported that a cavalcade of private cars and about six buses will leave from the vicinity of the Community Centre at 1 p.m. He advised that there would be two bands in attendance and he requested the Council to authorize the Mayor to proclaim December 9th "North Shore United Day."

Moved by Alderman McDevitt, seconded by Alderman Gostick that His Worship Mayor Goldsworthy be authorized to issue a Proclamation proclaiming December 9th 1950 as North Shore United Day. Carried

Mayor Goldsworthy explained that he would be unable to be present at Callister Park on the above occasion as it would be necessary for him to be at the opening of the Mount Seymour Highway on that date.

Letter was received from the North Shore Joint Remembrance Day Committee thanking the Council and the various Departments for their co-operation in putting on the 1950 Rememw brance Day Service.

Moved by Alderman Gostick, seconded by Alderman McDevitt that the above letter be acknowledged with thanks and that the Council's appreciation be forwarded to the Committee for the splendid arrangements they made for the holding of the 1950 Remembrance Day Services. Carried.

A Copy of a letter from the Municipal Clerk of West Vancouver to the Chairman of the North Vancouver General Hospital under date of December 1st 1950 was read. The f letter advised that a referendum would be held in West Vancouver at the December elections as to whether the electors desire to participate in an addition to the North Vancouver General Hospital or whether they wish to construct their own hospital in West Vancouver.

Mayor Goldsworthy explained that at the last meeting of the Hospital Board a representative from the West Vancouver Council and a West Vancouver Ratepayer was present for the purpose of getting up-to-date information on the

matter of Hospital accommodation. The Board made it clear to these gentlemen that it would welcome West Vancouver participation in the construction of an addition to the North Vancouver General Hospital. The Board stated its requirements and pointed out that it had previously approved of West Vancouver's participation in a North Vancouver Hospital Society which would operate the Hospital.

certain residents in the 300 block between 25th and 26th Streets and which had not been signed by a sufficient number of owners at that time, was now being resubmitted but required the signature of the Corporation as owner in order to secure the necessary number of owners to be sufficient under the "Local Improvement Act."

Superintendent Greenwood reported that the Convent known as Sisters of the Child Jesus would provide the necessary material for the construction of a culvert near their property provided the City would carry out the necessary work of installation.

Moved by Alderman Suttis, seconded by Alderman Stewart that the Superintendent of Works be authorized to proceed with the work as outlined by him on the understanding that the material is to be provided by the Convent known as the Sisters of the Child Jesus. Carried

Alderman Cates reported that the boys from the local St. Paul's Indian School had done very well in the recent silver gloves competition. He understood they had captured nine out of the 14 championships which had been put on and he thought they should be commended.

Moved by Alderman Cates, seconded by Alderman Stewart that a letter of congratulation be sent by the Council to the boys of St. Paul's Indian School on their recent success at the Silver Gloves Competition in Vancouver. Carried.

Whereupon the bylaw was reconsidered, finally adopted and passed by the Council, signed by the Mayor and City Clerk, and sealed with the Corporate Seal, and numbered 2008.

AND OTHER COMPETENT BUSINESS

Alderman Templeton said that he had had no opportunity to speak on the motion to reconsider the "Ferry Referendum Bylaw 1950" as it had been dealt with too quickly. He said that he did not wish the Council to be swayed by any opinions he might express against the bylaw, but nevertheless he had consulted two authorities on the English language, and both these gentlemen thought the use of the word "subsidy" is not straightforward, and makes for an unfair question designed to produce a definite result, and he wished to be recorded as being against the wording of the present plebescite. He said that it was his understanding that the ferry referendum would be put in the form of questions to the electors, accompanied by a booklet giving facts on the system, together with a list of pro and con statements covering the questions to be asked. He thought that the Council should reword the plebescite, and contended that the Council should not put forward such a question as proposed, which he felt was a leading question. He suggested that the matter be given reconsideration.

Mayor Goldsworthy advised that Alderman Templeton should have made his statements at the time when the by-law was being reconsidered earlier in this meeting and that now was not the time to discuss it.

Alderman Gostick said that Alderman Templeton's views and his own views are different. He said the question on the referendum was not a leading question and that what we wanted to know is whether the electors wish to subsidize the ferry system. He had always been in favour of one question of this type and the decision of the Council to change from the set of five questions to the one question at the previous Council meeting on December 4th came as a shock to him, he said.

Alderman Templeton said that the City Solicitor had pointed out that none of the questions on the ballot should contain any propaganda.

Mayor Goldsworthy pointed out that the question of the ballot had not been changed. It remains as is -- but the other four questions are simply struck out.

Alderman Templeton said that Mr. McGregor, an

English language expert had told him that the question was designed to secure "NO" for an answer. He again reiterated his stand that he was against the referendum question in its present form.

Moved by Alderman Stewart, seconded by Alderman Gostick, that this Council now adjourn. Whereupon the Council adjourned at 8: 50 a.m.

# CERTIFICATE OF THE RETURNING OFFICER

Result of the Municipal Election held in the City of North Vancouver on the 14th day of December 1950.

I, Ronald Clement Gibbs, Returning Officer for the City of North Vancouver, do hereby certify that as directed by Statute and resolutions of the City Council, I gave notice to the Electors of the City of North Vancouver on the 30th day of November 1950 to the effect that Nominations for the purpose of electing three persons to represent them as Aldermen and two persons to represent them as School Trustees would be received by me at any time between the date of the Notice and 12 o'clock noon on Thursday the 7th day of December 1950 and Notice was given on the 7th day of December to the electors of the City of North Vancouver that the vote of the said electors would be taken at the same time and at the same place as arranged for the annual elections on the following question:

"Are you in favour of the City of North Vancouver continuing to operate and subsidize if necessary the present Ferry System?"

and notice was given to the electors on the 30th day of November 1950 that the vote of the said electors would be taken at the same time and at the same place as arranged for the annual election on the following question:

"Are you in favour of the Council granting to the North Vancouver Public Library Association, aid out of the general revenue in a sum not exceeding the equivalent of \$1.00 per capita of population of the City according to the last Canadian census?"

At the expiration of the time appointed for the nomination of Candidates as aforesaid, only two Candidates, namely HOWARD CARSON GRAHAM and ANDREW ARCHIBALD REID were nominated for the office of School Trustee for a two year term, and I forthwith declared the said HOWARD CARSON GRAHAM and ANDREW ARCHIBALD REID duly elected School Trustees for the years 1951 and 1952, and returned their names to the Clerk of the Municipality.

CORRESPONDENCE

From the Amalgamated Meat Cutters Local 212 and Retail Grocery and Food Clerks Union, Local 1518 drawing attention of the Council to the disregard of the "Early Closing By-laws" affecting Meat and Grocery Stores.

Mayor Goldsworthy advised that the matter of Store Closing hours 2 was being discussed with representatives of the North Vancouver Business Association by the Legal and Policy Committee and suggested that this matter should be dealt with by such Committee.

Moved by Alderman Cates, seconded by Alderman Stewart that the above letter be referred to the Council's Legal and Policy Committee to consider when dealing with the general subject of Store Closing hours. Carried

From the Amalgamated Meat Cutters Local 212 and Retail Grocery and Food Clerks Union, Local 1518 drawing attention to the violation of the Council's By-law No. 370 which provides for a Weekly Half-holiday in the City.

Mayor Goldsworthy advised that in his opinion this complaint had regard to quite a different situation. He pointed out that the electors had voted to establish Wednesday as the day for the Weekly Half-Holiday in the City and the By-law should be enforced.

Half-Holiday in the City and the By-law should be enforced.

Moved by Alderman McDevitt, seconded by Alderman Stewart that the Police Department be instructed to enforce the provisions of By-law No. 370 known as the "Weekly Half Holiday By-law, 1917." Carried

From the Union of B.C.Municipalities, enclosing a letter from the Commissioner of Hospital Insurance, who pointed out that unless some other suitable arrangement can be suggested by the Union, all Municipalities will revert to the basis of paying the Municipal Hospital Grant on a per diem basis of 70 cents per day, effective January 1st 1951.

Alderman Gostick reported that the Council's attitude to this question was that the Municipality should not pay the per diem grants at all, feeling that it was a form of subsidization of the Hospital Insurance Service. In our own case the payment of a lump sum to the Government was estimated to be higher than what we would pay on a 70¢ per day basis. Last year he pointed out we paid an 4 amount of \$14,000.00 in such Grants. The Council agrees he said that the work of establishing residence in all Municipalities is a costly one.

The Clerk pointed out that the City's position was set out in a resolution which was submitted by the Council to the Union Convention in 1949 which stated that while the Council did not agree to the principle of paying per diem grants, it felt that if it was to be continued then those Municipalities which owned and operated Hospitals within their boundaries should be given an allowance to cover depreciation on such asset and should not have to pay the same amount as those Municipalities which do not have the responsibility of maintaining a Hospital.

Moved by Alderman Gostick, seconded by Alderman McDevitt that the Clerk be instructed to inform the Union Secretary of the Council's opinion on the matter of Hospital per diem grants. Carried

From the Canadian Legion, Lynn Valley Branch No. 114, expressing appreciation for the cleaning of the Cenotaph in Victoria / Park and the placing of a Plaque on same.

Ordered received and filed.

From the Royal Canadian Mounted Police, Ottawa, enclosing the proposed 1951 Policing Agreement.

His Worship referred this matter to the Police Committee for early consideration.

From School District No. 44, enclosing supplementary Extraordinary Estimates No. 2 for 1950, amounting to \$225,000.00 the City's share of which will be \$58,417.76.

Alderman Gostick advised that his Committee would meet with the

Alderman Gostick advised that his Committee would meet with the School Board next Wednesday evening at 8 o'clock to discuss the above estimates and would report back to Council.

From the Department of Lands, Victoria, advising with respect to the City's application for a lease of Crown Lands in the Lynn Valley Watershed that the lands in question are the subject of an application for the purpose of a Municipal Forest and accordingly the City's application "is being held in abeyance in the meantime."

Mayor Goldsworthy reported that he had mentioned this letter at the Stewardship meeting in view of the importance of the matter. Since then he had had a discussion with Commissioner Sowden who promised him that the District would not go into the Watershed without consulting the City Council.

Mayor Goldsworthy suggested that the Board of Works Committee and the Superintendent of Works meet with Commissioner Sowden as soon as possible to discuss this matter. He pointed out that if chlorination was necessary because of any Forest programme in the Lynn Valley Watershed 3500 families in the City would be affected and 700 in the District.

He also asked the Council if it would care to allow him to visit Victoria and clear up some of the misunderstanding which apparently has arisen with regard to the situation in our watershed.

A lderman Gostick agreed to the steps as outlined by His Worship. He pointed out that in one of the newspapers there was a quotation from the Department of Lands & Forests letter to the effect that eventually the Lynn Valley Watershed would be deeded over to the Greater Vancouver Water District and this City Council certainly had no intention of agreeing to such a proposal. He was of the opinion that we should require the refilling of Rice Lake pursuant to the Agreement and notice to refill which had been given to the Water District some time ago. He felt that this matter should be checked to see that the Water District does not have any excuse that it does not have time enough to refill the latter in accordince with the agreement.

The Clerk was instructed to make a report of the situation regarding the refilling of Rice Lake by the Greater Vancouver Water District.
