Minutes of the Regular meeting of the Council, held in the Council Chamber, City Hall, on Monday, December 3rd 1951 at 8 p.m. Present **SOCCX** 

His Worship Mayor F.R. Goldsworthy, Alderman M.F. Aldous, Alderman C.W. Cates, Alderman K.H. Gostick, Alderman J.C. McDevitt, Alderman A. Stewart and Alderman J.A. Suttis.

MINUTES Moved by Alderman Stewart, seconded by Alderman McDevitt, that the Minutes of the Regular Meeting of the Council held on November 19th 1951 be taken as read and adopted, copies of same having been given to all the members of the Council. Carried

Before the regular agenda was commenced Alderman McDevitt introduced Mr. Ray Munro, the new representative of the "Daily Province".

His Worship welcomed Mr. Munro.

CORRESPONDENCE

From the District of North Vancouver expressing appreciation for the use of the City Council Chambers by the District & Council, during the past 9 months.

Moved by Alderman McDevitt, seconded by Alderman Stewart that this letter be received and filed.

From the North Vancouver Junior Chamber of Commerce, enclosing a Brief on the North Vancouver Ferry system in which the Chamber expressed the opinion that the Ferry system should be abolished and suggesting that the electors again be given an opportunity of voting on this matter at the December election. Alderman Cates said that while he will not be on the Council

Alderman Cates said that while he will not be on the Council next year he felt that the Ferries should not be done away with. He commended Alderman McDevitt for the work which he had done during the past year which had resulted in lowering the amount of deficit which had been estimated at the beginning of the year. He pointed out that the citizens had voted on this matter

under the same conditions last year as existed now and he did not feel that we should put a plebiscite again at this time. Alderman McDevitt said he was very happy with the interest

that the Junior Chamber of Commerce had taken in this matter but he pointed out that there was between 2500 and 3000 people using the system every day and a real service is being given in looking after the transportation needs of this group. He said that he disagreed with Alderman Cates as he felt that we 3 should once again, as last year, secure the opinion of the electors and felt confident that they would vote in favour of retaining the ferry vessels.

Alderman Stewart thought as one of the Council who is going up for re-election, as far as he could see the citizens are in favour of the ferries and paying their "mite" towards continuing the ferries. He pointed out that the Ferries carried freight which is a great service to local business concerns being much faster than the trucking service over the Bridge. He said that there were lots of angles to the ferry question pointing out that the Jaycees had referred to the maintaining of a monument to the City's past. At the same time he felt that if this plebiscite is again put it will carry by more than 4 to 1 and he personally was not afraid of a referendum on the matter.

Alderman Aldous said he was not for or against the ferries but he was in favour of a plebiscite as long as the loss continued. He said he could not as a Council member, support the loss in the system each year.

Alderman Gostick said that he felt that we had asked this question last year and had given the electors all of the facts

and they had voted 4 to 1 in favour of retaining and subsidizing the system. He pointed out that the 1951 loss is nearer \$40,000.00 rather than \$50,000.00 as estimated at the beginning of the year. He said that he could not see why another plebiscite should be taken now especially when the Aldermen seem to be of the opinion that the electors will vote in favour of retaining the ferries. He said that any question put to the electors would be a repetition of the old question put last December and further that there was not time to give them information. He said that he felt that until the situation is worse than last year he could not see the necessity of going back again to the electors.

Alderman Suttis said that he felt that the other Aldermen had expressed it correctly when they said it is not a per-sonal question of whether the ferries should run or not. He pointed out that last year this matter had developed into a personal argument in the Council between those Aldermen who thought the Ferries should be discontinued and those who thought they should not. He referred to the letter from the Engineers, Masters and Mates and Deckhands later on in the Agenda pointing out that these letters were asking for changes in their wages and working conditions. He said that this means that we do not know what next year's operating costs will be and the Ferry system is not like a private business where you can increase fares to meet the higher cost of operation. He felt that when the Council makes up its annual budget each year we should know whether the people are ready to pay whatever the estimated deficit of the system would be.

Alderman Suttis also pointed out that it has already been stated in the Press that a Ferry Referendum will be held this December and most people are ready for such a question even though there is not much time to give information to the Electors. He felt as did Alderman Aldous that the electors should be asked annually whether they wish to pay the Ferry subsidy.

Alderman Cates asked permission to speak again on this subject and he pointed out that the City has other services such as Ambulance, Parks, etc. which give a public service and cost the citizens money but these services are part of the community of North Vancouver and are necessary to retain the community on a sound basis. He thought it would be disastrous to do away with the ferry system and he did not think there was a man on the Council who could visualize North Vancouver without its ferry system. He also thought it a shame that this matter should be brought up at all. His Worship referred this matter to the Ferry Committee

to take up in its Ferry Report later on in the evening.

### PETITIONS

Petition was received from Jean E. Heys, 862 Cumberland Crescent and others requesting certain street improvements and additional street lights, in the area between Fell Avenue and Hamilton Avenue and Marine Drive and 20th Street.

A delegation was present.

Moved by Alderman Stewart, seconded by Alderman Cates that the delegation be heard. Carried

Mrs. Jean Heys and Mrs. Lyttle then spoke to the Council. Mrs. Heys said that the petitioners did not want anything unreasonable but did want to know definitely what can be done this coming year to improve the road conditions and street lighting in their area.

Mayor Goldsworthy said that the Council appreciated the interest which had been taken by the Petitioners in this matter but he pointed out that the City will be installing a water main on Hamilton Avenue and 20th Street next Spring so that nothing can be done to improve the surface of Hamilton Avenue until this work is completed. He said that so far as the Street lighting is concerned a survey of the area has been made. Alderman Aldous advised that the street lighting survey report

would be considered at the next Committee meeting.

Mayor Goldsworthy said that if the present Fell Avenue Bus service is discontinued the area will have a bus service operating down from the Highlands and then down Fell Avenue to Marine Drive so that it will have as good a bus service as it has now. He said that in the meantime the Council appreciates the position of the residents in the area.

Alderman Cates said that the Council has a hard time trying to do the many things which it is necessary to do but is limited both by time and finances. He agreed however, that his Department had had a good year this year because of the exceptionally good weather and he referred to the Edgemont Boulevard construction as an example. He said when his Committee had received the petition with regard to the Hamilton Avenue area an inspection f had been made but it was found that until the watermain is installed it would be difficult to promise what we can do during the coming year. He felt however, that the request of the petitioners could be included in the preliminary estimates for 1952 and submitted the following recommendation:-RECOMMEND that Mrs. Jean E. Heys and other petitioners requesting road improvements and street lighting improvements in the area between Fell Avenue and Hamilton Avenue, be advised that the City cannot consider any permanent improvement to Hamilton Avenue as requested, until such time as the new watermain has been installed on this street and that the Electrical Inspector be instructed to study the street lighting in the area referred to by the petitioners and report his findings to the City Council, and that the road improvement as requested by the Petitioners be referred to the 1952 Preliminary Estimates.

Moved by Alderman Cates, seconded by Alderman McDevitt that the above resolution of the Board of Works Committee be adopted. Carried

Alderman Aldous reported that the Christmas lighting is now installed on Lonsdale Avenue and he felt that such lighting was an improvement over last year's. He said that we now have permission from the B.C. Telephone Company and the B.C. Electric Railway Co. to utilize their poles to prevent sagging of the lighting strings.

### BOARD OF WORKS COMMITTEE

Alderman Cates reported that he had just received a request from Superintendent Greenwood for authority to reshingle the Lonsdale and Scout Hall and that Mr. Greenwood would like to call for tenders for this work.

Moved by Alderman Cates, seconded by Alderman McDevitt that the Superintendent of Works be authorized to call for tenders for the complete reshingling of the Lonsdale Hall. Carried.

Alderman Cates reported that at different times the Superintendent receives requests for permission to cut down timber on City property. He said that his Committee feels that if in future further requests are received of this nature we will either do the work ourselves or advertise such timber 4 for sale by public tender.

RECOMMEND that until further notice, no further sales of timber be made from property owned by the City. Moved by Alderman Cates, seconded by Alderman McDevitt that the above recommendation of the Board of Works Committee be adopted. Carried

#### FERRY COMMITTEE

Alderman McDevitt submitted the following traffic report for the month of November pointing out that the situation is getting more encouraging each month:

Alderman McDevitt said he would like to briefly touch on the 6 fare collection methods now being used. He said that the Superintendent had been authorized to experiment with the 4

collection of fares on the vessels themselves during non-rush hours. To date, he said 16,939 such fares had been collected but it was felt that we should wait for a little longer before submitting a definite report on this matter.

Alderman McDevitt advised that the future handling of the Ferry ' advertising is still receiving the consideration of his Committee.

Moved by Alderman McDevitt, seconded by Alderman Suttis that the electors again be asked to vote on the following question:-"Are you in favour of the City of North Vancouver continuing & to operate and subsidize if necessary the present ferry system?"

at the December election. The motion was carried with Alderman Gostick and Alderman Cates

voting against same.

<u>WATERWORKS & INDUSTRIAL COMMITTEE</u> Alderman Stewart reported that the Waterworks Department were in need of radio equipment for their truck. He said that by so equipping such vehicle the Superintendent will be able to get in touch at all times with his Waterworks foreman.

Moved by Alderman Stewart, seconded by Alderman McDevitt that the Superintendent of Works be authorized to purchase a twoway radio unit for the truck used by the Waterworks foreman at a cost of approximately \$655.00, such expenditure being in-cluded in the estimates for the current year. Carried

Alderman Suttis said that he was Board of Works Chairman when the two-way radio equipment was installed in the Board of Works trucks and when it had been installed there had been some He said that at the time he was convinced of the criticism. desirability of such equipment and since that time he has seen how it has paid off. He said that personally he was in favour of the two-way radio installation in our Board of Works and Waterworks trucks.

Alderman Stewart reported that he had attended the regular meeting of the Greater Vancouver Metropolitan Industrial Development Commission on November 15th and several other meetings of special Committees of the Commission. He said that in order to clarify the work of the Commission the Minutes of the last meeting of same should be read to the Council and a copy of same given to all members. He pointed out that the City of Vancouver has only about 7000 industrial lots left to sell and some of these are not suitable. The only recourse then for new industries is to go to the Greater Vancouver area and he cited one industry which had located in Coquitlam where there was sufficient trackage. He said that when the Commission is properly set up the North Shore will be in a happy position to utilize its services to secure new industries.

With the permission of the Mayor, the Clerk then read the Minutes of a meeting of the Greater Vancouver Metropolitan Industrial Development Commission held in the City Hall on November 15th 1951. One of the more important points in the Minutes was that

letter would be sent to the affiliated Municipal Councils advising of the proposed budget for the year 1952 and asking for immediate consideration of the Municipalities sharing their portion of the budget on the basis of  $5\phi$  per capita. Alderman McDevitt requested that copies be made available

to the Council and to the press. Mayor Goldsworthy said he appreciated Alderman Stewart's

work on the Commission and asked if the Council will be asked to contribute towards the cost of operating same.

Alderman Stewart replied that a levy of 5¢ per capita from participating Municipalities would be requested. He said that a Secretary will handle the office until March 31st when an expert manager will be hired.

Mr. Harty in the audience asked permission to speak on Industrial sites.

Moved by Alderman Gostick, seconded by Alderman Cates that Mr. Harty be heard. Carried

Mr. Harty said that he was a salesman for Sharpe Realty Company. He said that they had made an inspection of North Vancouver Industrial locations and had found that there was very little left. He said that this should be borne in mind when talking of participating in the Metropolitan Industrial Commission. He pointed out that while the Council is a member of such Commission on the other hand it has refused an application from one of his clients at tonight's meeting for the sale of a lot for industrial use.

After repeated questioning by the Mayor, Mr. Harty advised that his client, E.S. Livsey & Co. had applied for such lot for storing his trucking equipment and for expanding his Company operations. Mayor Goldsworthy pointed out that we have the Canadian

Mayor Goldsworthy pointed out that we have the Canadian National Railway Development in view and must keep in mind the necessity of retaining sufficient land for spur lines. He said the Council did not want to sell one lot that would tie up a whole area.

National Harbours Board lands. Ordered received and filed.

Mayor Goldsworthy expressed appreciation to the Clerk and to the Comptroller for the work which had been done in compiling the City's brief on the question of taxation of Crown lands. He said that there was a likelihood of the City getting a grant from the Federal Government.

A letter was received from the North Shore United Veterans Council advising that one of their units has not accepted the proposal of the City Council to charge full rates for graves in the Veterans Plot in the North Vancouver Cemetery but advising that it will continue to urge this Unit to accept the City Council's offer in this regard.

Referred to the Parks Committee for consideration.

A letter was received from the Town Planning Commission advising that the Commission has reconsidered the application of Mr. & Mrs. J.A. Pittman for the re-zoning of their property Lots 28 and 29, Block 228, D.L. 545 to a Commercial District, but has reached the same conclusion as it had done on the original application that such re-zoning was not recommended.

# ANY OTHER COMPETENT BUSINESS

Alderman McDevitt said that he understood that both of the Candidates for Mayor have Committees working for them and in some cases the Candidates are not responsible for what the various Committee members do. In this regard he said he was against any claim such as was inferred in a recent advertisement that the Council members are under dictation by the Mayor. He said that while we do have some fights in Council he had never at any time been subject to dictation. Alderman Stewart said he did not see any harm in these

things being said. He said he had had his trouble in Council several years ago pointing out that this matter comes up every year but thought it would be better however, if the Candidates Committees who are responsible should pay particular attention to what they say.

Alderman Suttis said that he thought Alderman Stewart had covered the situation. He said it was difficult for anyone running for office to take care of every detail in his campaign. He said that he did not know whether he personally had been taken for a sheep and that possibly it was not the intention of anyone to so convey such impression. He said he hated to think that when the Council worked out its problems we were bound to take what someone else had said and to follow such advice. He said in some cases there had been considerable discussion but it was democratic to get the other person's opinion. He felt that in the Committees he has benefitted by the suggestions of the Mayor and other

Committee members and without such suggestions we would not be fulfilling our work. He said that never at any time had any member of the Council been so set in his mind as to hold out but were always willing to take cognizance of the other person's views. He said that he hoped that personalities would be kept out of the present campaign.

Alderman Cates said he had always been used to working in an organization and compared the Council to a ship. He said he always felt he should be loyal to the Captain and that many times he had relinquished some of his most ardent views in order to go along with the majority of the Council. He

also stated that nobody was going to push him around. Alderman Aldous said that if the political parties took everything that had been said to heart there would be a lot of bad feeling created. He believed that the very fact that the seven members of the Council are elected and not appointed is the surest guarantee of the freedom of the individuals to express themselves.

Mayor Goldsworthy said that he appreciated all that had been said by the various Council members.

Alderman Gostick said we had some pretty good campaign speeches here to-night but he personally felt that it was not the proper place to discuss the matter although he agreed that the Aldermen had every right to express their own opinions.

Alderman Gostick said that as the Council is aware the Bridge Company is negotiating with the Canadian National Railway for a lease of the Second Narrows Bridge and the Mayor and himself are the Council representatives on the Bridge Company. He said that the Bridge Solicitor, Mr. Donaghy, has advised that it is not necessary to have the vote of the electors on any proposed lease of the Bridge but that he personally as one of the Council's representatives on the Board of Directors of the Bridge would like some direction from the Council as to its feelings in this regard. He said that he felt that he as a Director did not wish to agree or disagree on the question of whether or not the electors should vote on this matter until the Council directs him. He pointed out that the Council does not meet again until after the next Bridge meeting at which the Directors may be called upon to ratify the Bridge lease.

Moved by Alderman Gostick that the City's representatives on the Board of Directors of the Burrard Inlet Tunnel and Bridge Company be instructed not to approve the signing of any agreement without first having the approval of the electors of the City of North Vancouver.

There was no seconder to the motion.

Mayor Goldsworthy said that we have not a final agreement with the C.N.R. as yet only an agreement on certain principles. He said that he has promised the Council and other organiza-tions copies of the final agreement for study before it is finalized. He said that until the actual technical language is worked out it would not be fair to ask the Council to vote on the agreement or on whether or not it should go to the electors.

Alderman Gostick again pointed out that the Council does not meet until after the next meeting of the Bridge Company. He said it is not a matter of approving the agreement or not but that when the agreement is finalized the Council will have to make a decision in view of the previous By-law which had been put to the electors as to whether another similar By-law should be again submitted. He said that by the 13th of December the Bridge Company would have a completed agreement.

Alderman Gostick said that it did not matter whether the Council expressed its opinion to-night or not but he felt that some direction should be given to the Council's representatives on the Board of Directors prior to the Bridge Company finalizing the agreement.

Mayor Goldsworthy said that if the Council has enough information on this subject then it should instruct its Directors accordingly.

Alderman Suttis said that he did not think that the Council was being asked to decide on the agreement itself but on whether it should go to the people.

Alderman Gostick said that was the question - Do we want to go to the people with the agreement?

Alderman Aldous said he did not feel we should <del>go to the</del> electors but that any agreement that is finalized should be submitted to the City Council. Take action on any single phase of the proposed agreement until the finalized agreement had been presented to the consideration.

Alderman Cates pointed out that the last Bridge Agreement had been considered very thoroughly with members of the District Council and he presumed that that was what we would do with the new agreement.

Mayor Goldsworthy said that that was the intention.

Moved by Alderman Stewart, seconded by Alderman Cates that the Council do now adjourn. Whereupon the Council adjourned at 10 p.m.

Alderman Suttis advised that it had been the custom for the past few years to make a Grant to help in paying the costs of the Remembrance Day services at the Cenotaph.

/ RECOMMEND that the City Council make the usual grant of \$50.00 to the North Shore United Veterans Council as its share of expenses incurred in conducting the Remembrance Day Ceremonies. Moved by Alderman Suttis, seconded by Alderman Gostick that the above recommendation of the Finance Committee be adopted. Carried

Alderman Suttis advised that earlier in the year the Finance Committee had met with the Directors of the Memorial Community Centre regarding their financial position. However, after the first meeting the Centre had reorganized its entire method of operation and a further meeting had been held with representatives of the Centre when the Council had made a grant of \$750.00 to keep the Centre operating.

He said that they have now submitted an operating statement to the end of the current year showing a deficit.

Alderman Suttis said that the Finance Committee is satisfied that the Community Centre is being operated on as economical a basis as possible and they are certainly taking advantage of all of their time, for the various programmes which they sponsor. He said that the Committee feels that those responsible for operating the Centre need encouragement so that they will continue their worthwhile endeavours. RECOMMEND that an additional grant of \$500.00 be made to the North Vancouver Memorial Community Centre.

Moved by Alderman Suttis, seconded by Alderman Gostick that the above recommendation of the Finance Committee be adopted.

Alderman Suttis said that he now has the outline of the Council's financial position. He said that he did have some additional copies but that certain corrections had been made on them and it will be necessary to have new copies made for the Council and for the press.

Alderman Suttis then read his Annual report as Chairman of the Finance Committee for the year 1951.

Alderman Gostick said that his Committee had several matters before it and wished to make certain recommendations as follows:-

<u>Firstly.</u> It would be necessary for an amendment to be prepared covering the sub-lease of the St. George's Avenue waterlot between the City and Burrard Dry Dock Co.Ltd., in order to take care of the storm sewer on the lot and also in order to extend the term of the sublease as requested by the Company.

RECOMMEND that the Solicitor be instructed to prepare an amendment to the sub-lease of April 1, 1949 between the City and Burrard Dry Dock Company Limited to provide for the Corporation maintaining its sewer on the St. George's Avenue Waterlot, with the Company saving harmless the Corporation from any damage which might result to such sewer from any action of the Company or its servants,

# ANY OTHER COMPETENT BUSINESS

Mayor Goldsworthy said that there were several matters he wished to draw to the attention of the Council.

His Worship pointed out that there are now four men in the Lynn Creek Watershed area working on the Zinc Claims situated in such area. He said 7 more men are going into the watershed to-day with preliminary equipment and supplies and that 10 more are expected to enter the area in the near future. He said it looks like a permanent mining camp will be set up within the watershed area.

Mayor Goldsworthy suggested that the Council ask the Union Board of Health to inspect the Lynn Creek Watershed area and if necessary hire an Inspector to patrol and inspect the property in order to protect our people.

Alderman Gostick said that under the "Health Act" the Board would be liable for the cost of such inspection.

The City Solicitor said that it had occurred to him that the costs of inspection of the Lynn Creek Watershed area could be said to affect the City and District and West Vancouver if it is put on a Health basis pointing out that Typhoid and similar other diseases could affect the whole North Shore. For this reason he thought that the Union Board of Health would have to share the cost of inspection of the Lynn Creek Watershed area among all its members. He suggested that the situation should be put up to the Union Board of Health and let them carry out in their own way, the necessary inspections.
