<u>COMMUNITY CENTRE GRANT</u> Alderman Suttis stated that the last time we spoke about this Grant every member of the Council had different ideas and everyone was going to come back with a suggestion as to how they wished to see it handled. It evolved around the Civil Defence. We were going to ask Mr. Cartwright of the Community Centre to take over the duties of Office Manager for the North Shore area provided the three Municipalities agreed and we were all agreed on this but so far we have not heard from West Vancouver. He said while the District has not officially said so, their representative is in favour. He said this means an expense of about \$50.00 per month for extra help for Mr. Cartwright and on top of this the Community Centre wants \$1000.00. He said they had \$1200.00 last year and nothing this year so far; their first request being for \$1500.00 this year.

Alderman Suttis stated the Community Centre have kept down to economical operating and are trying to do good work with the help of the Police. He said he thought we could give them \$1000.00 and a little rent for Civil Defence. He said it seems unfair to

drag it along any longer. Moved by Alderman Suttis, seconded by Alderman Johnson that the North Vancouver Community Centre be given a grant of \$1000.00. Carried

<u>NEON SIGN</u>

Alderman McDevitt reported on the application of Neon Products of Western Canada Ltd., to put up a "Province" Neon Sign over the Paine Hardware Building. He said after seeing the sign and talk- γ ing with some officials he thinks that we should amend the By-law to get it. He said it is a beautiful sign and he thinks it would be an acquisition to the City. He said it tends to be rather gloomy in that part of the Town and the sign would brighten it up. A discussion took place and Alderman McDevitt explained that the Sign is very big and the By-law at present does not allow such a large sign and also it has to be attached to a building strong enough to hold it.

The Mayor suggested it might be better up at 8th and Lonsdale over Barlow's but Alderman McDevitt said that building would not hold it.

Alderman McDevitt said it was thought that the Paine Hardware building would be suitable but the Sign people would have to

see the roof first as the sign is very heavy. It was agreed that if the Neon Products of Western Canada Ltd., find a suitable location for the "Province"Sign the Council would be prepared to amend the Sign By-law.

Letter was read from School District No. 44 in which they amended the date for filing Supplementary Extraordinary Estimates, to October 20th 1952.

REPORTS OF COMMITTEES

LEGAL, POLICY & FERRY COMMITTEE

Alderman McDevitt said he had had a further discussion with representatives of Neon Products of Western Canada Ltd.,with respect to the Company's application to install a large Neon Sign in the City. He pointed out that the sign is larger than the present By-law will allow but the Council would be prepared to make the necessary amendment to the By-law to permit the installation if a suitable location can be found. He advised that the Company has just about completed arrangements with a local store to erect a display on the building and accordingly he advised that he will bring in a definite recommendation on this matter at the next meeting of the Council.

Alderman McDevitt reported that because of the absence of Council members at the Union of B. C. Municipalities Convention the matter of the Meat Store Closing By-law had not been dealt with by his Committee.

A lderman McDevitt submitted the following Ferry Traffic report for the month of September 1952 pointing out that while the number of vehicles carried is up from last year the passengers carried are down and he attributed this decrease to the layoffs in the local Shipyards:-

HEALTH, FIRE & LIGHT COMMITTEE

Alderman Johnson advised that because of prior commitments she had been unable to attend the last meeting of the Metropolitan Health Committee and the North Shore Union Board of Health meetings.

BOARD OF WORKS COMMITTEE

A Iderman Copping advised that the Board of Works Committee have just completed a very creditable job in connecting the new St. David's Avenue Sewer outfall with the main trunk north of the National Harbours Board Railway at the foot of St. David's Avenue. To do this five lines of track had to be lifted. He said the completed project would give an outfall comparable in size to some of the larger sewer outfalls in Vancouver. He said the work had proceeded without a hitch except that there had been some hold-up in the operation of the shovel and the Department had only the period between 8 a.m. Saturday and 8 p.m. Sunday to do the job and he felt that the Staff should be commended for the fine work which had been done.

Moved by Alderman Copping, seconded by Alderman Stewart that this Council express its appreciation to Superintendent Greenwood and his Staff for the expeditious and efficient manner in which the St. David's Avenue Sewer outfall work had been carried out.

The Council members agreed and the motion was carried unanimously.

PARKS & TRANSPORTATION COMMITTEE

Alderman Aldous advised that there are a number of Parking complaints which have been received by the Council in the past and his Committee will be dealing with these matters this week.

WATERWORKS & INDUSTRIAL COMMITTEE

A lderman Stewart said that the Metropolitan Industrial Development Commission had recently had the opportunity of hearing an address by Mr. James Sinclair, M.P. He said that the latter was very interested in getting new industries into British Columbia and especially into his own riding. Mr. Sinclair had advised that his taxes in Ottawa were approximately \$550.00 a year for a 50' lot with an average dwelling on it. He had stated that one of the reasons why the taxes were so high was because they did not have industries.

Alderman Stewart said that when we get more industries into North Vancouver our taxes will be greatly reduced. He advised that he had had a letter from Mr. Ekman, Chairman of the Industrial Commission to the effect that inquiries for Industrial sites on the North Shore had been held in abeyance during the

recent vote on the Bridge Agreement. He thought they have now been opened and advised that they can come in to the North Shore.

Mayor Goldsworthy said that he believed that the Metropolitan Industrial Commission is doing a very good job especially in regard to the finding of Industrial sites on the North Shore.

NEW BUSINESS

The Clerk submitted the certificate of the Returning Officer of the result of the Poll held on October 3rd 1952 dealing with the Schedule attached to the "City of North Vancouver Second Narrows Bridge By-law, 1952."

UNFINISHED BUSINESS

The Clerk submitted a report with respect to the powers of the Council to deal with unfinished and unsightly buildings in the City.

With respect to unfinished buildings he pointed out that to more effectively deal with same it will be necessary to amend the "Municipal Act" and the "Building By-law" and suitable amendments had been previously prepared by the former Solicitor Mr. Donaghy.

With respect to unsightly buildings such as the Lonsdale Theatre the Clerk advised that Legal advice should be obtained before taking any action in such cases.

Moved by Alderman McDevitt, seconded by Alderman Suttis that the Clerk be authorized to secure a legal opinion as to the Council's powers to deal with unsightly buildings such as the Lonsdale Theatre. Carried

ANY OTHER COMPETENT BUSINESS

Alderman McDevitt said that having read the column in the "North Shore Press" under the heading of the "Sidewalk Inspector" in the last issue, he would like to point out that the reference to the Council and some of the City's employees were lies and he would like to take issue with the writer of the column and ask him to appear at a public meeting to substantiate his charges. He said that the great difficulty was that people accepted such remarks as gospel. He referred to a statement which had been made that new blood was required in the Council. Alderman McDevitt said that it was very difficult to encourage new blood in the Council because of unwarranted attacks which were made on Council members such as this one he was referring to. He said that he had known the author of the article for a long time and he had never done anything constructive in the past to his knowledge. He said

Anything constructive in the past to his knowledge. He said that whenever the Council had something constructive it was opposed by the author of the column referred to. He said that the remarks of the columnist in the last issue had reflected not only on the Council but on some of its Department Heads. He said that people should have confidence in our employees and in the Council and he felt very badly because of the tremendous work which had been done for example by the Council and the Mayor in the recent Bridge Plebiscite. He said that never at any time had the remarks referred to come close to the truth and he felt that the author should be compelled to bring any facts that he has forward.

Alderman Stewart agreed and pointed out that this was his seventh year on the Council and at his last election he had offered to step down but was voted in by the Electors. He said he thought that the writer referred to by Alderman McDevitt was trying to get the Council's goat and we should not pay too much attention to him. Alderman Copping said that the Council took too much notice of these things referring to past criticism of the Council which Alderman McDevitt had made when he was a columnist.

Alderman McDevitt said that there was no objection to receiving criticism but he did object to the lies which had been printed.

Mayor Goldsworthy said he was sure we endorsed the memarks of Alderman McDevitt. He said we are driving people away from public office. He said that Mr. Loutet, who writes the "Sidewalk Inspector" has done good service, but if he has any constructive criticism he should bring it before the Council or at least write under his own name. Alderman Suttis said that he had no comment except to say we have confidence in our Department Heads and he would hate to think also that the remarks of the columnist referred to our former Comptroller. He said that he agreed with Alderman Copping and you always go through this sort of thing in any public office. He said also that he did not think we should worry unless it affects our Department heads.

Mayor Goldsworthy said that he appreciated Alderman McDevitt bringing this matter up for discussion in the Council.

Moved by Alderman Stewart, seconded by Alderman McDevitt that Mr. John O'Neill be appointed Acting Treasurer. Carried
