From the St. John's Ambulance Association, North Vancouver, asking for the use of certain rooms in the Social Welfare Building for the training of First Aid classes.

Alderman McMillan said that this matter came up several months ago and it had been referred to Mr. Gray, our Civil Defence officer who is responsible for Civil Defence training classes and he thought that this request should be referred to Mr. Gray also.

AND FURTHER that this Council does not contemplate the diversion of this creek, although in the distant future it may be the policy of the Council of that day to divert various creek beds into culverts and storm sewers, as

has been done in Vancouver.

Moved by Alderman Copping, seconded by Alderman Bryan that the above recommendation of the Board of Works Committee be adopted. Carried

Alderman Copping advised that with respect to the complaint of Mr. A. A. Turner of July 16th 1954 a report had been prepared by him regarding this matter and he asked the Clerk to read same.

Whereupon the Clerk submitted the following report of the Chairman of the Waterworks Committee:-

Re Water Main Burst on Mahon Avenue
July 12/1954

Dear Sirs:

The Board of Works Committee have considered very thoroughly the complaint of Mr. A. A. Turner of July 16th with respect to the above matter, and wishes to express its sincere regrets to Mr. and Mrs. Turner for the great

inconvenience and discomfort caused by the bursting of this main on the afternoon of July 12th 1954.

Because of the seriousness of the matter it was felt that a thorough enquiry must be made before replying to Mr. Turner's letter, and it is now possible to report as follows:-

- 1. A chart in the City's chlorination plant clearly shows that the break in the main occurred at 4.45 p.m. on the above date, and that the water was shut off at 5.10 p.m. on the same date.
- 2. A report from the Superintendent of Works office indicates that the call was received at 4.45 p.m. and the Acting Waterworks Foreman immediately contacted.
- 3. The report from the Acting Waterworks Foreman states that on receiving the call at 4.45 p.m. he forthwith proceeded to the scene of the break and turned off the water, and this was completely turned off by 5.10 p.m.

4. The Foreman then contacted his men and commenced a repair job, and water was turned on again by 9.00 p.m. the same day.

The Committee does not want to minimize the inconvenience and discomfort caused to Mr. and Mrs. Turner and the damage suffered by their property, but it would point out that during the past 8 years a continuous and systematic replacement of old wooden water mains has been carried out in this City, and never at any time has there been any thought of discontinuing this work until all the old wooden pipes have been completely replaced. At this date there is about 20% of our water system remaining to be replaced by new mains.

RECOMMEND that Bus Stop changes in the vicinity of 15th Street and the Grand Boulevard, 17th Street and the Grand Boulevard, 3rd Street and Lonsdale Avenue, and the change in routing of the Capilano Bus inbound to 3rd Street and Lonsdale Avenue to the Ferry Wharf, as outlined in the letters from the B. C. Alderman Copping advised that in view of the expense of building new stops at the Grand Boulevard at 15th Street as requested by the Company it had been thought that it would be proferable if the two stops at the north and south sides of 15th Street just west of the Grand Boulevard could be used and transfers made at this point.

Discussion followed.

RECOMMEND that a 24 hour Passenger Zone be established on the west side of Lonsdale Avenue just south of 3rd Street, pursuant to Section 38 of the "Street and Traffic By-law, 1950."

Moved by Alderman Bryan, seconded by Alderman Copping that the above recommendation of the Transportation Com-

mittee be adopted.

Alderman Copping explained that at the present time the Grand Boulevard bus stops at 3rd Street at McMillan Motors and will now stop in front of the Chinese Lantern. The Capilano bus he said will go via 3rd Street to Lonsdale Avenue and will also stop in front of the Chinese Lantern. The Lonsdale bus instead of stopping in front of McCulloch Motors will also stop south of 3rd Street at the Chinese Lantern.

Discussion followed.

Acting Mayor Stewart said that he had met the returning North Shore United Football team when it arrived from Winnipeg and had shaken hands with each player and congratulated them on reaching the finals of the Canadian Championship. He said he could see they had been through a tough series, having 5 games in Edmonton and then having to take a plane to Winnipeg with no chance of rest: He said he believed they deserved our praise for getting into the Canadian final and suggested that the Clerk send a letter of congratulation to Mr. J. Spencer, the Team Manager and to Fire Chief Thomson, the Club President.

The Clerk advised that Mayor Cates had inspected the proposed diversion of the Lane in Block 11, D.L. 273 and had discussed the same with Alderman Copping and he agreed that this By-law which had previously been tabled, should now go forward.

UNFINISHED BUSINESS

A letter was received from the Hon. W. A. C. Bennett, Minister of Finance, advising that the Council's request for a Ferry Subsidy cannot be considered favorably as it was felt that this would establish a precedent.

it was felt that this would establish a precedent.

Acting Mayor Stewart could not see where a precedent could be established as most of the other Ferries in the Province are run by the Government.

Alderman Bryan said he was almost positive that our request would not create a precedent.

Alderman Copping suggested that this matter should be referred to the Ferry Committee. He said that this matter is tied into B. C. Electric Railway inter-city fares and he pointed out that the recent bus fare increase apparently penalized travel by our Ferry system inasmuch as the bus fares via such system were increased 25% whereas the increase via the First Narrows Bridge was only 15% and therefore it is going to be harder on the City's Ferry system.

Discussion followed.

Moved by Alderman Bryan, seconded by Alderman Johnson that the City Clerk be instructed to send a registered letter to Mr. George Tomlinson, M. L. A. requesting him to make arrangements for a delegation from this Council to meet with the Provincial Cabinet to discuss the City's request of June 25th 1954 for a Ferry Subsidy. Carried

The Clerk advised that with reference to the proposed change in the Agreement with Central Mortgage and Housing Corporation and the removal of certain Wartime houses, that the necessary resolution had been prepared by the City Solicitor in this regard and that Alderman McMillan would now present this to the Council.

Letter was received from the District of North Vancouver, advising that they regret they are unable to share in the flushcoating of 29th Street as suggested in their Engineer's letter of July 21st due to the serious depletion of funds in their Board of Works Committee.

Alderman Copping said he was very disappointed that we will not be able to proceed with this work at this time.

Moved by Alderman Copping, seconded by Alderman McMillan that the Clerk be instructed to advise Mr. Geo. H.Johnson that as the District of North Vancouver is unable to provide funds for the flushcoating of 29th Street this year, this matter will have to be laid over until 1955. Carried

ANY OTHER COMPETENT BUSINESS

Alderman McMillan said that residents of the Lower Mainland are very disappointed at the increase in bus fares which has been granted to the B. C. E. R. Company. He suggested that it was an opportune time for the Mayors and Reeves of the Lower Mainland Municipalities to meet as a Committee and discuss the possibility of an Appeal. He said he understood that 28 days' were allowed for such an appeal. He said at least we should make an effort to ascertain if it is possible to make an appeal.

Acting Mayor Stewart said he understood that Reeve Mc-Sorley of Burnaby has such a discussion in mind.

Alderman McMillan said that Mr. Brackenridge, who represented the City of Vancouver at the P. U. C. Hearing, was going to recommend to his Council that an Appeal be made.

Discussion followed.

Moved by Alderman McMillan, seconded by Alderman Copping that Mayor Cates be requested to take up with the Mayors and Reeves of the Lower Mainland the possibility of an Appeal to the P. U. C. against the recent increase granted

on B. C. Electric Railway Bus fares.

Alderman Copping said he thought that this was a matter which should be taken up with the U. B. C. M. He said we do not have the time or the money to deal with the problem. He said last week he had read in one paper that the West Vancouver bus service was in the "hole" but later on he had read in another paper that it had made a profit and he could not understand this.

The motion was then put and carried.

Alderman McMillan said Mr. John H. Stewart of the Board of Trade had advised him that the Board had appointed a Committee to meet with Mr. Bowman, the General Manager of the P. G. E. Railway to discuss the desirability of having the passenger terminal near the Ferry wharf. He said Mr. Stewart had asked him if he had any suggestions and he had told him we should realize the congestion now existing on the south end of the First Narrows Bridge so that it is not reasonable for any Board studying the matter of Inlet crossings to recommend another Bridge at the First Narrows. He said the more you talked about this subject the more you find arguments against such a Bridge and that any additional crossings should be in the Eastern part of the City. He said he advised Mr. Stewart that many people feel the same way and that if the P. G. E. places their terminal at the foot of Lonsdale Avenue they would be in the centre of the two Bridges crossing the Burrard Inlet at the present time.

Alderman McMillan said he believed the Mayor should find out the viewpoint of the people responsible for taking the recent traffic count over Burrard Inlet as North Vancouver should know what their information is so that it can be given to the City Council.

Moved by Alderman McMillan, seconded by Alderman Copping that the Mayor be requested to secure definite data from the Burrard Inlet Crossing Committee as to the result of

their study of this subject. Carried

Moved by Alderman Copping, seconded by Alderman Suttis that this Council do now resolve itself into Committee of the Whole with Acting Mayor Stewart as Chairman. Carried

The Clerk asked if the appointment of Dr. Mott as Medical Health Officer had been approved by the North Shore Union Board of Health as he was employed and paid by that body. Alderman Johnson advised that this appointment had been confirmed by the local Board.

Mayor Cates said that when he was in Kelowna recently he was asked for his advice as to a corrosion problem in the water system of the Kelowna General Hospital, and that when he was in Los Angeles he had spoken to a representative of the Turko Company who had said that his company wouldn't consider treatment of the domestic water supply because in their opinion it was dangerous to add anything to water which was being used for domestic consumption. The suggestion was that a municipality might leave itself open for prosecution if it could be proved that they were adding chemicals to their drinking water.

Alderman Johnson said that she would like to discuss this matter further at next Monday's Committee meeting.

He said that he was afforded an opportunity of speaking to the delegates in Indian and he felt that North Vancouver had received a lot of good publicity. He advised that the North Vancouver booklets which he had distributed had been well received and he thought that consideration should be given to a new publication along these lines.

Mayor Cates then described his trip to St. Paul where he had visited the graves of some of his early relatives who had participated in the Civil War. Following that he had visited Los Angeles and had been royally treated by

Mayor Paulson of that city.

Mayor Cates said that after returning home he had received an invitation to speak at the unveiling of a plaque which had been erected at Midway, B.C., to commemorate the establishment of the International Boundary on the 49th Parallel at that point. He referred to a tree which is planted at the site which has two trunks at the bottom and which grow together at the top, and he said that the Indians have a legend to the effect that we are all related whether we live in the States or in Canada, and he

had been able to tell them of a similar story which is told by the Squamish Indians. He said that this had been very much enjoyed.

Alderman Johnson said that she would like to move a

vote of thanks to the Mayor for his fine report.

Alderman Stewart advised that he had represented His

Worship at a meeting of the P.N.E. Directors and had thoroughly enjoyed himself.

Mayor Cates said that he was sorry that he had neglected to thank Alderman Stewart for looking after his programme during his absence and wished to do so now.
