Moved by Alderman Johnson, seconded by Alderman McMillan that the B. C. Electric Co. be authorized to install at the earliest possible date two 400 c.p. street lights at the following locations:

One at 21st Street and Hamilton Avenue One at 19th Street and Hamilton Avenue and that the Rotary Club and School District No. 44 be advised accordingly. Carried

Alderman Johnson referred to the recent letter received by the Legal Committee from the Jaycees, advising that 6 they will be providing further benches at bus stops,

and will pay particular attention to the intersection at 15th Street & Lonsdale Avenue and at 15th Street and the Grand Boulevard.

MacSorley, Burnaby, Reeve W. T. Richardson of Chilliwhack, and Mayor C. W. Cates of the City of North Vancouver, has been appointed to consider the new legislation, and the Council is urged to send as soon as possible to the U.B.C.M. Moved by Alderman Bryan, seconded by Alderman Suttis that this request be referred to the Transportation Committee for a recommendation.

General discussion followed.

Alderman Suttis said he hoped that the Transportation Committee would see the necessity for a regular traffic light at 13th & Lonsdale, and some control of this light being exercised from the Fire Hall.

The motion was then put and declared carried.

Alderman Johnson said that she understood that the meetings of the P.T. Associations on this subject have not been unanimous, nor are the opinions of the principals unanimous on the matter. She said that she would suggest that the Parent Teacher Associations be advised that the City Council has this matter under consideration. Discussion followed.

Alderman Johnson said she would like to propose a vote of thanks to the Fire Department for the work done during the flood. She described the difficulties encountered by the Department in trying to pump out basements in her locality.

From St. Andrews & St. Stephens Presbyterian Church, extending an invitation to Council members to attend the opening of their new Church, at 27th St. and Chesterfield Avenue, on Sunday, November 27th, 1955, at 3 p.m.

Moved by Alderman Copping, seconded by Alderman Bryan that the St. Andrews & St. Stephens Presbyterian Church be thanked for their kind invitation and advised that as many of the Council members as possible will attend the opening of the new Church on November 27th, 1955. Carried

From Messrs. Mayall & Irvine, asking if the City would pass a by-law to exchange lane allowances in Block 75, D.L. 549, so as to provide a lane allowance along the north boundary of Lot D, instead of along the east 5 boundary, as at present.

The Clerk advised that this matter had been discussed by the Legal Committee some months ago, and they had agreed that this was in order. He advised that a by-law had been prepared, in case the Council wished to proceed further with it tonight.

FINANCE COMMITTEE

and we have built-up residential areas, the question of whether or not residents should be allowed to keep all sorts of animals should be reviewed. RECOMMEND that the Town Planning Commission be asked to include in its present review of the City's Zoning By-law the desirability or otherwise of prohibiting of the keeping of all poultry, livestock and other animals kept for produce or profit within City limits. Moved by Alderman Suttis, seconded by Alderman McMillan that the above recommendation of the Finance Committee be

adopted.

Alderman Copping said that he could see no objection to the above recommendation, as it is merely asking the Town Planning Commission to study the subject, but he thought it would be terrible if we had no noise of any kind except from car horns, etc.

Discussion followed.

The motion was then put and declared carried.

Alderman Suttis submitted a further recommendation on behalf of his Committee, as follows:

RECOMMEND that the Board of Works Committee give favourable consideration in 1956 to the opening up of undeveloped City property for sale, by the installation of suitable services in order to maintain the present level of receipts from this source.

BOARD OF WORKS COMMITTEE

Alderman Copping said that he would like to take this opportunity to thank the Board of Works Staff, the outside workers and the waterworks employees for their

b devotion to duty during the recent flood emergency. He said at this time it was not possible to assess the full damage done, except for one item--namely the loss of the bridge on 15th Street, at Mosquito Creek. He said all of the Staff was on duty for 24 hours one night and the next night half of them worked.

AldermanCopping said he thought the Council should also convey its appreciation to Mr. Andy Gray, and to Mr. W. N. Keeling, Social Welfare Administrator, for their work during the emergency.

Alderman Suttis said that the work of the Auxiliary Police Force and the regular Police Force should be recognized, not only for their efficiency, which we take for granted, but for their very kind and courteous conduct during a very trying time.

Discussion followed.

Mayor Cates said that Major General C. R. Stein and Air Vice Marchall Heakes, of the Civil Defence Organization had made an inspection here, and as far as he knew, were quite satisfied with the way things had been handled.

Alderman Suttis suggested that the Red Cross should also be thanked for their efforts. Alderman McMillan said that he thought that the average

citizen should be thanked for his contribution and help during the flood.

Mayor Cates said that he thought that the Civil Disaster Plan had worked very well.

The Clerk suggested that the Press and Radio, and particularly Station C.K.L.G. should be thanked for their fine co-operation in giving out bulletins and information to the general public.

Mayor Catessaid he thought we are all familiar with the problem at hand, which is the necessity of re-installing the auxiliary waterline to the Greater Vancouver Water District's 90 inch pipeline.

Discussion followed.

Moved by Alderman Copping, seconded by Alderman Bryan that the Superintendent of Works be authorized to proceed immediately with the installation of an 18 inch wood watermain from the City's connection on the 90 inch watermain of the Greater Vancouver Water District at Station 350 plus 50 to the City's chlorination plant on Evelyn Road, and that the necessary by-law be prepared to expend the estimated sum of \$25,000.00 from Tax Sale Lands Reserve, for this purpose. Further discussion followed.

Alderman Suttis said that he wondered if the Waterworks Committee would consider replacing this money from the Waterworks profit. He said he realized that this would shorten our revenue picture, but it was only sensible to assume that taxes will have to go higher. Superintendent Greenwood said that he thought that he should make some report with respect to the water situation, for the record.

He said the reason for being in a hurry for the above by-law

is because of an emergency situation at the Intake. He said the reason for the purchase of a wood watermain is that we cannot get any other type of pipe at the present time. He advised that the span which crosses Lynn Creek will be of steel, properly lined, and will be a permanent construction, and a further line can also be put alongside, if required in the future.

He reported that the 20 inch steel pipe required for the crossing of Lynn Creek Canyon had been acquired from the Trans Canada Pipeline, through the Dominion Bridge Company

He advised that the life of the wooden section of the line is about 20 years.

Discussion followed.

Superintendent Greenwood advised that it would have taken about 4 months to get cast iron pipe for the main line.

He advised that the anticipated cost of the new line, including the bridging over Lynn Creek will be under \$25,000.00, although, he could not be too sure on this point. He said that he had met to-day with Engineers from Dominion

Bridge, and with our own Consulting Engineer, Fred Stewart, and the bridge had been approved by both engineers, although its

construction embraces a completely new principle. In reply to a question as to the possibility of freezing, Supt. Greenwood said there will be drains at the bottom of the line to prevent freezing.

Actually, he said, the principle of the construction crossing Lynn Creek will be that of a suspension bridge upside-down. He said it is actually a complete bridge in itself. However,

it can be moved, if necessary.

In other words, the bridge had to be built so that it could be moved if the District of North Vancouver put a regular type bridge over the Canyon at that point.

Supt. Greenwood said they hoped to have water in the auxiliary line by next Friday.

Mayor Cates said that since he had been on this Council he had known about the former auxiliary connection with the Waterboard under Lynn Creek, and had never been very satisfied as to its location.

He referred to the violent action of some creeks and to how difficult it was to hold them.

Moved by Alderman Copping, seconded by Alderman Johnson that this Council do now adjourn. Carried.

Whereupon the Council adjourned, at 5:25 p.m.

Minutes of a Public Hearing of the City Council, held under the "Town Planning Act" on Monday, November 14th, 1955, at 7 p.m.

Present:

His Worship Mayor Charles W. Cates, Alderman J.M. Bryan, Alderman E.N. Copping, Alderman Violet M. Johnson, Alderman T.C. McMillan, and Alderman J.A. Suttis.

A delegation was present.

The Clerk advised that this Public Hearing had been advertised and posted as required by the "Town Planning Act", and was for the purpose of considering any complaints or objections to the application of Alderman E.N. Copping for the re-zoning of Lots 3-26 inclusive, Block 4, D.L.265, from "B" Urban Single Family District to "G" Light Industrial District.

The Clerk advised that he had received one letter from Mr. J.K. McGuigan, 2020 Westview Drive, advising that property owners in the Larson Road district would be represented at the Hearing to express their views regarding the application for re-zoning.

Moved by Alderman Suttis, seconded by Alderman McMillan that Mr. McGuigan be now heard. Carried.

Mr. McGuigan then addressed the Council.

He said that the delegation was there not to confirm the application for re-zoning, but on the contrary were opposed to it on the basis of several points.

He advised that in the view of the delegation, residential property in the vicinity would deteriorate if the application went through and the property was re-zoned.

went through and the property was re-zoned. It was also mentioned that the safety of the children using Westview School would be affected.

Mr. McGuigan pointed out that this change in zoning could be the thin edge of the wedge, and as a result, in the future, the property could be developed more and more for other industrial uses, even though the present purpose was for the location of a new City Yard.

He suggested that the area should be set aside as a park, and that this would be a wonderful opportunity to provide a buffer between the residential property and the industrial property to the south.

He advised that Mrs. Law was building a new commercial building in the area as a result of the increased residential growth and it was felt that this would be retarded if light industrial uses were permitted, as requested.

Alderman Copping said he thought the Council should explain that the re-zoning is not for industry, but is for the City's use.

He pointed out that there is a steep incline from the area in question to the residential area above.

Mr. McGuigan said he appreciated there would likely be a fringe of trees between the light industrial area and the residential area, but said it is the thin edge of the wedge, and referred to the Kitsilano district of Vancouver, where industry is encroaching onto the residential area.

He said he thought a buffer zone was needed between the two districts.

He referred to the buffer zone which had been placed along Marine Drive.

Alderman Copping said he thought there could be a fringe of trees around the proposed block.

Mr. McGuigan replied that the cobweb of industry is inclined to spread out over the years. He admitted that the area was not desirable for residential

He admitted that the area was not desirable for residential development, as it was low-lying, but he said if it was used for industry the upper areas would decay and he stated the City would lose 100-fold through loss of taxes.

He referred to the application of Mr. Wallace to erect a split-level home on the north side of 16th Street & Bewicke. Discussion followed.

Mr. McGuigan said he was in sympathy with the City's desire to expand its Yards, but he felt that as soon as an opportunity is given to industry it will creep into the area, and he again referred to similar areas in Vancouver. Mr. McGuigan said also that there isn't a City or Munici-

pality in the world that has enough parks in it.

Discussion followed.

Alderman Copping asked how Mr. McGuigan felt with respect to the suggestion that the property be restricted only to City use.

Mr. McGuigan replied that they were asking simply for an opportunity to study the problem before any further steps were taken.

Discussion followed.

Another delegate asked as to what extent the property would be used for trucks, and whether or not this would constitute a menace to children.

Discussion followed.

Alderman McMillan said he thought we should hear any of the delegates who wished to speak, and discuss the matter later.

Mr. Wallace, a member of the delegation, then spoke, and advised he was the party who had bought property from the City at 16th and Bewicke, and at that time it was a Single Family area.

He said he had been assured by at least two mortgage companies that a re-zoning of the block to the south would result in his being turned down on a mortgage.

He said he had purchased this property on the understanding that it was Single Family Residence property and he felt strongly against changing from this classification.

He said he had had considerable experience with Town Planning and it was a good policy always to put a strip between zones of varying nature, particularly between industrial and residential zones.

He said also there is no city in the world which can claim that it has too much park and playground area.

Industry, he said, is fine. As a matter of fact, his own firm prospered from the growth of industry, but there are other things in this world more important, such as children. He said we would sacrifice anything before we sacrifice our family.

He pointed out also that we have limited recreation facilities, and it is one of the prime considerations in the curbing of juvenile delinquency, the occurrence of which, he advised, was on the increase.

advised, was on the increase. He said he did not think that any community in Canada can afford to jeopardize its recreational areas, particularly 1

when they would serve a logical purpose in addition as a buffer zone between residential and industrial property.

Alderman Copping, he said, had pointed out that the area could be screened by trees, and would occupy only a small portion of the site. He said this was the viewpoint of the Council in 1955, but ten years from now the area might not be suitable, and it might not be sufficient. However, he said, the damage would have been done. He asked also what would be the disposition of the portion of the area which it is not planned to use at the present time.

He said he thought that the Council should think about this phase.

He mentioned the fact that Alderman Copping had suggested that a person should not erect a dwelling costing \$14,000.00 on the west side of Bewicke.

He said he did not agree with Alderman Copping in this He said that he was going to do the same thing himregard. self.

He said he had spoken to Mr. Briggs, the City's Land Agent, and had a lot of discussion with him, and had looked over the lots. He said he had seen no reason since then to change his mind. He said he thought the area would build up into a good residential section.

He said he felt strongly against the nose of the camel entering the tent.

My experience, he said, has been that once you allow any encroachment by industry into a residential area, you allow a decay to set in. He referred to areas in Vancouver which were once fine residential areas, and through the encroachment of industries have been made into slums.

He said to allow industry north of Marine Drive will lead to

deterioration of the residential area north of 16th Street. He asked if any of the Council members considered whether they would like to have a yard next to their property, and that if the Council members looked at it this way, they might reconsider the situation.

Mayor Cates said that one of the Council's main troubles was from the situation of park and playground areas near residential property.

Mr. McGuigan said that one suggestion was that the Heywood Community Centre be moved into the proposed block.

In reply to a question from His Worship, Mr. Wallace said that he certainly had no objection to playing fields in the area under discussion. As a matter of fact, he said, he enjoyed watching and listening to the children at play. He said he hoped that the day would never come when he would not be in favour of such playing fields in the vicinity of his home.

Mayor Cates said that he would like to know if the delegation as a whole was in favour of playing fields in the area.

The members of the delegation expressed themselves as being in favour of the suggestion that playing fields or a park be established in the area under consideration.

Alderman Suttis said that he thought that we should consider the extent of use of the proposed block. If the City yard was to be located in the centre of same, with only one entrance, out, then the rest of the block could be left for a park area.

Alderman Copping asked if the delegation would appoint a committee of three to meet with Council representatives and discuss this matter further.

Discussion followed.

Mr. McGuigan said the main objection is against the rezoning for industrial use, and that no suggestion has been advanced tonight which is acceptable to them.

Further discussion followed.

Mayor Cates said he thought the discussion had gone far enough to show that the application isn't going to be passed in this form.

He suggested that the ideas of the Committee should be studied, as the Council does not want to do anything contrary to the wishes of the delegation.

He said that the Council represents the citizens and everybody should be satisfied.

He suggested that the matter be discussed at a further meeting.

Mr. McGuigan said that the delegation appreciated that suggestion.

Further discussion followed.

Another delegate said that he had lived in the vicinity for a long time and pointed out that if a buffer strip was provided in the block in question there would not be too much room for a City yard, as the yard could not be too near the creek on the west boundary. Under the circumstances, he said, the City might be better off to stay where they are.

Moved by Alderman Suttis, seconded by Alderman Johnson that this Hearing now adjourn until December 12th, 1955, at 7 p.m., and in the meantime, the delegation appoint several representatives to discuss the matter further with the Board of Works Committee at its next meeting on November 28th, 1955, at 8 p.m.

The Hearing then adjourned, until December 12th, 1955.

FIRE, LIGHT & HEALTH COMMITTEE

Alderman Johnson submitted the following report on behalf of the Health Committee

"Attended meeting of Metropolitan Health Committee on Wednesday, November 16th. Dr. Gayton, Dr. Reba Willetts, Miss Trenna Hunter and Mr. H. P. Reusch, Chief Sanitary Inspector, spoke on the Annual Report of the Metropolitan Health Committee.

Dr. Willett's reported that of 18,425 students examined by doctors, 90% were found to be in "A" category, indicating a satisfactory state of health. 64.1% could be considered protected against smallpox and 71% against diphtheria.

Prevention of epidemics of either of these dis-eases is surely a worthwhile service but much of the public is apathetic until an epidemic occurs.

Mr. Reusch, the Sanitary Inspector, was perturbed about the rat menace but said most municipal dumps were in excellent shape. He thought some consideration should be given to the presence of livestock and poultry in the residential areas. It is felt that a point in the City's development has been reached when this type of operation should only be permitted on larger sites more suited to the purpose.

Mr. Reusch also spoke of the trouble experienced by buildings, especially duplex and apartment houses where there were no sewers and too small a disposal field for septic tanks."

A letter was received from the Loyal Protestant Home for Children, thanking the Council for granting permission to / hold their recent Tag Day on October 1st, 1955, and advising that the total amount collected was \$12,424.83, of which North Vancouver contributed \$862.24. Ordered received and filed.

Moved by Alderman Suttis, seconded by Alderman Bryan that this Council now adjourn. Carried. Whereupon the Council adjourned, at 8:55 p.m.
