Mayor Cates then presented a scroll to Miss McCready, signed by / all members of the Council, in appreciation of her more than 39 years of service with the City and her contribution to the Civic Government and the community. He said that he hoped this scroll would serve to remind Miss McCready of the various members of the Council and of their best wishes to her in her retirement. He said that this scroll was a token of the esteem in which the Council members held Miss McCready.

Miss McCready then thanked the Council for their gifts and said it was far more than she had ever expected. She expressed her best wishes to Mayor Cates and to Alderman Copping and Alderman Johnson who would be up for re-election this year. Moved by Alderman McMillan, seconded by Alderman Copping that the above letter be referred to the Legal Committee and the Board of Works Committee for report. Carried.

From the National Association of Marine Engineers of Canada, advising that they wish to re-open their Agreement in 1956. Moved by Alderman Suttis, seconded by Alderman Johnson that this matter be referred to the Labour Relations Committee for consideration. Carried.

From the Canadian Merchant Service Guild, advising that they wish to re-open their Agreement in 1956.

Moved by Alderman Suttis, seconded by Alderman Johnson that this matter be referred to the Labour Relations Committee for consideration. Carried.

From the North Vancouver Parent-Teacher Council, enclosing copy of a letter received from the U.B.C.M. Director advising that Councils have the power to pass by-laws dealing with the control of fireworks etc.

Alderman Johnson said this matter had been brought up in Victoria at a U.B.C.M. Convention several years ago. At that time the Deputy Minister of Municipal Affairs was against too

much restriction and didn't think that legislation could take the place of parental control.

She said that at the present time we advertise each year the provisions of our Fireworks By-law.

Moved by Alderman McMillan, seconded by Alderman Johnson that the above letter from the North Vancouver Parent-Teacher Council be received and filed. Carried.

From the Lower Mainland Park Advisory Committee, enclosing a resolution for endorsation, which resolution asked that the Municipal Act be changed to provide that a certain percentage

of each sub-division be set aside for park purposes. Moved by Alderman Bryan, seconded by Alderman Suttis that this matter be referred to the Parks Committee for consideration. Carried.

From Mr. K.J. Preiswerck, 910 Grand Boulevard, complaining of flood damages which he alleged were caused as a result of boulders blocking the culvert underneath 9th Street, and advising that he would be sending the repair bills to the City for payment.

Alderman Copping said the policy is that if anyone wants a culvert then they pay for it.

Moved by Alderman Copping, seconded by Alderman Bryan that this complaint be referred to the Superintendent of Works, with power to act in so far as dealing with the culvert referred to.

Discussion followed.

The motion was then put and declared carried.

From School District No.44 (North Vancouver), advising that they propose to increase the number of school traffic patrols, 3 and asking the Council's approval of same under Section 46, Sub-section 6.

From Burrard View Parent Teacher Association, asking if the Council would take immediate steps to ensure construction of a new hospital "without any excuses or delay".

Moved by Alderman McMillan, seconded by Alderman Johnson that the letter from Burrard View Parent Teacher Association with respect to the need for new Hospital facilities be received and filed.

Alderman McMillan said that as far as he knew we have taken all the required steps to facilitate this matter and there has been publicity in the papers as to the various steps that have been taken.

Alderman Copping asked if the above Association was not located in the District of North Vancouver and was advised that this was so.

Alderman Bryan asked if the letter was addressed to the City Council, and the Clerk advised that it was so and that a copy had

been sent to the District. The motion was then put and declared carried.

From Mr. P.C. Barker, Solicitor, on behalf of Albert Hansell, asking that steps be taken under the City's power to eliminate an alleged nuisance at 344 West 2nd Street where welding and general truck 2 repairs are carried out.

Moved by Alderman McMillan, seconded by Alderman Johnson that the letter from Mr. P. Barker on behalf of Albert Hansell and complaining about the operation of a welding and tire repair service at 344 West 2nd Street be referred to the Solicitor for a report. Carried.

From School District No.44 (North Vancouver), asking if the City would convey to the Board Lots A & B, Block 111, D.L.548, for the sum of \$1.00, and asking what price the City has set on Lot C in the same block.

Moved by Alderman Suttis, seconded by Alderman McMillan that School District No.44 (North Vancouver) be advised that the Council is prepared to sell Lots A, B & C, Block 111, D.L.548, for the assessed value plus 75 per cent, provided the said property is used for School Board purposes. Carried.

From the Evangelical Free Church, 14th and Sutherland Avenue, asking for exemption from taxation.

Moved by Alderman Suttis, seconded by Alderman McMillan that the Clerk be authorized to prepare the necessary by-law to exempt from taxation the Evangelical Free Church and the lot upon which it stands, namely Amended Lot 11, Subdivision 1-3, Block 12, D.L.616. Carried.

From the Assistant Commissioner, R.C.M.P., enclosing contracts for policing the municipality from June 1, 1955, to May 31, 1956, at an annual rate of \$2360.00 per man.

The Clerk advised that the Council had previously authorized this Agreement on the basis of \$2379.00 per man, so that the new rate is Slightly lower.

Moved by Alderman Suttis, seconded by Alderman McMillan that the Mayor and City Clerk be authorized to sign and seal with the Corporate Seal an Agreement with the R.C.M.P. for the Policing of this City for the period from June 1, 1955, to May 31, 1956, at the rate of \$2360.00 per man, on the understanding that the provisions with respect to the payment to the Municipality of fines and costs will still be in effect. Carried.

From B.C. Electric Railway Company, advising that certain of the Capilano detour trips via St. Edmunds Church and School are not being used as passengers are using the Inter-City bus service, and they & therefore ask for permission to discontinue certain trips.

Moved by Alderman Bryan, seconded by Alderman Copping that the B.C. Electric Railway Company be advised that the Council agrees to the changes in the Capilano bus detour trips as set out in their letter of November 21, 1955. Carried. 408

From the Deputy Minister of Finance, advising that action cannot be taken with respect to the City's request for financial aid for flood damages until a detailed supplemental statement describing the actual loss has been forwarded to the Government. Moved by Alderman Copping, seconded by Alderman Bryan that Mr. J.V. Fisher, Deputy Minister of Finance, be thanked for his letter and advised that the contents have been meted and ofter ONIEU

Moved by Alderman Copping, seconded by Alderman Bryan that Mr. J.V. From Mrs. Surine, Secretary of the Westview P.T.A., asking if some temporary crossing could be built in the vicinity of 15th Street or 16th Street between Fell Avenue and Bewicke Avenue over Mosquito Creek, as 180 school children are now being forced to travel along Marine Drive, constituting a hazard. Alderman Copping said that the Board of Works Committee had

Alderman Copping said that the Board of Works Committee had met a delegation recently and discussed this matter, and that his department was hoping to do something at 16th Street to alleviate the situation.

Moved by Alderman Copping, seconded by Alderman Bryan that Mrs. Surine, Secretary of the Westview P.T.A., be advised that a delegation met the Board of Works Committee, on Monday, November 28, 1955, regarding this bridge, and the matter is being studied at the present time.

Mayor Cates said that the delegation had been very co-operative and understood what we were up against. The motion was then put and carried.

From Mr. James A. Hay, 1104 Marine Drive, asking for permission to remodel and remove a building at that address to a lot at 20th and Neilson Avenue.

Mr. Hay enclosed a petition signed by a number of owners in the vicinity, advising that they have no objection to his plans in this regard.

Moved by Alderman McMillan, seconded by Alderman Bryan that the above request be forwarded to the Architectural Control Committee with power to act.

Discussion followed.

The motion was then put and carried.

LEGAL & BUILDING

Alderman McMillan said that his first recommendation referred to an application from Mr. John McLoughlin and others to increase the allowable height of buildings on Lonsdale Avenue between 6th and 8th Streets from the present three stories to five stories. In this regard he submitted the following recommendation of his Committee:

RECOMMEND that this Council approve of an amendment to the Zoning By-law to permit a maximum height of five stories for buildings

5 erected on lots fronting or facing on Lonsdale Avenue between Sixth Street and Eighth Street, and that a Public Hearing be held under the "Town Planning Act" on December 19th, 1955, at 7 p.m. to consider any objections to such an amendment; AND FURTHER that the application of Mr. John McLoughlin and others in this regard be referred to the Town Planning Commission for a report to the Council, if possible before December 19th, 1955.

Moved by Alderman McMillan, seconded by Alderman Johnson that the above recommendation of the Legal, Building & Zoning Committee be adopted.

Alderman McMillan said the main objection to this proposal in the past had been that it would block off the view. He said, however, that a survey shows that there is a 50 ft. differential between 6th and 8th Streets, and allowing 9 ft. between floors this would mean that a five storey building would only take up 45 ft. of the differential.

Alderman Copping said that there should be a proviso for such a type of building for off-street parking. Alderman McMillan said that this was very well taken care of in

the plan proposed, as in Mr. McLoughlin's case he is providing space for 16 cars while the by-law only calls for space for 13 cars. The motion was then put and declared carried.

Alderman McMillan submitted the following other recommendations on behalf of his Committee:

RECOMMEND that the Building Inspector be authorized to have the con-

demned City dwelling located on E¹/₂ Lot 6 and Lot 7, Block 73, D.L. 1 548 demolished, and the property advertised for sale by public tender. Moved by Alderman McMillan, seconded by Alderman Johnson that the above recommendation of the Legal & Building Committee be adopted. Carried.

RECOMMEND that the City Clerk advise the owners of property on which are situated illegal signs that such signs must be removed on or before December 19th, 1955, otherwise the Council regrets that it

² will have to institute prosecutions under the Billboard Regulation By-law.

Moved by Alderman McMillan, seconded by Alderman Johnson that the above recommendation of the Legal & Building Committee be adopted. Carried.

RECOMMEND that the first-class fire limits of the Corporation be extended to cover all lots facing, fronting or flanking on Lonsdale 3 Avenue between the north boundary of 8th Street and the south boundary of 23rd Street.

Moved by Alderman McMillan, seconded by Alderman Johnson that the above recommendation of the Legal, Industrial and Building Committee be adopted. Carried.

RECOMMEND that Mr. J.A. Hemm be advised that the old garage at the rear of his property at 123 Lonsdale Avenue had been included on the list of fire hazards compiled by the Fire Warden and Assistant Building Inspector because it was considered that it was a fire hazard until the debris had been removed from the lot, and that as such y removal was carried out on November 21, 1955, the requirements of the Fire Warden have now been met.

Moved by Alderman McMillan, seconded by Alderman Johnson that the above recommendation of the Legal, Building and Industrial Committee be adopted.

Alderman McMillan said that the Council would recall that we had a letter from Mr. Hemm saying that the building above referred to was not there, but actually the debris of the building was still there and it had to be cleared up. The motion was then put and declared carried.

FIRE & LIGHT

Alderman Johnson submitted the following recommendation on behalf of her Committee:

RECOMMEND that the B.C. Electric Co. be asked to withhold further , action on the City's request for street lights in the Unit Blocks on Esplanade, First and Second Streets under date of December 11th, 1953, and September 9th, 1955, and that the Electrical Inspector be asked to survey this area and submit a Report for consideration by the 1956 Council.

Moved by Alderman Johnson, seconded by Alderman McMillan that the above recommendation of the Fire and Light Committee be adopted.

Alderman Johnson said that the engineers of the B.C. Electric Company seemed over-burdened and in this case we had hoped to have two 20,000 lumen lights in the down-town area, but the Company

thought this would make the other areas dark by comparison. She said her Committee had again gone over the situation but it was not satisfactory and it was therefore decided to leave the whole matter until next year. ONIEU

The motion was then put and declared carried.

BOARD OF WORKS

Alderman Copping said that his first recommendation dealt with a complaint from Miss Sally Morrison as to drainage difficulties in her area, and his Committee wished to recommend as follows: RECOMMEND that the complaint of Miss S.K. Morrison, asking for better drainage in the lane between 19th and 20th Streets and Moody Avenue and the Boulevard, be referred to the Superintendent of Works with power to act.

Moved by Alderman Copping, seconded by Alderman Bryan that the above recommendation of the Board of Works Committee be adopted.

Alderman Johnson said that she lived in this vicinity and had gone round the area quite a bit. She said she thought a ditch from Moody Avenue to Sutherland School would prevent water in the basements in the vicinity and also help Miss Morrison. The motion was then put and carried.

Alderman Copping said that we had received a complaint as to ditched crossings from Mr. A.K. Marriott, and the Committee's recommendation was as follows: RECOMMEND that the application of A.K. Marriott for help with

RECOMMEND that the application of A.K. Marriott for help with regard to a proper entrance to his driveways be referred to the Superintendent of Works with power to act.

Moved by Alderman Copping, seconded by Alderman Bryan that the above recommendation of the Board of Works Committee be adopted. Carried.

Alderman Copping said the next matter dealt with a complaint from Mrs. M.J. Black, 2053 Westview Drive, that the recent flood had destroyed part of the bank at the rear of her property and had got into another channel. He said this complaint had been investigated very thoroughly and the Committee now recommended as follows:

RECOMMEND that Mrs. Black be advised that Mosquito Creek changed its course at this point during the recent flood through no fault of the City, and the Council regrets that it can take no responsibility for returning the creek to its former channel.

Moved by Alderman Copping, seconded by Alderman Bryan that the above recommendation of the Board of Works Committee be adopted. Carried.

Alderman Copping said the Council had received a request from the B.C. Electric Company for permission to erect a high tension pole line up Keith Road from the District's Seymour area, and this would run to the foot of the Grand Boulevard. He said that presently the Company has high tension poles on 4th Street and these interfere with no homes. The Committee therefore wished to recommend as follows:

RECOMMEND that the B.C. Electric Railway Company be written to asking if the high tension poles on 4th Street cannot be used for their 60 kv transmission lines instead of the poles on Keith Road.

Moved by Alderman Copping, seconded by Alderman Bryan that the above recommendation of the Board of Works Committee be adopted. Carried.

Alderman Copping said that an application for a water licence had been received from the Canadian Melrose Distillers and the Water Rights Branch had asked if we had any objection to this licence.

Rights Branch had asked if we had any objection to this licence.
His Committee had investigated this and wished to recommend as follows:
RECOMMEND that the Comptroller of Water Rights be advised that the City has no objection to the application of the Canadian

Melrose Distillers Ltd. for a Water Licence, as set out in their application.

Moved by Alderman Copping, seconded by Alderman Bryan that the above recommendation of the Board of Works Committee be adopted. Carried.

Alderman Copping said that his Committee had a recommendation arising out of the over-all sewerage survey plans as follows: RECOMMEND that the Superintendent of Works be advised that it is the Council's intention to re-establish 3rd Street in itsoriginal location prior to the subdivision of Wartime Housing Ltd. between

Fell Avenue and Mackay Avenue,

AND THAT he be authorized to go ahead with his plans for an interceptor sewer along the old line of 3rd Street, AND FURTHER THAT it is the Council's intention to re-plot the

existing subdivision of the area.

Moved by Alderman Copping, seconded by Alderman Bryan that the above recommendation of the Board of Works Committee be adopted. Alderman Copping said that this will mean that our main interceptor sewer will go along 3rd Street instead of having some jogs in it, and will bring it to a point in the District where a com-bined disposal and treatment plant is planned for the future. The motion was then put and declared carried.

> Alderman Bryan said his Committee had a recommendation to make in regard to a recent request from the North Vancouver Traffic and Safety Council for space in Mahon Park for their Playground Traffic School, and this recommendation was as follows:

RECOMMEND that the North Vancouver Traffic and Safety Council be advised that they have not answered the City's previous suggestions regarding locations for their Playground Traffic School, and if these cannot be obtained there is a portion of school playground on the Chesterfield Avenue side of Lonsdale School which might be suitable,

AND FURTHER, in the meantime, the Council regrets it has no funds left this year and it cannot commit the 1956 Council to any expenditures.

Moved by Alderman Bryan, seconded by Alderman Copping that the above recommendation of the Parks & Transportation Committee be adopted. Carried.

LABOUR RELATIONS

The Clerk advised that settlement had been reached between Management Research (Western) Ltd. and the Seafarers' International Union the terms of which had been communicated to him by 'phone, but the actual letter had not been received. He said he understood that Alderman Suttis, Chairman of the Committee, was aware of the settle-ment which had been made.

Alderman Suttis advised that he had a recommendation to make in this regard, as follows:

RECOMMEND that the Mayor and City Clerk be authorized to sign and seal with the Corporate Seal an Agreement with the Seafarers'

"International Union on the same terms and conditions as in 1954, subject to the following:

- That a three per cent increase be granted, retroactive to January 1st, 1955. (1)

Carried.

Alderman Bryan said that Mr. Milman had prepared some information for him regarding the possibility of eliminating the evening Ferry service.

He said something must be done to take care of the increasing Ferry deficit.

He advised that by cutting the service to the period 6.40 a.m. to 6.40 p.m. the crews could be reduced from six to four, and the deficit could be cut by approximately \$26.000.00.

the deficit could be cut by approximately \$26,000.00. He said this reduction would inconvenience a few, but he thought that they will have to put up with this in the interests of economy, and that only a few will be caught after the last bus leaves Vancouver at 12.30 a.m.

He said the evening service is a luxury that we can afford no longer.
