2 From the North Vancouver General Hospital applying to charter the City Ferries for an evening dance cruise in August.

Moved by Alderman Angus, seconded by Alderman Suttis that the North Vancouver General Hospital be advised that the cost of chartering Ferries No. 4 or No. 5 for a four-hour cruise around the Harbour would be \$100.00 for each Ferry.

THAT the decorating of ferries prior to the cruise would be by arrangement with the Ferry Superintendent

AND THAT prior arrangements for the use of coffee bar facilities would be made through Messrs. Stepney and Jeal. Carried.

From the Burrard Inlet Tunnel & Bridge Co., enclosing a copy of a letter from the Company's Solicitors to the Directors of the Bridge Company, concerning a Covenant contained in the Agreement between the Company and the Canadian National Railway Co., under which the Bridge Company must not do anything to encumber the bridge property which will be conveyed to the Railway Company at the end of 21 years from November 1st, 1952.

In reply to a question, Mayor Cates said that the Bridge Company have never had any communication from the Provincial Toll Authority which is constructing the new bridge over the Second Narrows.

Moved by Alderman Copping, seconded by Alderman Gostick that the above letter from the Bridge Inlet Tunnel and Bridge Co., be acknowledged with thanks and received and filed, and that the Company be requested to do everything in its power to safeguard the City's interests in this matter. Carried.

From the Union of B.C. Municipalities enclosing a copy of the reasons for the judgment of Mr. Justice Coady in the recent case involving the District of Surrey and the B.C. Electric Co. Ltd., under which it became clear that P.U.C. has the overriding authority with respect to utility franchises and that little control remains with a Municipality.

Moved by Alderman Gostick, seconded by Alderman Copping that this matter be referred to the Legal Committee for consideration, and in the meantime the City Solicitor be requested to submit a report on this matter to the Committee. Carried.

From the City of Prince George asking for endorsement of their Resolution which requested the Federal Government to increase Federal aid towards the construction of new

Hospitals.

Moved by Alderman McMillan, seconded by Alderman Copping that the letter and Resolution from the City of Prince George requesting increased grants in aid of new hospital construction from the Federal Government be referred to Mayor Cates for consideration after hearing the discussion of Delegates at the Canadian Federation of Mayors and Municipalities Convention. Carried.

The Clerk submitted a report from the City Poundkeeper in accordance with the instructions of the Council, and dealing with certain allegations made by the S.P.C.A. concerning the operation of the City Pound.

Mr. Parker pointed out in his letter among other things, that the City Pound facilities had been constructed by Mr. Ricardo of the S.P.C.A. about six years ago, and that the method of destroying by carbon monoxide gas is one that is recommended by the American Humane Association. Mr Parker said that although it was probably true that the District Pound received a good many City calls the reverse was also true that he handled many District calls.

Moved by Alderman McMillan, seconded by Alderman Copping

Moved by Alderman McMillan, seconded by Alderman Copping that the report from Mr. C. Parker, City Poundkeeper be received with thanks, and that the S.P.C.A. be advised that this Council feels that our pound facilities and the method of destroying dogs is satisfactory and that while the S.P.C.A. receive a number of calls involving City pound work, a number of similar calls are received by the City Poundkeeper with reference to complaints from the District of North Vancouver.

Discussion followed.

The Motion was then put and carried.

Moved by Alderman McMillan, seconded by Alderman Copping that The Polio Committee of the North Vancouver Kinsmen Club be advised that while the particular case referred to by the Committee is not a City of North Vancouver resident, we are constantly being requested to permit the use of wartime housing within the municipality but this is against Council policy and therefore, under the circumstances, even if this case was a City responsibility, the Council would have to refuse the request of the committee for the use of wartime housing facilities.

From Russell & DuMoulin, Solicitors, enclosing a draft sub-lease of the water channel west of Fell Avenue in favour of their client, The Fullerton Lumber Company. Moved by Alderman McMillan, seconded by Alderman Gostick

that Messrs. Russell & DuMoulin be advised that because of the proposed industrial development of the area between Bewicke and MacKay Avenues, it is necessary for the City to maintain adequate public access for water borne cargoes and therefore, the Council can only consider leasing the water lot west of Fell Avenue to their client Fullerton Lumber Company on a year to year basis, at the usual Harbours Board rental of l¢ per square foot. Carried.

From the North Vancouver Community Players requesting the renewal of the Scout Hall lease on the same terms as last year.

Moved by Alderman McMillan, seconded by Alderman Copping that the North Vancouver Community Players be advised that the City will lease the Scout Hall to their Group for a period of 12 months commencing August 1st, 1956, on the following conditions:

- The heating and caretaking services to be furnished by the 2. City as in the past.
- The Community Players to have the use of the building on Mondays, Tuesdays and Fridays and on Thursdays for rehearsals only.
- The Community Players to co-operate with other groups desiring the use of the Scout Hall from time to time.
- The lease to be subject to immediate cancellation if any fire hazard is created in the building by the Community Players.
- The Community Players to agree to relieve the City of any claim from loss or damage of their property while stored on the premises.
- 7. The Corporation reserves the right to cancel the lease at any time if the property is required for Corporate purposes.

Carried with Alderman Gostick refraining from voting.

From School District No. 44 advising that the Board has decided that the proposed exchange of lane allowances in Block 11, D.L. 273 is not required.

Moved by Alderman McMillan, seconded by Alderman Gostick that the necessary by-law be prepared to repeal by-law No. 2286 which authorized the exchange of certain lane allowances with School District No. 44, in Block 11, D.L. 273. Carried.

From C.M. Sharpe Realty advising that their client, Mr. J. Anthony, would like to speak to the Council with respect to the refusal of the Architectural Control Committee to permit the erection of an apartment building on his lot on 15th Street east between St. George's and St. Andrew's Avenues.

Moved by Alderman McMillan, seconded by Alderman Copping that this matter be referred to the Architectural Control Committee with power to act after discussion with other members of the Council. Carried.

AND WHEREAS the Municipalities are still being required to contribute the sum of  $70\phi$  per day for each of their residents who become patients in such hospitals.

THEREFORE be it resolved that the Provincial Government be requested to remove the  $70\phi$  per diem hospital payments by Municipalities unless such fees are paid directly to the Hospital Boards operating hospital facilities.

2. WHEREAS the electors of the municipalities of the Province have elected Councils to carry on the business of operating their municipalities

AND WHEREAS such Councils should be permitted to administer their municipalities without outside control,

AND WHEREAS some municipalities operate municipal cemeteries in most cases, at a financial loss,

THEREFORE be it resolved that this Council protest the recent regulations imposed by the Provincial Government through the Public Utilities Commission for the control of municipal cemeteries by the Commission without prior discussion with the Union of B.C. Municipalities.

Alderman Angus said that he agreed but he did not want apartment permits to run wild.

Alderman Gostick suggested that the proposed amendment with respect to off-street parking should be wound up to-night and that a new survey of the Zoning By-law by Harland Bartholomew & Associates authorized.

Discussion followed.
