A circular letter was received from the North Shore Council of Women extending an invitation to Council Members to attend a Conference on Citizenship to be held in North Lonsdale United Church on Monday, October 30th, 1961.

Moved by Alderman Chadwick, seconded by Alderman Humphreys that the above circular letter be received and filed and the group advised that as many of the Council Members as possible will attend. Carried.

A letter was received from the Royal Canadian Legion, North Vancouver Branch 118, requesting the usual Welfare grant for 1962.

Moved by Alderman Goldsworthy, seconded by Alderman Humphreys that the above application be referred to the 1962 Provisional Budget for consideration. Carried.

From School District No. 44 advising that the District Planning Department will likely be undertaking a new survey of School Board requirements and the Board would appreciate the co-operation of the City's Officers in this survey.

A further letter was received from School District No. 44 advising that a study will be made by District Planning Officers to determine the location and costs of school sites required for kindergarten classes.

Moved by Alderman Chadwick, seconded by Alderman Golds-worthy that School District No. 44 be advised that the City will be pleased to co-operate in any future study of the Board with respect to School Board site requirements in this Municipality. Carried.

A letter was received from Mr. R.H. Forster on behalf of the Delbrook Baptist Church advising they are interested in ascertaining whether a proposed new Church could be erected in the area bounded by Westview Drive, Queens Road and the Trans Canada Highway.

Moved by Alderman Goldsworthy, seconded by Alderman McDevitt that the above inquiry be referred to the Land Agent to advise Mr. Forster of any City property which might be available in the area in question. Carried.

s A letter was received from Mr. W.B. Jones, 830 West 16th Street advising that he still has had no relief from the nuisance of dogs running at large in his area.

General discussion followed with respect to the enforcement of the City's Dog Tax & Pound By-law by the S.P.C.A., the general feeling being that the present situation is not satisfactory and will have to be improved.

Moved by Alderman Burns, seconded by Alderman McDevitt that this matter be referred to the Civic Affairs Committee Chairman so that he can obtain from the S.P.C.A. their side of the problem to see if it is possible to get a better working agreement and that the Chairman bring back a written report to the Council from the S.P.C.A. as soon as possible.

4. From Catherine M. Langton asking for a review by Council of its 1960 decision not to rezone her property at 439 East Third Street from 2-family to apartment use.

Moved by Alderman Goldsworthy, seconded by Alderman Humphreys that the above application be referred to the Advisory Planning Commission for a recommendation and that this Council hold a Public Hearing at 7:00 p.m. on October 23rd, 1961 to consider the rezoning of Lots 8 & 9, Block 144, D.L. 274 (439 East Third Street) from 2-family to apartment district. Carried.

From the North Vancouver City Communist Party of Canada requesting permission to present a brief with respect to fall-out shelters.

Moved by Alderman Humphreys, seconded by Alderman McDevitt that the above organization be advised to forward sufficient copies of their brief for study by all members of Council. Carried.

Mayor Angus reported at this point that a Civil Defence Meeting would be held a week from next Wednesday, viz. October 11th, 1961.

A letter was received from West Coast Daily Advertising Company Limited asking if the City is interested in renting advertising space on the street litter bins.

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that the above Company be advised that the Council does not wish to consider their proposal that the City take advertising space on the Company's street litter bins. Carried.

A letter was received from the St. Alice Hotel Limited withdrawing its application to lease Lots 1 & 2, Block 140, D.L. 274 for parking purposes.

- Moved by Alderman Goldsworthy, seconded by Alderman, Humphreys that the letter from the St. Alice Hotel advising that they do not wish to pursue their application to lease Lots 1&2, Block 140, D.L. 274 (south side 100 Block East 3rd Street) be received and filed. Carried.
- 2 A letter was received from Mr. J.P. Harbottle, 242 West 25th Street recommending that parking be restricted to one side only on West 27th Street because of the narrowness of the travel portion.

Alderman McDevitt reported that the question of the width of 27th Street had received a lot of consideration and pointed out that to widen it on the south side would double the costs. He said the matter had been checked with the Police and the latter had advised that 27th Street is not a highly used traffic artery and therefore the Board of Works Committee felt that a 30 ft. width would be sufficient.

Carried.

A circular letter was received from the Union of B.C. Municipalities giving information with respect to their new service on municipal salaries and benefits in British Columbia.

Moved by Alderman McDevitt, seconded by Alderman Humphreys that the above circular letter be received and filed. Carried.

A letter was received from the North Vancouver Kinsmen Club asking for permission to hold their Annual Apple Day drive on October 18th and 19th, 1961.

Moved by Alderman Humphreys, seconded by Alderman Goldsworthy that the North Vancouver Kinsmen Club be granted permission to hold their Annual Apple Day drive on City streets on October 18th and 19th, 1961. Carried.

Jordan to rezone Lot 9, Block 8, D.L. 616 from single family dwelling to local business use and that in the meantime the applicant be requested to submit adequate plans of the proposed commercial premises to be erected on the said Lot.

HEALTH & CIVIC AFFAIRS COMMITTEE

Alderman Humphreys advised that the Sanitary Inspectors of the Province had recently prepared a standard draft By-law for food establishments and had sent it to the Health Unit with a request that each Council enact the necessary By-law. He advised that his Committee has considered this matter and submitted the following recommendation:

RECOMMEND that the North Shore Union Board of Health be advised that inasmuch as this Council agrees that the regulation of health matters is presently enforced on a metropolitan basis and in view of the fact that the Council approves in principle the enforcement of uniform health regulations throughout the Province; THEREFORE BE IT RESOLVED that the North Shore Union Board of Health be requested to approach the problem of health regulations for food establishments through the Provincial Department of Health with the object of having new Provincial regulations drawn up rather than each Municipality preparing separate By-laws for each Community.

Moved by Alderman Humphreys, seconded by Alderman Goldsworthy that the above recommendation of the Health & Civic Affairs Committee be adopted. Carried.

BOARD OF WORKS & WATERWORKS COMMITTEE
Alderman McDevitt submitted the following recommendations
on behalf of his Committee giving the background in each
case.

RECOMMEND that the City Superintendent be authorized to expend the sum of \$10,216.60 being a portion of the remainder set aside in the 1961 budget for Winter Works projects for the cost to the City of clearing, re-grading and draining of roads and lane allowances where brush has encroached on the boulevards in the case of roads and the brushing out and re-grading to the full width in the case of lanes. Total cost (City share) - \$10,216.60.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that the above recommendation of the Board of Works & Waterworks Committee be adopted.

Discussion followed.

Alderman Chadwick advised that the above expenditure would employ 10 men for 55 days.

The motion was then put and carried.

RECOMMEND that the necessary by-law be prepared to expend a sum not to exceed \$39,845.64 out of the Tax Sale Lands Reserve Account for the following expenditures of a capital nature:

(a) Sewer survey to attempt to discover points of infiltration in the sanitary sewer system to employ two men for three months.

Total cost including materials \$2,500.00

(b) The re-grading, removal of excess shrubs, and levelling and seeding of the remainder of the Grand Boulevard between Keith Road and 19th Street at \$3931.12 per block (9½ blocks to be done)

Total cost \$37.345.64

TOTAL \$39,845.64

Moved by Alderman McDevitt, seconded by Alderman Chadwick that the above recommendation of the Board of Works & Waterworks Committee be adopted.

Alderman Chadwick advised that the above expenditure would employ 7 men per block for three weeks.

PARKS & BUILDING COMMITTEE

one 300 watt lamp at St. Georges Avenue and Trans Canada Highway (North);

both the above lamps to light the sidewalks on the Trans Canada Highway;

one 300 watt lamp at Chesterfield Avenue and Trans Canada Highway (South) to light the access road;

one 20,000 lumen mercury vapour lamp at East Keith Road and the West Grand Boulevard;

one 20,000 lumen mercury vapour lamp at East Keith Road and the East Grand Boulevard;

one 20,000 lumen mercury vapour lamp on East Keith Road at Sutherland Avenue;

PROVIDED the City will not be required to pay any portion of the installation costs of same AND PROVIDED THAT the District of North Vancouver will bear 50% of the energy costs of the 20,000 lumen installation at Keith and Sutherland.

Moved by Alderman Burns, seconded by Alderman McDevitt that the above recommendation of the Transportation & Light Committee be adopted. Carried.

- Alderman Burns reported that the overhauling and changeover of all street lights is progressing well and about 25% of the City has been completed.
- Alderman Burns reported that the Light Committee has met with representatives of the Lonsdale Chapter of the Business Association to arrange for suitable Christmas Street Lighting.

TRAFFIC & SAFETY ADVISORY COMMITTEE

AND WHEREAS the Council of this municipality is not in agreement with all the recommendations of the said Joint Committee:

THEREFORE BE IT RESOLVED that a Brief in the form approved by the Council in Committee on October 10th, 1961 be now approved by the Council as an expression of its opinion with respect to the said Report.

Alderman Humphreys outlined for the benefit of the Press and the members of the public present the various functions involved in the Metropolitan Joint Committee study and the Council's point of view with respect to each.

The motion was then put and carried.

Alderman Goldsworthy reported that the subject of secondary dwelling units in single family dwelling areas had been discussed again by the Council Members in Committee and the latter had endorsed again the resolution passed by the Council on May 11th, 1959 concerning this matter. He said he had a recommendation along these lines but pointed out that the date for a proposed Public Hearing to consider the matter had not yet been agreed upon.

/ Alderman Goldsworthy then submitted the following recommendation:

RECOMMEND THAT the Council re-endorse a resolution passed by it on May 11th, 1959 concerning secondary dwelling units in single family dwelling areas as follows:

WHEREAS this Council agrees with the definition of "single family" as described in most dictionaries as being "a household or group of related persons";

AND FURTHER THAT this Council goes on record as approving and encouraging families to provide suitable accommodation as hereinafter defined for parents and/or blood relations of the owner or occupant of the main dwelling unit;

AND FURTHER THAT this Council recognizes the fact that such accommodation would have limited use if confined only to parents or other blood relations;

AND WHEREAS Section 17:A and 17:A:2 of the present Zoning By-law No. 2668 provide that the Council may by resolution authorize a single family dwelling in a single family district to be used as a two-family dwelling, provided it has not less than 1,200 square feet of floor area on one floor or not less than 1,750 square feet of floor area on two floors and has the necessary site area and off-street parking facilities;

AND WHEREAS Order-in-Council No. 200 passed by the Federal Government during the last War over-rode Municipal zoning by-laws and permitted multi-family use of single family dwellings and remained in effect until March 31, 1955;

THEREFORE it is recommended that the "Zoning By-law, 1958" No. 2668 be amended to provide, subject to the approval of Council, for a secondary dwelling unit in a single family dwelling in the present single family district for not more than two persons;

PROVIDED HOWEVER the following conditions are fully complied with:

- (1) That premises conform to all Municipal by-laws including those with respect to building, electrical, gas, water regulation, plumbing, health and fire;
- (2) That such dwellings are in harmony with the surrounding area and are well and properly maintained;
- (3) That no more than one main entrance shall be permitted nor more than one postal address to each site area;
- (4) That a secondary dwelling unit in a single family dwelling shall contain one or more habitable rooms, with not more than one bedroom, consistituting a self-contained dwelling unit with a floor area of not less than 400 square feet, used or intended to be used together by mot more than two people for living and sleeping purposes, and containing properly ventilated kitchen facilities with a sink, and a separate bathroom with basin, water closet, and a bath or shower;

AND THAT a Public Hearing of the Council be held at 7 p.m. on 1961 to consider the above amendment.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of a Committee Meeting of Council Members held on October 10th, 1961 be adopted.

Discussion followed.

/ Moved by Alderman Burns, seconded by Alderman Humphreys that the above recommendation be tabled by this Council for further consideration. Carried.

Electric Company and the District of North Vancouver advising that the City's recent request for the installation of street lights had been approved and that insofar as the lamp at East Keith Road and Sutherland Avenue was concerned, the District would share in the cost of this installation of a 50/50 basis as it is a boundary light.

Moved by Alderman Burns, seconded by Alderman Humphreys that the above letters from the B.C. Electric Company and the District of North Vancouver be received and filed. Carried.

Alderman Goldsworthy said that he would, at this time, like to refer to a recent item in the Press alleging certain statements by Mayor Angus with respect to the control of dogs running at large, etc.

He said that the alleged statement of His Worship gives the impression that the City is going to establish its own Pound next year and that this statement is not true because all that has been done was that the Members of Council in Committee had asked for a report from the City Superintendent on the cost of operating our own Pound, and that after this report was received, the whole matter would be studied to see whether there would be any advantage in doing so.

Mayor Angus said that he had expressed his own personal view on this matter, that the former method of operating the Pound by the City was good and that the present operation under the SPCA is a mess. He said he also objected to the SPCA being financed by the Community Chest.

Discussion followed with the majority of the Members of Council indicating that they intended to wait until the City Superintendent's report is received before expressing an opinion one way or the other.

Alderman Goldsworthy said that he understood that Council Members wished to meet next Monday night to expedite the construction of a Police Administration Building and he therefore moved the following resolution:

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that a special meeting of the City Council be held on Monday, October 23rd, 1961 at 9:30 p.m. to take the necessary steps to implement the construction of a new Police Administration building and also to consider by-laws. Carried.

Moved by Alderman Chadwick, seconded by Alderman Humphreys that this Council now adjourn. Carried.

Whereupon the Council Meeting adjourned at 9:35 p.m.

The Chairman asked if Mrs. Jordan would be inconvenienced if the matter was laid over for two weeks and Mrs. Jordan said that such a delay would not seriously bother her. She said the neighbourhood misses the former Sutherland store and it was her intention to run the proposed store herself and provide an adequate control to keep out the hoodlum element.

The Mover and Seconder of the motion to grant approval withdrew.
