Moved by Alderman Burns, seconded by Alderman Goldsworthy that the resolution of Council dealing with the closing of certain lane allowances in Block 122, D.L. 271, adopted June 4th, 1962, be deleted from the Minutes of that meeting and the following, being the resolution which was actually read and signed by the mover and seconder, be substituted:-

"that the lane or lane allowance between 5th and 6th Streets and west of Mahon Avenue, at the rear of Lots 5, 6, 7, 8, 9 and 10, of Block 122, and that section of the T-lane west to 6th Street, up to within twenty feet of the west side of Lot 12 of Block 122, be stopped up and the necessary cancellation be applied for." Carried.

Alderman Goldsworthy said that there would have to be a further amendment in order to convey the intended meaning.

Moved by Alderman Goldsworthy, seconded by Alderman Burns that the resolution dealing with the closing of certain lane allowances in Block 122, D.L. 271 signed and read at the June 4th, 1962 Council Meeting and entered into the Minutes of same by the above resolution, be amended by changing the word "west" where it appears after the words "up to within 20 feet of the" and before the words "side of Lot 12 of Block 122" to the word "east".

The motion was then put and carried.

Moved by Alderman Burns, seconded by Alderman Goldsworthy that the Minutes of the Regular Meeting of Council held on June 4th, 1962 as amended, be taken as read and adopted, copies of same having been given to all members of Council Carried.

CORRESPONDENCE

A circular letter was considered from the Union of B.C. Municipalities with regard to the U.B.C.M. resolutions and 1962 Conference program, etc.

Discussion followed.

Mayor Angus ordered the above letter received and filed.

An application was considered from Seaboard Advertising Company Limited for permission to add a third panel to their installation at Marine Drive and Hamilton Ave.

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that permission be given to Seaboard Advertising Company Limited to construct a third panel in accordance with their application of June 13th, 1962. Carried.

An application was considered from B.R. Sibbald, 415
3 West 26th Street for an extension of time in which to complete construction of a sail boat on his property.

Moved by Alderman Irwin, seconded by Alderman Christopher that the permission given by Council on December 4th, 1961 to Mr. B.R. Sibbald, 415 West 26th Street to construct a 26 ft. sail boat in the rear yard of his property, be extended until July 15th, 1962.

Discussion followed.

The motion was then put and carried.

A request was considered from F.C. Tossell asking for an explanation of the background of the expropriation of the easterly 10 feet of property known as 2360 Western Avenue for lane purposes.

Moved by Alderman Irwin, seconded by Alderman Christopher that the City Clerk be authorized to advise Mr. F.C. Tossell of the details of the expropriation of the east 10 feet of property described as 2360 Western Avenue for lane purposes.

The Clerk was requested to explain the background of these negotiations for the benefit of the audience and the members of the Press present, and did so.

The motion was then put and carried.

A circular letter was considered from the City of London. 5 Ontario, asking for endorsation of a resolution for a time extension of the Federal Sewerage Financing program.

Moved by Alderman Irwin, seconded by Alderman Christopher that the circular letter from the City of London, Ontario, dated May 29th, 1962, dealing with the extension of certain Federal legislation on the financing of certain sewer construction be tabled until the first Council meeting in September.

Discussion followed.

The motion was then put and carried.

## **PETITIONS**

A letter was received from Mr. B. Bratsberg enclosing a petition from residents in the 100 Block West 22nd Street with regard to the construction of sidewalks and road surfacing in their block.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that Mr. B. Bratsberg be advised on behalf of owners in the 100 Block West 22nd Street that the City will attempt

- to keep their street in as good condition as possible pending construction of their local improvement sidewalk for which a petition has been received; THAT they be further advised that the Motor Vehicle Act forbids parking on the perimeter of school grounds; that a strong recommendation will be made to the 1963 Council for passage of this local improvement work AND THAT if passage is effected they are assured that priority will be given to its construction during 1963. Carried.
- A letter was considered from Nels Waddell Shell Service Station, 13th and Lonsdale with an attached petition signed by various persons in favour of his service station remaining open after regular operating hours.

Discussion followed on the justification for Council acting as regulators of the service station business and as to whether an operator who had expressed himself as willing to stay open 24 hours each day, should not be allowed to do so.

It was pointed out that the City had been taking action only after being requested to do so by the Automobile Retailers Association, of which Mr. Waddell is a member, the Association having expressed itself as against having extended operating hours.

Moved by Alderman Chadwick, seconded by Alderman Burns that Nels Waddell Shell Service Station be advised that Council has acted on the advice of the Automobile Retailers Association, of which he is a member, but if he wishes to review this matter in the Fall, the Council members will be pleased to hear him.

Carried on division, with Alderman Goldsworthy asking to be recorded as voting against the motion.

TENDERS

Aldeman Chadwick reported that Staff Sergeant Wales and Magistrate Pool have approved a list of furniture for the new Public Safety building at 13th and St. Georges. He said that the list has been drawn up according to Canadian Office and School Furniture specifications but that bids could be presented using any comparable specifications.

Considerable discussion followed as to whether tenders should be solicited in this manner, or whether the architects should be requested to handle them.

Alderman Chadwick advised he was withdrawing his motion and Alderman McDevitt agreed to withdraw as seconder.

Moved by Alderman McDevitt, seconded by Alderman Irwin that Chomick & LeBlond, Architects, be requested to look after the furnishing of the Police Administration building at a cost of 10% of the cost of such furnishings.

The motion was put and carried on division, with Alderman Chadwick asking to be recorded as voting in the negative.

Moved by Alderman Burns, seconded by Alderman McDevitt that the resolution passed on June 4th, 1962 dealing with the lane allowance between Fifth and Sixth Streets west of Mahon Avenue, be amended by adding the following words "and that the lane be continued through the east 20 feet of Lot 2, Block 122, D.L. 271 north to Sixth Street."

It was argued that Lots 1 and 2 in this block were unsuitable for the construction of a duplex but would serve very well for a small park area.

Discussion followed.

The motion was then put and carried on division.

ANY OTHER COMPETENT BUSINESS

A letter was considered from Scholes Driving School advising that the North Vancouver Traffic & Safety Council will not require the use of Mahon Park Pool on July 1st, 1962 for their Water Display.

Moved by Alderman Chadwick, seconded by Alderman Christopher that the above letter be received and filed. Carried.

It was drawn to the Council Members' attention that it had been necessary to request permission for the New Democratic Party to hold a rally in Victoria Park last Friday before a Council meeting could be convened.

The Clerk reported that he had been able to contact five of the seven Council Members and had received oral permission from them.

Moved by Alderman Goldsworthy, seconded by Alderman McDevitt that this Council ratify oral permission granted for the holding of a rally by the New Democratic Party in Victoria Park on June 15th, 1962. Carried.

Moved by Alderman McDevitt, seconded by Alderman Burns that this Council Meeting now adjourn. Carried.

Whereupon the Meeting adjourned at 10:10 p.m.
