FINANCE & LEGAL COMMITTEE

Alderman Goldsworthy submitted the following recommendation on behalf of the Police Committee:

RECOMMEND that the necessary By-law be prepared to expend the sum of \$3,000.00 from Machinery and Equipment Reserve for the purchase of a Servi Car for use by the new By-law Enforcement Officer.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of the Police Committee be adopted.

Carried.

BOARD OF WORKS & WATERWORKS COMMITTEE

Alderman Irwin submitted the following recommendations on behalf of his Committee, giving a background explanation in each case:

2 RECOMMEND that the City Superintendent be instructed to have the planters on Lonsdale Avenue between 14th and 16th Streets removed.

Moved by Alderman Irwin, seconded by Alderman Chadwick, that the above recommendation of the Board of Works & Waterworks Committee be adopted.

Alderman Humphreys expressed agreement with the above recommendation, but asked if Council would permit the Civic Affairs Committee to look at the subject of beautification of Lonsdale Avenue in an effort to give it a distinctive personality.

It was suggested instead that the Parks Committee could attend to the planting of these concrete tubs for this summer, and that they could be ordered removed in the fall.

Alderman Cates pointed out that the City would be put to a good deal of expense in order to keep these planters attractive, and said that if the merchants would co-operate even to the extent of keeping them watered, it would be less discouraging.

Alderman Humphreys then suggested that the City provide attractive planters in front of every mercantile premises.

No action taken on the above suggestions.

The motion was then put and carried.

- RECOMMEND that negotiation be entered into with the Squamish Indian Band for a lease or easement of lands for the construction of a Low Level Industrial road to include the following:
 - 1. Relocating the two houses that would be on the right-of-way at its westerly end.
 - Construct a concrete sidewalk along the north side of the highway.
 - 3. Building a retaining wall where the Indian Cemetery abuts the proposed right-of-way.
 - 4. The City will lease the right-of-way, comprising 2.22 acres of right-of-way and 0.32 acres made unusable south of the right-of-way for a total of 2.54 acres at a rate of \$900.00 per annum per acre, for a total annual figure of \$2,286.00.

Moved by Alderman Irwin, seconded by Alderman Chadwick that the above recommendation of the Board of Works & Waterworks Committee be adopted.

General agreement was expressed with the above resolution although it was pointed out that the members of the Finance Committee had never seen a plan of the project.

Mayor Angus advised that plans have been available for some considerable time, and could have been inspected by any member of Council upon request.

It was pointed out also that where probable costs are known they should be made available to all Council members, although probably kept on a confidential basis at this time.

After further discussion the motion was put and carried.

Aldeman Irwin advised that the third recommendation of his Committee on this evening's agenda concerning policy with respect to expropriation of property required for Corporate purposes was being withdrawn for further study.

PARKS & CIVIC BUILDINGS COMMITTEE

Alderman C. Cates submitted the following recommendation on behalf of her Committee:

RECOMMEND that the North Vancouver Memorial Community

Centre be granted exclusive use of the southern tennis
court, Lonsdale Hall Grounds on Mondays and Thursdays up
to and including July 9, 1964, during the hours of 7 p.m.
to 9 p.m.

Moved by Alderman C.M. Cates, seconded by Alderman Chadwick that the above recommendation of the Parks & Civic Buildings Committee be adopted.

Carried.

His Worship advised that he had received two letters today too late to be placed on the Agenda, or circularized. He said one was from the Vancouver "Sun" and one from the Soccer Association, both thanking Council for what they did with respect to putting on the "Parade of Champions", and asking also that the Staff members who had worked on this project be thanked.

His Worship asked if the City Clerk would kindly pass this information along.

TRAFFIC & SAFETY ADVISORY COMMITTEE

Alderman Chadwick advised that there were no resolutions to submit this evening.

Alderman Irwin said that it is apparent that the two-hour parking restrictions just instituted in part of the hospital parking lot is not the answer to the parking problem here as had been hoped, and asked that the matter be placed on the next agenda.

LABOUR RELATIONS COMMITTEE

- Alderman Goldsworthy reported on the latest negotiations between his Committee and representatives from the North Vancouver Civic Employees Association, stating that the Association has now proposed a settlement on the basis of four items, with a one-year agreement to run from January 1st to December 31st, 1964, as follows:
 - 1. Wages 7¢ per hour across the board.
 - 2. Annual Vacations four weeks holiday after 16 years of service.
 - 3. Ten Statutory Holidays to be paid for.
 - 4. Service recognition pay on a cash formula basis of \$5.00 per month after 5 years service, a further \$5.00 per month after 10 years service,

and a further \$5.00 per month after 15 years of service, with a \$15.00 monthly ceiling.

Alderman Goldsworthy then presented figures which showed that the Union's request, if granted, would give the North Vancouver Civic employees substantially more than the 1964 award just made to City of Vancouver employees.

Alderman Goldsworthy pointed out that his Committee had spent a good many hours negotiating this year, and had attended innumerable meetings with the employees' representatives, and although it appeared last week that settlement was near, the attitude of the employees seems to have been suddenly reversed.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the North Vancouver Civic Employees Association be advised that the offer made on behalf of the Association at a meeting with Council representatives held on May 19th, 1964, is unacceptable to Council, and that application will be made in due course for the services of a Conciliation Board.

MINUTES of a Special Meeting of Council held in the Council Chambers, City Hall, on Friday, May 22nd, 1964, at 9:00 A.M.

Present:

Mayor W.M. Angus, Alderman C.M. Cates, Alderman J.A.W. Chadwick, Alderman D. Humphreys, and Alderman W.R.B. Irwin.

His Worship called the meeting to order and advised that it was being called under Section 180 of the Municipal Act for the purpose of returning to Council for reconsideration a resolution adopted at the regular Council meeting on May 19th, 1964, with respect to the calling for tenders for blacktopping and reconstruction of portions of 15th Street, 13th Street, and Queensbury Avenue.

His Worship advised that after further reflection and discussion of this matter with the City Superintendent he felt that Council had made a mistake in asking for separate bids for the three jobs, inasmuch as each project was for machine paving. He said that the volume method of tendering was most economical. He said that if awards were made to three separate firms it would mean the movement of three sets of equipment to the job, and this would be more expensive to the City's taxpayers. He said that he had checked on these points very carefully, and that his opinion had been confirmed by several authoratitive sources.

Moved by Alderman Chadwick, seconded by Alderman C. Cates that the resolution of Council adopted on May 19th, 1964, authorizing the call of separate tenders for the machine paving and rebuilding of portions of 15th Street, 13th Street, and Queensbury Avenue be reconsidered. Carried.

Moved by Alderman Chadwick, seconded by Alderman Irwin that the resolution of Council adopted on May 19th, 1964, authorizing the call of separate tenders for the machine paving and rebuilding of portions of 15th Street, 13th Street, and Queensbury Avenue be rejected.

Carried.

Moved by Alderman Irwin, seconded by Alderman Chadwick that tenders be called by Council for the rebuilding and machine paving of 15th Street from Lonsdale Avenue to West Boulevard; 13th Street from St. Andrews Avenue to East Boulevard; and Queensbury Avenue from 3rd Street to Keith Road; And that such tenders close at 4:00 P.M. on Wednesday, June 10th, 1964.

Discussion followed.

Alderman Humphreys said that it was quite likely that a firm could submit a lower bid on all three projects, but it was just possible that smaller contractors, with their lower overhead, could bid lower on one of the jobs if they were treated separately. He said he was concerned lest the little man was squeezed out, and that as a matter of principle he would like to see an amendment that tenders be allowed both on a separate basis and as one project.

Alderman Chadwick said that he had also given some thought to the matter, and was afraid that if bids were on a separate basis, bidders would put their prices higher in the eventuality that they were awarded only one of the jobs instead of all three. Mayor Angus advised that in some cases large jobs in Burnaby and Vancouver had been secured by a group of smaller firms banding together and submitting one tender.

After further discussion the motion was then put and carried, with Alderman Humphreys asking that it be recorded that he had voted in the negative.

Moved by Alderman Chadwick, seconded by Alderman C. Cates that this meeting now adjourn. Carried.

Whereupon the meeting adjourned at 9:25 A.M.
