MINUTES of the Regular Meeting of the City Council held in the Council Chambers, City Hall, on Monday, April 5th, 1965, at 8:00 P.M.

Her Worship, Mayor Cates, entered the Council Chambers and called the meeting to order.

MINUTES

Moved by Alderman Chadwick, seconded by Alderman Dewhurst that the Minutes of the Regular Meeting of Council held on March 15th, 1965, of the Court of Revision held on March 22nd, 1965, and of the Special Meeting of Council held on March 30th, 1965, be taken as read and adopted, copies of these Minutes having been previously circularized among all Council members.

Carried.

CORRESPONDENCE

From Westview Shopping Centre Ltd., applying for a ninety-day extension from March 21st, 1965, in which to display a directional sign facing the Upper Levels Highway.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that the Westview Shopping Centre Ltd. be granted a time extension as requested by them in their letter of March 18th, 1965.

Carried

From Mrs. Gertrude Todd, 1804 Lonsdale Avenue, requesting a grant of \$200.00 towards the "Miss North Vancouver" Beauty Contest for 1965.

Moved by Alderman McDevitt, seconded by Alderman Suttis that the sum of \$200.00 be provided towards the 1965 "Miss North Vancouver" Beauty Contest.

Discussion followed.

The motion was then put and carried.

From Mr. James D. Cameron, proprietor of the "Pop Shop", 3 224 Lonsdale Avenue, asking permission to remain open until 8:00 P.M.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that "Shops Regulation By-law, 1959, No. 2" be amended to exempt music stores from the provisions of Section 859 of the "Municipal Act", as permitted by Section 861 of the said Act. Carried.

From School District No. 44 (North Vancouver), recommending the installation of a sidewalk along the south side of 19th Street, between Moody Avenue and the Grand Boulevard, and also asking if the City-owned property on the north-west corner of 21st Street and Lonsdale Avenue could be tidied up.

Moved by Alderman Irwin, seconded by Alderman Dewhurst that the above letter be referred to the Board of Works Committee for consideration and report.

Discussion took place.

The motion was then put and carried.

From the Lower Mainland Regional Planning Board advising that the 1965 levy on the City of North Vancouver for Board operation is \$1,419.00.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that this letter be referred to the City Solicitor for a report. Carried.

Further letter from the Lower Mainland Regional Planning Board advising that a Committee of Board members has been appointed to discuss with Council any differences which Council may have with the Board.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that this letter be also referred to the City Solicitor for a report.

Alderman McDevitt said that he felt that the City is forced to pay for something for which we are receiving no value. He pointed out also that the Provincial Government has not honoured its commitments to the Planning Board this year.

The motion was then put and carried.

From the Office of the Assessment Commissioner advising of Area Meetings planned throughout the Province for instruction of Assessors.

Moved by Alderman Chadwick, seconded by Alderman Suttis that the Assessment Commissioner be asked to advise Council as to where the proposed instructional meetings will be held, when they will be held, how often they will be held, and the possible cost involved to the municipality. Carried.

Interim Report from the Special Union of B.C. Municipalities 3 Advisory Committee on pensions.

Moved by Alderman Chadwick, seconded by Alderman Suttis that the interim report from the U.B.C.M. Special Committee on pensions of March 10th, 1965, be received and filed.

Carried.

From Malcolm A. MacDonald, Solicitor, asking if the City would sell the Lonsdale Private Hospital at 147 East 12th Street to his clients, Mr. and Mrs. R.B. Baillie, present operators of the Hospital.

Moved by Alderman Chadwick, seconded by Alderman Suttis that Mr. M.A. MacDonald, Solicitor for Lonsdale Private Hospital, be advised of the restrictions in the City's Zoning By-law with respect to the use of property by the Hospital at 147 East 12th Street, for hospital purposes, and ask him if his clients are still interested in purchasing the property after they have been so advised.

Carried.

From the Minister of Municipal Affairs advising that the Annual Conference of the B.C. Municipal Officers Association will be held this year on May 31st, June 1st and June 2nd, in Victoria.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that the following officers be authorized to attend the 1965 Convention of the Municipal Officers Association of British Columbia to be held in Victoria on May 31st, June 1st and 2nd, 1965:-

and that the usual expense allowance be provided by the City.

From the North Vancouver Business Association asking for ploading zones in front of four business establishments on the east side of the 1400 Block Lonsdale Avenue.

Moved by Alderman Dewhurst, seconded by Alderman Suttis that the above letter be referred to the Traffic and Safety Advisory Committee for study and recommendation. Carried.

From the North Vancouver Memorial Community Centre requesting exclusive use of two of the Boulevard tennis courts at times specified in their letter.

Moved by Alderman Chadwick, seconded by Alderman Suttis that the North Vancouver Memorial Community Centre be granted exclusive use of two tennis courts at Boulevard Park every Tuesday from 7:00 P.M. to 9:00 P.M. commencing April 27th, 1965, and ending June 29th, 1965; and every Saturday from 1:00 P.M. to 2:00 P.M. commencing May 1st, 1965, and ending June 26th, 1965.

Carried Carried.

The City Clerk advised that one further letter had been received too late to be placed on the agenda.

Moved by Alderman Suttis, seconded by Alderman Chadwick that this letter be now read. Carried.

Letter from H.A. Roberts Ltd., giving further particulars with respect to a previous application from the Company for the use of the street end of Chesterfield Avenue in connection with the proposed development of a deep sea wharf on adjacent property.

Moved by Alderman Suttis, seconded by Alderman Chadwick that the above letter be tabled until consideration of the Fire and Industrial Committee report.

REPORTS OF COMMITTEES

Each Chairman, when submitting recommendations on behalf of his Committee, also gave a short background explanation in each case.

FINANCE & LEGAL COMMITTEE

Alderman Chadwick submitted the following recommendations on behalf of his Committee:

RECOMMEND that the North and West Vancouver branch of the Navy League of Canada be advised that if it gives an undertaking to build their new building in the 1500 block Forbes Avenue in the location set out in their plan submitted recently to the Building Department, the Council will give favourable consideration to rezoning the area to Public Use and this will permit them to erect a building with only a 15 foot front yard on Forbes Avenue.

Moved by Alderman Chadwick, seconded by Alderman Suttis that the above recommendation of the Finance and Legal Committee be adopted. Carried.

RECOMMEND THAT WHEREAS The Corporation of the City of North Vancouver (hereinafter called the City), is the owner of a parcel of land in the City of North Vancouver, (not being required for Municipal purposes and not being reserved or dedicated), namely, the parcel of land hereinafter described, upon which there is not any building or structure of any kind and it is not the intention of the Council that the said land be sold by Public auction:

Alderman Irwin asked that it be recorded that he was refraining from voting on this motion.

The motion was then put and carried.

RECOMMEND that the Licence Inspector be instructed to forward an accompanying letter with each home-occupation licence issued, such letter to be drafted by the City Solicitor and to outline in it the pertinent parts and restrictions set out in the home-occupation section of the City's Zoning By-law.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that the above recommendation of the Finance and Legal Committee be adopted.

Discussion followed.

The motion was then put and carried.

RECOMMEND that Mr. and Mrs. T.M. Bone, 448 East 18th Street, and other petitioners signing a petition received on November 18th, 1964, opposing high-rise buildings, be advised that their comments will be kept in mind by the Council's Zoning Committee when considering the overall zoning of the municipality in the near future and in the meantime their petition be received and filed.

Moved by Alderman Chadwick, seconded by Alderman Suttis that the above recommendation of the Finance and Legal Committee be adopted. Carried.

FIRE & INDUSTRIAL COMMITTEE

Alderman Suttis submitted the following recommendations on behalf of his Committee:

RECOMMEND that H.A. Roberts Ltd. be advised in reply to their letter of March 3, 1965 that this Council regrets that it cannot approve of their proposal for the use of Chesterfield Avenue as a part of a commercial operation as outlined therein and as discussed with the Chairman of the Industrial Committee and Mayor Cates at a meeting held on March 16, 1965, as such operation involves closure to the Public.

Moved by Alderman Suttis, seconded by Alderman McDevitt that the above recommendation of the Fire and Industrial Committee be adopted. Carried.

Alderman Suttis explained that his Committee had met with Mr. Follis of H.A. Roberts Ltd. on this matter and had promised Mr. Follis to inform him as soon as the Committee had made their decision. He said that Mr. Follis had been advised of the recommendation which the Committee had intended to submit some days ago.

Alderman Suttis said that now a further letter had been received from Mr. Follis, giving further particulars and asking that the proposal of his Company be reconsidered. He said that he had discussed this letter with his Committee, and would now like to recommend as follows, since his Committee felt that a deep sea wharf would be an asset to the City, although Council could not agree to closing a street end to the Public:

RECOMMEND that the proposal of H.A. Roberts Ltd. for the development of a deep sea wharf be referred for consideration by the Port Development Committee in the hope that that Committee can suggest a suitable location for such facilities.

Moved by Alderman Suttis, seconded by Alderman McDevitt that the above recommendation of the Fire and Industrial Committee be adopted. Carried.

HEALTH & CIVIC AFFAIRS COMMITTEE

Alderman McDevitt advised that his Committee had no recommendations to submit this evening.

Alderman Chadwick said he would like at this time to congratulate Alderman McDevitt on the appearance of the City's advertisement in the Progress Edition of the "Citizen" this year. He said that he felt that congratulations should be

extended to the "Citizen" newspaper also for an excellent effort.

BOARD OF WORKS & WATERWORKS COMMITTEE

Alderman Irwin submitted the following recommendations on behalf of his Committee:

RECOMMEND that the City acquire an easement for sewer purposes through the westerly five feet of Lot B, Block 201A, D.L. 544, AND THAT the sum of \$150.00 be paid to the owner of the said Lot B for this purpose.

Moved by Alderman Irwin, seconded by Alderman Jardine that the above recommendation of the Board of Works and Waterworks Committee be adopted.

The City Clerk advised that this should be considered as a key easement and not construed as setting a precedent when obtaining future easements.

The motion was then put and carried.

In reply to a question, Alderman Irwin confirmed that these γ figures are estimates only, and that tenders will be called for the purchase of these pieces of equipment.

The motion was then put and carried.

Alderman McDevitt said before leaving the Board of Works Committee he must report that he had received several favourable 5 comments on the new look of our garbage collectors, who are now attired in white uniforms.

PARKS & CIVIC BUILDINGS COMMITTEE

Alderman Jardine said that he had decided not to submit the recommendations prepared by his Committee this evening, which dealt with the allocation of funds for improved facilities for Loutet Park and Mahon Park, inasmuch as some members of Council have not had sufficient time to study the plans for these improvements.

Alderman Chadwick pointed out that these recommendations would serve simply to place an amount for these improvements in this year's Budget. He said that Council members could study the plans before actually dealing with the Budget.

The City Clerk advised that if these amounts are to come out of general revenue the recommendations should be dealt with tonight because of the time element involved. He said that if they were to come out of reserve funds, however, the time element would not be important.

Alderman Jardine said in the light of the above remarks he would submit his Committee's recommendations as follows:

RECOMMEND that the Engineering Department plan dated March 22, 1965, and numbered 1566, showing six new tennis courts in Mahon Park and a revamping of the recreational facilities in that area, be approved, and if feasible, this plan be implemented during 1965 at a cost estimated to be approximately \$25,000.00.

Moved by Alderman Jardine, seconded by Alderman Irwin that the above recommendation of the Parks and Civic Buildings Committee be adopted. Carried.

RECOMMEND that an amount estimated to be approximately \$35,000.00 be allocated in the 1965 Capital Budget for the construction of two new playing fields and a changing room in Loutet Park.

Moved by Alderman Jardine, seconded by Alderman Irwin that the above recommendation of the Parks and Civic Buildings Committee be adopted. Carried.

TRANSPORTATION & LIGHT COMMITTEE

Alderman Dewhurst advised that his Committee had no recommendations to submit this evening.

TRAFFIC & SAFETY ADVISORY COMMITTEE

Alderman Dewhurst advised that there were no recommendations to submit on behalf of this Committee either.

SPECIAL COMMITTEE - (New City Hall)

Alderman Chadwick submitted the following recommendation on behalf of the above Committee:

Alderman Irwin said it was interesting to note that the present City Hall building was first considered to be for temporary use only, although it has actually been used for a City Hall upwards of half a century.

The motion was then put and carried unanimously.

Whereupon the Public Hearing adjourned at 7:55 p.m. and re-convened at 7:56 p.m.

Mr. Hoffman said that Council should condemn the building on this property and leave it zoned Two-Family. He said he had bought his property because it was apartment-zoned and has paid taxes on it as being apartment-zoned. He said these areas should be developed first.

A Mrs. Bone spoke from the gallery and asked if this apartment was going to be high-rise and was advised that it was not.

An unidentified woman spoke from the gallery as a property owner on West 6th Street and said that although her property was zoned Apartment, she could not get a permit to build one.

The Chairman advised that Council had not adopted the recommendation of the Lower Mainland Regional Planning Board and said that Council's Zoning Committee was working very hard on a new plan.

Alderman Chadwick said that Mr. Hoffman's remarks were correct and that slum conditions were not an excuse for rezoning. He said that the Zoning Committee is working on a new By-law and that the plan which was presented has been revised and that the By-law has also been revised. He said our Consultant is ready to have a meeting with the Zoning Committee and our own Staff so that we can resolve what we hope will be the best zoning for the City. He suggested that this application be referred to the Zoning Committee for consideration on the overall plan and that Council not approve the application this evening.

Moved by Alderman Chadwick, that this application be referred to the Zoning Committee and that the Solicitor be requested to find out if we can get a performance bond.

Alderman Suttis seconded the motion for discussion purposes.

Mr. Derrick Humphreys, 140 West Keith Road, then spoke from the gallery. He referred to a report from Harland Bartholomew dated 1957. He said it is evident that apartment construction drops to the lowest level. He said any apartment will take advantage of the lowest standard permitted in the Building Code. He said the Apartment Zone is far too big. He referred to a report from the Advisory Planning Commission, dated October 21st, which recommended that no further consideration be given to any application for rezoning until finalization of a new Zoning By-law.

Mr. Humphreys said that the Advisory Planning Commission recommended an apartment for this piece of property. He said they had originally recommended a park for children, but Council could not afford to buy the property and do this. He said this should not go through because of the adjacent apartments being built around. He said there are no schools. He referred to the letter from Blane, Fullerton & White which stated that school costs will be nil, as only adults will live there, yet they plan for two-bedroom units. He said this property is presently zoned Duplex and should remain as such.

Mr. Davidson, residing in the 1600 Block St. Andrews, then spoke from the gallery on behalf of a group of property owners in this area.

He said these people are "Community Boosters" and have maintained their property. He said the present owner must have bought this property on speculation, as very little money has been spent and very little effort made to maintain it over the years. He said this is not fair to the property owners opposite this property.

He said this property is not surrounded by apartments and that Council has a moral responsibility to give them consideration. He said the Planning Commission have suggested that it be retained single family or park property. He said the Real Estate Agents propose 46 suites. He said there is no property for a school. He suggested the Advisory Planning Commission were not doing a good job.

The Chairman advised that we have a fine Advisory Planning Commission who serve voluntarily, and they look at all property which comes to their attention.

Alderman Suttis said that the Advisory Planning Commission have done a lot of work on this and had made this resolution only after doing a great deal of thinking on it. He said every Member of Council had looked at it.

Alderman McDevitt said he and Alderman Dewhurst had looked this property over several times and cannot see anything else for it but Apartment. He said it would not be good to delay a decision.

Alderman Chadwick said he found it interesting to note that most of the opposition, except for Mr. Davidson, was from present Apartment property owners, and said that the right thing to do is to refer it to the Zoning Committee at this time. He agreed that the building on it is an eyesore, and if the people would petition against it, Council would have it removed. He said the new By-law would be ready soon and a short delay would do no harm.

Alderman Irwin said Council could make a decision on this matter tonight. He said the opinion of the Advisory Planning Commission coincides with his own.

Alderman Dewhurst said he is also of the same opinion. He said this particular site is not spot-zoning. He said the property is ideally suited for apartment and it would bring considerable revenue to the City.

Alderman Jardine said this matter should be referred to the Zoning Committee.

The Chairman then put the motion to vote.

The motion was declared lost.

Moved by Alderman Irwin, seconded by Alderman McDevitt that the application of Blane, Fullerton & White be approved.

Alderman Suttis said it would be wiser to take another look at it to see if the new plan of our Consultants makes much change in our rezoning.

Moved by Alderman Chadwick, seconded by Alderman Suttis that a Public Hearing be held at 7:00 P.M. on Monday, May 10th, to consider the rezoning of the Armoury Block from Single Family Dwelling to Public Use District, AND THAT in the meantime the Advisory Planning Commission be asked for their opinion with respect to this proposed change. Carried.

Circular letter from the Mayor of the City of Saskatoon, extending an invitation to send representatives to the Canadian Association of Fire Chiefs Convention held in Saskatoon on August 21st to 26th, 1965.

Moved by Alderman Suttis, seconded by Alderman McDevitt that the Mayor of Saskatoon be thanked for his letter, and that we wish them every success with their Convention, but regret to advise that Fire Chief Spencer will not be able to attend, as he will just have returned from the B.C. Convention, and that we also congratulate the Province of Saskatchewan on its 60th birthday.

Letter from Doug's New and Used Boats, Ltd., 740 Marine Drive, asking for permission to use an adjacent City lot for parking or storage purposes.

Moved by Alderman Chadwick, seconded by Alderman Suttis that Doug's New and Used Boats Ltd., 740 Marine Drive, be advised that Council is not prepared to grant the use of City Lot 18, Block 10, D.L. 265, fronting the Company's property, for parking or display purposes, as the Council is not satisfied with the present conditions of the Company's own property, AND FURTHER THAT the By-law Enforcement Officer and the City Superintendent be instructed to report as to whether there are any violations of the City's By-laws by the said Company and surrounding companies.

Alderman Chadwick pointed out that this figure is at least 2% high on purpose, so that we have some leeway.

MINUTES of a Special Meeting of the City Council held in the Council Chamber on Thursday, April 22nd, 1965, at 4:30 p.m.

Proper Notice had been given of this Special Meeting in accordance with the requirements of the Municipal Act.

The business to be considered was as follows:-

- (a) Tenders for the construction of the new City Yard.
- (b) Notice of possession to be sent to the owners of four properties to be expropriated by the City for municipal purposes.
- (c) By-laws.

TENDERS - CITY YARD BUILDING

Mayor Cates said that after thinking over the action of Council on the 20th instant in awarding the contract for this building to Johnston Bros. Construction Ltd. of North Vancouver, although they were not the lowest tenderer, she felt that the decision should be reconsidered in view of the implications of what this might mean in the future as there could be a tendency for firms outside of North Vancouver not bidding on future City contracts.

A general discussion then followed and particularly as to whether the awarding of City contracts to a local firm when they were not the lowest tenderer was in the best interests of the City.

Alderman Jardine pointed out that the District of North Vancouver have in the past given the local firm a contract when they were within reasonable proximity of the lowest bid, and Alderman Chadwick also reported that the National Harbours Board follow a policy of giving a percentage advantage to local firms as against bids from say outside the Province and outside of Canada.

Moved by Alderman McDevitt, seconded by Alderman Suttis, that the Resolution of Council adopted by Council on April 20th, 1965, awarding the construction contract of the new City Yard building to Johnston Bros. Construction Ltd. for the sum of \$104,200.00 be reconsidered. Carried.

Moved by Alderman McDevitt, seconded by Alderman Irwin, that the Resolution of Council adopted by Council on April 20th, 1965, awarding the construction contract of the new City Yard building to Johnston Bros. Construction Ltd. for the sum of \$104,200.00 be rescinded.

Discussion followed.

The motion was then put and carried.

Moved by Alderman McDevitt, seconded by Alderman Irwin, that the tender of Brockbank and Hemingway Limited in the amount of \$104,000.00 for the construction of the City Yard building be accepted. Carried.

Further general discussion followed on future policy in these matters and Alderman Irwin said his Board of Works Committee would give further study to the matter.

Alderman Jardine asked to be excused and left the meeting at 5:07 p.m.

NOTICE OF POSSESSION - EXPROPRIATED PROPERTIES

The City Clerk reported that the City Solicitor had advised that the Notice of Possession, passed by Council on April 20th, 1965 with respect to properties at 2640 Westview Drive, 2200 Eastern Avenue, 2210-12 Eastern Avenue and 2220 Eastern Avenue, should be effective from May 1st, 1965 and not April 1st, 1965 as previously recommended by him.

Moved by Alderman Chadwick, seconded by Alderman McDevitt, that the Recommendation of the Finance and Legal Committee adopted by Council on April 20th, 1965 authorizing the City to take possession of certain properties expropriated for municipal purposes be reconsidered. Carried.

Moved by Alderman Chadwick, seconded by Alderman McDevitt, that the Recommendation of the Finance and Legal Committee adopted by Council on April 20th, 1965 authorizing the City to take possession of certain properties expropriated for municipal purposes be amended by striking out the date April 1st, 1965 and substituting the date May 1st, 1965 therein.

Discussion followed.

The motion was then put and carried.

BY-LAWS

The City Clerk said that he had one By-law up for reconsideration and final adoption; namely, "Zoning By-law 1958, Amendment By-law 1965, No. 3", which was for the purpose of rezoning property at 1609 St. Andrews Avenue for apartment purposes.

The City Clerk said he had received a letter from the Advisory Planning Commission today respecting this application and asked if Council wished to have it read at this time.

Moved by Alderman Chadwick, seconded by Alderman McDevitt, that the letter referred to by the Clerk be now read.

Carried.

The Commission in its letter said that they felt that some guarantee should be obtained from the owner to ensure that the old building presently on the property would be removed and that the new apartment block would proceed within a reasonable time.

Discussion followed.

Moved by Alderman Chadwick, seconded by Alderman McDevitt, that 'Zoning By-law 1958, Amendment By-law 1965, No. 3", be not reconsidered at this time and that the owner of the property described in the said By-law be advised that the By-law will be reconsidered by Council as soon as (a) the latter has received from him written assurance of the removal of the

present building from the site within thirty (30) days from

/ this date, (b) he deposits a Performance Bond equal to thirty
percent (30%) of the estimated cost of constructing the proposed apartment block on the site so as to ensure the building
of the said apartment block substantially in accordance with
preliminary plans submitted by Blane, Fullerton & White, and
(c) he has submitted a statement to Council giving a firm
date as to when he will commence construction of the proposed
apartment block.

Carried.

A general discussion followed as to a possible policy to be followed under which Performance Bonds, etc. may be required in cases of rezoning, and Alderman Chadwick said his Legal Committee would discuss this matter.

Alderman McDevitt said at this time he would like to point out that his criticism of telephone accounts at the Council Meeting on the 20th instant was not a reference to the City Hall accounts but to the Social Welfare Department.

A brief discussion followed as to the desirability of an automatic exchange in the City Hall and the City Clerk reported that the Telephone Company had recommended the present expanded manual board for the time being with a view to the installation of a fully automatic board in the new City Hall.

Moved by Alderman McDevitt, seconded by Alderman Chadwick, that this Council now adjourn. Carried.
