MINUTES of the Regular Meeting of the City Council, held in the Council Chambers, City Hall, on Tuesday, September 7th, 1965, at 8:00 p.m.

#### Present:

Her Worship Mayor C.M. Cates, Alderman J.A.W. Chadwick, Alderman T.R. Dewhurst, Alderman W.R.B. Irwin, Alderman J.C. McDevitt and Alderman J.A.S. Suttis.

Her Worship, Mayor Cates, called the Meeting to order.

#### MINUTES

The City Clerk suggested that the Minutes of the Regular Meeting of Council, held on August 16th, 1965, be amended by adding the following words, in brackets, at the end of the list of tenders from Clarence Construction Ltd. on page 2, otherwise there was no evidence to show why the high bid from this Company on one lot was not accepted:

"(Deposit cheque not certified)".

Moved by Alderman Chadwick, seconded by Alderman Suttis that the Minutes of the Regular Meeting of Council held on August 16th, 1965 be amended in line with the remarks of the City Clerk, and that these Minutes as amended, the Minutes of the Public Hearing of Council held on August 30th, 1965 and the Minutes of the Special Meeting of Council held on August 30th, 1965 be now adopted, copies of same having been circularized among all Council Members. Carried.

#### CORRESPONDENCE

Letter from D.A. McGregor, 943 Grand Boulevard, re two-way traffic on the Grand Boulevard.

Mayor Cates said that the next two letters on the Agenda dealt with the same subject, and she asked if it was Council's wish that these be considered at the same time.

Moved by Alderman McDevitt, seconded by Alderman Suttis that letters numbered 1, 2 and 3 on the Agenda be now considered.

Carried.

3 The City Clerk then read letters from John R. Wheatley, 1844 Grand Boulevard and Gordon Kittson, 957 Grand Boulevard, re two-way traffic on the Grand Boulevard.

Discussion followed.

Moved by Alderman McDevitt, seconded by Alderman Dewhurst that the above letters be referred to the Traffic & Safety Advisory Committee for study and report. Carried.

Letter from Mr. R.G. Jessup, President, North Shore Neighbourhood House, asking the City to help in constructing their new building as a Winter Work Project, etc.

Moved by Alderman Chadwick, seconded by Alderman Suttis that the above letter be referred to the Finance & Legal Committee, to meet with representatives from the North Shore Neighbourhood House to discuss this matter; AND THAT the meeting in Committee planned for 7:00 p.m. on September 13th, 1965, be postponed to a later date after the report of the Finance & Legal Committee has been received.

Discussion followed.

The motion was then put and carried.

Letter from School District No. 44, advising that surplus municipal funds for the vocational secondary school on Jones Avenue are to be used for additional vocational shops and classrooms at Argyle Secondary School.

It was agreed to consider at the same time a copy of a letter from the District of North Vancouver to the School Board, objecting to the proposal of the Board to use certain vocational funds for other than the vocational school on Jones Avenue.

Alderman Chadwick said that in his opinion these funds were supplied by the municipal Councils for a specific purpose, and that any unexpended balance which resulted because of additional Government grants, should have been returned to the Councils concerned. He said we are entitled to an accounting of the funds.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that School District No. 44 be asked for an accounting of the funds used in the construction of the vocational secondary school on Jones Avenue; and also that they be advised that Council disapproves of their action in using these surplus funds to provide for an additional vocational shop and classrooms to Argyle Secondary School; and further that should a similar situation arise in the future, Council would appreciate a request from the Board for permission to use surplus funds in this manner.

Further discussion followed.

The motion was then put and carried.

2 Letter from the Lower Mainland Regional Planning Board, enclosing an invoice for services in July, 1965, at the rate of \$55.00 per day, and amounting to \$51.37.

Alderman Chadwick suggested that the Advisory Planning Commission and the Zoning Committee should be advised that they are not to ask for the services of the Lower Mainland Regional Planning Board without prior approval of the Mayor, in order that we do not over-expend the funds set aside for this purpose.

Further discussion followed.

Moved by Alderman Chadwick, seconded by Alderman Suttis that the Treasurer be authorized to pay the account of the Lower Mainland Regional Planning Board in the amount of \$51.37; and that the Advisory Planning Commission and the Zoning Committee be advised that the approval of the Mayor must be obtained before using the services of the Lower Mainland Regional Planning Board. Carried.

Letter from Anglo-Canadian Timber Products Ltd., 369 East Esplanade, requesting a permit under the Noise Regulation By-law.

Discussion followed.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that a permit be issued under authority of the Noise Regulation By-law permitting Anglo-Canadian Timber Products Ltd., 369 East Esplanade, to operate on weekdays from 8 p.m. to 1:15 a.m. until December 31st, 1965. Carried.

Letter from the District of North Vancouver, agreeing to provide the necessary funds for its share of an additional civilian telephone operator at the Police Headquarters.

Moved by Alderman McDevitt, seconded by Alderman Suttis that the above letter be received and filed. Carried.

Letter from the Building Inspector, recommending the demolition of a building situated  $\varepsilon$ t 225 Lonsdale Avenue (rear).

Letter from the Fire Chief, recommending that the shed at the rear of 225 Lonsdale Avenue be destroyed, removed or repaired.

Moved by Alderman Chadwick, seconded by Alderman Suttis that pursuant to Section 873 of the Municipal Act, this Council declare the 30' x 24' building attached to the rear of the main building on Lot 15, Block 140, D.L. 274, and known as 225 Lonsdale Avenue, a nuisance, and hereby directs and orders that the same shall be removed or pulled down by the owner thereof within sixty (60) days after service of the order upon the owner of the said property, the said building being in the opinion of this Council in so dilapidated or uncleanly a condition as to be offensive to the Community; AND FURTHER THAT in the case of default by the said owner to comply with the order referred to in the above paragraph within the period set forth in same, the Municipality, by its City Superintendent and his assistants, shall enter and effect such removal or pulling down at the expense of the person so defaulting and hereby orders that the charges for so doing (including all expenses incidental thereto), if unpaid on the 31st day of December, 1965, shall be added to and form part of, the taxes payable in respect of Lot 15, Block 140, District Lot 274, as taxes in arrear. Carried.

Letter from R. Thompson, owner of property near the south-west corner of 12th Street and Lonsdale, objecting to a proposed church building on the corner by the Salvation Army.

Discussion followed.

Moved by Alderman McDevitt, seconded by Alderman Chadwickthat Mr. Thompson be advised that the Council are satisfied that their decision to allow the Salvation Army to locate their church building at the corner of 12th and Lonsdale is the right one; and that a public hearing is not necessary under the Zoning By-law. Carried.

Letter from Mr. E.L. Plant re traffic conditions on Marine Drive, particularly between McKay and Pemberton Avenues.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that the letter from Mr. E.L. Plant re possible opening of an access road between McKay Avenue and Hamilton Avenue be referred to the Traffic & Safety Advisory Committee; AND THAT a copy of Mr. Plant's letter be sent to the District of North Vancouver for consideration of the other matters which involve the District area. Carried.

5 Letter from the Avalon Motor Hotel Ltd., asking if they could purchase or lease a portion of the park property on the corner of McKay and Hamilton Avenues.

Moved by Alderman Chadwick, seconded by Alderman Suttis that the above letter be referred to the Finance & Legal Committee and to the City Solicitor for his opinion as to the status of this property. Carried.

¿ Letter from Bradshaw's Big O Tire Store, requesting permission to maintain certain facia signs, etc.

Discussion followed.

Moved by Alderman Suttis, seconded by Alderman Chadwick that

Bradshaw's Big O Tire Store be given thirty days in which to comply with the regulations of the City's Sign By-law.

Carried.

Letter from the North Vancouver Recreation Centre Committee, recommending that the City and District provide funds for landscaping the new Recreation Centre.

Alderman Chadwick advised that a report from the District of North Vancouver Parks Superintendent was attached to the above letter, but for some reason or other the City's Parks Department had not been asked to report although it was the intention of the Recreation Centre Committee to have both the City and the District Parks Committees report on this matter.

Further discussion followed.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that the above report be referred to the City Super-intendent for his comments particularly with respect to the suggested costs and any other recommendations he would like to make, as it had been the intention of the Recreation Committee that both Parks Departments were to report on this matter. Carried.

2 Further letter from the North Vancouver Recreation Centre Committee, recommending installation of ornamental street lighting on 23rd Street between Lonsdale and St. Georges Avenue.

Discussion followed.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that the District of North Vancouver be advised that the City is prepared to install ornamental street lighting on 23rd Street between Lonsdale and St. Georges Avenues because of the construction of the Recreation Centre in these blocks and to share in the cost of such lighting on the same basis as the other Recreation Centre expenditures. Carried.

Further letter from the North Vancouver Recreation Centre Committee, requesting approval for the expenditure of an additional amount up to \$5,000.00 for Change Orders for the Recreation Centre project.

Alderman Chadwick said that Change Orders for a project of this size have not been very great, and that some have been changes requested by the City. He said the item of \$1,734.00 for Electrical Connection is in dispute, and he felt that this item should not be paid, as it was his understanding that this was in the overall tender price.

Moved by Alderman Chadwick, seconded by Alderman Dewhurst that the Recreation Centre Committee be authorized to pay up to \$5,000.00 for any further Change Order's required in the construction of the Recreation Centre. Carried.

Circular letter from the Township of Langley, suggesting certain amendments to the Regional Plan, as proposed by the Lower Mainland Regional Planning Board.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that the above circular letter be received and filed.

Carried.

Letter from the City of White Rock approving the official Regional Plan of the Lower Mainland Regional Planning Board.

Discussion followed.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that the above letter be received and filed. Carried.

#### APPLICATIONS TO PURCHASE PROPERTY

The City Clerk advised that he had received a letter from H.L. Waddell & Associates Ltd. agreeing to an exchange of property with the City involving their clients' lots on the south side of the 100 Block West 16th Street, and the City's lot on the south-west corner of Chesterfield Avenue and 14th Street. He said both parcels had been appraised, the City parcel at \$30,000 and the other parcels at \$25,000.

Alderman Chadwick suggested that the City Superintendent be asked to clarify his statement in this regard.

Further discussion followed.

The motion was then put and carried.

Letter from Mander Chevrolet Oldsmobile, 845 Marine Drive, re previous application received by Council for a car wash operation on the Company's site.

The City Clerk advised that the application for a car wash had been from ALD Canada Ltd., and that Manders had turned down the proposal and that therefore no application need be considered.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that the correspondence with respect to the application of ALD Canada Ltd. be received and filed. Carried.

Report from the City Superintendent with respect to a request from Kiwanis Senior Citizens Homes Ltd., for a relaxation of certain provisions of the City's Zoning By-law for their new apartment building.

He said he had told them that the City was not pushing them out of the building, and that they had been quite happy about this. He said there are many old age pensioners occupying the building.

- Alderman Chadwick reported that last Thursday evening he along with a couple of the City Firemen had worked for over an hour to free an injured dog from a covered drain under 12th Street at St. Andrews Avenue. He said according to reports, the S.P.C.A. had been called but had not been able to rescue the dog, and that they had said they would come back the following day. He said if this is true he felt the S.P.C.A. should be reprimanded. He said he had later called the S.P.C.A. but that the inspector was out.
- Mayor Cates said she would like to bring up the subject of accommodation for the Christmas Bureau. She said it is some time since we had promised to find a place for them.

Discussion followed.

Alderman Chadwick said there were two vacant stores at the Foot of Lonsdale which might be available at a reasonable rental.

Alderman McDevitt promised to investigate and see what could be done.

MINUTES of the Regular Meeting of the City Council, held in the Council Chambers, City Hall, on Monday, September 20th, 1965, at 8:00 p.m.

#### Present:

Her Worship Mayor C.M. Cates, Alderman J.A.W. Chadwick, Alderman T.R. Dewhurst, Alderman W.R.B. Irwin, Alderman G.A. Jardine, Alderman J.C. McDevitt and Alderman J.A.S. Suttis.

Her Worship, Mayor Cates, called the Meeting to order.

Mayor Cates said that before proceeding with the Regular business of Council she had a statement she wished to make, and she then read the following statement:

"As Members of Council are aware, Alderman Irwin was recently convicted of an impaired driving charge. I have consulted our Solicitor and he advises that Section 50 of the Municipal Act requires disqualification, subject to Section 123, as follows:-

#### Section 123

"Where an elected member of Council has become so disqualified, his office shall nevertheless not be vacated and he shall not be prevented from voting or acting as a Member of Council unless and until

- (a) a declaration has been made by a Judge that he has become disqualified from continuing in office as a member of Council, or
- (b) such person files a written disclaimer with the Clerk renouncing all claim to the office, or
- (c) a Resolution has been passed by the Council declaring his office vacant, etc., etc."

It could well be that we, as a Council, are properly bound to take the step mentioned in (c) above but in view of the fact that in the present instance the Member of our Council has only a little more than three months to serve of his current term and in view of the fact that we have been short a Member of Council for a considerable length of time due to illness (remembering too that unexpected circumstances might occur to cause absence from Council of still other Members), it would seem to me that it would not be in the best interest of our City for us to declare the seat vacant and allow it to continue so until the December election. A By-election could be called but in that case the person elected would only hold office until the end of this year and would of necessity have to stand for re-election in December.

With all due regard to Alderman Irwin's fine record of public service and in consideration of his advice to me that he does not intend to seek nomination in December, I would therefore respectfully suggest to Council that no action be taken at this time to declare the seat vacant and I would request that if Council is in agreement with this recommendation, a motion of endorsation be passed so that this can be properly recorded in the Minutes.
