Moved by Alderman McDevitt, seconded by Alderman Dewhurst that the Minutes of the Regular Meeting of Council held on April 18th, 1966 and the Special Meeting of the Council held on April 25th, 1966 be taken as read and adopted, copies of same having been circularized to all Members of Council.

CORRESPONDENCE

Letter from School District No. 44 asking if the City will sell certain lands in the vicinity of Sutherland and 26th Street for a joint Elementary School site and asking the price of the land.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that this matter be referred to the Finance and Legal Committee for report.

Carried.

Letter from E.P. Cummins, 4190 Dollarton Highway, re Third Street East.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that the City Clerk write a suitable letter to Mr. E.P. Cummins explaining that the matter of re-naming streets which are continuous to Third Street, and other streets with similar situations, is a matter which is receiving consideration by the Council. Carried.

Letter from A. D. Long, Solicitor, advising of the proposal to establish a Crematorium adjacent to the City Cemetery by the North Shore Crematorium Ltd.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that the letter from Mr. A.D. Long be received and filed.

The City Clerk advised that because the initial request of the S.P.C.A. was reported to a public meeting it is therefore necessary to report this withdrawal in the same manner.

Moved by Alderman Dewhurst, seconded by Alderman Chadwick that the correspondence from the B.C. Society for the Prevention of Cruelty to Animals with respect to the Leash By-law be now received and filed.

Carried.

Letter from Mr. N.M. Crute, 512 East 12th Street, commending the Council for its Leash By-law.

Moved by Alderman Dewhurst, seconded by Alderman Chadwick that this letter be tabled to later in the Agenda under 'Petitions' when the same matter will be given consideration. Carried.

Further letter from A. Mosher, 1704 Chesterfield Avenue, re blockage of sewer.

Alderman Suttis advised that Mr. A. Mosher's request had been reviewed by the Board of Works and Waterworks Committee but the Committee can only confirm its earlier statement.

Moved by Alderman Suttis, seconded by Alderman McDevitt that the resolution of the Board of Works & Waterworks Committee dated April 12th, 1966, as adopted by the Council on April 18th, 1966, i.e. "Mr. A. Mosher be advised the City does not accept responsibility for the blocking of the sewer at 1704 Chesterfield Avenue", be reaffirmed. Carried.

Report of the City Superintendent re need for a replacement of the Lynn Creek Bridge at Cotton Road.

Moved by Alderman Suttis, seconded by Alderman McDevitt that the District of North Vancouver be requested to agree to the employment of consulting engineers to study the construction of a new Lynn Creek Bridge.

Carried.

Application from C.W.M. Burge, Solicitor, for the rezoning of property at 903 and 907 West 16th Street to Commercial Use.

- Moved by Alderman McDevitt, seconded by Alderman Suttis that the application from C.W.M. Burge for the rezoning of property at 903 and 907 West 16th Street for commercial purposes be referred to the Advisory Planning Commission for study and report.

RECOMMEND that the City's delegates to the 1966 Convention of the Municipal Officers' Association of British Columbia be authorized to attend a one-day Seminar at the conclusion of the Conference for study of the Basic Techniques of Operation Research and that their expenses be paid by the City.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Alderman Chadwick submitted the following recommendation on behalf of this Committee:-

RECOMMEND that Lot 6, Block 32, D.L. 272 be not sold and that Mr. D. Brondgeest be advised of the situation after the Lynn Creek bridge relocation design is finalized so that if there is any portion of Lot 6 remaining he might apply again for consideration to see whether there is sufficient land left for sale to him for consolidation with the adjoining lot located in the District of North Vancouver.

Board of Works & Waterworks Committee

Alderman Suttis in submitting the following recommendation of the Board of Works & Waterworks Committee advised that it has been amended by deleting the clause regarding sale of Jones Avenue property and by removing the frontage of the Carson Graham School property from the sidewalk estimate because the School Board could not be assessed for this work:-

RECOMMEND that the City Superintendent be asked to prepare estimated costs to construct a six (6) foot sidewalk on the west side of Jones Avenue between 15th Street and 23rd Street, less the frontage of Carson Graham School, and a four (4) foot sidewalk on the east side of Jones Avenue between 15th Street and 23rd Street, as an Initiative local improvement.

Alderman Dewhurst inquired whether the East side of Jones Avenue, where property is being held for parking purposes, could not be merely curbed rather than a sidewalk being constructed.

It was felt a sidewalk would help clean up the area.

Moved by Alderman Suttis, seconded by Alderman McDevitt that the above recommendation of the Board of Works & Waterworks Committee be adopted. Carried.

Alderman Suttis submitted the following recommendation on behalf of this Committee:-

RECOMMEND that authority be given to purchase an Essick V.R. 54 TEW Vibratory Roller on a rental-purchase basis costing \$5,364.00, in accordance with quotation dated April 13th, 1966, received by the City Superintendent, the monthly instalment to be charged against the Public Works By-law.

Moved by Alderman Suttis, seconded by Alderman McDevitt that the above recommendation of the Board of Works & Waterworks Committee be adopted. Carried.

Parks, Building & Zoning Committee

Alderman McDevitt in submitting the following recommendation of this Committee asked that the word "uncleanly" be changed to "unsanitary."

The City Clerk advised that the word "uncleanly" is legally correct.

RECOMMEND that pursuant to Section 873 of the Municipal Act, this Council declares the building, approximately 600 square feet in area, situated on Lot 26, Block 168, D.L. 274, and known as 334 East Esplanade, a nuisance, and hereby directs and orders that the same shall be removed or pulled down by the owner thereof within sixty (60) days after service of the order upon the owner of the said property, the said building being in the opinion of this Council in so dilapidated and uncleanly condition as to be offensive to the Community; AND FURTHER THAT in the case of default by the said owner to comply with the order referred to in the above paragraph within the period set forth in same, the Municipality, by its City Superintendent and his Assistants, shall enter and effect such removal or pulling down at the expense of the person so defaulting and hereby orders that the charges for so doing (including all expenses incidental thereto), if unpaid on the 31st day of December, 1966, shall be added to and form part of, the taxes payable in respect of Lot 26, Block 168, District Lot 274, as taxes in arrear.

Moved by Alderman McDevitt, seconded by Alderman Suttis that the above recommendation of the Parks, Building & Zoning Committee be adopted. Carried.

Alderman McDevitt submitted the following recommendation of this Committee:-

RECOMMEND that no consideration be given to the request of Mr. L.O. Lund on his application to rezone and consolidate property in Block 63, situated on the corner of 14th Street and Chesterfield Avenue until the new Zoning By-law has been thoroughly discussed.

Moved by Alderman McDevitt, seconded by Alderman Suttis that the above recommendation of the Parks, Building & Zoning Committee be adopted. Carried.

Transportation, Traffic & Safety, and Light Committee

Alderman Wallace advised that there was nothing to report under this Committee

Police Committee

Alderman Chadwick advised that there was nothing to report under this Committee.

Labour Relations Committee

Alderman Chadwick advised that there was nothing to report under this Committee.

North Vancouver Recreation Centre Committee

Alderman Chadwick advised that there was nothing to report under this Committee.

North Vancouver Recreation Centre Board

Alderman Chadwick advised that there was nothing to report under this Committee.

Committee Meeting of All Council Members (April 25th, 1966)

Alderman Chadwick submitted the following recommendation on behalf of the Committee Meeting of all Council Members:-

RECOMMEND that authority to make purchases of investments be provided on the same joint basis as now practised in regard to sale of investments, i.e., authority be vested in the Mayor (or the Chairman of the Finance Committee), together with the Treasurer.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that the above recommendation of the Committee Meeting of All Council Members be adopted.

Alderman Dewhurst stated that he would like to see another Member of Council named in this resolution and asked if this matter might not be tabled for further discussion at a future meeting.

Alderman Dewhurst's motion to table was not seconded.

The motion was then put and carried.

Alderman Chadwick submitted the following recommendation on behalf of this Committee:-

RECOMMEND that with respect to a third alternative member of Council signing cheques in place of the Mayor and Acting Mayor, the immediate preceding Acting Mayor automatically become the third Signing Officer.

Moved by Alderman Chadwick, seconded by Alderman Wallace that the above recommendation of the Committee Meeting of all Council Members be adopted. Carried.

Alderman Chadwick, in submitting the following recommendation, advised that this had been amended from that passed by the Committee Meeting of all Council Members on April 25th, 1966 and that now the mill rate for General Purposes remains at virtually the same as for 1965, the only increase being in the mill rate for School Purposes over which the Council has no control.

RECOMMEND that the 1966 Budget be accepted, setting the mill rate for general purposes at 38.6, and for school purposes at 28.95, AND THAT the necessary By-law be prepared.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that the above recommendation of the Committee Meeting of all Council Members be adopted.

Alderman McDevitt pointed out to the meeting that this Council should make every endeavour to obtain more assistance from the Provincial Government to cover the School Budget.

In the general discussion it was pointed out that even though not included in the Budget, many works such as the paving of Fourth Street could be provided for during the year 1966.

The motion was then put and carried.

Alderman Wallace submitted the following recommendation on behalf of this Committee:-

RECOMMEND that the City Clerk be authorized to employ another independent appraiser to obtain a second appraisal on two or three selected properties in the proposed City Hall site; AND FURTHER THAT the City Clerk be authorized to take steps on behalf of the City of North Vancouver to take possession of the following properties effective June 1st, 1966:

Lot 4; Lots 5, 6 and 7; Lot Am. 8; Lot Am. 14; Lot 15; Lot 16 $(E_{\frac{1}{2}}^{\frac{1}{2}} \& W_{\frac{1}{2}}^{\frac{1}{2}})$; Lot 17; Lot 18; and Lots A and B, all of Block 62, D.L. 548;

AND FURTHER THAT the City Clerk be authorized to arrange for the setting of rentals on these properties; AND FURTHER THAT the City Solicitor be authorized to arrange for an Arbitration Board or Boards, as required, in order to establish the proper amount of compensation to be paid.

Moved by Alderman Wallace, seconded by Alderman Chadwick that the above recommendation of the Committee Meeting of all Council Members be adopted. Carried.

Alderman McDevitt submitted the following recommendation on behalf of this Committee:-

RECOMMEND that Mr. J.A. DeJong be appointed as the City Planner effective the 1st of June, 1966, at a salary of \$9,744.00 per year on the understanding that this shall be the salary paid him for one year, and also on the understanding that the appointment is made on a six months' probationary period, and that the present fringe benefits received from the City of Victoria be transferred.

Moved by Alderman McDevitt, seconded by Alderman Suttis that the above recommendation of the Committee Meeting of all Council Members be adopted.

Alderman Chadwick inquired whether there was any merit in withholding the hiring of a Planner until the amalgamation study report is received.

Members of Council felt, however, that the hiring of a Planner should be proceeded with immediately because even if the ratepayers vote for amalgamation this cannot become a fact for a long period of time.

The motion was then put and carried.

Alderman Chadwick submitted the following recommendation on behalf of this Committee:-

RECOMMEND that the recommendation of the Reference Committee be accepted which will provide for the extension of the City Hall as per Plan No. 1649, dated April 18th, 1966, at a cost of \$20,000.00, the necessary funds to be included in the 1966 final Budget, AND THAT the work proceed immediately.

Moved by Alderman Chadwick, seconded by Alderman Suttis that the above recommendation of the Committee Meeting of all Council Members be adopted. Carried.

Alderman Chadwick submitted the following recommendation on behalf of this Committee:-

Alderman Chadwick submitted the following recommendation on behalf of this Committee:-

RECOMMEND that the report of the Conciliation Board, dated April 13th, 1966, be accepted, with the understanding that the premium pay referred to in the last sentence of Section 3 of the Report is payable after regular hours on any day worked, and on the two days off; AND FURTHER THAT the City's share of the account of the Corporation's member on the Board be paid in the amount of \$170.00.

Alderman Dewhurst asked that consideration be given to the City of North Vancouver not being included in the Official Regional Plan.

Alderman McDevitt offered to change his resolution to read that the Official Regional Plan be rejected.

Alderman Chadwick and Alderman Suttis stated that the City of North Vancouver should consider itselfan integral part of the Lower Mainland region and should therefore, even though on the fringe, remain in the structure of the Plan.

It was pointed out that the Lower Mainland Regional Planning Board requires an answer for its meeting on May 19th, 1966.

Alderman Wallace stated he is not opposed to the Plan; however, he wished to compare it against the City's final Zoning By-law and suggested that the Zoning Committee meeting on the evening of Thursday, May 5th, 1966 should first consider the Heavy Industrial District in order to thereby give consideration to the Official Regional Plan.

Moved by Alderman Wallace, seconded by Alderman Dewhurst that the consideration of this matter be tabled to the Council Meeting on May 16th, 1966. Carried.

Further letter from the Lower Mainland Regional Planning Board enclosing their report on the Canada Safeway development on East 13th Street.

The meeting was advised of the following motion passed at the meeting on April 28th, 1966 of the Committee dealing with the new Zoning By-law:-

Alderman Goldsworthy advised that the Finance and Legal Committee recommendation dated May 9th, 1966, was drafted with the Committee having the impression that this money was required for the 1967 Convention, whereas later checking has revealed that this grant was requested for the purpose of publicity at this year's Convention in order to obtain the Convention for this area next year.

Moved by Alderman Suttis, seconded by Alderman McDevitt that Mr. William Zodor be advised in connection with his complaint regarding the condition of the sidewalk, boulevard and road in the 100 Block East 18th Street, that this work is scheduled in the works program for this year. Carried.

Letter from the Attorney-General's Department advising of the resignation of Magistrate A.D.Pool effective June 15th, 1966.

In submitting the following motion Alderman Goldsworthy advised that this is altered from the recommendation passed by the Committee Meeting of All Council Members on May 9th, 1966, due to more information having been received.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the Council concur with the letter from the Attorney-General dated May 4th, 1966, in connection with the salary schedule and sharing basis for the Chief Magistrate to be appointed by the Attorney-General.

Carried.

APPLICATIONS TO PURCHASE PROPERTY

The City Clerk read a letter received from Mr. H. Rytters-gaard, 759 East 3rd Street in which he advised that he could not afford to pay the price of \$704.48 (which includes the sum of \$300.00 for subdivision plans) for the portion of land adjacent to his lot.

Mr. Ryttersgaard asked for the return of his cheque.

Moved by Alderman Chadwick, seconded by Alderman McDevitt that this letter be received and filed and the City Treasurer authorized to return the deposit. Carried.

TENDERS

/ A report from Chomick and Le Blond, Architects, dated May 12th, 1966, advised that two tenders had been received:-

Alfred Horie Construction Co., Ltd. \$41,375.00 Prossegger Construction Limited \$35,700.00.

The Architects recommended that "since the Prossegger Construction Limited bid is reasonably close to the \$35,000.00 amount set aside by Council, we would recommend that the contract be awarded to Prossegger, and that we are instructed to have them make an immediate start".

Moved by Alderman McDevitt, seconded by Alderman Chadwick that the contract be awarded for the construction of the North Vancouver Lawn Bowling Clubhouse at a cost of \$35,700.00 to Prossegger Construction Limited, and that the Mayor and City Clerk be authorized to sign and execute the necessary contract.

A short discussion ensued as to whether the demolition of the old building is included in this price.

On reading of the tender proposal it was found that this work is included and the motion was therefore put and carried.

Alderman Chadwick asked that consideration be given at this time to the report of the Purchasing Agent and the Fire Chief in respect to tenders received for the new Fire Truck.

This was agreed to.

Class "A", triple combination pumping fire engine be accepted and the necessary by-law be prepared in the amount of \$25,261.90 subject to the District of North Vancouver agreeing to the trade-in of the 1942 Dodge Pumper, the chassis of which was donated by the A.R.P. in 1942 to both the City and the District; and further that the necessary funds be provided from the Equipment and Depreciation Fund. Carried.

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that tenders be called for the sale of \$280,000 par value City of North Vancouver 6% 1-20 years Serial Debentures for the City's share of the cost of constructing and equipping the North Vancouver Recreation Centre such tenders to close at 4.00 p.m. on Monday, June 6th, 1966. Carried.

REPORTS OF STANDING COMMITTEES

A Background explanation was given by each Member of Council submitting recommendations.

Finance and Legal Committee

Alderman Goldsworthy submitted the following recommendations on behalf of this Committee:

RECOMMEND that the Recreation Centre Board be advised that they should obtain an independent appraisal of the property at Trans Canada and Lonsdale Avenue which will be required by the Department of Highways; AND THAT the City and District representatives on the Board report back to their respective Councils for information only.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of the Finance and Legal Committee be adopted.

Alderman Chadwick enquired whether a policy might not be formulated whereby the Purchasing Agent, without obtaining Council's approval each time, may call for tenders to dispose of scrap whenever a sufficient quantity is on hand.

Alderman Goldsworthy in introducing the recommendation of the Finance and Legal Committee in regard to Capital Financing regarding completion of the 6th and 7th floors of the Lions Gate Hospital and other alterations to the Hospital Annex asked that the resolution of Council dated January 17th, 1966, should first of all be rescinded, inasmuch as there is a conflict between the two resolutions.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the resolution of Council dated January 17th, 1966, with respect to Capital Financing re Lions Gate Hospital be reconsidered. Carried.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above resolution be now rescinded.

Carried.

The following recommendation was then submitted:

/ RECOMMEND that the Board of Management of the Lions Gate Hospital be advised that the City of North Vancouver is pleased to make a grant of \$131,167.00 for the completion of the sixth and seventh floors also certain other alterations to the Hospital Annex on the fourth floor; AND certain other additional service departments required at this time to service the above expansion, such services to be constructed on the land recently purchased from the City; AND THAT this grant is made on an equal sharing basis including the cost of the recently purchased City lands with the other two Municipalities for this phase of the program only, and is in no way to prejudice the City's position for future sharing of Hospital costs.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Fire and Industrial Committee

Alderman Chadwick advised he had nothing to report under this Committee.

Health and Civic Affairs Committee

Alderman Dewhurst submitted the following recommendation on behalf of this Committee:

RECOMMEND that the Social Welfare Administrator be granted permission to attend the 1966 Provincial Welfare Administrators' Meeting to be held in Victoria on May 19th and 20th, 1966, and his necessary expense be paid by the City.

Moved by Alderman Dewhurst, seconded by Alderman Goldsworthy that the above recommendation of the Health and Civic Affairs Committee be adopted. Carried.

Board of Works & Waterworks Committee

Alderman Suttis submitted the following recommendations on behalf of this Committee advising that the first recommendation has been amended from that submitted by the Committee as a result of further consideration.

RECOMMEND that as funds have been provided in the budget for the rental of street cleaning equipment during the current year, that the matter of purchase of such equipment be referred to the estimates of the year 1967 as at that time the program of permanent paving now being undertaken will necessitate the greater use of such equipment.

Moved by Alderman Suttis, seconded by Alderman McDevitt that the above recommendation of the Board of Works and Waterworks Committee be adopted. Carried.

RECOMMEND that the snow clearing policy of the City be reaffirmed, and that the clearing of lanes be not attemptted for the following reasons:

1. the extremely high cost;

- the need to haul snow away because of lack of room;
- 3. a practical difficulty of removing snow from 20 ft. lanes without damage to the property on either side;
- 4. the above measons applying also to commercial lanes.

Transportation, Traffic & Safety and Light Committee

Alderman Wallace submitted the following recommendation on behalf of this Committee.

2 RECOMMEND that the North Vancouver Business Association be advised that the same procedure with respect to Christmas Lighting on Lonsdale Avenue be followed in 1966 as in 1965; AND THAT the matter be reviewed following the installation of the new Lonsdale Lighting.

Moved By Alderman Wallace, seconded by Alderman Suttis that the above recommendation of the Transportation, Traffic & Safety and Light Committee be adopted.

A short discussion took place in which it was stated that the new Lonsdale Lighting is expected to be installed early in 1967. In the meanwhile through liaison with the City, Alderman Wallace stated that the North Vancouver Business Association will only purchase that type of equipment which can be utilized with the new lighting system.

Alderman Chadwick reported for the information of Members of Council that the deficit in regard to the opening celebrations of the Recreation Complex was in the vicinity of \$1600 to \$1800. This deficit has been underwritten by the North Vancouver Centennial Committee with the stipulation that, should that Committee's funds become depleted in 1967, the Recreation Board will reimburse 50% of this amount.

CORRESPONDENCE

The City Clerk read two letters from the North Vancouver Civic Employees' Association, dated May 17th, 1966, advising that the employees have rejected the proposals outlined for a new collective agreement; and serving forty-eight hours' strike notice effective May 18th, 1966.

Moved by Alderman Chadwick, seconded by Alderman Wallace, that this correspondence be received and filed.

Carried.

A letter was read from the Labour Relations Branch assuring that the facilities of the Department of Labour are available for the purpose of assisting the City and the Union in resolving their difficulties.

Moved by Alderman Chadwick, seconded by Alderman McDevitt, that this letter be received and filed.

Carried.

The City Clerk advised that following a Reference Committee meeting a letter was sent to the Union asking for the provision of essential services as follows:

"Social Welfare Dept. (Child Welfare)

That the Union give consent to the Provincial Social Workers carrying out any duties required in the apprehension and care of neglected or abandoned children, as this could involve crossing picket lines.

Board of Works

- 1. That the Union authorize the Parks Foreman two hours a day, seven days a week, to water and look after plants that otherwise will perish in the greenhouse.
- 2. That the Union authorize the Board of Works Foreman and the Waterworks Foreman to come out when called, to put up barricades or carry out other work of an emergency nature.
- 3. That the Union authorize the employment of a caretaker at the Waterworks Intake for 24hours per day, seven days a week, and that the Waterworks Foreman be permitted to service the chlorination plant daily.

4. That the Union establish with the City Superintendent a working procedure whereby the Union would designate certain workmen who may be called by the City in the case of emergencies such as plugged sewers or broken water mains.

Cemetery

That the Union permit interments in the City Cemetery and designate appropriate personnel for this purpose."

The North Vancouver Civic Employees' Association replied to these requests as follows, under date of May 24, 1966:

- "(1) The Union gives consent to Provincial Social Workers to carry out any duties required in the apprehension and care of neglected or abandoned children.
- (2) With respect to the Parks Foreman working two hours per day on a seven day basis to water the plants and ventilate the greenhouse this also is granted.
- (3) With respect to your request pertaining to the Board of Works Foreman and Waterworks Foreman and with respect to the establishment of a procedure please be advised:
 - (a) That the Union will maintain comprehensive and qualified emergency crews and we would suggest that in order to expeditiously meet any emergency that the Board of Works Foreman and the Waterworks Foreman be permitted to have their regular City vehicles under their care and for their use during any emergency.
 - (b) When an emergency situation arises the procedure will be that the emergency will be made known to Strike Headquarters at 2345 Lonsdale Avenue or by telephone at YU 8-7244 or YU 8-7255. The Union will, upon receipt of such advice or request, thereupon deal with the emergency.

With reference to your request for the employment of a Caretaker at the Waterworks Intake for 24 hours per day this matter has been considered by the Union and you will be advised at the earliest possible time of our decision.

With reference to your request that the Waterworks Foreman be permitted to service the chlorination plant daily please be advised that the request is denied. We are well aware, as undoubtedly your City Superintendent is, that an alternative is available insofar as water supply is concerned.

With respect to interments at the City Cemetery, arrangements can be made with the Union for interments excepting that the Union will not honour any permit issued on or after May 24th, 1966. Should it be necessary to carry out an interment where arrangements have been made prior to May 24th we respectfully suggest that you contact Strike Headquarters at the address or telephone numbers herein before mentioned."

Moved by Alderman Chadwick, seconded by Alderman Dewhurst, that this correspondence be received, and that copies be referred to the Labour Relations Committee.

Carried.

Alderman Chadwick, in drawing attention to the Union's decision re the Chlorination Plant and employment of the Caretaker necessitating the switching to the Greater Vancouver Water Board system at a possible cost of \$400 per day, stated this will probably entail the early institution of

- sprinkling regulations.
- Her Worship stated it is regretted that burials will not be allowed in the Cemetery.

ANY OTHER COMPETENT BUSINESS

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that the Fire Chief and/or Fire Warden be instructed to use their discretion to enforce the provisions of Section 3 of Part 2 of the Fire By-law and the nuisance section of the Air Pollution Control By-law during the present strike of civic employees.

Carried.

The City Clerk advised that Chomick & LeBlond, Architects, had submitted for execution by the City, their standard form of contract to cover architectural services to cover a second storey addition to the Justice Administration Building, 160 E ast 13th Street.

Moved by Alderman McDevitt, seconded by Alderman Goldsworthy, that the Mayor and City Clerk be authorized to sign and execute the agreement with Chomick & LeBlond, Architects, covering architectural services in the erection of a second storey addition to the Justice Administration Building, 160 East 13th Street, North Vancouver.

Carried.

- The City Superintendent reported that in order to control the consumption of water, he was imposing sprinkling restrictions immediately.
- Mr. Greenwood reported further that all City machinery, with the exception of one piece of equipment, has been secured in the Yard for the duration of the strike, and also that all excavations had been filled in.

Moved by Alderman Goldsworthy, seconded by Alderman Wallace, that this meeting now adjourn.
