Her Worship, the Mayor, called the meeting to order.

MINUTES

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that the Minutes of the Regular Meeting of Council held on September 19th, 1966, be taken as read and adopted, copies of same having been circularized to all members of Council. Carried.

CORRESPONDENCE

/ Letter from Mrs. P. Meier, 650 West Keith Road, requesting school zone signs and crosswalk sign near Bewicke Avenue and West Keith Road.

Moved by Alderman Wallace, seconded by Alderman Chadwick that Mrs. P. Meier be advised that there is a pedestrianactivated light at the intersection of Bewicke Avenue and Marine Drive and a concrete sidewalk from Marine Drive to 15th Street on the West side of Bewicke Avenue and from 15th Street to 17th Street on the East side; that there is no reason for children to walk on the road; and that Council does not feel it is practical to put school zone signs several blocks away from the school. Carried.

Letter from the North Vancouver Schools Band requesting a 1967 grant in aid of the Band's trip to Expo-67 in Montreal.

Moved by Alderman McDevitt, seconded by Alderman Dewhurst that the above letter be referred to the 1967 Budget with the recommendation that a grant of at least \$500.00 be made to the Band for this purpose: Carried.

Jetter from Mr. R.M. Howard, Solicitor for Miss E.L. Simpson, accepting an offer made by Council to purchase Lots 5, 6 & 7, Block 62, D.L. 548, on March 10th, 1966.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that the above letter be tabled until the amount of compensation to be paid by the City for the property involved is settled by a Board of Arbitration. Carried.

Letter from Mr. A.G. MacKinnon, Solicitor for Beryl Joyce # Smith, accepting an offer from the City in the amount of \$9,666.66 as her share of compensation for Lot 14, Hock 62, D.L. 549.

Moved by Alderman Chadwick, seconded by Alderman Dewhurst that this Council confirm the settlement reached by the City Solicitor and Mr. A.G. MacKinnon, Solicitor for Beryl Joyce Smith, under which the City will pay the sum of \$9,666.66 for her one-third interest in Lot 14, Block 62, D.L. 549; AND THAT the latter sum be expended from the "City Hall Site and Construction Special Reserve Fund By-law, 1965", less any required adjustments for taxes, rent, etc. Carried. Circular letter from the Canadian Federation of Mayors and Municipalities advising of the 30th Annual Conference to be held in Montreal, July 23rd - 27th, 1967.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the Canadian Federation of Mayors and Municipalities be advised that at least four delegates from the City of North Vancouver will attend the Oth Annual Conference to be held in Montreal July 23rd - 27th, 1967; THAT the City Clerk be authorized to make the necessary arrangements for accommodation for such delegates; AND THAT the necessary expenses in this regard be paid by the City. Carried.

2 Letter from Ocean Cement Limited, asking for traffic regulations on the Low Level Road during the construction of the Saskatchewan Grain Wheat Pool Elevator project.

The City Clerk advised that the next letter on the agenda dealt with the same matter.

Letter from Dillingham-Marwell requesting special traffic regulations on the Low Level Road during construction of the elevator in this area.

Moved by Alderman Goldsworthy, seconded by Alderman McDevitt that Dillingham-Marwell, and Ocean Cement Limited be advised that the City will construct a detour road for public traffic at the expense of the contractors for the new Saskatchewan Grain Wheat Pool Elevator, cost not to exceed \$2,500.00, or give permission for the contractors to construct the said detour road at their expense, provided such road is constructed in accordance with the City's specifications. Carried.

Letter from Mr. E. Plant, 254 West Windsor Road, regarding # traffic conditions on Marine Drive.

Discussion followed.

Alderman Wallace advised he had talked with Mr. Plant and had pointed out to him that while Council is aware of the traffic problem on Marine Drive they cannot agree that the light at the corner of Hamilton and Marine Drive is the cause nor can they take full responsibility for traffic congestion at Pemberton and Marine.

Further discussion followed.

Moved by Alderman Wallace, seconded by Alderman McDevitt that the above letter be received and filed. Carried.

APPLICATIONS TO PURCHASE PROPERTY

Application from Cronkhite (Vancouver) Ltd. to purchase Lot 2 of Lot 6, Block X, D.L. 265, on the East side of Hanes Avenue between First and Third Streets, for the sum of \$7,500.00.

The City Clerk advised that this application can now be proceeded with as the Company has complied with our requirements and have submitted general plans and also a lay-out plan of their proposed development of the property.

Moved by Alderman Chadwick, seconded by Alderman Dewhurst that the application of Cronkhite (Vancouver) Ltd. to purchase Lot 2 of Lot 6, Block X, D.L. 265 for the sum of \$7,500.00 be accepted subject to development of the property generally in accordance with plans submitted to Council; AND THAT the sale of this lot be placed on the next by-law for conveyance. Carried. The City Clerk advised that four additional applications to purchase property had been received.

The Clerk advised there were two matters dealing with applications to purchase property which do not appear on the s agenda, the first one concerning the application from Keith Plumbing who purchased property under the name of Star Holdings Ltd. He said the Company are now requesting an extension of time in which to commence building on the property, as under the Conveyance Agreement the City has until Oct. 26, 1966 to exercise its option to re-purchase. Moved by Alderman Chadwick, seconded by Alderman Dewhurst that Keith Plumbing be advised that unless they commence construction of their proposed building on Lot 1 of Lot 6, Block X, D.L. 265 by October 17th, 1966, the City will exercise its right under the Conveyance Agreement, to repurchase the property by resolution on that date.

Carried.

The Clerk advised that he would also like to report on an application from Housecraft Enterprises for the purchase of Lot 8, Block 33, D.L. 272, on the south-west corner of Cotton Road and Brooksbank Avenue, preliminary approval having been given by Council on August 4th, 1966. He advised that an Application to Purchase form had been sent to the Company on August 10th, 1966, for completion but has not been returned.

Moved by Alderman Dewhurst, seconded by Alderman McDevitt that Mr. V. Lone be advised that Council cannot at this time exchange his Lot 14, Block 12, D.L. 550 for other City property. Alderman Chadwick indicated that he disagreed with the above motion.

Discussion followed.

The motion was then put and carried with Alderman Chadwick requesting to be recorded as voting against the motion.

Whereupon the said By-law was read a third time in short form, passed subject to reconsideration and numbered 3734.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the "Temporary Loan By-law, 1966, Amendment By-law" be now reconsidered. Carried.

Whereupon the said By-law was reconsidered.

Moved by Alderman Wallace, seconded by Alderman Dewhurst that the above By-law be finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal. Carried.

Whereupon the said By-law was finally adopted, signed by the Mayor and City Clerk and sealed with the Corporate Seal.

Alderman Dewhurst advised the meeting that as a result of conversations he has held with all parties involved, the resolution prepared by the Health and Civic Affairs Committee need not now be passed.

Moved by Alderman Dewhurst, seconded by Alderman McDevitt that the letter from the North Vancouver Christmas Bureau be received and filed, and that Mrs. L.S. McGill be advised that the facilities in the basement of the

- / Justice Administration Building, used by the Bureau last year, are available to them again at this time. Carried.
- Letter from the North Vancouver Recreation Centre Board advising the Board is going to study community recreation and social welfare facilities in North Vancouver.

Moved by Alderman Dewhurst, seconded by Alderman Chadwick that the North Vancouver Recreation Centre Board be advised that this Council would appreciate the Board confining its activities to the operation and maintenance of the Recreation Centre in accordance with the powers given to the Board by the respective By-laws of the City and District, and the proposed study of social welfare facilities as contemplated by the Board should not be undertaken as such an activity is outside the powers and jurisdiction of the Board as established by the said By-laws.

Members of the Council felt that this study might be carried out by a Committee appointed jointly by the District of North Vancouver and the City of North Vancouver.

The motion was then put and carried.

J Letter from the B.C. Hydro & Power Authority enclosing plans and requesting approval for the construction of a transmission line crossing the City cemetery.

Moved by Alderman McDevitt, seconded by Alderman Wallace that the request of the B.C. Hydro & Power Authority for an easement to construct a power line across the City Cemetery be referred to the City Solicitor for report, it being considered at this time that there is no objection to the request being granted. Carried.

Letter from School District No. 44 re continuance of # Steering Committee on Labour Relations matters, etc.

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that the School Board be advised that the City of North Vancouver does wish to retain the Steering Committee, but that the City does justify its action which the Council took in extending the M.S.A. Extended Health Benefits to the City employees at the time negotiations were being carried out. Carried.

Letter from the North Vancouver Civil Defence Committee 5 suggesting a reception for members of the R.C.M.P. Auxiliary Police.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that a reception be held for North Vancouver Auxiliary Police, up to a maximum cost of \$200.00, and subject to the District of North Vancouver confirming it will participate by paying half the cost. Carried.

Mayor Cates advised that two further letters had been received since the close of the agenda and asked whether Council wished to deal with these at this point.

Agreed.

The Council then considered an application submitted on behalf of Lions Gate Hospital by its Architects to construct a temporary storage building, to be used for

Discussion followed.

Moved by Alderman Goldsworthy, seconded by Alderman McDevitt that the applicant be advised that, although the Council is desirous of doing whatever it can to approve this facility, inasmuch as this temporary building is anticipated to remain for at least five years and would not, as pointed out by the Building Inspector, harmonize with surrounding buildings, the Council would ask them to find some other source of storage space. Carried.

The Council then considered a letter received from Ocean Cement Ltd., advising that the construction of a detour road at the Saskatchewan Wheat Pool site is not feasible at this time, and asking whether, under prevailing conditions, the Low Level Road could be closed and used for local traffic only for the completion of the project.

Discussion followed.

Moved by Alderman Goldsworthy, seconded by Alderman Dewhurst that Ocean Cement Ltd. be advised that the Council still feels, in view of advice received from the Traffic Detail of the R.C.M.P., that the construction of a detour road at the site, to permit better access and turning facilities, is the best solution to the problem, and the Council does wish them to build this bypass road, which would cost approximately \$2500.00, as recommended earlier by this Council; and further that as it is expected the P.G.E. railway strike will shortly be concluded, the inconvenience from potash and sulphur shipment unloading will soon be terminated.

Alderman Chadwick asked whether the Traffic Detail of the Police Department should not direct traffic in the area between the hours of 7:00 and 8:00 A.M. and 4:00 and 5:00 P.M. during this construction period.

Her Worship suggested that lowering the speed limit from 40 to 30 miles per hour on this road might also help.

The motion was then put and carried.
