- Alderman McDevitt advised that the fence constructed by 4 the contractor building the Toronto-Dominion Bank building at 15th and Lonsdale obscures the adjacent jewellery store, the owner of which has been refused permission to place a sign on the fence.

Moved by Alderman McDevitt, seconded by Alderman Chadwick that a letter be written asking the contractor and the Toronto Dominion Bank if they will permit the merchant, Kris's Watch Shop, to place his sign on the fence. Carried.

Moved by Alderman Wallace, seconded by Alderman Chadwick that this matter be referred to the Transportation Committee for report, and the Public Utilities Commission be advised this Council is giving consideration to the application.

Carried.

Letter from the Department of Municipal Affairs advising that there is the sum of \$25,000.00 under By-laws 3493 and 3672 which has not been used and requesting a certified copy of a Council resolution stating that there will be no further borrowing under By-law No. 3493.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the Department of Municipal Affairs be advised the City does not require any further borrowing under By-law No. 3493. Carried.

Letter from Emery Politzer, 1616 Eastern Avenue, asking if they can complete another suite in their apartment block at that address.

Moved by Alderman Chadwick, seconded by Alderman Dewhurst that this matter be referred to the Building Committee for report.

Carried.

Letter from the Royal Canadian Mounted Police advising that the Municipalities in 1967 - 1968 will be required to pay \$5,378.00 per annum for each of the first five members of the Detachment, and \$8,067.00 per annum for the sixth and each additional member under the contract.

#### BOARD OF WORKS & WATERWORKS COMMITTEE

Alderman McDevitt submitted the following recommendations on behalf of this Committee:

RECOMMEND that the necessary by-law be prepared for the construction of a six-foot concrete sidewalk on the west side of Jones Avenue from 16th Street to 23rd Street, the estimated cost of \$14,834.00 to be included in Supplementary budget for 1966.

Moved by Alderman McDevitt, seconded by Alderman Wallace that the above recommendation of the Board of Works and Waterworks Committee be adopted. Carried.

RECOMMEND that the following City-owned equipment, formerly in Lonsdale Hall, be turned over to the care and custody of the Recreation Centre: 254 wooden chairs 36 cups 227 side plates 130 dinner plates

Ward and Associates in respect to their amalgamation study. He referred particularly to outside contractors for new construction and maintenance on Page 7; new buildings on Page 9; staffing on Page 9; capital expenditures on Page 10; Mayor's secretary on Page 13; senior management on Pages 17 and 18; Treasurer's department on Page 19; legal advisor on Page 19; summary of staff on Page 36; law enforcement on Page 42; water system on Page 58; and further that no mention is made in the report regarding the City's own water system, the reduced water rates in the City, and the fact that

the City refunding debt will be completely paid up in 1972.

Moved by Alderman Goldsworthy, seconded by Alderman McDevitt that the sum of \$6,000.00 be paid to Joseph B. Ward & Associates (International) Ltd., and they be advised the Council is not satisfied with the report as it does not comply with the terms of reference in the agreement with the City dated June 10th, 1966.

Alderman McDevitt also expressed his dissatisfaction with the report, remarking particularly that the terms of reference asked for both advantages and disadvantages to be shown, and this he felt had not been done. He stated further that the study did not qualify its figures and therefore its findings could not be justified.

Alderman Chadwick suggested that Council should meet with the writers of the report to obtain their reasons for certain remarks.

Alderman Wallace felt that without substantiation, which Joseph B. Ward and Associates may be able to give, the report is worthless.

Her Worship then requested that her statement, as follows be recorded in the Minutes:

"I am dissatisfied with this report for which such a large sum of money is to be paid and I make no apologies for this statement because I believe it is my duty to give priority to the interest of the taxpayers of the City of North Vancouver at all times.

"The report infers that amalgamation will result in a saving to all the people of the area but it contains mis-statements, and there are omissions which make it impossible for me to convey to City residents a clear picture of the financial advantages and disadvantages of amalgamation."

The motion was then put and carried.

Moved by Alderman Chadwick, seconded by Alderman Wallace that Joseph B. Ward & Associates (International) Ltd. be advised this Council wishes to meet with them before the end of the month to discuss the report and questions pertaining to it.

Carried.

Alderman McDevitt is recorded as voting against this motion.

Alderman Goldsworthy contended that the Association should be at liberty to circulate their petition in their attempt to obtain the required percentage of

, homeowners within a 200 ft. radius to give approval.

Alderman Chadwick asked whether, instead of passing this motion, the Mayor might not write to the Association and ask them to cease harassment of neighbours who have refused to sign their petition.

The motion was then put and carried on division.

Alderman Chadwick is recorded as voting in opposition to this motion.

Her Worship, Mayor Cates, stated that the agreement with Joseph B. Ward & Associates stipulated that only twelve copies of the report would be supplied to the City and twelve copies to the District, and this is the reason copies are not available for individuals and organizations. The specified number of copies was placed into the agreement by Joseph B. Ward & Associates.

The motion was then put and carried.

Alderman Chadwick questioned the wisdom of giving this matter publicity and stated that it should simply be understood the Council supports any appointment which the Mayor may make to the suggested Committees.

Discussion followed.
