Present:

Mayor Cates called this Regular Meeting of the Council to order.

MINUTES

Moved by Alderman Chadwick, seconded by Alderman Wallace that the Minutes of the Special Meeting of Council held on April 14th, 1967, and of the Regular Meeting of Council held on April 17th, 1967, and the Minutes of a Court of Revision held on April 24th, 1967, be taken as read and adopted, copies of same having been circularized among all Council Members. Carried.

CORRESPONDENCE

/ Letter from H.L. Waddell & Associates Ltd., asking if the Council would give permission for a building encroachment at 640 East 14th Street on to the public lane.

Moved by Alderman Chadwick, seconded by Alderman Wallace that this letter be referred to the Finance and Legal Committee for a recommendation. Carried.

Letter from the Kinsmen Club of North Vancouver applying for ² a grant of \$250.00 to their Kinsmen Queen Contest during the Carnival celebrations.

Members of Council briefly discussed the organization of the Queen contest this year.

Moved by Alderman Suttis, seconded by Alderman Dewhurst that a grant of \$250.00 for the Kinsmen Queen Contest be awarded to the Kinsmen Club of North Vancouver. Carried.

Letter from the North Vancouver Recreation Centre Board asking ³ for approval of the Board entering into contracts for services, etc.

Alderman Chadwick explained the necessity for this request, it being made because the Board does not have authority under the existing by-law to enter into agreements covering monies not included in the current year's budget.

Moved by Alderman Chadwick, seconded by Alderman Wallace that the City Council ratify the execution of the contract between the North Vancouver Recreation Centre Board and Best Cleaners and Contractors Ltd. for a two year period commencing February 15th, 1967, at a monthly charge of \$2,388.00. Carried.

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that the City Solicitor be asked, in consultation with the FS

- District Solicitor, to draw up the necessary amendment to the North Vancouver Recreation Centre By-law expanding the present powers of the Board to authorize it to enter into contracts for labour, services, etc., for a two or three year period, provided sufficient monies are in the budget for the first year's portion.
- Letter from J.H.S. Fletcher and W.E. Stinson, 2008 Fell Avenue, requesting the demolition of a vacant building at 2020 Fell Avenue.

Moved by Alderman Chadwick, seconded by Alderman Dewhurst that this matter be referred to the Building Committee for a report. Carried.

Letter from Mr. and Mrs. S.A. Lane, 836 Grand Boulevard, asking the Council to again consider making traffic on the Grand Boulevard in one direction on each side of the Boulevard.

Moved by Alderman Dewhurst, seconded by Alderman Freeze that this matter be referred to the Transportation Committee and the Board of Works Committee for a study and report.

Carried.

4 Letter from the Vancouver Art Gallery applying for a grant of \$1,000.00.

Moved by Alderman Goldsworthy, seconded by Alderman Wallace that the application of the Vancouver Art Gallery for a grant in the amount of \$1,000.00 be not granted.

Alderman Goldsworthy, in presenting this resolution prepared by the Finance and Legal Committee, stated that in his opinion the City of North Vancouver should not be expected to make this type of a grant because it is mainly a "bedroom municipality", supplying workers to the industrial and commercial areas of the City of Vancouver, which areas provide a much greater tax revenue than residential property.

The motion was then put and carried.

- 6 Letter from School District No. 44 enclosing 1967 Budget.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the Annual Budget of School District No. 44 (North Vancouver), for the year 1967, be received and filed.

Alderman Goldsworthy, in presenting this resolution prepared by the Finance and Legal Committee, stated that the increases in the home owner grant are offset by the increases in the School Budget over the years. He complimented the School Board for providing educational facilities of a high calibre in North Vancouver, but stated there is little the Council can do about school costs.

The motion was then put and carried.

7 Letter from Griffiths & Griffiths, Auditors, making comments concerning the City's 1966 Financial Statements.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the letter from Griffiths & Griffiths, Auditors, dated April 12th, 1967, be received and filed. Carried.

Letter from J.T. Edwards, Solicitor, on behalf of Cronkhite (Vancouver) Ltd., asking for an extension of time, etc., in which to build on Lot 2 of Lot 6, Block X, D.L. 265, on Hanes Avenue. Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that Cronkhite (Vancouver) Ltd. be advised that Council will grant an extension until May 31st, 1967, in their agreement with the City, for the commencement of construction of the improvements on Lot 2 of Lot 6, Block X, D.L. 265; AND THAT all time schedules, completion date, etc. be extended accordingly; AND FURTHER THAT the Mayor and City Clerk be authorized to execute the necessary document in this regard.

Letter from Keith Plumbing & Heating Co. Ltd., advising they wish to go ahead with development of Lot 1 of Lot 6, Block X, D.L. 265, at Hanes Avenue and Third Street.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that Keith Plumbing & Heating Co. Ltd. be advised that Council passed a recommendation on April 17th, 1967, authorizing the City Solicitor to proceed with the reconveyance of Lot 1 of Lot 6, Block X, D.L. 265, back to the City; AND THAT Mr. W.R. Stubbs, Solicitor for the Company, be advised that Council will not reconsider this action in view of the long delay by the Company in developing this property.

Alderman Goldsworthy reviewed the past history of this sale and the Council Members agreed that Council must live up to its established policy.

The motion was then put and carried.

Moved by Alderman Wallace, seconded by Alderman Goldsworthy that the circular report from the Union of B.C. Municipalities, dated April 17th, 1967, on the disposition of resolutions endorsed by the 1966 Convention of the Union, etc., be received and filed. Carried.

Letter from Orr's Stores advising they have complied with the 5 City's requirements for a storm sewer connection at 1320-1336 Lonsdale Avenue under protest.

Moved by Alderman Suttis, seconded by Alderman Dewhurst that the letter dated April 18th, 1967, from Orr's Stores regarding a storm sewer connection at 1320-36 Lonsdale Avenue be received and filed.

Alderman Suttis, in presenting this resolution, advised that the situation has been known for some time. However, the urgency in correcting the matter occurs because of the work being done on Lonsdale Avenue this year.

The motion was then put and carried.

The motion was then put and carried.

Letter from Canada Iron Foundries Ltd., Dominion Bridge Co. Ltd., Northern Construction Co. and J.W. Stewart Ltd., and Swan Wooster Engineering Co. Ltd., submitting a Brief showing a proposed new parallel span across the First Narrows.

Moved by Alderman Goldsworthy, seconded by Alderman Wallace that the letter from Canada Iron Foundries Ltd., Dominion Bridge Co. Ltd., Northern Construction Co. & J.W. Stewart Ltd., and Swan Wooster Engineering Co. Ltd., submitting a Brief showing proposed new parallel span across the First Narrows, be received and filed.

Alderman Goldsworthy stated the proposal submitted is not unlike the proposal which was contained in the original proposition considered by the Technical Committee, and further that in the opinion of the Committee considering finances, it does not offer any substantial savings, and in addition leads traffic to inconvenient locations at both ends.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Alderman Wallace presented the following recommendation on behalf of this Committee:

RECOMMEND that the Junior Amateur Sports Stadium Society be advised that the Council is sympathetic towards their request for a grant to the Building Fund of the proposed Junior Amateur Sports Stadium in Central Park and that the sum of \$2,811.00 has been included in this year's budget for this project.

Moved by Alderman Wallace, seconded by Alderman Goldsworthy that the above recommendation of the Finance & Legal Committee

be adopted.

Alderman Chadwick pointed out that this resolution differs from that prepared by the Finance Committee last week inasmuch as the City, in formulating its budget, has been able to allocate monies for this purpose.

Alderman Goldsworthy noted that the decision to alter the resolution was approved by all Council members.

Alderman Freeze commented that he favoured the resolution, but stated he saw little difference in the benefits derived by children from this Stadium to the benefits derived from the Art Gallery, which grant had been refused this evening.

The motion was then put and carried.

Alderman Goldsworthy submitted the following recommendations on behalf of this Committee:

RECOMMEND that Ker & Ker be advised that inasmuch as their firm had an office within the City of North Vancouver at the time negotiations were entered into for the sale of Lot 2, Block X, D.L. 265, to Brantford Holdings Ltd., commission on the said sale will be paid to them when conveyancing is completed.

Moved by Alderman Goldsworthy, seconded by Alderman Wallace that the above recommendation of the Finance and Legal Committee be adopted.

Alderman Dewhurst contended that the City has co-operated fully with the developers of this property, and that the City properties were sold for consolidation with privately obtained property for which a premium price was paid. He felt the City's price should be net.

Alderman Dewhurst moved that this resolution be tabled until such time as Council obtains more information on the matter,

No seconder was obtained for this tabling motion.

The motion was then put and carried.

Alderman Dewhurst and Mayor Cates are recorded as voting in opposition to the motion, and advised their opposition was to the payment of commission only.

RECOMMEND that the Mayor and City Clerk be authorized to execute a Discharge with respect to certain title conditions registered against Lot A of Lot 5, Block X, District Lot 265, owned by the B.C. Equipment.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of the Finance and Legal Committee be adopted.

Alderman Goldsworthy, in presenting this recommendation, stated that he has received assurances from the Company that they will pave the lot, go along with the proposed sidewalk on Marine Drive, and install planters along the side of their property.

The motion was then put and carried.

Alderman Chadwick presented the following recommendation on behalf of this Committee:

5 RECOMMEND that the City Solicitor be instructed to prepare a

by-law for the purpose of expending the sum of \$119,238.01 from "The Corporation of the City of North Vancouver Hospital Grant By-law, 1958" which, together with a grant of \$11,928.99 from current revenue will make up the City's share of a grant to the Board of Management of the Lions Gate Hospital for the purpose of completing the sixth and seventh floors of the said Hospital and making certain additions to the said Hospital and for acquiring additional land therefor, in accordance with the resolution of Council passed on May 16th, 1966, subject to the District of West Vancouver and the District of North Vancouver providing their one-third share of the municipal portion of the total cost.

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Alderman Goldsworthy presented the following recommendations on behalf of this Committee:

RECOMMEND that the necessary by-law be prepared to expend the sum of \$100,000.00 from Tax Sale Land Reserve Account to take care of the 1967 storm sewer program.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Alderman Goldsworthy then presented a summary of revenues and 3 expenditures of the 1967 Annual Budget and asked whether Council would give approval in principle to the Budget this evening in order that it may be presented to the Minister of Municipal Affairs prior to May 15th, 1967, as required.

Alderman Goldsworthy gave a brief explanation of the items contained in the Budget, and advised that the general mill rate, according to this Budget, will be 38 mills, compared with 38.6 mills last year.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the 1967 Budget of Revenue and Expenditures totalling \$5,225,308.00, be approved in principle and forwarded to the Minister of Municipal Affairs for approval under the "City of North Vancouver Refunding Act", and that the necessary by-law be prepared when such approval has been received. Carried.

Alderman Chadwick asked whether the Library Board could be 4 advised that their full budget has been restored, but Alderman Goldsworthy asked that this be delayed until May 15th, 1967.

NORTH VANCOUVER RECREATION CENTRE BOARD

Alderman Chadwick advised there was no report on behalf of this Board.

BOARD OF WORKS, WATERWORKS, & ZONING COMMITTEE

Alderman Suttis presented the following recommendation on behalf of this Committee:

/ RECOMMEND that Mrs. J.S. Bartley, 335 East 9th Street, be advised that the City of North Vancouver will endeavour to make the necessary improvements to East Ninth Street, from Grand Boulevard to Eighth Street, such as paving, storm sewer and curbing, and it is hoped to include this in the 1968 Budget.

Moved by Alderman Suttis, seconded by Alderman Dewhurst that the above recommendation of the Board of Works, Waterworks, and Zoning Committee be adopted. Carried.

Alderman Chadwick then asked whether he could advise the Council on behalf of the Recreation Centre Board that plans are underway to blacktop the parking lot at the Recreation Centre prior to the Centennial Caravan arriving on the 25th of June. He said tenders have been called for the lighting of the parking lot. However, he said there was uncertainty as to whether this could be installed because it may interfere with the Caravan.

PARKS & BUILDINGS COMMITTEE

Alderman Dewhurst submitted the following recommendation on behalf of this Committee:

BOARD OF WORKS, WATERWORKS & ZONING COMMITTEE

Alderman Suttis advised that his Committee had prepared a recommendation to purchase certain equipment at an estimated cost of \$76,300.00 and which included the purchase of a street sweeper at a cost of \$22,000.00. He advised that in the past the City has always rented a sweeper, but because of previous Council discussions, it was decided to purchase one this year. However, a letter has just been received **f**rom the rental company in which they assure us that a machine can be made available on 24 hours notice, and that this alters our thinking with regard to rental or purchase. Alderman Goldsworthy advised that this is one item the City can afford, and with the immense paving program in the City this year, he would like to see this amount remain in the recommendation. He said that this is one piece of equipment we could share with the District of North Vancouver for use on boundary streets and also on Lonsdale Avenue right up to the top, and he therefore recommended that the Board of Works Committee retain this item in their recommendation.

Alderman Chadwick advised that he did not agree, pointing out that the cost of the sweeper is a large investment for this municipality. He suggested that a survey be made of the costs in the surrounding municipalities.

Alderman Wallace indicated he was in favour of the purchase of the sweeper, and suggested that because of Council's sidewalk policy, more and more machine paved streets will be added each year, a good deal of the attractiveness will be lost if the streets are not kept clean.

Alderman Freeze suggested that the Board of Works should take a look at the rental offer before making a decision, and he recommended that the item should be deleted from the recommendation pending further consideration.

Alderman Dewhurst agreed he would like this matter laid over for further consideration.

Moved by Alderman Suttis, seconded by Alderman Freeze that the matter of the purchase of a Street Sweeper, 3½ to 4 cu.yd. costing \$22,000.00 be referred back to the Board of Works Committee for further study, and also to the Finance & Legal Committee for consideration and report. Carried.

Moved by Mayor Cates, seconded by Alderman Dewhurst that the Council arrange for the mailing of a questionnaire to the taxpayers with their 1967 Tax Notices, asking for an expression of opinion on the amalgamation of the City and District.

Mayor Cates said she would like to give a word of explanation at this time with respect to an item which had appeared in the weekend Citizen about the release of information of a notice of motion presented by Alderman Chadwick at the same time as her motion was presented. She said there was absolutely no breach of confidence on the part of any member of staff as inferred in the press item. She said some weeks ago she had urged Council to put a question to the people asking for an expression of opinion on amalgamation, but that Council did not agree to it at that time.

Mayor Cates advised that in order to mail this questionnaire with the tax notices, an early decision would have to be made.

Alderman Dewhurst said that in seconding the motion, it was his opinion that this was the clearest, quickest and probably the simplest way of getting an expression of opinion, and he hoped the other members of Council would see it in that light.

Alderman Freeze advised he was unable to support this motion, as he felt there are problems involved that cannot be overlooked, such as the wording of the questionnaire and also how the results would be interpreted.

In speaking to the motion, Alderman Wallace said there are two things which concern him, first, are we in any better position now to answer taxpayers' questions on amalgamation than we were a year ago, and secondly, the Minister of Municipal Affairs in two recent meetings spelt out very clearly the procedure which should be followed, viz. submission of an agreement to the taxpayers of both municipalities at the same time. He said, anxious as he is for an expression of opinion on this matter, he could not support the motion, and he did not think we have any other course but to follow the procedure outlined by the Minister.

Alderman Suttis also spoke against the motion, pointing out that the taxpayers in both the City and District of North Vancouver must first be advised of what amalgamation will entail for them. He said he believed the District territory is already too large, and that perhaps some thought should be given to exploring the extension of the City itself so that two medium sized municipalities would result.

Alderman Suttis said he is not an advocate of amalgamation, but felt that further study should be given to the possible benefits to the City and District.

Alderman Chadwick said he would like to state that with respect to the press statements, he did not transfer any information to staff regarding his notice of motion on the amalgamation question.

Alderman Chadwick suggested that perhaps his motion could be embodied in the Mayor's resolution if the wording of the questionnaire was similar to the final paragraph of his resolution. He said if Council would support putting some sort of notice to the people, this would prviously be the quickest way to do it.

Moved by Alderman Chadwick, seconded by Alderman Freeze, that the resolution submitted by Mayor Cates be tabled for further discussion at a Committee Meeting of all Council Members to be held at 7:30 p.m. on Monday, May 29th, 1967, In Camera.

Alderman Suttis advised that whereas the Zoning Committee was most sympathetic to the Private Hospital application the fact that under this same clause a Retarded Children's School could be instituted here had not been considered.

Alderman Freeze pointed out that if the City Solicitor's ruling is applied to P-2 Zoning then the Council could not zone any property within the City for Church Use unless it was located next door to another church.

Alderman Wallace pointed out his remarks had been made in connection with the question of zoning for the advantage of a particular individual.

Alderman Chadwick recalled that the City Planner and the Advisory Planning Commission have recommended in favour of this application. The motion was then put and carried after a recorded vote.

Against: Mayor Cates, Alderman Wallace.

The City Clerk then advised it might be wise to obtain the City Solicitor's opinion as to whether the present By-law is practical to operate under as it concerns rezoning for Assembly Use.

Moved by Alderman Chadwick, seconded by Alderman Wallace that the City Solicitor be asked to report as to whether the present Zoning By-law is practical as it pertains to zoning for Assembly Use in the P-2 Zone. CARRIED

Alderman Suttis submitted the following recommendation on behalf of the Board of Works, Waterworks and Zoning Committee noting that the wording had been altered somewhat:-

RECOMMEND that the amendment to the Zoning By-law required by the Department of Highways regarding parking in the Heavy Industrial Zone be approved AND THAT the said amendment be considered at the same Public Hearing being held to consider the rezoning of Lots 18, 19 and 20, Resub. "B", Block 215, D.L. 544.

Moved by Alderman Suttis, seconded by Alderman Freeze that the above recommendation be adopted. CARRIED

Moved by Alderman Chadwick, seconded by Alderman Dewhurst that this meeting now adjourn. CARRIED
