MINUTES of the Regular Meeting of the City Council held in the Council Chambers, City Hall, on Monday, November 6th, 1967 at 8:08 p.m.

Present:

Her Worship Mayor C.M. Cates, Alderman J.A.W. Chadwick, Alderman T.R. Dewhurst, Alderman G.A. Freeze, Alderman F.R. Goldsworthy, Alderman J.A.S. Suttis and Alderman W.L. Wallace.

Mayor Cates called this Regular Meeting of Council to order.

MINUTES

Moved by Alderman Chadwick, seconded by Alderman Dewhurst that the Minutes of the Regular Meeting of Council held on October 16th,1967, be taken as read and adopted, copies of same having been circularized among all Council members. Carried.

CORRESPONDENCE

Letter from J. Kilbey, 304/230 East 16th Street, advising that store workers do not want to be penalized by extended shopping hours.

Moved by Alderman Chadwick, seconded by Alderman Dewhurst that in view of the fact a resolution regarding extended shopping hours will be considered later this evening that this letter be received and filed. Carried.

Letter from Mrs. J.H. Smith, 992 20th Street, West Vancouver, complaining of the noise on 13th Street which annoys hospital patients.

Moved by Alderman Chadwick, seconded by Alderman Freeze that this matter be referred to the City Superintendent with power to act in regard to the installation of the necessary signs in the vicinity of the Lions Gate Hospital.

Alderman Goldsworthy emphasized that all four streets surrounding the hospital should be signed in this manner.

The motion was then put and carried.

Letter from the North Vancouver Christmas Bureau, asking for a grant towards the Bureau's work.

Moved by Alderman Goldsworthy, seconded by Alderman Suttis that the City make a grant of \$200 to the North Vancouver Christmas Bureau in recognition of the work they do on behalf of those in need. Carried.

Letter from Diamond Developments Ltd., asking for recon-, sideration of the Council's turndown of their application in July for a rezoning of property at 14th and Chesterfield for apartment purposes.

Moved by Alderman Chadwick, seconded by Alderman Dewhurst that the application of Diamond Developments Ltd. for the rezoning of Lot A at 14th Street and Chesterfield from duplex to RM1 be reconsidered. Carried unanimously.

Mayor Cates then asked if Council wished to set a date for this reconsideration.

Moved by Alderman Chadwick, seconded by Alderman Freeze that the reconsideration of Diamond Developments Ltd. application for rezoning of Lot A at 14th Street and Chesterfield be held at the next Committee Meeting of all Members of Council on November 13th, 1967. Carried.

Letter from Len Churchill, Vancouver Sun Agent, asking ² if they could use a portion of City owned property in Block 257 at Larson Road and Larson Crescent in view of the elimination of their distribution hut site at 26th and Westview.

Moved by Alderman Dewhurst, seconded by Alderman Suttis that permission be granted Mr. Len Churchill, Vancouver Sun Agent, to lease a portion of City owned property in Block 257, D.L.544, a triangular property at Larson Road and Larson Crescent, for the location of their carrier station, subject to the approval of the City Superintendent that the usual procedures and restrictions are observed. Carried.

3 Letter from John R. Wheatley, 1844 Grand Boulevard, asking for an answer from Council on traffic problems on the Grand Boulevard.

Movel by Alderman Freeze, seconded by Alderman Chadwick that this letter be referred to the Transportation, Traffic and Safety and Light Committee for report. Carried.

Letter from the North Vancouver Recreation Centre Board ⁴ advising that the submission of their 1968 Provisional Budget will not be completed by the October 31st deadline, etc.

Alderman Chadwick reported that he expects this budget will be in the hands of the Council at the end of November.

Moved by Alderman Freeze, seconded by Alderman Goldsworthy that the North Vancouver Recreation Centre Board be given a thirty day extension with regard to the submission of their 1968 Provisional Budget. Carried. / Letter from Goodyear Tire & Rubber Co. of Canada Ltd., applying for rezoning of p roperty on the north side of East 14th Street to CS-1 use.

Moved by Alderman Chadwick, seconded by Alderman Dewhurst that this letter be referred to the Zoning Committee for a report. Carried.

z Letter from Mr. F.J. Gallagher, 433 East 3rd Street, protesting traffic noise.

Moved by Alderman Chadwick that Mr. J. Gallagher, 433 East Third Street be advised that the whole problem of noise in his area is under study, and that he be advised that once improvements have been made to the Low Level Road all heavy trucks will then be diverted on to this road. Carried.

Application from Dirasser, James & Jorgenson, Architects, 3 applying for the rezoning of Site 4 in the Westview Shopping Centre to Site 1 use, etc.

Moved by Alderman Suttis, seconded by Alderman Dewhurst that Dirassar, James and Jorgenson, Architects, be advised that before consideration is given to their application on behalf of the Westview Shopping Centre to rezone Site 4 on Comprehensive Development 1 to Site 1, with the exception of a 25 foot strip to be rezoned to Site 3, that they be asked to submit a plan bringing the parking requirements on the site to the necessary figure. Carried.

Letter of application from Mitten Realty Co.Ltd., applying for permission to move a house from 2444 St. Georges Avenue to a lot on the south side of the 700 Block East 16th Street.

Moved by Alderman Dewhurst, seconded by Alderman Suttis that approval be granted to Mitten Realty Ltd., applicants on behalf of Mr. Aleksich, to move a house from 2444 St. Georges Avenue on to Lot 1, Block 7, D.L.616, situated on the south side of the 700 Block East 16th Street, subject to the proper application being received with a plot plan, compliance with all the City by-laws, and subject to the house front facing on to 16th Street, and receipt of the cash completion bond as offered in the letter from Mitten Realty Ltd. dated October 12th, 1967. Carried.

The City Clerk advised that he had received an application to purchase Lot 8, Block 7, D.L.272, being a triangular lot situated on the south side of the 1100 Block East Keith Road. He stated that siting of a building to be constructed there would require the approval of the Zoning Board of Appeal.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the sale of Lot 8, Block 7, D.L.272, situated on the south side of the 1100 Block East Keith Road at \$4,250.00 to Mr. Norman C.F. Kartz, be approved, subject to the siting of the building to be constructed thereon being approved by the Zoning Board of Appeal, and that the necessary by-law be prepared if such approval is given. Carried.

INOUIRIES

Alderman Chadwick inquired whether in view of the traffic congestion which has developed on Marine Drive with the opening of the Capilano Mall Shopping Plaza, the handling of this extra traffic should be included in the terms of reference of the consultant who is presently working on the traffic problems in this area of the City. 258

He felt this matter should be dealt with quickly.

Mayor Cates felt this matter had been taken into consideration by the consultant.

TENDERS.

Report from the City Clerk with respect to tenders received for a number of City lots recently put up for sale.

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy, that the tender received from North Shore Realty Ltd. in the amount of \$8,100.00 for Lots 56, 57 & 58, Block 167, D.L.274; the tender received from Advance Plastics in the amount of \$2,820.00 for Lot 29, Block 154, D.L.274; and the tender received from Gilmour Clark in the amount of \$10,500.00 for the West 75' of Lots 29, 30 & 31, Block 153, D.L.274 be accepted; AND THAT the deposit of the unsuccessful tenderer, Karibou Glass & Millwork Co.Ltd., be returned;

Alderman Dewhurst inquired whether approval from the Fire Marshall should not be obtained prior to the sale of property to a plastics firm in view of the fact that the location of such a use may cause insurance rates of adjacent properties to be increased.

Discussion followed.

Alderman Chadwick suggested that the Industrial Committee 3 be asked to investigate Advance Plastics to see what type of operation they intend to instal on this location, prior to the sales by-law receiving its final reading.

The motion was then put and carried.

The Council then considered the lots not tendered on. Moved by Alderman Chadwick, seconded by Alderman Dewhurst that whereas The Corporation of the City of North Vancouver, (hereinafter called the City), is the owner of parcels of

REPORTS OF COMMITTEES

Background explanations were supplied in each case where recommendations were submitted.

Finance and Legal Committee

Alderman Dewhurst submitted the following recommendation on behalf of this Committee: RECOMMEND that the necessary by-law be prepared to impose a 5% Business Tax commencing in 1968, in the City of North Vancouver, in accordance with the report of the Reference Committee dated October 6th,1967.

Moved by Alderman Dewhurst, seconded by Alderman Freeze that the above recommendation of the Finance and Legal Committee be adopted.

Alderman Chadwick in speaking against the motion stated that the City should lay this matter over until a recommendation has been received from the Amalgamation Committee on whether amalgamation should be proceeded with, or not.

Alderman Freeze contended that enlightened communities are turning more and more to Business Tax, and an amalgamated municipality could either remove the tax or place it on the entire area. He felt this would not hinder amalgamation studies.

Alderman Goldsworthy stated that whereas he considers the Business Tax is appropriate, he is convinced that in view of the amalgamation studies it should be postponed until next year. He felt that the City should not impose this tax until it has been discussed with the District of North Vancouver.

The City Clerk advised that if the Council decides to impose the Business Tax, it must make its decision very soon in order that the By-law may be prepared and passed prior to November 30th,1967.

Alderman Chadwick suggested that the matter be taken up at the next Amalgamation Committee Meeting on November 9th,1967.

Alderman Dewhurst stated he could not see why it was necessary to consult with the District in this matter.

Moved by Alderman Wallace, seconded by Alderman Suttis that this matter be tabled until the next Meeting of Council, thus giving the City representatives on the Amalgamation Committee an opportunity to discuss this matter with the District's representatives at the next Meeting on November 9th,1967, bringing a recommendation back to Council.

The tabling motion was then put and carried.

The City Clerk advised that tabling this matter to the next Regular Meeting of the Council would preclude the preparation of the By-law in the necessary time limit.

Moved by Alderman Wallace, seconded by Alderman Suttis that a Special Meeting of the Council be held on Friday, November 10th,1967 at 4:45 p.m. to discuss the matter of Business Tax, and to hear the report of the City representatives on the Amalgamation Committee on this matter. Carried. Alderman Goldsworthy submitted the following recommendation on behalf of this Committee:

/ RECOMMEND that a grant of \$200.00 be made to the North Vancouver Business Association towards the cost of the "Lonsdale Action Happening" held on September 29th and 30th,1967, such grant being calculated on the basis of 50% of the total costs involved less the City's expenses for flags, barricades and street cleaning; AND THAT this amount be included in the City's Supplementary Budget.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of the Finance and Legal Committee be adopted.

Moved by Alderman Freeze, seconded by Alderman Dewhurst that this recommendation be tabled until after the report of the Transportation, Traffic and Safety and Light Committee report.

Alderman Chadwick submitted the following recommendation on behalf of this Committee:

3 RECOMMEND that the application from Mr. B.J. Ewald, to purchase Lot 8, Block 153, D.L.274, subject to Lots 9 & 10 in the same block being made available for sale, be not accepted; AND THAT he be advised that when a survey has been made of the property, consideration will then be given to the sale of Lots 9 and 10 by public tender.

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Alderman Goldsworthy submitted the following recommendation on behalf of this Committee:

RECOMMEND that a grant of \$200.00 be made towards the \div cost of a Fireworks Display which was held in Grand Boulevard Park on Halloween, such money to be included in the City's Supplementary Budget for this year.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Fire and Industrial Committee

Alderman Chadwick advised that he had no report to make on behalf of this Committee.

Health and Civic Affairs Committee

Alderman Wallace advised that he had no report to make on behalf of this Committee.

Board of Works, Waterworks and Zoning Committee

Alderman Suttis submitted the following recommendations on behalf of this Committee:

RECOMMEND that consideration with respect to the closure of a lane north of 25th Street be struck from the agenda of the Board of Works Committee, as this closure is no longer necessary; AND FURTHER THAT the matter of the closure of 8th Street west of Lonsdale be taken off the agenda of the Board of Works Committee on the understanding that this may be brought forward at a later date if the City Superintendent or a member of the Committee considers this necessary.

Moved by Alderman Suttis, seconded by Alderman Dewhurst that the above recommendation of the Board of Works, Waterworks and Zoning Committee be adopted. Carried.

RECOMMEND that the City Superintendent be instructed to obtain firm estimates on the installation of a reducing valve between the Greater Vancouver Water District 90-inch Seymour main and the City's Water System, the funds to come from the Water Works Reserve Account.

Moved by Alderman Suttis, seconded by Alderman Dewhurst that the above recommendation of the Board of Works, Waterworks and Zoning Committee be adopted. Carried.

Parks and Buildings Committee

Alderman Dewhurst submitted the following recommendation on behalf of this Committee:

RECOMMEND that no action be taken at this time regarding the demolition of the dwelling at 2229 Lonsdale Avenue, but if, within a reasonable length of time, no attempt is made to bring the building to an acceptable standard, the matter be reconsidered.

Moved by Alderman Dewhurst, seconded by Alderman Suttis that the above recommendation of the Parks and Buildings Committee be adopted.

Alderman Chadwick stated a definite time should be given in this resolution in which to bring the building to an acceptable standard.

Discussion followed.

The City Clerk pointed out that whereas the City Building Inspector has stated the house at 2229 Lonsdale Avenue could remain if it is improved, he nevertheless has recommended that the garage and greenhouse at this location should be removed.

Discussion followed.

The motion was withdrawn.

Moved by Alderman Goldsworthy, seconded by Alderman Freeze that pursuant to Section 873 of the Municipal Act, this Council declares that the garage and greenhouse situated on Lots 17 & 18, R/S 4/7, Block 206, D.L.545 known as 2229 Lonsdale Avenue, a nuisance, and hereby directs and orders that the same shall be removed or pulled down by the owner thereof within sixty (60) days after service of the order upon the owner of the said property, the said garage and greenhouse being in the opinion of this Council in so dilapidated and uncleanly condition as to be offensive to the community;

AND THAT in the case of default by the said owner to comply with the order referred to in the above paragraph within the period set forth in same, the Municipality, by its City Superintendent and his Assistants, shall enter and effect such removal or pulling down at the expense of the person so defaulting and hereby orders that the charges for so doing, (including all expenses incidental thereto), if unpaid on the 31st day of December, 1968, shall be added to and form part of the taxes payable in respect to Lots 17 & 18, R/S 4/7, Block 206, D.L.545, as taxes in arrear;

AND FURTHER THAT the dwelling located at the same address be brought up to an acceptable standard in accordance with the City Building Inspector's letter dated October 4th, 1967, by January 30th, 1968. Carried.

Transportation, Traffic and Safety and Light Committee

Alderman Freeze submitted the following recommendations on behalf of this Committee:

RECOMMEND that the report of the City Superintendent advising that he has instituted one hour parking on both sides of 8th Street from Lonsdale to its intersection with 12th Street, and advising that one hour parking already exists on the south side of 12th Street, be received and filed, this action being considered sufficient for the time being for facilitating parking in the area of the Centennial Library, and that Mr. C.R. Rustemeyer be so advised.

Moved by Alderman Freeze, seconded by Alderman Suttis that the above recommendation of the Transportation, Traffic and Safety and Light Committee be adopted. Carried.

RECOMMEND that the City Superintendent be authorized to have two extra street lights installed above the stairs leading down to the Senior Citizens' Housing on First Street and one light in front of, or as close to the front as possible, of the Neighbourhood House on East 2nd Street. Moved by Alderman Freeze, seconded by Alderman Suttis, that the above recommendation of the Transportation, Traffic and Safety and Light Committee be adopted. Carried.

, RECOMMEND that the City Superintendent be instructed to institute two-way traffic on Lonsdale Avenue south of Esplanade in conjunction with parallel parking.

Moved by Alderman Freeze, seconded by Alderman Suttis that the above recommendation of the Transportation, Traffic and Safety and Light Committee be adopted.

The members of Council expressed their pleasure with this recommendation.

The motion was then put and carried.

Police Committee

Alderman Chadwick submitted the following recommendation on behalf of this Committee:

RECOMMEND that an inquiry be forwarded to the Attorney General's Department regarding the paradoxical situation whereby it is lawful and legal for a person to purchase a muffler which immediately when installed may cause the owner to face prosecution for excessive noise being emitted from such a muffler, AND FURTHER THAT the District of North Vancouver be asked if they will make similar representation to the Attorney General's Department regarding this matter.

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that the above recommendation of the Police Committee be adopted. Carried.

Alderman Goldsworthy submitted the following recommendation on behalf of this Committee:

RECOMMEND that a letter be written to the District of North Vancouver asking if they will keep the City informed regarding any further regulations they may be considering to control motor vehicle noise in order that the City may work together with the District on this matter.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of the Police Committee be adopted. Carried.

Labour Relations Committee

Alderman Chadwick advised he had no report to make on behalf of this Committee.

North Vancouver Recreation Centre Board

Alderman Chadwick advised he had no report to make on behalf of the Board.

COMMITTEE MEETING OF ALL COUNCIL MEMBERS (October 23, 1967).

Alderman Wallace submitted the following recommendation on behalf of this Committee Meeting of All Council Members:

RECOMMEND that the Reference Committee be asked to ' recommend an Architect to proceed with plans and specifications for a new City Hall designed to serve the requirements of an expanded or amalgamated municipality should this come about and that preparation of such plans and specifications proceed forthwith.

Moved by Alderman Wallace, seconded by Alderman Goldsworthy that the above recommendation of the Committee Meeting of all Council Members held on October 23rd, 1967, be adopted.

Discussion followed during which some Members expressed the opinion that this matter should be discussed with District representatives before this move is made.

Alderman Goldsworthy stated that in view of the fact that this resolution only calls for the staff to recommend Architects who will design and bring forward plans of a new City Hall it would be appropriate for the Council to pass this resolution at this time.

Discussion followed.

The motion was then put and carried.

Alderman Chadwick submitted the following recommendation on behalf of this Committee Meeting of All Council Members:

RECOMMEND that the Council at the next Committee Meeting of All Members consider the revision of the Shops Regulation By-law to allow shopping on Thursday evenings, and that the existing by-law be reviewed at the same time for other amendments which may be opportune.

Moved by Alderman Chadwick, seconded by Alderman Suttis that the above recommendation of the Committee Meeting of All Council Members held on October 23rd,1967, be adopted.

At this point Alderman Chadwick gave a letter to the City Clerk which he had received dealing with extended shopping hours, which he felt other Council Members should also read.

The motion was then put and carried.

Alderman Goldsworthy submitted the following recommendation on behalf of this Committee Meeting of All Council Members:

RECOMMEND that Mr. A.A. McDonald be advised that he must execute a Deed to the property taken by the City and this must be registered in the Land Registry Office, free of all encumbrances, AND FURTHER THAT if such Deed is not deposited in the Land Registry Office by November 15th,1967, the compensation monies plus interest of 6% to that date be deposited in the Supreme Court with Mr. McDonald's assignment in favour of The Gulf and Fraser Fishermen's Credit Union, so that a Court Officer can execute the Deed in favour of the City.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of the Committee Meeting of all Council Members held on October 23rd,1967, be adopted. Carried.

COMMITTEE MEETING OF ALL COUNCIL MEMBERS (October 30,1967).

Alderman Dewhurst submitted the following recommendation on behalf of this Committee Meeting of All Council Members:

2 RECOMMEND that the invitation to the Lower Mainland Parks Advisory Board to hold their next meeting in the City of North Vancouver be endorsed, and that funds be provided in the 1968 Budget.

Moved by Alderman Dewhurst, seconded by Alderman Wallace that the above recommendation of the Committee Meeting of all Council Members held on October 30th, 1967, be adopted.

Alderman Chadwick inquired whether the amount of money involved was known.

Alderman Wallace stated the amount is in the area of \$600 or \$700, and about 150 guests would be in attendance.

Discussion followed.

Alderman Wallace stated further that the District may share in the costs.

The motion was then put and carried.

Alderman Freeze submitted the following recommendation on behalf of this Committee Meeting of all Council Members:

The City Clerk advised that he had already asked the District for advice as to whether they would be exempting the City's watershed lands, as any by-law to do so would have to be passed by the end of this month.

Alderman Dewhurst then asked if the Council would be willing to supply a copy of the Council Meeting Minutes to the Advisory Planning Commission as they had asked for a copy of same.

Moved by Alderman Dewhurst, seconded by Alderman Suttis that a copy of the Minutes of the Regular Meetings of Council be supplied to the Chairman of the Advisory Planning Commission. Carried.

Mayor Cates asked how many meetings had been held of the Joint Council Amalgamation Study Committee.

Alderman Chadwick advised that one had been held and that there would probably be another one next week.

The City Clerk advised that two meetings of the Joint Staff Committees had been held.

Mayor Cates said that Council must consider the staff situation now because it is a busy time of the year, and she hoped that the Joint Council Committee could spare the staff as much as possible during this period.

Alderman Chadwick said this was also the feeling of the Joint Committee, and certain references to the Treasurers were being deferred.

The City Clerk reported that the first two items referred to the Joint Staff Committee, namely, joint services and regulatory by-laws would be reported on before the end of this month, but that the finance reports would probably not be made until after January 1st.

Moved by Alderman Chadwick, seconded by Alderman Suttis that this Meeting now adjourn. Carried.

CORRESPONDENCE

Letter from the North Vancouver Chamber of Commerce asking that the proposed Business Tax be considered further before being imposed.

- Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that the letter from the North Vancouver Chamber of Commerce be tabled until consideration is given to the by-law dealing with Business Tax, which will be introduced later this evening. Carried.
- Letter from Gordon Gill, 714 East 5th Street, appealing against a decision of the R.C.M.P. to refuse his application for a chauffeur's permit.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the appeal of Mr. Gill be refused.

Alderman Goldsworthy stated it is regrettable that the Council cannot see any way to grant this application.

Plant, 254 West Windsor Road, be advised the City has had a firm of Consultants study the traffic problems in the area of Marine Drive, Fell Avenue, and Hamilton Street, which report is expected within the next two weeks, but that final plans for the solution to these problems cannot be arrived at until the location of the new First Narrows crossing is known. Carried.

TENDERS

Consideration of Tenders for air conditioning work in the 3 Justice Administration Building.

The Council had before it a report from Mr. A.A. Chomick,

Architect, in which he stated that the low tender, plus the electrical miscellaneous work would result in an amount of \$16,153.00 being expended for this work, which is far in excess of the \$10,000.00 budgeted for this item. He recommended that all tenders be rejected and that the existing ventilating system remain in operation during the next summer to ascertain whether a refrigerated air condition system is warranted. Mayor Cates stated she understood the City Solicitor has been unable to discuss the matter with the Solicitor of the Company, but advised she would check into the matter again.

³ Alderman Chadwick then inquired whether the audit of the North Shore Neighbourhood House books, as requested by the Council, has proceeded.

Mayor Cates advised that this matter is proceeding.

REPORTS OF COMMITTEES

Chairmen submitting recommendations gave a background explanation in each case.

Finance and Legal Committee

Alderman Goldsworthy submitted the following recommendation on behalf of this Committee:

RECOMMEND that an option be granted to a syndicate of Odlum # Brown & T.B. Read Ltd. and Bell, Gouinlock & Company Limited, for a period of fourteen days from November 21st, 1967, to sell an issue of \$500,000.00 of City of North Vancouver Debentures authorized under By-law No. 3835, at a yield rate of 7.86%.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that the above recommendation of the Finance and Legal Committee be adopted.

Alderman Goldsworthy stated that this recommendation is made in order to finance capital works constructed under the City's Capital Works By-law, and that, although the money has already been borrowed from the bank, it will be necessary to market the debentures in order that the City's temporary borrowing in the new year will not exceed the limit allowed.

The motion was then put and carried.

Alderman Chadwick submitted the following recommendation on behalf of this Committee:

RECOMMEND that Anavets Senior Citizen Housing Society and A.N.V.A. be advised that Council will allow the present Staff House to remain until the first of their new housing units is

completed and ready for occupancy, upon receipt of a request from the Society for this extension.

Moved by Alderman Chadwick, seconded by Alderman Goldsworthy that the above recommendation of the Finance and Legal Committee be adopted.

Alderman Chadwick explained that the tenants have requested this in order that they will not have to seek temporary accommodation prior to the first building being completed.

The motion was then put and carried.

Fire and Industrial Committee

Alderman Chadwick submitted the following recommendation on behalf of this Committee:

2 RECOMMEND that Fire Chief Spencer be authorized to add one new Fireman to the strength of the Department, and that one of the present first-class Firemen be transferred to act as Assistant to the Fire Warden effective January 1st, 1968.

Moved by Alderman Chadwick, seconded by Alderman Wallace that the above recommendation of the Fire and Industrial Committee be adopted.

Alderman Chadwick advised that the Fire Warden is experiencing difficulty in making all the inspections required of him by law.

Alderman Goldsworthy inquired whether consideration should not be given to a plan whereby these inspections would be done by several members of the Fire Department who, even though they were involved in such inspections, would still be on call because of radio equipped trucks. He stated this would result in a saving to the City of approximately \$9,000.00 per year.

Discussion followed.

Moved by Alderman Suttis, seconded by Alderman Dewhurst that the above recommendation be tabled, and that in the meantime the Fire Committee consult again with the Fire Chief regarding the suggestion made this evening. Carried.

Health and Civic Affairs Committee

Alderman Wallace advised he had no report to make on behalf of the Health and Civic Affairs Committee, except to say that the Medical Health Officer, Dr. Luck, has tendered his resignation. He stated that Council should be made aware of the fact that it is unlikely the North Shore Health Unit will be able to hold a man of Dr. Luck's ability at the salary now offered, and that it should be brought to the attention of the senior Governments that their contribution for the operation of the Board is quite inadequate.

Board of Works, Waterworks, and Zoning Committee

Alderman Suttis submitted the following recommendations on behalf of this Committee.

RECOMMEND that the City Superintendent be instructed to prepare the necessary reports and estimates of cost for the construction of the following work, as a local improvement on the initiative basis:

4'0" concrete sidewalk on the north and south sides of the 100 Block West 8th Street and the machine paving of the 100 Block West 8th Street. Moved by Alderman Suttis, seconded by Alderman Dewhurst / that the above recommendation of the Board of Works Committee be adopted. Carried.

RECOMMEND that the policy of the City with regard to the ² opening of lanes will be that the City will not participate in the construction of fences.

Moved by Alderman Suttis, seconded by Alderman Dewhurst that the above recommendation of the Board of Works Committee be adopted.

Members of the Council considered whether this would conflict with the City's policy now in effect in connection with the deeding by property owners of property for lane purposes.

Discussion followed.

Moved by Alderman Goldsworthy, seconded by Alderman Chadwick that this matter be tabled for further consideration by the Board of Works Committee. Carried.

Parks and Buildings Committee

Alderman Dewhurst submitted the following recommendations on behalf of this Committee:

RECOMMEND that the North Shore Neighbourhood House be advised the City is not prepared to develop the property situated in the 200 Block East First Street, directly behind the Neighbourhood House, as a playground at this time because of the urban renewal study presently being carried out which affects this area.

Moved by Alderman Dewhurst, seconded by Alderman Suttis that the above recommendation of the Parks and Buildings Committee be adopted.

Discussion followed wherein it was determined that although a playground and park is needed in this area, the exact location of this has not yet been determined.

The motion was then put and carried.

RECOMMEND that "Building By-law, 1946" be amended by striking out Section 25 pertaining to First Fire Limits and substituting therefor the following:

11

FIRST FIRE LIMITS

25. There is hereby established in the City of North Vancouver a first fire limit, being that area zoned and designated by Zoning By-law, 1967, and as amended from time to time, and shown on Zoning Map of the City of North Vancouver as

C-1	Central Commercial
C-2	General Commercial
CS-3	Special Commercial
CD-3C	Comprehensive Development
CD-3S	Comprehensive Development."

Moved by Alderman Dewhurst, seconded by Alderman Suttis that the above recommendation of the Parks and Buildings Committee be adopted. Carried.

Transportation, Traffic and Safety, and Light Committee

Alderman Freeze submitted the following recommendations on behalf of this Committee: RECOMMEND that Mr. J.R. Wheatley, 1844 Grand Boulevard be advised, in answer to his inquiry regarding the traffic situation on Grand Boulevard, that the Engineering Department of the City is currently developing plans to widen East Grand Boulevard in his Block with curbs on either side, Council's policy being that where concrete sidewalks are or have been constructed, the City machine paves the street; AND THAT he be advised that the reason this has not been done before is because it had been hoped the entire street could be done at the same time; AND FURTHER THAT he be advised the City is not prepared to institute one-way traffic and change its policy with regard to traffic on the Grand Boulevard at this time.

Moved by Alderman Freeze, seconded by Alderman Suttis that the above recommendation of the Traffic Committee be adopted.

Alderman Chadwick asked if costs had been arrived at for a six months' experimental trial of one-way traffic on Grand Boulevard.

Alderman Freeze advised that costs have been given to the Committee, although he could not quote them at this time. He said if one-way traffic is instituted there should be a sufficient flow in order for this to be self regulating, and the present amount of traffic does not warrant a one-way experiment.

The motion was then put and carried.

RECOMMEND that the reading of "Traffic Regulation By-law, 1967" which will have the effect of diverting truck, tractor, and semi-trailer traffic from the 3rd Street hill westbound between the hours of 8:00 p.m. and 7:00 a.m. to the Low Level Road, be proceeded with.

Moved by Alderman Freeze, seconded by Alderman Suttis that the above recommendation of the Traffic Committee be adopted.

Alderman Chadwick inquired whether this regulation should not be extended over a twenty-four hour period in order that the noise will be eliminated for the benefit of shift workers sleeping during the day time, and to alleviate traffic tie-ups during the normal business hours.

Alderman Suttis contended that a hardship would be placed on certain vehicles which service stores in the City, and he also thought that the co-operation of truck drivers would be obtained in using the Low Level Road voluntarily, as this road has now been improved.

Discussion followed.

The motion was then put and carried.

RECOMMEND that the matter of overnight parking problems in the core area of the City be left in the hands of the City Superintendent with power to act, it being considered that the nature of necessary regulations will not be known until the street sweeper has been placed in use.

Moved by Alderman Freeze, seconded by Alderman Suttis that the above recommendation of the Traffic and Safety Committee be adopted. Carried.

RECOMMEND that Mr. J. Brondgeest be advised in response to his request for more parking in the Lower Lonsdale area, that the Council would be prepared to entertain a petition for a local improvement to establishing parking areas between 3rd Street and the waterfront, with the property owners paying the full cost, and that if he wishes any information with respect to this he should contact the City Planner.

Moved by Alderman Freeze, seconded by Alderman Suttis that the above recommendation of the Traffic and Safety Committee be adopted. Carried.

Labour Relations Committee
