MINUTES of the Regular Meeting of the City Council, held in the Second Floor Court Room of the Justice Administration Building on Monday, June 7th, 1971, at 8:00 P.M.

Present:

Mayor T.H. Reid, Alderman J.A.W Chadwick, Alderman S.A. Dean, Alderman M.B. Howard, Alderman J.E. Loucks, Alderman B.G. Terrace, and Alderman J.M. Warne.

Mayor Reid called this Regular Meeting of Council to order.

MINUTES

Moved by Alderman Chadwick, seconded by Alderman Terrace that the Minutes of the Regular Meeting of Council held on May 17th, 1971, a Special Meeting of Council held on May 19th, 1971, a Special Meeting of the Finance and Legal Committee held on May 19th, 1971, a Special Meeting of the City Council held on May 25th, 1971, an Adjourned Public Hearing of the Council held on May 25th, 1971, two Public Hearings of Council held on May 25th, 1971, the Regular Meetings of the Standing Committees held on May 25th, 1971, and an Adjourned Meeting of the Standing Committees held on May 31st, 1971, be taken as read and adopted, copies of same having been circularized among all Council Members and read by them.

Mayor Reid at this point read a proclamation designating the week of June 6th to 12th, 1971, as "Pioneer and Elderly Citizens" Week in the City of North Vancouver.

CORRESPONDENCE

Letter dated June 1st, 1971, from Mrs. M.M.K. Young, 1420 Forbes Avenue, supporting the proposed beautification of Keith Road West by the Council.

Moved by Alderman Dean, seconded by Alderman Warne that the above item, and the following items, be held in abeyance until the Council has dealt with the recommendation of the Parks and Buildings Committee to delete the Lynmouth Park project from the Federal-Provincial Loan Project and spend the money on landscaping the Boulevard on West Keith Road:

- Letter dated June 1st, 1971, from Mr. and Mrs. C.M. Wilson, 514 West Keith Road, and Mr. and Mrs. C. Bumstead, 510 West Keith Road, asking the Council to give early consideration to the improvement of West Keith Road Boulevard, etc.

Moved by Alderman Dean, seconded by Alderman Chadwick that this letter be referred to the City Engineer for report.

Carried.

Letter dated June 2nd, 1971, from the Pacific Apartment Management Association, asking for a by-law to make it illegal for intercom services to be turned off in apartment buildings in the evening.

Moved by Alderman Chadwick, seconded by Alderman Terrace that this matter be referred to the City Solicitor for his opinion as to the City's jurisdiction in this matter. Carried

Circular letter from AMCHITKA 2 asking for Council's support in stopping the use of Amchitka Island for any further nuclear testing.

Moved by Alderman Dean, seconded by Alderman Howard that this Council go on record as endorsing the resolution of AMCHITKA 2 contained in their letter received on May 25th, 1971, opposing any further testing by the U.S. Automatic Energy Commission on Amchitka Island; and that copies of this resolution be forwarded to Mr. D. Brousson, M.L.A., Mr. Barrie Clark, M.L.A., and the Hon. Jack Davis, M.P. Carried.

Letter dated June 1st, 1971, from the North Vancouver Recreation Centre Board re disposal of Schomberg Ice Resurfacer and the purchase of certain equipment from the depreciation reserve in the amount of \$11,697.50.

Moved by Alderman Dean, seconded by Alderman Terrace that authority be granted for the North Vancouver Recreation Centre Board to expend the sum of \$11,697.50 from the Reserve for Depreciation Account to cover the purchase and replacement of equipment and for the disposal of the Schomberg Ice Resurfacer in accordance with the Manager's letter dated June 1st, 1971, subject to the approval of the District of North Vancouver.

Letter dated June 1st, 1971, from Gulf Oil Canada Limited, re proposed new building at 13th Street and Lonsdale Avenue. (Parking restrictions).

Moved by Alderman Terrace, seconded by Alderman Dean that this matter be referred to the Advisory Planning Commission, with the Zoning Committee, and the City's Planning Consultants through the City Engineer for report; and that the City Engineer be requested to clarify items 2 and 6 in the report of the Building Inspector dated May 25th, 1971. Carried.

Letter dated May 25th, 1971, from Ted Gofers, 4605 West 13th Avenue, Vancouver 8, B.C., enclosing copy of the Lower Lonsdale Study made by him and his associates.

Moved by Alderman Chadwick, seconded by Alderman Dean that this letter and the enclosed study be received and filed with thanks, it being noted the Council members may see the report in the City Clerk's office if they so wish.

Carried.

Circular dated May 28th, 1971, from the Union of B.C. Municipalities enclosing a report by T.J. Plunkett Associates on the municipal picture in British Columbia.

Moved by Alderman Dean, seconded by Alderman Terrace that this circular be received and filed with thanks, and that Council members receive a copy of the report. Carried.

Letters dated May 14th, 1971, and May 18th, 1971, from Coronation Credit Corporation Ltd., and H.L. Waddell and

Associates Ltd. re lane allowance on 5th Street near Chester-field Avenue.

Moved by Alderman Chadwick, seconded by Alderman Warne that Coronation Credit Corporation Ltd. be advised that the City is not prepared to cancel the lane allowance situated east of Chesterfield Avenue between 5th Street and the east-west lane immediately south of 5th Street, but that they be further advised that the City would consider recommending closure of the lane provided the equivalent amount of open space, available to the public, would be incorporated in their development.

Moved by Alderman Dean, seconded by Alderman Howard that the resolution be amended by striking out all the words from the resolution after "5th Street" where it occurs the second time, and inserting therefor "and that Council invite the developers to come to the next Committee Meeting for further discussion"

Moved by Alderman Terrace, seconded by Alderman Warne that consideration of this matter be tabled and be given consideration at the next meeting of the Legal and Finance Committee.

Carried.

Letter dated May 11th, 1971, from the North Shore Association for the mentally retarded, asking for exemption of business licence.

Moved by Alderman Chadwick, seconded by Alderman Warne that the Council accept the recommendation of the Licence Inspector to grant a licence to the North Shore Association for the Mentally Retarded to initiate a sheltered workshop for male and female mentally retarded and physically handicapped at 165 East First Street, and that a grant be given to this organization to cover the required licence fee.

Carried.

Letter dated May 16th, 1971, from J.L. Rudelsheim, 2228 Mahon VAvenue, complaining about the handling of certain complaints made against him because of back yard burning, etc.

Moved by Alderman Loucks, seconded by Alderman Terrace that Mr. J.L. Rudelsheim, 2228 Mahon Avenue, protesting against the handling of complaints against him with respect to burning of building rubbish, etc., be advised that the Council considers the complaint handled in a satisfactory manner by the Fire Department and does not intend to change its policy of investigating complaints.

Carried.

Letter dated May 19th, 1971, from Harry Haggard, 4090 St. Paul's Street, North Vancouver, re ferry system, etc.

Moved by Alderman Terrace, seconded by Alderman Loucks that the letter from Harry L. Haggard, 4090 St. Paul's Avenue, North Vancouver, endorsing a ferry system between North Vancouver and Vancouver instead of a third crossing of the Inlet, be received and filed.

Carried.

Letter dated May 19th, 1971, from Mr. R.G. Nickel, 154 East W27th Street, Chairman of an ad hoc Committee for the continuance of the ferry service.

Moved by Alderman Terrace, seconded by Alderman Dean that Mr. R.G. Nickel be thanked for his presentation to the members of Council in Committee on behalf of the ad hoc committee to save the ferries; AND THAT he be advised the Council has taken the whole matter under consideration. Carried.

APPLICATIONS TO PURCHASE PROPERTY

Letter and application from H.L. Waddell & Associates Ltd., for the purchase of Lots 4 and 5, Block 125, D.L. 274, on the south side of the 100 Block West 5th Street.

Moved by Alderman Chadwick, seconded by Alderman Terrace that the above application be approved and the following property placed on the next by-law for conveyance:

Lot Block D.L. Name of Purchaser Price 125 274 Macor Developments Limited \$62,300.00

(Subject to consolidation with the adjoining Lot 3, and the West 25' of Lot "E", both in Block 125, D.L. 274. the sale being by way of an Agreement for Sale, with \$5,000.00 as a down payment, non-returnable, with the balance of \$57,300.00 at any time, but not later than September 1st, 1971, with interest at 81/2%. And subject to the purchaser putting in a retaining wall on the south side of the lane, or developing the property, Lot "G", Block 125, D.L. 274, on the south side of the lane first. Should the purchaser of Lots 4 and 5, Block 125, D.L. 274, default, he will be required to pay an amount in lieu of taxes on the land from the date of sale to the date of default). Carried.

Proposed posting resolution for City property at the foot of Lonsdale Avenue, as received from the City Solicitor.

Moved by Alderman Dean, seconded by Alderman Warne that in view of the City asking for an appraisal of the property at the foot of Chesterfield Avenue, the Council also ask for an appraisal of the property at the foot of Lonsdale Avenue, having in mind the kind of rental money that can be obtained on a marina operation, and that an appraisal of the pier be obtained as well.

A recorded vote was called for.

Moved by Alderman Warne, seconded by Alderman Chadwick that the City property, inclusive of the waterlots and street end being held on National Harbours Board lease or owned outright by the City, at the foot of Lonsdale Avenue, be appraised by an independent appraiser. Carried.

PETITIONS

Petition received on June 2nd, 1971, for the improvement of

Mahon Avenue from 21st to 23rd Streets, etc.

Moved by Alderman Chadwick, seconded by Alderman Dean that the City Engineer be instructed to prepare the necessary reports and estimates of cost for the construction of the following work as a local improvement:

Improvement of Mahon Avenue from 21st Street to 23rd Street, including the paving of same and the construction of a concrete sidewalk on the east side of Mahon Avenue from 21st Street to 23rd Street. Carried.

Petition from a number of persons asking the City of Vancouver and the City of North Vancouver to take whatever vaction is necessary to preserve the operation of the daily ferry service between the two centres.

Moved by Alderman Dean, seconded by Alderman Terrace that this petition be received and filed. Carried.

INQUIRIES

Alderman Terrace inquired as to the status of the present vacant properties within the City of North Vancouver immediately south of Highway 401, as well as the status of the interchanges with Highway 401 and Lonsdale and Westview Avenues.

Mayor Reid noted that the properties had been obtained by the Department of Highways some time ago for highway widening purposes, and that although representations had been made at various times with respect to the interchanges, no commitment had been received.

Alderman Terrace asked whether another approach might be made.

In answer to Alderman Dean, Mayor Reid stated that Mr. Brousson had not replied with respect to the interchange matter placed before him at his meeting with Council members.

Alderman Warne inquired as to the status of the discussions with respect to low cost housing.

Mayor Reid stated that a meeting had been held between senior governmental officials and himself approximately ten days ago, but he had not as yet received any reply with respect to proposals placed before these officials at the meeting.

Alderman Loucks inquired when a report would be received from the Consultants with respect to the Tempe Boundary proposals.

Mayor Reid replied that June 15th was the tentative date for this report, according to the City Clerk.

Alderman Chadwick inquired whether the Mayor would report on the several subjects which he took up at the Council's request with Government officials on his recent trip to Ottawa.

Mayor Reid stated that before he could do so he would have to obtain some information from staff members, as any answers would not be coherent without the necessary information from staff.

Alderman Chadwick asked if the members of Council could receive copies of the letter which the Mayor received from Victoria with respect to the Seven Seas.

Mayor Reid replied in the affirmative.

Alderman Dean inquired whether the \$40,000.00 item was included among those matter which the Mayor had discussed in Ottawa.

Mayor Reid answered in the affirmative.

REPORTS OF COMMITTEES

Chairmen presenting recommendations to Council gave a background explanation in each case.

Finance and Legal Committee

Alderman Chadwick presented the following recommendation on behalf of this Committee:

RECOMMEND that the accounts from Bull, Housser and Tupper in the amounts of \$1,355.15 and \$2,401.00, covering legal services provided from April 1st to 30th, 1971, be paid.

Moved by Alderman Chadwick, seconded by Alderman Howard that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Alderman Dean presented the following recommendation on behalf of this Committee:

RECOMMEND that the application of Mrs. Dalmir Bumstead for a licence to sell buckskin garments from a cart in the Lower Lonsdale area be approved, subject to the licence being at the pleasure of Council, and on the understanding that if this operation creates traffic congestion the permit may be cancelled by the Council; and further that this operation be confined to the area below Third Street, and subject further to the hours of operation being restricted to those contained in the Shops Regulation By-law of the City.

Moved by Alderman Dean, seconded by Alderman Warne that the above recommendation of the Finance and Legal Committee be adopted.

A recorded vote was called for.

Voting for the Motion: Mayor Reid, Alderman Dean, and Alderman Warne.

Voting against the Motion: Alderman Chadwick, Alderman Howard,

Alderman Loucks, and Alderman

Terrace.

The motion was therefore declared defeated.

Alderman Chadwick presented the following recommendations on behalf of this Committee:

RECOMMEND that an amount of \$222.81 be allocated to cover the adjustments necessary in the purchase by the City of Lots 1 and 2, Block 154, D.L. 274, from Mr. and Mrs. George Kasperczyk, the monies to come from the funds remaining in By-law No. 4228.

Moved by Alderman Chadwick, seconded by Alderman Loucks that the above recommendation of the Finance and Legal Committee be adopted. Carried.

RECOMMEND that the resolution of Council passed on April 19th, 1971, cancelling the agreement with the B.C. Telephone Company covering telephone cable across City property at the foot

of Chesterfield Avenue, subject to it not being required by the Company for their telephone service to the North Shore, and subject to the removal of it on the instructions of the City Engineer, be reconsidered.

Moved by Alderman Chadwick, seconded by Alderman Warne that the above recommendation of the Finance and Legal Committee be adopted. Carried.

RECOMMEND that the resolution of Council passed on April 19th, 1971, cancelling the agreement with the B.C. Telephone Company covering telephone cable across City property at the foot of Chesterfield Avenue, subject to it not being required by the Company for their telephone service to the North Shore, and subject to the removal of it on the instructions of the City Engineer, be rescinded.

Moved by Alderman Chadwick, seconded by Alderman Warne that the above recommendation of the Finance and Legal Committee be adopted. Carried.

RECOMMEND that the agreement with the B.C. Telephone Company covering telephone cable across City property at the foot of Chesterfield Avenue be cancelled, and the correspondence with respect thereto be received and filed.

Moved by Alderman Chadwick, seconded by Alderman Warne that the above recommendation of the Finance and Legal Committee be adopted. Carried.

RECOMMEND that the Canadian Council of Christians and Jews be advised, in response to their letter dated May 10th, 1971, requesting a grant, that their letter was received after the deadline date for receipt of applications for grants, and while the City cannot make a grant, it is understood that they are approaching organizations in the Community to assist in their work.

Moved by Alderman Chadwick, seconded by Alderman Warne that the above recommendation of the Finance and Legal Committee be adopted.

Moved by Alderman Howard, seconded by Alderman Warne that the resolution be amended by removing therefrom the section reading "(b) \$1,200.00 be provided for the purchase of shelving for a new central open-shelf filing system in the Engineering Department" Carried.

The motion as amended was then put and carried.

Moved by Alderman Chadwick, seconded by Alderman Dean that 'the effective date with respect to the above resolution be set as July 1st, 1971. Carried.

Moved by Alderman Terrace, seconded by Alderman Howard that \$1,200.00 be provided for the purchase of shelving for a new central open-shelf filing system in the Engineering Department.

Board of Works, Waterworks, and Zoning Committee

Alderman Warne presented the following recommendations on behalf of this Committee:

Concrete sidewalks and street improvements on

- (a) 29th Street from Regent to Boundary Road;

- (d) 200 Block West 6th Street, North and South sides of Ottawa Gardens.

Moved by Alderman Warne, seconded by Alderman Howard that the above recommendation of the Board of Works Committee be adopted. Carried.

RECOMMEND that the application of Mr. and Mrs. Keith Rice-Jones to purchase the adjoining lane allowance to their property be rejected, but that the applicants be advised that the building on the property will be allowed to remain at the pleasure of Council.

Moved by Alderman Warne, seconded by Alderman Howard that the above recommendation of the Board of Works Committee be adopted.

Carried.

RECOMMEND that the Mayor and Clerk be authorized to sign an easement agreement with the B.C. Hydro and Power Corporation for the installation of a guy wire on the edge of Ottawa Gardens at Chesterfield Avenue, subject to a clause being included in the agreement in a form satisfactory to the City Solicitor saving the City harmless from any claims for damages resulting from the granting of the said easement.

Moved by Alderman Warne, seconded by Alderman Howard that the above recommendation of the Board of Works Committee be adopted.

Carried.

Health and Civic Affairs Committee

Alderman Howard presented the following recommendation on behalf of this Committee:

RECOMMEND that monies be allocated from the Contingency Fund for the necessary expenses involved in the entertainment of the Mayor of the City of Chiba, Japan, and his Deputy, on June 30th, July 1st, and July 2nd, 1971.

Moved by Alderman Howard, seconded by Alderman Warne that the above recommendation of the Civic Affairs Committee be adopted.

Carried.

Transportation, Traffic & Safety, and Light Committee

Alderman Terrace presented the following recommendations on behalf of this Committee:

RECOMMEND that Harbour Ferries Ltd. be allowed to use the dock χ at the foot of Bewicke Avenue subject to the following conditions:

- 1. They provide a walkway of 3/4" plywood on top of the present deck a minimum of four feet in width and wider when needed for assembly areas.
- They strengthen the existing railing on the west side of the dock by additional bracing where needed to make it secure.
- 3. They provide a replacement float in a secure manner and dispose of the existing float in a manner satisfactory to the National Harbours Board.
- 4. They close and lock the gate providing access to the dock over night between the hours of 7:00 P.M. and 7:00 A.M.
- 5. They maintain signs posted by the City to read: "USERS OF THIS DOCK DO SO AT THEIR OWN RISK".
- 6. They indemnify the City from any claims arising from the use of this dock.

7. They provide liability insurance suitable to the City for an amount not less than \$1,000,000.00.

8. That this arrangement for the use of the dock is at the pleasure of the Council and can be terminated on seven days' notice.

- 9. In the event this venture proves successful at the end of the thirty day trial period, commencing June 23rd, 1971, Harbour Ferries to assume responsibility for the power supply to the dock and maintenance of harbour lighting.
- 10. At all times the Company will meet all legal requirements of public transportation systems in regard to the use of this dock.
- 11. That any agreement is subject to the City's Solicitor's approval.
- 12. All work to be done to the satisfaction of the City Engineer.

Moved by Alderman Terrace, seconded by Alderman Dean that the above recommendation of the Transportation Committee be adopted. Carried.

RECOMMEND that upon acceptance of the proposed agreement by Harbour Ferries Ltd., the City Solicitor be instructed to draw up the necessary posting resolution for the waterlot at the foot of Bewicke Avenue providing for a rental of \$1.00 for the first two months and for a review of the rental upon completion of the first two months.

Moved by Alderman Terrace, seconded by Alderman Loucks that the above recommendation of the Transportation Committee be adopted.

Carried.

Moved by Alderman Chadwick, seconded by Alderman Terrace that School District No. 44, North Vancouver, be advised of the City's policy which gives the Christmas Bureau first opportunity in obtaining unclaimed bicycles, with any excess going to Welfare Industries, and that the School Board be advised to contact the District of North Vancouver with respect to any unclaimed bicycles that municipality may have.

- (a) Until some other person has entered into a contract with the Municipality for the performance of the work or the supply of materials specified in the notice inviting tenders, or
- (b) Until and unless the municipality consents to such withdrawal either with or without a proper investigation by an independent party, the costs of such investigation to be borne, at the discretion of the Municipality, by the bidder involved, or
- (c) Until 30 days after the time affixed for receiving tenders, whichever occurs first.

Moved by Alderman Howard, seconded by Alderman Warne that the above recommendation of the Civic Affairs Committee be adopted.

Carried.

Mayor Reid recommended that Council consider submitting a resolution to the Union of B.C. Municipalities for greater exemption of people in public office.

Moved by Alderman Warne, seconded by Alderman Terrace that the City Clerk draft a resolution for submission to the Union of B.C. Municipalities recommending that municipal Council members be granted similar additional tax exemptions to those presently received by other groups. Carried.
