MINUTES of the Regular Meeting of the City Council, held in the Second Floor Court Room of the Justice Administration Building on Monday, November 1st, 1971, at 8:00 P.M.

Present:

Mayor T.H. Reid, Alderman J.A.W. Chadwick, Alderman S.A. Dean, Alderman B.G. Terrace, and Alderman J.M. Warne.

Mayor Reid called this Regular Meeting of Council to order.

MINUTES

Moved by Alderman Chadwick, seconded by Alderman Terrace that the Minutes of the Regular Meeting of Council held on October 18th, 1971, the Special Meeting of Council held on October 25th, 1971, the Committee Meeting of all Council Members held on October 25th, 1971, and the Regular Meetings of the Standing Committees held on October 25th, 1971, be adopted as circularized.

Alderman Warne noted that in the minutes of the Special Meeting of Council held on October 25th, 1971, his motion with respect to the question on the post card ballot in connection with the Tempe Heights development should have read "A regional shopping Centre with some parks and housing" rather than "A shopping Centre with some parks and housing".

- The Clerk advised the ballots were printed and could not be changed. Alderman Terrace noted that the Minutes of the Regular Council Meeting held on October 18th, 1971, were in error insofar as the motion on Page 3 of same, regarding Miss Betty Fullerton, referred to Miss Fullerton as a former planner, whereas she was an employee in the Planning Department, and this should therefore be amended.
- The mover and seconder agreed to amend the motion by striking out the word "Planner" and substituting the word "employee".

The motion as amended was then put and carried.

CORRESPONDENCE

W.E. Fletcher - Objection to Third Crossing

Moved by Alderman Warne, seconded by Alderman Terrace that the letter from Mr. W.E. Fletcher, dated October 22nd, 1971, (West Vancouver), objecting to any proposed third crossing of Burrard Inlet, and suggesting instead that the money be spent on ferries, parking terminals, helicopters, and improved mass transit be received and filed.

Alderman Loucks entered the meeting at 8:05 P.M.

The motion was then put and carried.

Mr. S.O. Mortensen - Construction of Boat

Moved by Alderman Chadwick, seconded by Alderman Terrace that Mr. S.O. Mortensen, 315 West 23rd Street, be given permission

to construct a 40 foot fibreglass boat at the rear of his property at 315 West 23rd Street, subject to his obtaining the permission of the two adjacent property owners and also the owner at the rear of his premises, provided that an agreement be entered into between the City of North Vancouver and Mr. Mortensen specifying that the boat will be completed within one year of commencement of construction, and that the boat and all building materials involved in the construction of same will be removed within one year; and further that the Mayor and Clerk be authorized to sign such an agreement. Carried.

Mrs. D. Alder - Objection to Tempe Heights Commercial Development

Moved by Alderman Chadwick, seconded by Alderman Terrace that Mrs. D. Alder, 2669 Ailsa Crescent, dated October 25th, 1971, objecting to any proposed commercial development in the Tempe Heights area, be received and filed; and that Mrs. Alder be advised that the City is conducting a postcard ballot in this connection, and further that she be informed that both types of development being considered provide for a residential area adjacent to the school.

It was noted that Mrs. Alder was a District of North Vancouver resident.

The motion was then put and carried.

Canadian Federation of Mayors and Municipalities - Federal Government Initiative Programmes

Moved by Alderman Dean, seconded by Alderman Warne that this Council go on record as endorsing the position taken by the Canadian Federation of Mayors and Municipalities on the Federal Government Economic and Fiscal Programme to combat unemployment, and that municipal representatives be included in the planning and coordination and election process of this programme; and further that this resolution be forwarded to the Federal Minister of Finance, Mr. E.J. Benson, and the Hon. Dan Campbell, as well as to the Canadian Federation of Mayors and Municipalities.

Deputy Minister of Municipal Affairs - Guidelines re Loan Applications

Moved by Alderman Chadwick, seconded by Alderman Terrace that the letter from the Deputy Minister of Municipal Affairs, dated October 25th, 1971, attaching a copy of the guidelines to be followed with respect to loan applications under the Federal Provincial Employment Loans Programme, be referred to the City Administrator for consultation with the City Treasurer and other Staff for a recommendation to Council.

Mr. F.J. Gallagher - Truck Traffic Complaint

Moved by Alderman Dean, seconded by Alderman Chadwick that the letter dated October 20th, 1971, from Mr. F.J. Gallagher, 433 East 3rd Street, complaining of the heavy truck traffic in his area, be referred to the City Administrator for discussion with the Police Department and the City Engineer. Carried.

Elim Chapel - Exchange of Property

Moved by Alderman Chadwick, seconded by Alderman Dean that the

letter dated October 19th, 1971, from Elim Chapel, 124 West 8th Street, asking if they could exchange their property for City property on Jones Avenue between 21st and 23rd Streets be referred to the City's Planning Consultants and to the Finance and Legal Committee for recommendation. Carried.

St. Mark's Luthern Church - Building Site

Moved by Alderman Chadwick, seconded by Alderman Warne that the proposal submitted by St. Mark's Lutheran Church and the Lutheran Project Development Society of B.C., as submitted in their brief of October, 1971, for a church building as well as construction of low rent senior citizens' housing be approved in principle and that the matter be referred to the City Administrator for the purpose of discussing any available sites the City might have for this purpose, with the Church representatives.

School District No. 44 - Kindergarten Plebiscite

Moved by Alderman Chadwick, seconded by Alderman Loucks that School District No. 44 be advised, in reply to their letter dated October 14th, 1971, that Council authorizes the Board to appoint the City's Returning Officer for the purpose of holding a Kindergarten Plebiscite on December 11th, 1971.

Carried.

Mrs. S. Casey & Mrs. V. Tisdall - Complaints re Dumping of Fill

Moved by Alderman Dean, seconded by Alderman Terrace that the letter from Mrs. S. Casey, 1509 Rufus Avenue, and the letter from Mrs. V. Tisdall, 888 East 14th Street, complaining about the dumping of fill near their homes, be received and filed, in view of the Engineer's report of October 18th, 1971, setting out the City's position in this matter. Carried.

North Vancouver Public Library - Interchangeable Library Cards

Moved by Alderman Chadwick, seconded by Alderman Terrace that Council approve the recommendations of the Library Board, as contained in their brief dated October 14th, 1971, whereby library cards would be interchangeable between the City of North Vancouver, the District of North Vancouver, the District of West Vancouver, and Capilano College.

Regina Beiser and Irving Seidler - Application for Rezoning

Moved by Alderman Warne, seconded by Alderman Chadwick that Mrs. R. Beiser and Mr. I. Seidler be advised that their application for the rezoning of property at 114 West 21st Street to apartment district is rejected. Carried.

APPLICATIONS TO PURCHASE (OR LEASE) CITY PROPERTY

Seven Seas - Lease of Property at Foot of Lonsdale

(Letter from P.C.G. Richards, Solicitor, confirming their previous position and enclosing cheque for \$1031.46).

Moved by Alderman Chadwick, seconded by Alderman Loucks that the Mayor and Clerk be authorized to execute the agreement leasing property at the foot of Lonsdale Avenue to Seven Seas Seafood Restaurant and S.S. Marina Ltd. A polled vote was called for.

Voting in favour of the Motion: Alderman Chadwick, Alderman

Alderman Terrace, and Alderman

Loucks.

Voting Against the Motion: Alderman Dean, Alderman Warne, and

Mayor Reid.

The motion was declared lost.

Moved by Alderman Warne, seconded by Alderman Chadwick that the matter of the lease of the property at the foot of Lonsdale Avenue to Seven Seas Seafood Restaurant and S.S. Marina Ltd. be placed on the agenda of the next Council meeting for consideration.

Moved by Alderman Dean that this matter be tabled for the attention of the 1972 Council.

There was no seconder to Alderman Dean's motion.

The original motion was then put and carried.

PETITIONS

Lane Improvement - North of 3rd Street from Ridgeway to Moody Avenue (Certified by the Clerk)

Moved by Alderman Chadwick, seconded by Alderman Dean that the City Engineer be instructed to prepare the necessary reports and estimates of cost for the construction of the following work as a local improvement:

Improvement of the lane north of Third Street from Ridgeway Avenue to Moody Avenue, including the paving of same. Carried.

TENDERS

City Lots - 400 Block East 10th Street (Lot 11) and 500 Block West 25th Street (Lot 27)

Moved by Alderman Chadwick, seconded by Alderman Terrace that the tender received from Mr. N. Franco, 229 West 27th Street North Vancouver, in the amount of \$13,165.00, for Lot 11, Block 95, D.L. 550, in the 400 Block East 10th Street, be accepted, and that the deposits of the unsuccessful tenderers be returned; AND FURTHER THAT

WHEREAS The Corporation of the City of North Vancouver, (here-inafter called the City), is the owner of a parcel of land in the City of North Vancouver, (not being required for Municipal purposes and not being reserved or dedicated), namely, the parcel of land hereinafter described, upon which there is not any building or structure of any kind and it is not the intention of the Council that the said land be sold by public auction:

THEREFORE the Council of the City hereby resolves as follows:

- 1. That the City proposes to sell and hereby offers to be sold the said parcel of land in accordance with the Municipal Act and this resolution; and

3. That the City Clerk do cause the said list to be posted on the Notice Board in the vestibule of the City Hall, 209 West 4th Street, and in the Justice Administration Building, 160 East 13th Street, both in the City of North Vancouver.

Moved by Alderman Dean, seconded by Alderman Terrace that the matter of the formulation of a policy with respect to a time limit for the development of property purchased from the City, unless such property is to be consolidated with the adjacent land, be referred to the City Administrator for study and report back to Council. Carried.

Ambulance Units - Tenders

Moved by Alderman Warne, seconded by Alderman Dean that the matter of tenders for one or two van style ambulance units and equipment, etc., for the Fire Department, be referred to the Fire and Industrial Committee.

The Chairman of the Fire and Industrial Committee reported that the ambulance now in service is in need of repair, and that because of this and the number of ambulance calls received, the Fire Chief felt it would be beneficial to have available the two van type ambulances as well as the ambulance now in service.

The motion was put and defeated.

Moved by Alderman Chadwick, seconded by Alderman Loucks that the recommendation of the Purchasing Agent and the Fire Chief, as contained in their report of October 29th, 1971, be accepted; and that a by-law be prepared to provide for the expenditure of the amount of \$16,492.22 for the purchase of two van style ambulance units and equipment, including licence and registration, the necessary funds to come from the Machinery and Equipment Depreciation and Obsolescence Reserve Account; and further that this topic be placed on the agenda of the next Council meeting for discussion.

INQUIRIES

Mayor Reid advised that he had received a letter from the Central Mortgage and Housing Corporation wherein they advised they were not prepared to recommend the site at 2nd Street and St. Georges Avenue for low rental housing development.

Alderman Terrace inquired when Larson Road from 20th Street to 22nd Street would be resurfaced.

The City Clerk advised the City was presently initiating the improvement of this street.

REPORTS OF COMMITTEES

Chairmen presenting recommendations to Council gave a background explanation in each case.

Finance and Legal Committee

Alderman Chadwick presented the following recommendations on behalf of this Committee:

Accounting Services - Recreation Centre

RECOMMEND that the City Treasurer assume responsibility for accounting services for the North Vancouver Recreation Centre as of July 1st, 1972, rather than January 1st, 1972, and that the latter be advised accordingly.

Moved by Alderman Chadwick, seconded by Alderman Warne that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Renovations - City Hall

RECOMMEND that the renovations to the East side of the Second Floor of the City Hall be approved to cover accommodation for the City Administrator and other City Departments in accordance with the plan submitted, at a cost not to exceed \$8,000.00, with the proviso that washroom facilities be provided on this floor as well, the funds to come from the Administrator's Budget.

Moved by Alderman Chadwick, seconded by Alderman Loucks that the above recommendation of the Finance and Legal Committee be adopted. Carried.

City Administrator - Office Equipment

RECOMMEND that the Purchasing Agent be authorized to call for bids for the purchase of equipment for the offices of the City Administrator and his Secretary in the amount of \$3,910.00, as set out in the memorandum from the Purchasing Agent dated October 19th, 1971, the monies to be taken from the Administrator's Account.

Moved by Alderman Chadwick, seconded by Alderman Terrace that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Fullerton Lumber Co. - New Rental

RECOMMEND that the City Clerk be authorized to advise Fullerton Lumber Company that the City feels that the appraised rental figure of \$14,000.00 per annum is a fair one, and that this rental will be effective from November 1st, 1971; and further that a copy of the appraisal by Cunningham and Rivard be forwarded to them.

Moved by Alderman Chadwick, seconded by Alderman Warne that the above recommendation of the Finance and Legal Committee be adopted.

Moved by Alderman Dean, seconded by Alderman Warne that this matter be deferred until such time as the Administrator is able to obtain comments from the City's Land Agent and the City Assessor with respect to this appraisal.

The City Clerk advised that this property was actually a

street end which had been filled, and that the new rental was double that which had been received in the past. He also pointed out that the firms of Cunningham and Rivard and Bell Irving had been recommended by the Land Agent and the City Assessor as competent appraisers.

The motion to defer was defeated.

The original motion was then put and also defeated.

Moved by Alderman Chadwick, seconded by Alderman Loucks that the matter of the rental to be payable by Fullerton Lumber Company for the property at the foot of Fell Avenue from November 1st, 1971, be referred to the next meeting of the Legal and Finance Committee, and that in the meantime the City Administrator obtain comments from the Land Agent and the City Assessor on the appraisal by Cunningham and Rivard. Carried.

Bull, Housser and Tupper - September Account

RECOMMEND that the account submitted by Bull, Housser and Tupper for the month of September, in the amount of \$3,766.80, be paid, and that the matter of the possibility of the recovery of a portion of these costs be referred to the City Administrator.

Moved by Alderman Chadwick, seconded by Alderman Loucks that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Fire and Industrial Committee

Alderman Loucks reported that during the fireworks display on Halloween night, in Boulevard Park, Fireman Richard Burrows, who had volunteered for duty at this display under the direction of Captain Charles Todd, had been injured and taken to Lions Gate Hospital. He advised that three children had also been hurt and taken to hospital. Alderman Loucks stated also that Fireman Burrows' quick action had prevented more serious injuries to other spectators.

Moved by Alderman Loucks, seconded by Alderman Dean that Fireman Richard Burrows be commended for his action which prevented further more serious injuries to the public attending the fireworks display at Boulevard Park on Halloween night.

Carried.

Parks and Buildings Committee

Alderman Dean presented the following recommendations on behalf of this Committee:

Mr. A.W. Horwell - Attendance at Workshop in Victoria

RECOMMEND that the Council approve the expenditure in the amount of \$75.00 for the attendance of Mr. A.W. Horwell, Assistant Electrical Inspector, at the Electrical Inspectors' Association Workshop in Victoria on October 15th and 16th, 1971; and that the City Engineer be advised that in future such applications be submitted to Council prior to the date of the functions involved.

Moved by Alderman Dean, seconded by Alderman Terrace that the above recommendation of the Parks and Buildings Committee be adopted.

Carried.

Building By-law

RECOMMEND that the report of the Building Inspector dated October 21st, 1971, be adopted in principle and the City Solicitor and the City Clerk be instructed to draw up the necessary bylaw to be effective on March 31st, 1972, such by-law to remain in effect until the Greater Vancouver Regional District By-law or a Provincial By-law is in effect; and further that the recommendations contained in the Building Inspector's report of October 21st be incorporated into the City's by-law.

Moved by Alderman Dean, seconded by Alderman Terrace that the above recommendation of the Parks and Buildings Committee be adopted.

Carried.

Board of Works, Waterworks, and Zoning Committee

Alderman Warne presented the following recommendations on behalf of this Committee:

Mr. R.B. Archibald - Street Improvements

RECOMMEND that Mr. R.B. Archibald be advised that the block of Maitland Avenue above him was in poorer condition that in his block and has been given a temporary machine laid surface purely as a maintenance procedure, and should he wish his block to be improved, it may be done by petition, details of which can be obtained from the City Hall.

Moved by Alderman Warne, seconded by Alderman Chadwick that the above recommendation of the Board of Works Committee be adopted.

Carried.

Imperial Oil Company - Construction of Car Wash

Moved by Alderman Warne that the most recent draft of the bylaw to restrict car wash uses in the Service Commercial Zones of the City be presented to Council for first reading.

Alderman Warne withdrew his motion.

Moved by Alderman Warne, seconded by Alderman Terrace that the permit for the construction of a carwash on Lot 4, Resub. 8, Block 18, D.L. 549, (1700 Block Lonsdale Avenue), submitted by Imperial Oil Ltd. be withheld for a period of thirty days from the date of the application. Carried.

It was agreed that the order of business be suspended to consider Item No. 39 on the agenda, under "Unfinished Business", i.e., letters from the Advisory Planning Commission and Urban Programme Planners with reference to this subject.

UNFINISHED BUSINESS

Advisory Planning Commission and Urban Programme Planners - Zoning By-law Amendment re Car Washes

Moved by Alderman Warne, seconded by Alderman Dean that the most recent draft of "Zoning By-law, 1967, Amendment By-law No. 7, 1971", regulating car wash uses in the Service Commercial and other Zones, be presented to Council for first readings.

Mayor Reid refrained from voting on this subject due to conflict of interest.

Moved by Alderman Dean, seconded by Alderman Loucks that "Fluoridation Referendum By-law, 1971", as amended, be introduced and read a first time in short form. Carried.

Whereupon the said by-law was introduced and read a first time in short form, as amended.

Moved by Alderman Terrace, seconded by Alderman Loucks that "Fluoridation Referendum By-law, 1971", as amended, be read a second time in short form. Carried.

Whereupon the said by-law, as amended, was read a second time in short form.

Moved by Alderman Dean, seconded by Alderman Terrace, that "Fluoridation Referendum By-law, 1971", as amended, be read a third time in short form, passed subject to reconsideration, and numbered.

Carried.

Whereupon the said by-law, as amended, was read a third time in short form, passed subject to reconsideration, and numbered 4334.

Mayor Reid reported on a meeting held in his office between himself, Mr. McCairns, representing the Union, Mr. Gilmour, the Mediator, Mr. Leslie of the Labour Relations Bureau, Mr. Gibbs, and Mr. Raymond. He stated he has now received a letter from the Union wherein they challenge the right of the City to pass a by-law containing regulations such as those proposed in the "Fire Department Regulation By-law, 1966, Amendment By-law, 1971", (callbacks), as well as certain other regulations which are now in the Fire Department Regulation By-law.

Moved by Alderman Warne, seconded by Alderman Chadwick that "Fire Department Regulation By-law, 1966, Amendment By-law, 1971" be deferred until the Solicitor has commented on whether the by-law can be amended to read "on call" in
