MINUTES of a Special Meeting of the City Council held in the Second Floor Court Room of the Justice Administration Building on Monday, February 7th, 1972, at 7:05 P.M.

Present:

Mayor Reid called this Special Meeting of Council to order.

The City Clerk advised that this Special Meeting had been called to deal with items on the agenda of the Regular Meeting of Council to take place at 8:00 P.M.

MINUTES

Moved by Alderman Terrace, seconded by Alderman Warne that the Minutes of the Regular Meeting of Council held on January 17th, 1972, the Special Meetings of Council held on January 24th, 1972, and January 25th, 1972, the Finance Committee meeting held on January 18th, 1972, the Regular Meetings of the Standing Committees held on January 24th, 1972, and on January 31st, 1972, and the Special Meeting of the Finance Committee held on February 1st, 1972, be taken as read and adopted, copies of same having been circularized among all Council members and read by them.

Carried.

CORRESPONDENCE

J.A.W. Chadwick - Request for Agendas

Moved by Alderman Warne, seconded by Alderman Terrace that Mr. J.A.W. Chadwick, 323 East 12th Street, be advised, in response to his letter dated February 1st, 1972, that, as it is Council's policy that agendas are posted at the City Hall and are available at the R.C.M.P. Office, Council is not prepared at the present time to send out further copies of the agenda by mail.

Mr. and Mrs. J. McAndrews - Dangerous Trees

The City Clerk advised that the Tree People had been given an order by the owners of 133 East 26th Street, (the property adjacent to Mr. McAndrews'), to have this tree removed.

Alderman Howard entered the meeting at 7:10 P.M.

Moved by Alderman Terrace, seconded by Alderman Warne that as the Council is satisfied that a dangerous tree is located on Lot 10, ex. the N. 33', of Lot 3, Block 229, D.L. 545, known as 133 East 26th Street, the City Clerk be instructed to issue an Order to the owner of the said lot under the "Dangerous Trees Removal By-law" if the said tree is not removed by the owner before February 14th, 1972. Carried.

Mr. Norman Erikson - Barron and Strachan Report on Noise Survey

Moved by Alderman Terrace, seconded by Alderman Warne that

the letter dated January 19th, 1972, from Mr. Norman Erikson, 651 West 15th Street, commenting on the report by Barron and Strachan with respect to a noise survey, be deferred to the next meeting of the Health and Civic Affairs Committee pending further information on this subject to be received from the City Administrator.

Carried.

Silver Harbour Manor Society - Senior Citizens' Activity Centre - Endorsation by Recreation Commission

Moved by Alderman Warne, seconded by Alderman Terrace that the letter dated January 19th, 1972, from the Silver Harbour Manor Society advising that the Recreation Commission and the Governing Committee of the North Shore Division of the United Community Services have endorsed the proposal for the Senior Citizens' Activity Centre on Eastern Avenue, be received and filed.

Carried.

H.L. Waddell & Associates Ltd. - Continuation of Service Station Use - Forbes and 3rd Street

Moved by Alderman Warne, seconded by Alderman Wills that the letter dated January 31st, 1972, from H.L. Waddell & Associates Limited, asking if some arrangement could be made to continue the service station use at the north-east corner of Forbes Avenue and 3rd Street, be referred to the Advisory Planning Commission and the City Planner for a report, and that further consideration of this matter be deferred to the next meeting of the Zoning Committee.

The members felt that information should be obtained as to the views of the adjacent property owners with respect to a rezoning to permit continuation of this use.

Moved by Alderman Terrace, seconded by Alderman Todd that the motion be deferred until such time as further information is obtained from the Land Agent as to ownership of the adjacent property.

Defeated.

The mover and seconder agreed to amend the motion as follows: "That the Land Agent be instructed to obtain information as to the proposed development for this site; and that the matter of the continuation of the service station use be referred to the Advisory Planning Commission and the City Planners for a report."

The City Administrator noted that the application was for the rezoning of Lots 22 to 29, and it should be determined whether they have the authority of the adjacent owners to make an application for rezoning on their behalf, noting that they do not have the authority of the City to apply for rezoning for Lot 26.

The motion as amended was then put and carried.

Canadian Federation of Mayors and Municipalities - Conference - Quebec City

Moved by Alderman Warne, seconded by Alderman Todd that the Circular letter dated January 25th, 1972, from the Canadian Federation of Mayors and Municipalities advising of the deadline for resolutions to the Convention in Quebec City May 21st to 25th, and urging Council to send both elected and appointed officials to the Conference, etc., be received and filed.

Alderman Warne later withdrew his motion.

Moved by Alderman Warne, seconded by Alderman Terrace that Mayor Reid and either a Staff member or Council Member be authorized to attend the Conference of the Canadian Federation of Mayors and Municipalities in Quebec City from May 21st to 25th, 1972, and that their necessary expenses be paid by the City.

Carried.

Seven Seas - Amendment to Landscaping Plan

Moved by Alderman Howard, seconded by Alderman Terrace that the Agreement dated November 5th, 1971, with Seven Seas Marina be amended by new Schedules E (Landscape Plan), and F (Construction Budget), as submitted by the Lessee in accordance with his submission of January 27th, 1972, and that the necessary by-law and amending agreement be prepared.

The Administrator stated that the amendment to the plan did not alter the fact that the Seven Seas was still committed to spending \$50,000 for landscaping and parking.

Moved by Alderman Warne, seconded by Alderman Wills that the motion be amended to add "and that the Seven Seas be requested to provide actual receipts for the work done and that they be advised that the City's intention is to still require the full \$50,000 expenditure for improvements.

Carried.

The motion as amended was then put and carried.

Vancouver Bach Choir - Grant

Moved by Alderman Wills, seconded by Alderman Terrace that the letter dated January 13th, 1972, from the Vancouver Bach Choir requesting a grant for 1972, be referred to the 1972 Grants Committee.

North Vancouver Community Arts Council - Grant

Moved by Alderman Wills, seconded by Alderman Warne that a grant of \$1,000.00 be made to the North Vancouver Community Arts Council; and that a further grant be considered by the Grants Committee later on this year.

Moved by Alderman Warne, seconded by Alderman Wills that the motion be amended to insert the following after the word "Council": "for the operation of the North Vancouver Arts Centre, subject to completion of the facility in 1972".

The City Administrator noted that this group operated on a grant basis and there was no fund raising involved, other than membership fees.

The amending motion was then put and carried.

The motion as amended was then put and carried.

Mr. Glen Lim - Garage Encroachment on Lane

Moved by Alderman Wills, seconded by Alderman Terrace that Mr. Glen Lim be advised, in reply to his letter of January 14th, 1972, requesting permission to have his garage encroach on the lane allowance adjacent to his property at 208 East 22nd Street, that the encroachment may continue until such time as cancellation is necessitated by municipal requirements, at which time the garage is to be moved back whatever distance is required by the City's Zoning By-law. Carried.

Mr. Norman Erikson - Air Pollution Control By-law

Moved by Alderman Howard, seconded by Alderman Warne that the letter from Mr. Norman Erikson, dated January 19th, 1972, asking for certain information with respect to the operation, etc., of the new Air Pollution Control By-law, be referred to Fire Chief Spencer for his comments, and that the Fire Chief be requested to reply to Mr. Erikson, informing him of Council's policy with respect to the handling of complaints under the Air Pollution Control By-law, and advising him that Council will not initiate a test of air pollution control equipment on a regular basis.

District of Campbell River - Air-Sea Rescue Service

Moved by Alderman Todd, seconded by Alderman Terrace that in response to a recent request from the District of Campbell River, this Council request the Department of National Defence and the Department of Transport to take the necessary steps to consolidate air and sea rescue operations on the west coast into one department, so that these operations may be carried on more efficiently, and that the District of Campbell River be advised of Council's action.

Township of Richmond - Public Hearing re Proposed Power Line

Moved by Alderman Todd, seconded by Alderman Terrace that Council endorse the request of the Council of the Tonwship of Richmond to the Provincial Government that a Hearing be held under the Evnironment and Land Use Act on a proposal by Hydro to cross certain park property in the municipality with a transmission line, and that they be so advised. Carried.

Mrs. W. Larmour - Request for Local Improvement on Initiative Basis

Moved by Alderman Terrace, seconded by Alderman Todd that Mrs. W. Larmour, 342 West 24th Street, be advised, in reply to her letter dated January28th, 1972, enclosing incomplete local improvement petition and asking if the City would consider proceeding with this improvement on an initiative plan, that Council is not prepared at this time to initiate the improvement of 24th Street from Jones Avenue to Mahon Avenue.

Carried.

INQUIRIES

Alderman Terrace inquired if any date had been set for the meeting with the District with respect to the Tempe-Boundary development.

Mr. Raymond advised that Mayor Andrews of the District would return at the end of February, and it was suggested by Mayor Reid that the meeting be set for either February 17th or March 1st.

Alderman Wills asked if any information had been obtained with respect to his questions regarding land requirements for the approaches to the Third Crossing, and Mayor Reid advised such information would not be available until such time as it was known definitely whether the crossing will be built.

Alderman Wills felt this information should be obtained prior to the Council making any commitment.

Alderman Terrace inquired as to whether or not there had been any further development in negotiations with the Indian Band for a Low Level Road, and Mayor Reid advised there had not.

REPORTS OF COMMITTEES

Chairmen presenting recommendations to Council gave a back-ground explanation in each case.

Finance and Legal Committee

Alderman Wills presented the following recommendations on behalf of this Committee:

Sign-O-Lite Signs Ltd. - City Property at Fell Avenue and Marine Drive

RECOMMEND that Sign-O-Lite Signs Limited be advised that their lease of the City property at Fell Avenue and Marine Drive expires on February 29th, 1972, and that they be requested to vacate as of that date; and further that they be advised that the City will accept their cheque for the back taxes owing on the property.

Moved by Alderman Wills, seconded by Alderman Warne that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Mahon Pool - Agreement for Gas Service Heating

RECOMMEND that the Mayor and Clerk be authorized to execute the Agreement with B.C. Hydro to provide for gas service heating for Mahon Pool for one year.

Moved by Alderman Wills, seconded by Alderman Warne that the above recommendation of the Finance and Legal Committee be adopted. Carried.

Procedure for Handling Letters Addressed to Council - Report of Administrator

RECOMMEND that the Council adopt the report of the City Administrator, dated January 20th, 1972, dealing with a new procedure proposed for the handling of letters addressed to Council, as amended by the Finance and Legal Committee under date of January 31st, 1972.

Moved by Alderman Wills, seconded by Alderman Terrace that the above recommendation of the Finance and Legal Committee be adopted.

Carried.

C.H. Cates & Sons - Lease of Lands at Foot of Lonsdale Avenue

RECOMMEND THAT WHEREAS The Corporation of the City of North Vancouver (hereinafter called the City), is the lessee of a parcel of land in the City of North Vancouver, (not being required for municipal purposes and not being reserved or dedicated), namely the parcel of land hereinafter described, upon which there is not any building or structure of any kind, and it is not the intention of the Council that the said land be sub-leased by public auction:

RECOMMEND that Block E, D.L. 272, (north of Canada Pittsburgh Paint Co. on Cotton Road), be reserved by by-law for park purposes, in accordance with Section 467 of the Municipal Act; and that a by-law to provide for the dedication of this site as a park be placed before the electors at the first referendum or election in the current year.

Moved by Alderman Terrace, seconded by Alderman Wills that the above recommendation of the Parks and Buildings Committee be adopted. Carried.

Board of Works, Waterworks, and Zoning Committee

Alderman Warne presented the following recommendations on behalf of this Committee:

Mr. A. Dreszach - Complaint re Blasting Damage

RECOMMEND that Mr. A. Dreszach, of 417 East 20th Street, be advised, in response to his letter of September 3rd, 1971, complaing of damage to the stucco of his house by blasts at the new reservoir site, that this matter is the responsibility of the Blasting Contractor; and further that a copy of the report received by the City Engineer from Pacific Blasting Company, in which they deny any responsibility for damages, be forwarded to Mr. Dreszach.

Moved by Alderman Warne, seconded by Alderman Wills that the above recommendation of the Board of Works Committee be adopted.

Alderman Terrace presented the following recommendations on behalf of this Committee:

Delayed Green Traffic Signal -Highway 401 and Westview Drive -Cost Sharing with District

RECOMMEND that a letter from this Council go to the District Council, outlining the situation with respect to the installation of a delayed green signal at the intersection of Highway 401 and Westview Drive, and suggesting they share the City's portion of the cost, being \$1,000.00, on a 50/50 basis.

Moved by Alderman Terrace, seconded by Alderman Todd that the above recommendation of the Traffic Committee be adopted.

By-law to Regulate Access to and From Public Highways

RECOMMEND that the correspondence with respect to a proposed by-law to regulate access to and from a public highway, be received and filed.

Moved by Alderman Terrace, seconded by Alderman Wills that the above recommendation of the Traffic Committee be adopted.

Carried.

Labour Relations Committee

Alderman Warne advised there was nothing to report on behalf of this Committee.

Police Committee

Alderman Warne advised there was no report this evening on behalf of this Committee.

Recreation Centre Board Representative

Mayor Reid advised there was no report on behalf of the Board this evening.

Recreation Commission Representative

Alderman Warne advised that the Commission was considering a policy whereby more public use could be made of City Schools.

Department of National Defence - Agreement for Attack Warning Siren

Carried.

Extension - North Shore Neighbourhood House - Report of City Engineer

The City Clerk stated that members of Council had received copies of the report dated February 3rd, 1972, from the City Engineer on the proposed extension of North Shore Neighbourhood House.

Moved by Alderman Warne, seconded by Alderman Terrace that the firm of L.O. Lund & Associates be appointed architects for the extension of North Shore Neighbourhood House on the basis of an agreement suitable to the City Engineer and the City Solicitor; and that the Mayor and Clerk be authorized to execute the necessary contract.

Carried.

Moved by Alderman Warne, seconded by Alderman Todd that the question of whether Lot 1, Block 154, D.L. 274, or Lots 25 and 26 of Block 155, D.L. 274, should be used as the parking area for North Shore Neighbourhood House, be deferred to the Parks and Buildings Committee.

After discussion, Alderman Warne withdrew the deferring motion.

Moved by Alderman Wills, seconded by Alderman Terrace that Lots 25 and 26, Block 155, D.L. 274 be considered for rezoning to Public Use and Assembly Zone in order to provide the necessary parking for the extension to North Shore Neighbourhood House; and that the Clerk be authorized to obtain the necessary reports and set a date for a public hearing.

The mover and seconder agreed to amend the motion to add "and that Lots 1 and 2, Block 154, D.L. 274, be also rezoned to P-1 Public Use and Assembly Zone".

The motion as amended was then put and carried.

Moved by Alderman Terrace, seconded by Alderman Wills that His Worship's recommendation be accepted and that Mr. Victor Anderson and Mr. Philip Joe be reappointed to the Board of Variance as the City's representatives for a further three-year period commencing February 1st, 1972.

Subsidized Low Rental Family Housing - Motion by Alderman Warne

Moved by Alderman Warne, seconded by Alderman Terrace that Council accept the principle that some subsidized low rental family housing should be located within the City of North Vancouver boundaries.

The mover and seconder agreed to amend the motion as follows:

"That Council accept the principle that some low purchase cost or low rental family housing should be located within the City of North Vancouver boundaries".

The motion as amended was then put and carried.

Moved by Alderman Warne, seconded by Alderman Wills that future residential developments on land currently owned by the City are to provide a minimum of seven per cent of the housing units constructed for sale to the Greater Vancouver Regional District to be operated as low rental family housing, if considered practical by Council when each land parcel is developed.

Moved by Alderman Howard, seconded by Alderman Todd that the above motion be deferred for discussion in Committee. Carried.

Motion Standing in the Name of Alderman S. Dean re Tempe-Boundary Development

Moved by Alderman Howard, seconded by Alderman Wills that the motion standing in the name of Alderman S. Dean with respect to the development of the Tempe-Boundary area, be deferred to the next Regular Meeting of the Council. Carried.

Sale of Property to Eagle Enterprises & Starbac Construction - Approval from the Minister

Moved by Alderman Terrace, seconded by Alderman Howard that

the letters dated January 26th and January 28th, 1972, from the Deputy Minister of Municipal Affairs, enclosing approvals for the sale of property to Eagle Enterprises Limited and to Starbac Construction Limited, respectively, be received and filed. Carried

Moved by Alderman Terrace, seconded by Alderman Howard that this Special Council Meeting now adjourn. Carried.

RECOMMEND that a letter be sent to the Regional District, asking them to give one of the first priorities when they take over the function of air pollution control, to an analysis for carbon in the City of North Vancouver, smoke stack emissions from Horne's Shingle Mill, and dust from potash at Neptune Terminals, using a high volume sampler; AND THAT a copy of the letter dated February 7th, 1972, from the B.C. Research Council be forwarded to them; AND FURTHER THAT they be requested to advise Council as to the date on which they will be taking over the function of pollution control.

Moved by Alderman Warne, seconded by Alderman Wills that the recommendation be amended by deleting the clause "using a high volume sampler".

- (3) The City will consider further participation if a significantly better level of service to City residents is provided than is shown in "Appendix 'A' Plan for Expanded Bus System."

AND THAT the Greater Vancouver Regional District be asked for a reply to Council's letter dated December 23rd, 1971, with respect to this subject, at their earliest convenience.
