North Shore Daycare Council - Request for Zoning By-law Amendment

Moved by Alderman Dean, seconded by Alderman Wills that the letter dated June 7th, 1972, requesting an amendment to the Zoning By-law for child day care use be deferred until a further study of the City's by-law and those of other municipalities can be made by the Advisory Planning Commission, and that the Commission be requested to report back to Council in one month's time.

City Land & Water Lots, Foot of Bewicke Avenue, and Former City Yard Site - Report from Land Agent

The Council members considered the report from the Land Agent dated June 29th, 1972, with respect to tenders to lease City land and water lots, at the foot of Bewicke Avenue, and the former city yard site at 1st Street and Chesterfield Avenue, noting that no tenders had been received for the latter.
