Carried.

No delegations were present this evening.

Moved by Alderman Terrace, seconded by Alderman Wills that / Item No. 27 on the agenda, dealing with a request for a leave of absence for Mr. David Blair, be placed on the table.

Carried.

REPORTS OF COMMITTEES AND STAFF REPORTS

Mr. David Blair - Request for Leave of Absence - Report from Acting City Administrator

Moved by Alderman Terrace, seconded by Alderman Wills that Mr. David Blair, Timekeeper at the City Yard, be granted leave of absence with pay for the period August 14th to 21st, 1972, for the purpose of representing Canada at the World Paraplegic Olympics in Heidleberg, West Germany, and further that the Council wish him the best of success in the competitions.

CORRESPONDENCE

North Shore Realty - Application to Rezone - Lot 17, Block 120, D.L. 274 (500 Block Lonsdale)

Moved by Alderman Dean, seconded by Alderman Warne that Council endorse the recommendations of Urban Programme Planners and the Advisory Planning Commission to refuse the application from North Shore Realty, dated June 26th, 1972, to rezone Lot 17, Block 120, D.L. 274, (west side, 500 Block Lonsdale Avenue), from RH High Density Residential to C-1 Central Commercial, and that the applicants be so advised; and further that a copy of the report from Urban Programme Planners be forwarded to Mr. Black of North Shore Realty.

B.C. Hydro & Power Authority - re "Park and Ride" Service for North Shore

Moved by Alderman Warne, seconded by Alderman Wills that the B.C. Hydro and Power Authority be advised that this Council is disappointed that they are not prepared to participate in an early park and ride service, but that Council is willing to cooperate in a special Joint Committee to be set up with B.C. Hydro to explore the feasibility and arrangements for this project; and further that Alderman Bryan Terrace and City Engineer T.J. Scott be appointed to such Committee. Carried.

Moved by Alderman Warne, seconded by Alderman Dean that letters be written to the Members of the Legislature representing the North Shore, and to Premier Bennett, requesting their assistance in implementing a "park and ride" service for North Vancouver; and further that the facts and figures be obtained from Vancouver and West Vancouver with respect to the park and ride service provided in these two municipalities. Carried.

Provincial Minister of Recreation and Conservation - re "S.S. BEAVER"

Moved by Alderman Dean, seconded by Alderman Todd that the letter dated July 25th, 1972, from the Provincial Minister of Recreation and Conservation regarding the suggestion that the Province purchase "S.S. BEAVER" be received and filed.

Carried.

Union of B.C. Municipalities - re Resolutions Submitted to 1972 Convention

Moved by Alderman Dean, seconded by Alderman Terrace that Items 3 and 4 in the letter dated July 21st, 1972, from the Executive Director of the Union of B.C. Municipalities, dealing with the City's resolutions re railway noise pollution and traffic regulation enforcement on parking lots, be sent back to the Executive of the U.B.C.M., asking them to reconsider, as Council wishes that they be included in the resolutions submitted to the 1972 Convention. Carried.

Moved by Alderman Warne, seconded by Alderman Wills that the Union of B.C. Municipalities be advised that this Council feels that the Regional District concept should be reviewed by the U.B.C.M., in view of the fact that five years has elapsed since its inception and there are certain aspects, such as the principle of appointing Board Members rather than electing them, which should be re-examined, and Council therefore would like their resolution to go before the 1972 Convention. Carried.

District of North Vancouver - re North Vancouver Recreation Commission

Moved by Alderman Dean, seconded by Alderman Warne that Mr. D.A. Welsh, Municipal Manager of the District of North Vancouver, be advised, in reply to his letter of July 21st, 1972, that this Council favours nine members on the North Vancouver Recreation Commission, in accordance with the

original by-law; and that Council has concurred that Mr. Ted Harrison should be the 9th member; and further that it be stipulated that at least one member of the three Commissioners appointed to the Centre Management Committee by the Chairman of the Recreation Commission, be a City representative.

Northern Waterfront Holdings Ltd. Application for Land Use Contract - Report
from Administrator

Moved by Alderman Warne, seconded by Alderman Terrace that Mr. L. Marks, Manager, Real Estate, National Harbours Board, be thanked for his letter of July 19tb, 1972, with respect to Northern Waterfront Holdings Ltd., and that further information be requested from him, i.e, details of the lease with Northern 2 Waterfront Holdings, in particular the term of the lease, and the rental rate that will be charged. Carried.

Moved by Alderman Warne, seconded by Alderman Terrace that Meredith & Company, Solicitors for Northern Waterfront Holdings, be advised that Council is prepared to grant an extension to their clients for the occupation of the Chesterfield Avenue street end property until September 30th, 1972, while negotiations continue.

Tenders - Lease of Property at Foot of Bewicke Avenue - Report from Administrator

The City Clerk noted that the tender from Paul Furrer Yacht Brokers Ltd. for City property at Bewicke Avenue street end had been withdrawn.

Moved by Alderman Terrace, seconded by Alderman Dean that the Staff be instructed to obtain information as to the time of the transfer to the Squamish Indian Band of certain lands by the National Harbours Board, including the waterlot formerly leased by the Board to the City, and pursue a refund of rentals paid, as appropriate.

Carried.

Moved by Alderman Warne, seconded by Alderman Terrace that the Staff pursue the acquisition of a lease for the waterlot at the foot of Bewicke Avenue from the Squamish Indian Band for the purpose of subleasing. Carried.

Lease of Waterlot in Front of West Half of Fell Avenue - Report from City Engineer

Moved by Alderman Dean, seconded by Alderman Todd that Mayor Reid invite Mr. W. Rathie, member of the National Harbours Board, to meet with all the members of this Council for the purpose of discussing the rates and policy of the Board with respect to leases; and that this item be deferred until after such meeting has been held. Carried.

Mrs. B.J. Summers - Application for Rezoning - (400 Block Lyon Place and Keith Road) - Report from Advisory Planning Commission

Moved by Alderman Warne that a date be set for a Public Hearing in connection with the rezoning of Lot 24, Block 105, D.L. 550, to Two Family Use, and that the necessary advertisting be carried out.

There was no seconder for the motion.

Moved by Alderman Dean, seconded by Alderman Terrace that Mrs. Barbara J. Summers be advised that Council is deferring her application for the rezoning of Lot 24, Block 105, D.L. 550, to RT - Two Family Use until after the Long Range Development Programme prepared by the City's Planning Consultants, has been discussed.

Office Uses in M-1 Industrial Zones -Reports from Planners and Advisory Planning Commission

Moved by Alderman Dean, seconded by Alderman Wills that the recommendations of Urban Programme Planners and the Advisory Planning Commission be approved, and that no changes be made to the industrial zone regulations with respect to office space in these areas; but that applications for business licences in specific locations in industrial zones will be considered individually by Council. Carried.

Child Care Services - Request from Advisory Planning Commission for Extension of Reporting Time

Moved by Alderman Terrace, seconded by Alderman Wills that the Advisory Planning Commission be given a thirty day extension for further study of an amendment to the Zoning By-law relating to child care services. Carried.

Rezoning - 124 West 8th Street (Elim Chapel) - Reports from Advisory Planning Commission and Urban Programme Planners

Alderman Wills asked to be excused from discussion of this subject because of a possible conflict of interest and absented himself from the Council Table.

Moved by Alderman Dean, seconded by Alderman Todd that the application of North Shore Realty Ltd. for the rezoning of property at 124 West 8th Street, (Elim Chapel), from P-2 Zone to C-1 Commercial Zone, be refused.

Moved by Alderman Terrace, seconded by Alderman Howard that Mr. J.W. Black of North Shore Realty, be heard with respect to this subject.

Carried.

Mr. Black advised that the zoning he was requesting was not C-1, which would automatically permit a retail use, but a specific commercial zoning which would cover everything except retail, specifying the type of business allowed in the new zoning.

Moved by Alderman Howard, seconded by Alderman Dean that the application of North Shore Realty Ltd. for the above rezoning, be deferred until Council has had an opportunity to further study the plans submitted and to consult with the Staff on this matter.

Carried.

Alderman Wills returned to the meeting at 8:45 P.M.

Mr. John Simpson - Accessory Off-Street Parking in Residential Zones - Report from Advisory Planning Commission

Moved by Alderman Terrace, seconded by Alderman Dean that the 'Zoning By-law, 1967" be amended by deleting Section 508 (2)(c) and substituting the following therefor:

"house trailers, boat trailers or boats, except that one house trailer and one or more boats may be parked or stored on the lot, in any open space to the rear of the line of the building wall facing the street, to a maximum combined length of 40 feet;"

AND THAT a Public Hearing be held on September 5th, 1972, at 7:30 P.M., for this purpose, and that the Clerk be authorized to carry out the necessary advertising for such Hearing;

AND FURTHER THAT Mr. John Simpson, 235 East 26th Street, North Vancouver, B.C., be advised of the foregoing, and that subject to compliance with all other applicable City by-laws, the City Engineer is hereby authorized to grant a street crossing as applied for by Mr. Simpson.

Moved by Alderman Howard, seconded by Alderman Dean that the above resolution be deferred pending further information on this subject. Carried.

Applications for Building Permits - 1st Street and Donaghy Avenue and 144 West 15th Street - Report from City Engineer, etc.

Moved by Alderman Dean, seconded by Alderman Warne that the matter of the legality of withholding building permits on the recommendation of the Advisory Design Panel and the Advisory Planning Commission be referred to the City Solicitor for a ruling, and that in the meantime the Building Inspector be instructed to withhold building permits for the proposed industrial building at the northeast corner of 1st Street and Donaghy Avenue, and the proposed commercial building at 144 West 15th Street, in view of the fact the Council concurs with the recommendations of the Advisory Planning Commission and the Advisory Design Panel that the designs are not satisfactory. Carried.

Moved by Alderman Warne, seconded by Alderman Wills that the City Administrator be instructed to recommend a change in the "Advisory Design Panel By-law" for the purpose of streamlining the procedure to one similar to that used by the District of West Vancouver. Carried.

Moved by Alderman Dean, seconded by Alderman Wills that Item No. 29 on the Agenda, with regard to a land use contract for Northmount Medical Building, be now considered. Carried.

Northmount Medical Building - Land Use Contract - Report from Planners

Moved by Alderman Dean, seconded by Alderman Warne that in accordance with the recommendation of Urban Programme Planners in their letter of August 1st, 1972, the following steps be now taken with respect to the land use contract for the Northmount Medical Building:

- 1. Designation of the CD-4 Zone as a Development Area.
- 2. Initiate the closure of the north-south lane to vehicular traffic.
- 3. Holding of a Public Hearing for this purpose on September 5th, 1972, at 7:30 P.M. Carried.

Barron & Strachan Noise Survey - Report from Alderman Warne

Alderman Warne reported orally on the Noise Survey conducted by Barron & Strachan for the Greater Vancouver Regional District.

Alderman Warne stated that most of the stations in North Vancouver included in the report were actually located in the District, and as a result there was very little noise data for the City.

Moved by Alderman Wills, seconded by Alderman Dean that
Alderman Warne's report with respect to this subject be
received with thanks.

Carried

It was requested that staff obtain information with respect to a noise survey to be conducted in the City, and that it be recommended to the 1973 Council that monies for this purpose be included in the Budget.

Moved by Alderman Dean, seconded by Alderman Howard that the Greater Vancouver Regional District be again advised that this Council is not happy with the noise survey conducted by Barron & Strachan, pointing out that very few locations in the City of North Vancouver were covered in the survey, and also querying the fact that according to the survey, the south-eastern portion of the City showed a relatively low noise level. Carried.

B.C. Association of Assessors - 1972 Conference - Report from Administrator

Moved by Alderman Dean, seconded by Alderman Terrace that Council approve the attendance of Mr. Joseph S. Elkin, Senior Appraisor, at the 23rd Conference of B.C. Association of Assessors being held in Kamloops on September 6th, 7th, and 8th, 1972, and that his necessary expenses be paid in accordance with the City's policy. Carried.

Additional Staff & Equipment - Treasurer's Department - Report from Administrator

Moved by Alderman Dean, seconded by Alderman Wills that the request for additional staff and equipment for the Treasurer's Department be deferred pending further information on the cost of the program, the amount of overtime worked, etc., which items of the current workload in the Department are continuing and which will be ending at the end of this year, as well as the cost incurred in having a firm of consultants screen applicants for the position of senior accounting clerk.

Long Range Development Policy - Report from Administrator

Moved by Alderman Warne, seconded by Alderman Todd that the report entitled "Stage One - Development Alternatives for a Long Range Development Policy for the City of North Vancouver" be released to the public during the first week in September, 1972, and that the printing of 10,000 copies of the report, (in colour), at approximately \$600.00 plus mailing costs, be authorized for the purpose of circulation to all householders in the City of North Vancouver, and further that ratepayers and other groups be encouraged to hold public meetings, chaired by a member of Council, for the purpose of hearing the views of the public with respect to the future growth and development of the City.

Carried.

Camp Sites - Report from Administrator

Moved by Alderman Dean, seconded by Alderman Wills that this Council ask Mr. L.J. Wallace, Deputy Provincial Secretary, to look into the feasibility of creating camping sites in Seymour Park and Cypress Bowl, and that the City Engineer be requested to report with respect to the capital cost of constructing a camp site within the City of North Vancouver, the number of camping spaces available and the revenue which might be obtained from same, and the cost of operating such a camp site.

Carried.

XL Burgers - Application to Erect a Sign on City Property - Report from Land Agent

Moved by Alderman Terrace, seconded by Alderman Dean that the application from XL Burgers to erect a sign at the southeast of corner of Fell Avenue and Marine Drive, on City property, be refused.

Carried.

Tenants in Residences on New City Hall Site - Report from Land Agent

Moved by Alderman Dean, seconded by Alderman Terrace that this item be discussed in camera at the end of this meeting.

Carried.

Closure of Portion of Jones Avenue - Report from Land Agent

Moved by Alderman Dean, seconded by Alderman Wills that the City pay the legal fees for the closure of a 32 ft. strip of the east side of Jones Avenue fronting the property between West 23rd and West 21st Streets, including those incurred on behalf of Mr. R.G. Lebed, and that Mr. Lebed repay the City by instalments, including the usual interest, as suggested by the Land Agent.

The mover and seconder later withdrew their motion.

Moved by Alderman Warne, seconded by Alderman Dean that the reports from the Land Agent, dated July 25th and 27th, 1972, with respect to the closure of a 32 foot portion of the east side of Jones Avenue, in the 2100 and 2200 Blocks, be received and filed; and that the necessary by-law be prepared to stop up and close the said portion of Jones Avenue, and that staff take the necessary action to incorporate the closed portions with City-owned property in accordance with the Plans Cancellation Act.

Bandstands & Public Washrooms - Victoria Park - Report from City Clerk and City Engineer

Moved by Alderman Terrace, seconded by Alderman Warne that a cement floor be constructed on one of the terraced areas in Victoria Park, graded to be self draining, for use as a bandstand during daylight hours only, and for other recreational uses such as bike riding, tether ball, etc., and that the necessary funds for such construction be provided in the 1973 Budget.

Moved by Alderman Howard, seconded by Alderman Todd that staff be instructed to obtain estimates of cost for the construction of a portable platform on wheels, which could be

used for staging various events, including band concerts, and which might also be used as a base for a North Shore Parade Float.

Alderman Dean is recorded as voting against the motion.

Local Improvement Lane Petitions - Report from City Clerk

Moved by Alderman Warne, seconded by Alderman Todd that the City Engineer be instructed to prepare the necessary reports and estimates of cost for the construction of the following works as local improvements:

- (a) Paved lane north of Shavington Street from Kennard Avenue to Keith Road.
- (b) Paved lane north of 5th Street from Queensbury Avenue to Moody Avenue. Carried.

Lane West of Lonsdale - 23rd Street to Upper Levels - Report from City Engineer

Moved by Alderman Dean, seconded by Alderman Warne that the local improvement lane paving initiative west of Lonsdale Avenue from 23rd Street to the Upper Levels Highway be not proceeded with until such time as the Department of Highways finalizes its plans with respect to the widening and grade separation of the Upper Levels Highway. Carried.

Heywood Street Green Strip - Report from Land Agent

Moved by Alderman Dean, seconded by Alderman Terrace that this item be discussed in camera at the end of this ? meeting. Carried.

City Land Purchase - Moodyville Park - Report from Land Agent

Moved by Alderman Dean, seconded by Alderman Terrace that this item be considered in camera at the end of this meeting. Carried.

North Vancouver Fire Fighters Association - Report by Mayor Reid re Labour Negotiations

Moved by Alderman Dean, seconded by Alderman Todd that this item be tabled to the end of the meeting for discussion in camera. Carried.

The City Clerk advised that this Special Meeting had been called to consider the application of North Shore Realty Limited to rezone Lot 4, Block 86, D.L. 548/549, (124 West 8th Street - Elim Chapel), from P-2 Public Use and Assembly zone to C-1 Commercial zone.

Alderman Dean entered the meeting at 3:12 P.M.

Moved by Alderman Terrace, seconded by Alderman Todd that Fir. Black of North Shore Realty, who was present in the public gallery, be heard. CARRIED.

Moved by Alderman Dean, seconded by Alderman Howard that no action be taken at this time with respect to the rezoning of the subject property.

Mr. Tlack stated that he wished this property rezoned to C-1 Conmercial and that a special clause be used to provide that the property would be used strictly for office accommodation and not retail. He advised that if Council did not wish to consider rezoning, his clients would be quite happy to consider a land use contract. He stated that there are many properties which are apartment zoned but which are too small to be used for this purpose but which could be used very nicely for the type of commercial purpose mentioned.

The motion was then put and defeated.

Moved by Alderman Howard, seconded by Alderman Terrace that this Council go into Committee of the Whole to discuss this matter in camera. CARRIED.
