5. Portable Band Shell - Report from City Administrator

Moved by Alderman Todd, seconded by Alderman Howard that Council approach the District of North Vancouver and ask them if they would consider the purchase of a "Showmobile" portable band stand on a cost sharing basis with the City, at an approximate cost of \$21,000.00.

6. Northern Waterfront Holdings Ltd. -Temporary Occupation of Chesterfield Avenue Street End

Moved by Alderman Wills, seconded by Alderman Dean that the following recommendation of the Policy Committee be adopted:

RECOMMEND THAT a permit to occupy temporarily the foot of Chesterfield Avenue, in a form satisfactory to the City's Solicitor, be granted to Northern Waterfront Holdings, subject to:

- (1) Permission to use may be terminated by the City on thirty days' notice.
- (2) Fixtures as previously established will remain on the property on termination of this permit.
- (3) The permittee will carry liability insurance and meet requirements of Federal and Provincial regulations as regards the Inner Harbour, and pay any applicable Harbours Board rental on Parcel G.
- (4) The permittee to pay taxes or an amount in licu of taxes.
- (5) The permittee be required to provide temporary ferry docking facilities on his existing wharf should the City so require, on the basis that no charge be made for the ferry or passengers, but charges may be levied for motor vehicle parking.
- AND THAT the matter of development of this property be referred to the City Administrator with the instruction that any development provide for public access to the waterfront; it shall be consistent with the City's planning for the entire area, and costs of servicing outside the property be that of the developer.

Moved by Alderman Wills, seconded by Alderman Todd that the City of North Vancouver provide the old City Hall and property for the uses described in the brief submitted by the North Vancouver Community Arts Council, dated December, 1972, proposing the establishment of an arts centre for a period not less than five years and not more than ten years from the date of Council's vacating the premises to a new City Hall, subject to capital funds and operational cost sharing being arranged; and subject to the District of North Vancouver co-operating in this project on behalf of the citizen users residing in the District to the extent of including in their 1973 five year capital budget provision for the estimated capital expenditures as detailed in Section 4A of the said brief; and subject further to the City and District Councils sharing in the annual operating costs of an Arts Centre on a basis of a cost sharing formula as detailed in Section D of the brief.

Moved by Alderman Warne, seconded by Alderman Dean that the motion be deferred for one week. CARRIED.

 Silver Harbour Manor Society -Senior Citizens Activity Centre

Moved by Alderman Terrace, seconded by Alderman Wills that the matter of the development of the Senior Citizens Activity Centre be placed on the agenda.

CARRIED.

Mayor Reid advised that the Society had applied for a grant under the Local Initiatives Program, but that Manpower, who are handling these grants, had suggested that if the application was made as a municipal grant it would expedite the receiving of funds.

The motion as amended was then put and CARRIED.
