MINUTES of the Regular Meeting of the City Council held in the Second Floor Court Room of the Justice Administration Building on Monday, February 5th, 1973, at 7:38 P.M.

#### Present:

Acting Mayor G. Todd, Alderman J.B. Braithwaite, Alderman F.S. Marcino, Alderman J.M. Warne, Alderman C.E. Wills, City Administrator/Acting City Clerk Mr. E.A. Raymond, and Assistant City Clerk Mrs. L. Wilson.

Acting Mayor Todd called this Regular Meeting of Council to order.

## 1. MINUTES

Moved by Alderman Warne, seconded by Alderman Wills that the Minutes of a Public Hearing of Council held on January 29th, 1973, the Regular Meeting of Council held on January 29th, 1973, and of a Recessed Meeting of Council held on January 30th, 1973 be taken as read and adopted as circularized.

CARRIED.

#### DELEGATIONS

The Acting Clerk advised that although there were no delegations listed on the agenda, he had been advised that representatives of the Inner Harbour Parks on the Waterfront Society wished to address the Council with respect to the property at the foot of Bewicke Avenue, on which Council had accepted a tender in the name of Don Vaughan & Associates.

Moved by Alderman Warne, seconded by Alderman Marcino that the subject of the Bewicke Avenue Street-End Lease be placed on the agenda for discussion.

CARRIED.

 Inner Harbour Parks on the Waterfront Society - Foot of Bewicke Avenue

Moved by Alderman Marcino, seconded by Alderman Wills that a spokesman for this organization be heard. CARRIED.

Mr. Vaughan, speaking on behalf of the Society, advised that the lease for the Bewicke Avenue street end had been in the name of Don Vaughan and Associates, and they now wished to have it changed to the Inner Harbour Parks on the Waterfront Society, which is a non profit organization to develop the foot of Bewicke Avenue for park purposes. He noted that at the time of the tender there had not been an opportunity to arrange for such a change of name, and for this reason the tender had been submitted in the name of Don Vaughan and Associates. He said the Society was now incorporated under the Societies Act, and that it was comprised of a number of directors from various community groups, such as North Shore Neighbourhood House, the Community Arts Council, the Fish and Game Club, Lower Lonsdale Community Citizens Council, and several other organizations.

Mr. Vaughan stated the organization had applied for an L.I.P. grant, which would be available to a non profit organization but not to Don Vaughan and Associates, and it would be

necessary for the change of name before such a grant could be received.

Mr. Raymond noted that the terms of the lease permitted re-assignment of the contract, or subletting.

Moved by Alderman Braithwaite, seconded by Alderman Wills that the Mayor and Clerk be authorized to execute the lease between the City and Don Vaughan and Associates for the Bewicke Avenue street end, in accordance with the tender submitted, subject to the form of such lease having been approved by the City Solicitor and the Administrator.

CARRIED.

Moved by Alderman Wills, seconded by Alderman Marcino that Don Vaughan and Associates be authorized to assign the lease between them and the City for the Bewicke Avenue street end and dock to the Inner Harbour Parks on the Waterfront Society.

CARRIED.

## REPORTS OF COMMITTEES AND STAFF REPORTS

Mr. Raymond inquired if Council wished at this time to consider Item No. 14 on the agenda, the present status of City property on Jones Avenue, as several people in the gallery were interested in Council's decision on this subject.

Moved by Alderman Braithwaite, seconded by Alderman Warne that Item No. 14 on the agenda be discussed at this time. CARRIED.

3. City Property on Jones Avenue - Report from the Land Agent

Moved by Alderman Wills, seconded by Alderman Marcino that the report of the Land Agent, dated February 2nd, 1973, on the present status of the City property on Jones Avenue, and further consideration of the disposition of the said property, be deferred until the Council has had an opportunity to obtain more information with respect to the possible leasing of the property, and also to study the correspondence received from the Greater Vancouver Regional District suggesting use of this site in connection with their housing program.

CARRIED.

5. Draft Business Licence By-law

Moved by Alderman Warne, seconded by Alderman Wills that the motion be amended by adding the following:

"and that the Chamber of Commerce, the Merchants' Association, or any other business groups who have in the past made representations to Council be given copies of the draft by-law for perusal; and further that any other person wishing a copy of the by-law be provided copies at cost, and that anyone receiving the by-law be invited to comment on same by February 22nd at the latest, before the final passage of the by-law."

Alderman Braithwaite is recorded as voting against the amending motion.

The motion as amended was then put and CARRIED.

Alderman Braithwaite is recorded as voting against the motion.

## 6. Implementation of Business Tax

Moved by Alderman Wills, seconded by Alderman Warne that the City Administrator be instructed to conduct an indepth study of the feasibility of implementing a business tax across the North Shore, subject to the District of North and West Vancouver co-operating in the said study, for the purpose of providing information on the administrative costs of imposing such a tax, and the effects it would have on the business commmunity.

CARRIED.

7. Resolution to U.B.C.M. re Ceiling on Business Licence Fees

Moved by Alderman Wills, seconded by Alderman Marcino that a resolution be submitted to the Union of B.C. Municipalities requesting the removal of the present ceiling on business licence fees to permit a more proportionate share of licence fees to be borne by larger industries in municipalities which choose not to implement a business tax.

CARRIED.

Policy Committee - January 30th, 1973

Inter-Municipal Transportation Committee

Moved by Alderman Wills, seconded by Alderman Warne that two members of this Council be appointed to an inter-municipal transportation committee consisting of the representatives of the four North Shore Municipalities, (including the Squamish Indian Band), and the three North Shore M.L.A.'S, to be formed for the purpose of drawing up terms of reference with a view to resolving the problems of transportation in the four municipalities.

## 9. R.C.M.P. Staff - Report from Administrator

Moved by Alderman Marcino, seconded by Alderman Warne that the proposal of Inspector R.N. Heywood with respect to employment of four municipal employees, to release four policemen for other duties in the detachment, be approved in principle subject to the staff negotiating a satisfactory cost sharing formula with the District of North Vancouver, and subject further to a Municipal Labour Relations Bureau study confirming that a saving will be effected by such a move, and subject to the necessary funds being allocated in the 1973 budget.

CARRIED.

10. North Vancouver Recreation Commission - Revision of Budget - Report from Administrator

Moved by Alderman Wills, seconded by Alderman Warne, that the letter of the North Vancouver Recreation Commission dated January 18th, 1973, advising of the addition of \$31,690 to their Budget for the purpose of purchase of services from North Shore Neighbourhood House for recreation programs, be received and referred for consideration of the Budget Committee.

CARRIED.

11. North Vancouver Recreation Commission -Amendment of Agreement - Report from City Administrator

Moved by Alderman Warne, seconded by Alderman Wills that Clause 9(5)(b) of the agreement attached by By-law No. 4211 be amended to read as follows:

"The Commission is hereby empowered to hire, direct, discipline and discharge such employees as may be necessary for the operation and maintenance of its programs and facilities, and may negotiate in conjunction with the City of North Vancouver and the District of North Vancouver to enter into a collective agreement with Local 389, Canadian Union of Public Employees as the "Employer", as defined in the Labour Relations Act."

CARRIED.

12. Inspection Charges - Report from City Administrator

Moved by Alderman Warne, seconded by Alderman Marcino that the levying of an inspection charge at a rate of \$50.00 per dwelling unit be approved, and that City staff be instructed to prepare the necessary by-law for Council's consideration.

CARRIED.

Moved by Alderman Warne, seconded by Alderman Wills that the matter of establishing a special parks and playgrounds acquisition fund be referred to the Finance Committee for consideration.

CARRIED.

13. Rezoning Application - 143 East
Keith Road - Report from Administrator

Moved by Alderman Warne, seconded by Alderman Marcino that the by-law to rezone Lot 8, Block 114, D.L. 274, (143 East Keith Road), to RH - High Density Apartment Zone be approved by the Council.

Moved by Alderman Braithwaite, seconded by Alderman Wills that the matter of rezoning of the above property be deferred until Council is in receipt of further information with respect to the following, i.e., whether or not the developer would consider incorporating in his development

(a) full child daycare facilities for 20 to 25 pre-school children, which is a great need in this community, approximately 850 square feet of floor space, at ground

level or on the roof, including playground equipment and lavatory facilities, it being understood that the developer would not be responsible for the maintenance and operation of such a centre, but rather that it be run by a private individual or voluntary group with the assistance of the Provincial Government; or

(b) contribute in kind for the express purpose of enhancing the amenities of the community through the provision of playgrounds and playground equipment.

Moved by Alderman Wills, seconded by Alderman Warne that Mr. Norton of Norton Realty, present in the public gallery, be heard on this subject.

CARRIED.

Mr. Norton advised that the developer was prepared to build on three lots rather than on four which would result in a development of 55 suites rather than 80, which would result in a locked-in lot. He stated that although Hillside Baptist Church was willing to repurchase the property it would be difficult to use it as such because of the lack of parking.

Moved by Alderman Wills, seconded by Alderman Braithwaite that this matter be deferred for a maximum of two weeks in anticipation of receiving an undertaking from the developer that he is willing to include a day care centre in the development.

 $\boldsymbol{\gamma}$  The mover and seconder later withdrew this motion.

The deferral motion was then put and carried.

14. North Vancouver Chamber of Commerce Lease Agreement - Report from Administrator

Moved by Alderman Warne, seconded by Alderman Wills that the matter of the renewal of the lease agreement with the Chamber of Commberce for their occupancy of City property at 131 East 2nd Street be deferred to the next Council meeting, and that in the meantime the Administrator be requested to report on the possibility of establishing a rental for this property.

CARRIED.

15. Lane East of Jones Avenue, etc., Report from City Engineer

Moved by Alderman Marcino, seconded by Alderman Warne that the City bear the cost of extending the lane east of Jones Avenue between the lane north of 23rd Street and 24th Street, to provide ≯ access to the northerly eighteen feet of Lot 3, Block 213, D.L. 544, owned by Mr. J.G. Moir. CARRIED.

16. City Services - Lot 22, Block 68, D.L. 271 - Report from Engineer

Moved by Alderman Wills, seconded by Alderman Braithwaite that Standard Oil Co. Ltd. be informed that Council will not contemplate the sale of Lot 6 and a portion of Lot 22, in Block 68, D.L. 271, (at 3rd Street and Keith Road), at this time as the subject lots contain the bed of Wagg Creek which is a major outlet of drainage for the City.

Moved by Alderman Warne, seconded by Alderman Marcino that the / motion be deferred until such time as a further report is received from the City Engineer with respect to the possibility of extending the culvert in order to make Lot 22 usable, and that if the Engineer replies in the affirmative, then Standard Oil be requested to supply further information as to the use they intend to make of the subject property. CARRIED.

Moved by Alderman Dean, seconded by Alderman Braithwaite that the representative of the Cloverley Community Association and Mr. and Mrs. Plumbe be heard. CARRIED.

### Cloverley Community Association - re Noise from C.N.R. Yards

Mr. Terry O'Keeffe, Vice President of the Cloverley Community Association, stated his group had dealt with the C.N.R. on a personal basis and had put forward several suggestions to the Company for the elimination of noise caused by trains. He said the Association had cooperated with the Company when it had a firm of Consulting Engineers do a noise survey in their area and had been under the impression the results of that study would be made known to them. However, the Railway Company now refuses to provide them with a copy of the report. He said they were now asking Council to help them in any way possible to have the noise problem alleviated.

Moved by Alderman Warne, seconded by Alderman Wills that a letter be forwarded to Mr. A.H. Hart, Vice President, Canadian National Railway Co., asking if the Company had conducted a noise survey in the area of their North Vancouver yards, and if so, that they be advised that Council would appreciate receiving a copy of the report, or a summary of the noise data obtained.

Moved by Alderman Dean, seconded by Alderman Marcino that the motion be amended by adding: "and further that the Cloverley Community Association be advised of the previous resolution adopted by Council with respect to the assistance they would

be given by the City Prosecutor if any legal action were taken by the residents in the area; and further that a meeting be arranged with representatives of the Railway Company, the Cloverley Community Association, and members of the City Council with a view to solving the problem of noise from the C.N.R. yards in North Vancouver."

The motion as amended was then put and CARRIED.

Moved by Alderman Warne, seconded by Alderman Wills that an inquiry be made of Neptune Terminals Ltd. as to whether or not it is their intention to remove locomotives from coal trains after their arrival, and, if this is the case, when such action would be taken.

CARRIED.

 Complaint re Rezoning by "Land Speculators" - Plumbe and Rose -Report from City Administrator

Moved by Alderman Warne, seconded by Alderman Marcino that Item No. 10 on the agenda be considered at this time.

CARRIED.

Mrs. Plumbe stated that many of the homes in their block had been purchased by absentee landlords for speculation, and expressed concern that these people would be successful in having their block rezoned.

Moved by Alderman Dean, seconded by Alderman Todd that Mr. and Mrs. Plumbe and Mrs. Rose be thanked for their letters and that they be given assurance that it is the Council's policy that applications for rezoning must be made either by the owners themselves or the applicant must have the written consent of the owner prior to such applications receiving the consideration of the Council.

Moved by Alderman Warne, seconded by Alderman Wills that the motion be amended by adding: "except when long range planning studies conducted by the City result in the general rezoning of large areas of the City, such as the 1970 Lower Lonsdale Redevelopment Plan."

The motion as amended was then put and CARRIED.

4. Novaco Day Care Centre - Request for Grant - Report from City Administrator

Moved by Alderman Wills, seconded by Alderman Warne that Item No. 6 on the Agenda be considered at this time, and that Mr. Maurice Egan of the North Vancouver Christian Community be heard on this subject. CARRIED.

Mr. Egan stated that the Centre operated by the Novaco group was incorporated as a charitable organization under the Societies Act of the Province. He added that through information obtained from housing and recreation surveys conducted in the City and District, they had determined that the centre would be used by City and District residents on a basis of 35/65% respectively.

Moved by Alderman Wills, seconded by Alderman Todd that Council approve a capital grant in the amount of \$5,000.00 to the North Vancouver Christian Community, (NOVACO), such grant to be in trust towards the construction of a daycare facility in conjunction with Capilano College at Norgate School.

Moved by Alderman Dean, seconded by Alderman Marcino that the request of NOVACO for a grant towards the operation of a daycare centre in conjunction with Capilano College be deferred to the 1973 Budget Committee for consideration and recommendation.

CARRIED.

#### CORRESPONDENCE

 Mr. H. Shandler - re Marine Drive Street Improvements

Moved by Alderman Marcino, seconded by Alderman Dean that Mr. Shandler, present in the audience, be heard. CARRIED.

Mr. Shandler stated the improvements to Marine Drive would not benefit the small businessman on the street and that the cost of such improvements should be borne in part by the Provincial and Federal Governments.

Moved by Alderman Warne, seconded by Alderman Wills that Mr. H. Shandler be advised, in response to his letter of February 6th, 1973, that Council is carrying out the improvements to Marine Drive under a policy which applies throughout the City and is not prepared to place the burden of the cost of such improvements entirely on the taxpayer as a whole. CARRIED.

6. Mrs. M. Spees - Complaint re Litter on City Streets

Moved by Alderman Marcino, seconded by Alderman Warne that the staff be instructed to publicize a "clean up" campaign, and that the week of March 1st to 7th be declared as "Clean Up Week" in the City.

After discussion the mover and seconder WITHDREW the motion.

"WHEREAS the North Vancouver Recreation Commission has recommended a 1973 budget which will cost the taxpayers of the City of North Vancouver approximately \$120,000 and will cost the taxpayers of the District of North Vancouver approximately \$220,000; and

"WHEREAS the North Vancouver Recreation Commission is a creation of the Municipal Councils of the City of North Vancouver and the District of North Vancouver and is responsible to the

"municipal Councils of the City of North Vancouver and the District of North Vancouver; and

"WHEREAS the present Chairman of the North Vancouver Recreation Commission has failed to demonstrate any intention to follow the basic purposes and provisions of the City and District joint Recreation Commission By-law of 1970, particularly in the failure to implement recognition of the position of the North Vancouver Recreation Advisory Committee and in acting outside of the powers vested in the Chairman of the North Vancouver Recreation Commission and in acting outside of the powers of the North Vancouver Recreation Commission; and

"WHEREAS the present Chairman of the North Vancouver Recreation Commission has demonstrated a lack of responsibility in purporting to dismiss a senior employee of the North Vancouver Recreation Centre, in a manner that is invalid and improper in that,

- (a) The Chairman of the North Vancouver Recreation Commission acted without valid excuse or authority in that the decision to dismiss the said employee was not properly approved by the majority of the members of the North Vancouver Recreation Commission and was not recorded in the minutes of the meetings of that Commission.
- (b) The Chairman of the North Vancouver Recreation Commission failed to clear the dismissal with the North Vancouver Recreation Advisory Committee as required by section 13 of City and District Joint Recreation Commission By-law of 1970.
- (c) The Director of Recreation, in his memorandum of December 11, 1972, brought to the attention of the Municipal Councils that the discharge of employees is not within the scope of the North Vancouver Recreation Commission. The City of North Vancouver passed a resolution on February 5, 1973 to make an amendment to bring such power within the scope of the North Vancouver Recreation Commission but to this date the necessary Amending By-law has not been prepared, passed or adopted.
- (d) The Chairman of the North Vancouver Recreation Commission has purported to appoint the Director of Recreation to assume the duties and authority of the Manager of the North Vancouver Recreation Centre without a proper motion from the North Vancouver Recreation Commission and without clearance from the North Vancouver Recreation Advisory Committee,

and,

"WHEREAS the Director of Recreation has acted outside of his jurisdiction and outside of the jurisdiction of the North Vancouver Recreation Commission, in ordering the expenditure of funds for structural alterations in the North Vancouver Recreation Centre facilities without approval of the owners of those facilities, and

"WHEREAS the Director of Recreation has violated the principles of democracy, as well as exceeding any authority of his position or of the North Vancouver Recreation Commission, in his inter-office memorandum of February 13, 1973, purporting to prohibit anyone on the payroll of the North Vancouver Recreation Centre from contacting any alderman or mayor, and

"WHEREAS the actions of the Chairman of the North Vancouver Recreation Commission and of the Director of Recreation have seriously impaired the morale of the staff of the North Vancouver Recreation Centre and the actions of the Chairman have also subjected the North Vancouver Recreation Commission and in turn,

"the two municipalities and their taxpayers to possible legal expenses and expenses for damages for wrongful dismissal,

#### "IT IS RESOLVED

"FIRST, Alderman James Warne, the one member of the Municipal Council, appointed from among the members of and by the Municipal Council of the City of North Vancouver, be suspended from carrying out any duties as a member of the North Vancouver Recreation Commission until such time as this Council has had an opportunity to study a report of a Committee of Inquiry to be set up as outlined in part two of this resolution, and SECOND, that a special Committee of Inquiry be set up to be composed of the Administrator of the City of North Vancouver and the District Manager of the District of North Vancouver to hold a public inquiry and to make a written report of the findings of that public inquiry to the Municipal Councils of the City of North Vancouver, and

THIRD, that the Municipal Council of the District of North Vancouver be invited to cooperate in the appointment of the Special Committee of Inquiry as set out in part two of this resolution."

Moved by Alderman Warne, seconded by Alderman Marcino that preparation be authorized of a stopping-up by-law in accordance with Section 513 (1) (b) of the Municipal Act to cover that portion of St. Andrews Avenue, being the southerly portion of Lot 1A, Block 173, D.L. 274, Group 1, New Westminster District, Plan 972, having dimensions of 60.0' on the North, 54.38' on the East, 46.0' on the West, and 60.6' on the South; and that the staff be instructed to take all necessary steps with respect to the said stopping up.

CARRIED.

## 12. Winch Avenue Realignment - Report from Administrator

Moved by Alderman Warne, seconded by Alderman Todd that the City Clerk be authorized to give Public Notice in accordance with Section 509 of the Municipal Act with respect to the land exchange involved in the Winch Avenue realignment between Marine Drive and Third Street.

The Acting Clerk was requested to provide a sketch of the  $\gamma$  property involved for the benefit of the new members of Council.

## 13. Drainage Problem - 2240 Westview Drive, (Braithwaite) - Report from Engineer

Moved by Alderman Braithwaite, seconded by Alderman Wills that the City extend the storm sewer on Westview Drive from 21st Street to the lane at the rear of 2240 Westview Drive, the necessary funds to come from the 1973 sewer budget; and that the owner of the said property be advised that the construction of this extension to the sewer is subject to his agreeing to pay the connection and inspection fees of approximately \$190.00, and agreeing to hook up the basement in a proper manner to the said connection within one year.

Moved by Alderman Dean, seconded by Alderman Marcino that this matter be deferred pending further information as to whether the drainage problem at this address was the fault of the City or the owner of the property at the time the house was constructed.

Moved by Alderman Warne, seconded by Alderman Braithwaite that Council approve the application of Mrs. Judy Martin for the operation of daycare facilities at 227 West 16th Street for up to seven children, the consent of more than 60% of the property owners within a 200 foot radius of the premises having been obtained; and that the report of the Acting City Clerk with respect thereto be received and filed. CARRIED.

Mayor Reid advised that the Design Panel was comprised of more professional people who were ruling on the projects of other professional people, whereas the Commission was made up of lay people who made recommendations with respect to any zoning or developments within the City.

24. Transportation Committee - Inquiry by Alderman Braithwaite

Alderman Braithwaite inquired if all appointments had been made to the Inter-municipal Transportation Committee, and Mayor Reid advised he would obtain this information from Staff.

25. Alderman Braithwaite - re Difference between Administrator and Manager

Alderman Braithwaite inquired if there was any difference in authority or responsibility between a Municipal Administrator and a Municipal Manager, and why the City employed an Administrator rather than a Manager.

Mayor Reid referred Alderman Braithwaite to the Municipal Act under which a Municipal Manager type of government required the approval of the electorate, whereas Council could appoint an Administrator without the approval of the voters. He added that the duties of a Manager were contained in the Municipal Act.

Alderman Braithwaite stated he would like to have a written report on this subject.

Mayor Reid instructed the Administrator to prepare a report outlining the differences between an Administrator and a Manager, and to include therein the duties of Aldermen and how they work into the system, quoting as required from appropriate sections of the Municipal Act.

Alderman Wills, as Chairman of the Policy Committee, stated that Alderman Dean had been present when the subject was considered last year, and that, since the matter had now been finalized, he saw no point in reconsidering it.

Alderman Dean requested that the matter be placed on the agenda of the Committee.

## 29. Alderman Marcino - re Sign By-law

Alderman Marcino inquired if there was any provision in the City's Sign By-law which prohibits the painting of the inside of windows, advising this had been done in a certain commercial outlet and was detrimental to the appearance of the area.

30. North Vancouver Recreation Commission - Confidential Report by City Administrator

Moved by Alderman Warne, seconded by Alderman Marcino that the Confidential report from the City Administrator, dated February 23rd, 1973, with respect to dismissal of employees, be considered after the Council has dealt with Item No. 24, under the heading "Confidential Reports".
