Mr. D. Walker presented to the meeting a plan which he said indicated the operation of routes and how services are linked, with particular reference to the 88 MacKay and 86 Highland routes, and he said that if the traffic signal on Marine Drive at MacKay Avenue is removed and a physical barrier constructed on Marine Drive which would restrict left turns off MacKay Avenue this could result in major operating problems, a reduction in the efficiency of the operation and frequency of service, and possibly even the elimination of one of these routes altogether.

Mr. Walker requested that the traffic signal not be eliminated, and that no physical barrier be constructed on Marine Drive which would restrict left turns off MacKay Avenue, at least until a review can be made by the City's Engineering staff and B.C. Hydro staff. Mr. Walker said he understood that the elimination of the traffic signal and the placing of a physical barrier was to take place on September 1st, 1973, and he did not feel that this was sufficient time for B.C. Hydro to make changes in their schedules, and he asked that Council consider extending this date by one month in order to give the City Engineer's staff and B.C. Hydro an opportunity to establish a workable arrangement which would be agreeable to both parties.

Moved by Alderman Dean, seconded by Alderman Braithwaite that the City Engineer be advised to meet with B.C. Hydro Planning Department to discuss the three alternatives set out in Mr. Scott's report dated August 10th, 1973, AND FURTHER that action on the removal of the traffic light at MacKay Avenue be deferred until the first Council meeting after the joint meeting with the District of North Vancouver which takes place on August 29th, 1973.

Moved by Alderman Warne, seconded by Alderman Dean that the motion be amended by deleting those words after "deferred" and inserting instead: "until October 1st, 1973".

Moved by Alderman Warne, seconded by Alderman Wills that Alderman Braithwaite and Alderman Marcino be appointed with the Mayor, to form the Court of Revision for the 1974 Voters' List, which Court shall sit on the first day of October, 1973, in accordance with the requirements of the Municipal Act.

CARRIED.

6. Local Improvement Petition - Lane North of 2nd Street from Moody Avenue to Queensbury Avenue - Report from City Clerk

Moved by Alderman Dean, seconded by Alderman Warne that the City Engineer be instructed to prepare the necessary reports and estimates of costs for the construction of the following work as a local improvement:

Lane North of Second Street from Moody Avenue to Queensbury Avenue.

CARRIED.

7. Portion of road allowance adjacent to property at 1621 Bewicke Avenue - Report from Land Agent with respect to request of Mrs. M. Sherlock

The City Clerk gave some background information with respect to this item, and stated he had received a memorandum dated August 20th, 1973, from the General Superintendent of the City of North Vancouver saying his Department sees no reason to obtain this triangular piece of property, since there appears to be little likelihood that this will ever become a through street, due to the existence of creeks, ravines and other street closures.

Moved by Alderman Warne, seconded by Alderman Wills that this matter be referred back to staff for further information with respect to the estimated value of this property, AND FURTHER whether this piece of property could be of any value in future for road purposes and how this triangular portion was obtained in the first instance.

CARRIED.

8. Review of Landlord and Tenant Act by the Law Reform Commission of B.C. - Report from Land Agent

Moved by Alderman Dean, seconded by Alderman Wills that the Liaison Officer for the City of North Vancouver Landlord and Tenant Advisory Bureau be authorized to present the comments contained in his report dated August 15th, 1973, to the Law Reform Commission of British Columbia.

Moved by Alderman Braithwaite, seconded by Alderman Marcino that Item #5 in the Land Agent's report be amended to show that damage deposits be limited to \$35.00 for an unfurnished suite, and to \$50.00 for a furnished suite.

Moved by Alderman Dean, seconded by Alderman Braithwaite that Miss Lundy be heard. CARRIED.

Miss T. Lundy stated she is a tenant and a member of the North Vancouver Tenants Association. Miss Lundy said that the City of North Vancouver is one of only two municipalities who allow security deposits, and that in other municipalities this is an illegal practice, and she asked that the Council reconsider the policy of allowing damage and security deposits.

The amending motion was then put and defeated.

Moved by Alderman Warne, seconded by Alderman Marcino that Item #3 in the Land Agent's report be amended to show that a Landlord should not be required to give, in writing, the reason for his giving Notice to Vacate to the tenant provided that sufficient notice, such as three months, is given.

The amending motion was then put and defeated.

The main motion was then put and CARRIED.

9. Grand Holdings Ltd. - Application to purchase Lot 20, Block 137, D.L. 271 (Exchange for City Lot 16, in the same block).

Moved by Alderman Warne, seconded by Alderman Marcino that the sale of Lot 20, Block 137, D.L. 271, to Grand Holdings Ltd. be approved subject to the Purchaser giving to the City of North Vancouver a Deed of Land free and clear of all encumbrances to Lot 16, Block 137, D.L. 271, and to the demolition of all buildings on the said Lot 16 being the

responsibility of the Purchaser and the property being left in a clean condition and free from all debris; AND SUBJECT further to payment being received by the City of North Vancouver from the Purchaser in the amount of \$6,000.00; AND FURTHER that any applicable real estate fees be borne by the Purchaser; AND FURTHER that the necessary by-law be prepared.

The motion was then put and carried.

Moved by Alderman Warne, seconded by Alderman Marcino that the City Engineer be requested to prepare plans for the development of Lot 16, Block 137, D.L. 271, together with the portion of Semisch Avenue proposed to be closed and added to this Lot as a playground, and to include the funds for same in his estimates for the 1974 budget.

CARRIED.

10. Traffic Control on West Third Street - Report from the City Engineer

Moved by Alderman Warne, seconded by Alderman Marcino that the first five recommendations contained in the City Engineer's report dated June 20th, 1973, be adopted.

Moved by Alderman Wills, seconded by Alderman Warne that the motion be amended as follows: and that recommendation #4 in the said report be amended by adding the following words:

"and one at St. Andrews Avenue, the need for all to be reviewed once the Low Level Road is operational".

CARRIED.

The motion as amended was then put and CARRIED.

11. Application for Strata Title Subdivision of Apartment Building at 270 West Third Street - Report from the City Engineer

The City Clerk gave some of the background information in this case, and said that the City Engineer, in a memorandum, stated his Department has no objections to the proposal of posting a \$5,000.00 bond for each property to guarantee completion of the landscaping to his satisfaction.

The City Clerk also stated that he was handed a letter this evening from the Toronto-Dominion Bank in which they stated they undertake to guarantee the City of North Vancouver to the extent of \$10,000 that landscaping work will be completed to the City's satisfaction.

Moved by Alderman Wills, seconded by Alderman Warne that the application for approval of strata subdivision of the apartment building at 270 West 3rd Street be approved SUBJECT TO a \$5,000.00 Bond being posted for each of the properties at 270 West Third Street and 1610 Chesterfield Avenue.

CARRIED.

12. Application for Strata Title Subdivision of Lot "F", Block 133, D.L. 274 - Report from the City Engineer. (131 West 4th Street)

Moved by Alderman Dean, seconded by Alderman Warne that the application for strata title subdivision of Lot "F", Block 133, D.L. 274, be approved.

CARRIED.

Moved by Alderman Dean, seconded by Alderman Braithwaite that Council require in all applications for strata title subdivision that all patios and balconies be classified as common property.

CARRIED.

13. Application for a Land Use Contract at 121 East 12th Street - Report from the Acting City Administrator

Moved by Alderman Dean, seconded by Alderman Braithwaite that Council await the Planning Consultant's report as to how this property and others in a similar situation may be developed.

Moved by Alderman Wills, seconded by Alderman Warne that Mr. J. Black of North Shore Realty, be heard. CARRIED.

Mr. Black said that if this property were to be rezoned to Apartment Zone the maximum number of suites would be probably not more than four.

The motion was then put and CARRIED.

14. Rezoning to P-1 Public Use and Assembly Zone, Lot 7, Block 12, D.L. 272, 1200 Block Heywood Street - Reports from Urban Programme Planners and the Land Agent

Moved by Alderman Dean, seconded by Alderman Wills that Lot 7, Block 12, D.L. 272, Plan 4692 be rezoned from RS - Single Family Use to P-1 - Public Use and Assembly 1, AND FURTHER that a Public Hearing be called for September 10th, 1973, for this purpose, AND THAT the necessary by-law be prepared. CARRIED.

15. Proposed Amendment to Zoning By-law re "locked-in" lots - Reports from Acting City Administrator, City Engineer, Urban Programme Planners and Advisory Planning Commission

Moved by Alderman Marcino, seconded by Alderman Wills that Section 413 of the City's Zoning By-law be amended by deleting the word "residential" and adding the words: "It shall be unlawful to construct a building or structure in an RM-l or RH Apartment Zone which will create a locked-in lot, AND THAT a Public Hearing be held to consider this amendment to the Zoning By-law.

Moved by Alderman Warne, seconded by Alderman Wills that the motion be amended by adding the words: "subject to approval of the wording of the amendment by the City Solicitor".

The amending motion was then put and carried.

The motion as amended was then put and  $\underline{CARRIED}$ .

Moved by Alderman Marcino, seconded by Alderman Wills that Council adopt, subject to approval by the City Solicitor, items 1, (a), (b), (c) and 2 contained in the report of Urban Programme Planners dated August 7, 1973, AND THAT a Public Hearing be held to consider these changes to the Zoning By-law.

Moved by Alderman Wills, seconded by Alderman Dean that the recommendations contained in the report of Urban Programme Planners, dated August 7, 1973, be referred back to the City Administrator for clarification of the wording.

CARRIED.

16. Report from Minister of Municipal Affairs - re Alderman Dean's report on City Administration, and report of City Administrator.

/Moved by Alderman Warne, seconded by Alderman Wills that this report be released to the public.

CARRIED UNANIMOUSLY

17. Application for strata subdivision (conversion) 1450 Chesterfield Avenue - Report from City Engineer

Moved by Alderman Marcino, seconded by Alderman Braithwaite that, in view of the policy adopted by Council on August 6th, 1973, and that this application is for an older building, that this application be refused. CARRIED.

18. Land Use Contract Application by New World Music Promotions - Report from Acting City Administrator and the City Engineer. (135 West 1st Street).

The City Clerk handed to the meeting some plans and elevations with respect to this application.

Moved by Alderman Warne, seconded by Alderman Wills that Council approve in principle the application by New World Music Promotions, subject to later approval of the documents prepared by staff for development of the property at 135 West 1st Street under a Land Use Contract, waiving those areas of non-compliance with the existing by-law but meeting the construction requirements of the 1970 National Building Code, with the proviso that, providing they can obtain the necessary agreements and post the necessary bonds for offsite parking, they be permitted to develop on the basis of thirty-three parking spaces with a firm commitment to participate in the Lower Lonsdale Parking Scheme on the basis of thirty-five parking spaces, and any other appropriate items found on later investigation by staff.

Moved by Alderman Dean, seconded by Alderman Warne that the representative of this Company, sitting in the Public Gallery, be heard.

CARRIED.

Mr. Jeffrey Ehrlich said it is their intention to create a musical-listening club, and this would not include loud or rock-n-roll music, and he said it will have a small stage which would also limit the volume of music which they could have.

Mr. Ehrlich said his architect would answer any questions with respect to the condition of the building and whether it could be brought up to the National Building Code standard.

Mr. Ehrlich confirmed that he had given the City affidavits with respect to off-site parking.

The motion was then put and CARRIED.

Moved by Alderman Warne, seconded by Alderman Marcino that the above by-law be finally adopted, signed by the Mayor and City Clerk, and sealed with the Corporate Seal.

CARRIED UNANIMOUSLY.

Alderman Wills returned to the meeting at this point.

Moved by Alderman Warne, seconded by Alderman Marcino that "Highways Stopping Up and Closing By-law, 1973, No. 4615" be introduced and read a first time in short form, copies of same having been circularized among all Council members and read by them.

CARRIED.

Moved by Alderman Warne, seconded by Alderman Marcino that the above by-law be read a second time in short form.

CARRIED.

Alderman Dean is recorded as voting against the motion.

Moved by Alderman Warne, seconded by Alderman Marcino that the above by-law be read a third time in short form and passed subject to reconsideration.

CARRIED.

Alderman Dean is recorded as voting against the motion.

Moved by Alderman Warne, seconded by Alderman Marcino that "Land Sales By-law, 1973, No. 4616" be introduced and read a first time in short form, copies of same having been circularized among all Council members and read by them.

CARRIED.

Moved by Alderman Warne, seconded by Alderman Marcino that the above by-law be read a second time in short form.

CARRIED.

Alderman Braithwaite is recorded as voting against the motion.

Moved by Alderman Warne, seconded by Alderman Marcino that the above by-law be read a third time in short form and passed subject to reconsideration.
