9. News Letter - Recommendations from Policy Committee

Alderman Wills asked to be excused from the discussion with respect to this matter because of a possible conflict of interest, and left the Council Chamber at 8:02 P.M.

Moved by Alderman Warne, seconded by Alderman Marcino that the following recommendation of the Policy Committee held on September 24th, 1973, be adopted:

Alderman Dean is recorded as voting against the motion.

Moved by Alderman Warne, seconded by Alderman Marcino that the following recommendations from the Policy Committee held on September 24th, 1973, be adopted:

- (a) THAT the format of the proposed City news letter be a four-page sheet, similar to that published by the Municipalities of Delta and the District of North Vancouver, and that it be distributed to all residents in the City.
- (b) THAT Council not restrict the range of topics which might be included in the proposed news letter, but that the final selection be left to the discretion of the producer of the publication; and that, if Council members have any suggested topics for publication, they submit their suggestions to the Clerk.
- (d) THAT consideration of applications for the publication of a City news letter be deferred to an in camera meeting of the Policy Committee to be held on October 15th, 1973, at the expiration of the Council meeting.
- Moved by Alderman Warne, seconded by Alderman Marcino that Mr. Cross in the public gallery be heard on this subject. CARRIED.

Mr. Cross inquired if the proposed news letter would be circulated to owners or occupiers of businesses, and Mayor Reid advised it would be distributed to all residents.

The motion was then put and CARRIED.

Alderman Wills returned to the meeting at 8:07 P.M.

10. Annual Budget - Recommendations from Finance Committee

Moved by Alderman Warne, seconded by Alderman Marcino that the following recommendations from the Finance Committee Meeting held on September 24th, 1973, be adopted:

- (a) THAT a general written explanation of Municipal budgeting, with examples from past years, be presented to Council with the first budget draft.
- (b) THAT Council members be provided with an explanation of major budget items, unusual increases or decreases, and of budgeting procedures such as overhead allocations, capital financing, and shared-cost programs, and that wherever possible the explanation be placed beside the budget item; and that Council members be advised of any budget item over which the City has little or no control, such as welfare.
- (c) THAT items in the budget show the figures for the current year, and beside them the figures for the two previous years, showing also the percentage changes in each case.
- (d) THAT as close a comparison of assessment information as possible be obtained, taking into consideration the assessments of the previous year, and citing examples of the effect on individual properties.
- (e) THAT each Department assess its requirements for additional staff and substantiate their requests.
- (f) THAT the Inter-Municipal Grants Committee be disbanded, and that the Districts of North and West Vancouver be advised of Council's action in this respect.

- (g) THAT the Clerk send a form letter to all grant applicants outlining the information Council requires in connection with grant applications and the form in which it should be submitted, such form letter to be forwarded to all the past year's applicants by December 31st, 1973; and that the grants application deadline of February 28th be stated in the letter.
- (h) THAT the Chairman of the Finance Committee prepare an agenda for the meetings of the Budget Committee, setting out a specified portion of the budget for consideration each evening.

It was requested that the Clerk, when advising the Districts of North and West Vancouver of Council's resolution to disband the Grants Committee, explain to the two municipalities that, while Council felt such a Committee was a worth while effort last year and made some good policy decisions, its basic intention was to reduce time involved in processing grant applications and it was felt that this was not accomplished.

The motion was then put and CARRIED.

11. Tempe-Boundary Property -Recommendation from Finance Committee

Moved by Alderman Warne, seconded by Alderman Wills that consideration of any rezoning or designation of the City-2 owned Tempe property be deferred for one month. <u>CARRIED</u>.

Alderman Dean is recorded as voting against the motion.

12. R.C.M.P. Establishment Increases -Report from City Administrator

Moved by Alderman Dean, seconded by Alderman Wills that Inspector R.N. Heywood, R.C.M.P. North Vancouver Detachment, be authorized at this time to request two additional policemen for the City of North Vancouver for the 1975/76 fiscal year, in accordance with his letter of September 18th, 1973.

13. Advanced Poll By-law - Report from City Clerk

The City Clerk advised that the Solicitor had advised him of some minor amendments which were to be made to the proposed by-law which was included on this evening's agenda.

Moved by Alderman Dean, seconded by Alderman Wills that the report of the City Clerk dated September 27th, 1973, with // respect to an amendment to the Advanced Poll By-law be deferred to the next meeting of Council. <u>CARRIED</u>.

14. Heywood Street Traffic Control -Report from Traffic Advisory Committee

Moved by Alderman Wills, seconded by Alderman Braithwaite that Heywood Street be stopped up and closed between Third and Fourth Streets, with the exception of a provision for connecting the lane between Third and Fourth Streets to / Fourth Street; and that this portion be dedicated as park for the purpose of continuing the park strip between Queensbury Avenue and Keith Road.

Moved by Alderman Dean, seconded by Alderman Braithwaite that Mr. Cross in the public gallery be permitted to speak on this subject. CARRIED.

Mr. Cross stated he did not agree with the report from the Chairman of the Traffic Advisory Committee and requested that Council confirm the fact that either a P-1 zoned green strip or the Kennard Park is designated as a playground for children whether it is developed or undeveloped.

Moved by Alderman Dean, seconded by Alderman Wills that the matter of special traffic controls on Heywood Street be referred to the City Engineer for a report on the possible closure of Heywood Street between 3rd and 4th Streets and the dedication of this portion of the street as park; and
/ further that the Planning Consultants be requested to comment on this suggestion, pointing out that such a street closure would create an extra open area.

Moved by Alderman Warne, seconded by Alderman Wills that Mr. Young in the public gallery be permitted to speak on this subject. <u>CARRIED</u>.

Mr. Young stated that Heywood Street was unique in that it was a three block long street with no intersecting streets apart from a lane, of which most people using the street were not even aware, and consequently it was used as a drag strip.

It was suggested that the City Engineer in his report show the need for Heywood Street to be used as a collector street.

The referring motion was then put and CARRIED.

15. Drainage Survey - Phase I -Report from City Engineer

Moved by Alderman Wills, seconded by Alderman Dean that ravines such as those of Mosquito Creek, MacKay Creek, Mission Creek, and Wagg Creek and its tributaries should be reserved as drainage channels and not committed for building development of any kind, but which does include park uses *j* which would not interfere with the present or future major drainage facilities. CARRIED.

Moved by Alderman Dean, seconded by Alderman Wills that the subject of the conclusions and recommendations contained in the report on drainage prepared by Dayton and Knight Ltd. be placed on the agenda of the next Policy Committee meeting for the purpose of discussing the said recommendations as

for the purpose of discussing the said recommendations as well as the report, with the City Engineer to be present. CARRIED.

16. Resignation - Alderman S.A. Dean

The City Clerk at this point stated that he wished to report, as Returning Officer, that he had today received the resignation of Alderman S.A. Dean, under Section 126 of the Municipal Act, and that this would therefore necessitate filling the vacancy created for the balance of the term.

17. Notice of Motion - Alderman Dean re Amalgamation of City and District

The City Clerk stated that he had today received copies of a study released by the Jaycees and that copies of same had been distributed to members of Council.

Moved by Alderman Dean, seconded by Alderman Wills that this Council request the Minister of Municipal Affairs to take action to implement early amalgamation of the City of North Vancouver and the District of North Vancouver on terms equitable to the staff and residents of each municipality, so that problems may be considered on an overall basis, particularly the Marine traffic problem.

Moved by Alderman Wills, seconded by Alderman Dean that the above motion be referred to the Policy Committee for the purpose of rewording.

A polled vote was requested on the referring motion.

Voting in favour: Alderman Wills, Alderman Dean, Alderman Braithwaite.

Voting against : Alderman Warne, Alderman Marcino, and Mayor Reid.

The motion was declared DEFEATED.

Alderman Warne advised he would present the following motion to the next regular meeting of Council:

INQUIRIES

24. Alderman Braithwaite - re Removal of Trees - Third Street Hill

Alderman Braithwaite inquired if the Mayor or Administrator . could provide any information with respect to the trees which were being cut down on Third Street hill.

Mayor Reid advised that the trees were being cut down because of possible interference with the powerlines. Alderman Wills advised he had contacted the City Engineer in this respect and had been informed that any further cutting of trees in an excessive manner has since been stopped.

25. Alderman Braithwaite - Submission from G.V.R.D. re Housing Project - Jones Avenue Property

Alderman Braithwaite inquired when Mr. Wm. Casson, Director of Housing for the Greater Vancouver Regional District, would be submitting a proposal for low cost or subsidized housing for the City property on Jones Avenue.

Mayor Reid stated that Mr. Casson had approached staff with a view to holding an in camera meeting for the purpose of discussing this property, and he had advised him that no in camera meeting would be held.

26. Alderman Dean - re Employment Practices -North Vancouver Recreation Commission

Alderman Dean stated that several weeks ago she had requested information from the Chairman of the Joint Recreation Commission with respect to employment practices of the Recreation Commission, and the amount of money expended on advertisements for staff for the Commission, and to date this information had not been provided. She asked when this would be forthcoming.

Alderman Warne said he had checked with the Director of the Commission and had been advised that most of the data had been prepared. However, the expenditures with respect to advertising would have to be obtained from the Treasurer. He said a written reply to Alderman Dean's inquiry would be circulated with the agenda material for the next meeting.

Alderman Dean inquried further if the amount of money spent on advertising for Commission staff was included in the budget or if it was over-budgeted.

27. Alderman Wills - re Resignation of Alderman Dean

Alderman Wils inquired of the Clerk when Alderman Dean's resignation would become effective.

The Clerk advised that the resignation under Section 126 of the Municipal Act was in respect of an Alderman whose term had not expired, and who was running for the seat of Mayor, and as such Alderman Dean's resignation would be effective when her successor is such a further

3 when her successor is sworn in. In reply to a further question, the Clerk stated that a by-election to fill the vacancy would not be necessary as the election to fill this vacancy would be held in conjunction with the annual municipal elections.

The meeting recessed at 8:45 P.M. for the public question period, and reconvened at 8:55 P.M. with the same personnel present.

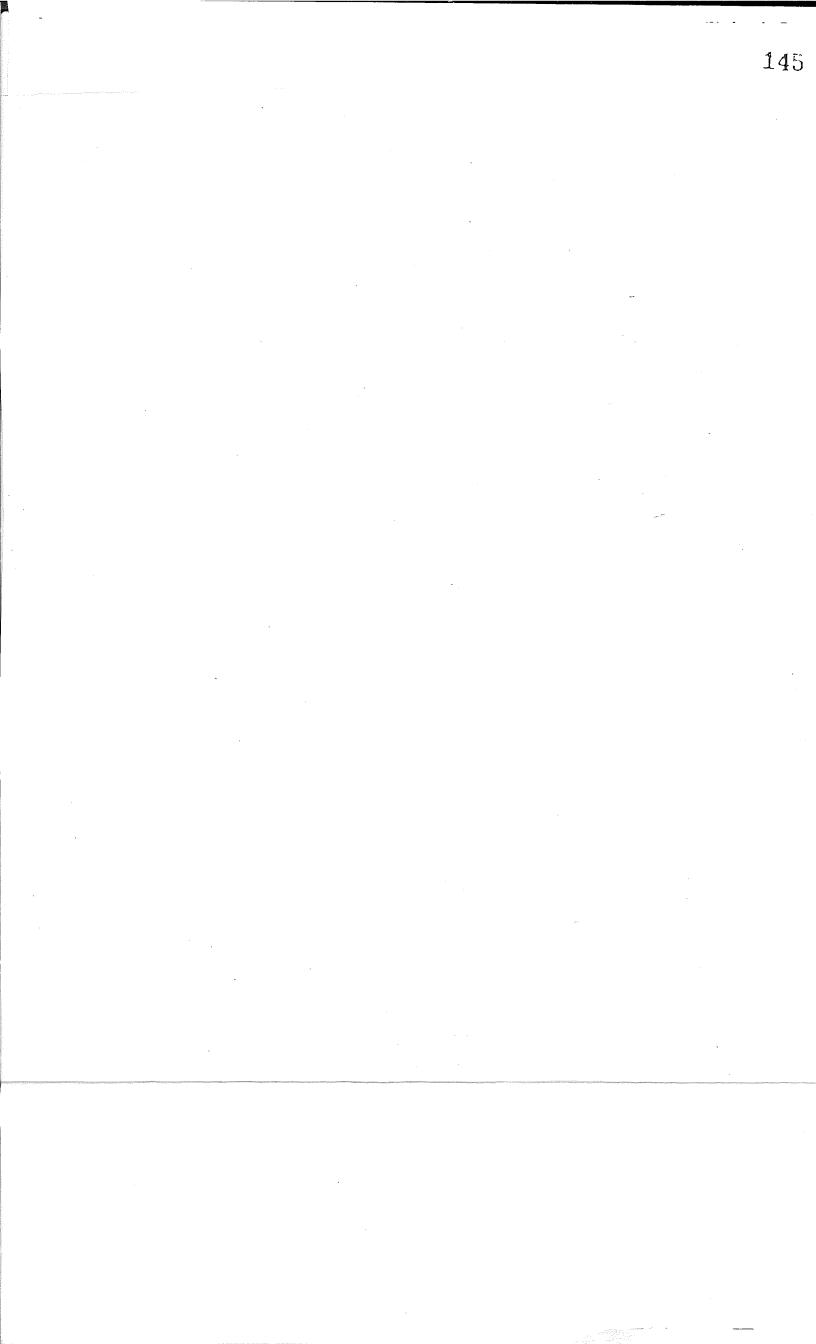
