Recreation Commission By-law 7. Amendment - Report from City Administrator

The Commission shall record minutes of all its meetings and circulate copies thereof to each of its members and to the Clerk of each of the parties hereto in sufficient quantity for distribution to all members of the Councils of the City and District."

Add a new Section 3(4) reading as follows: (2)

> "Notwithstanding anything to the contrary herein contained, the term of office of any member shall continue until the call to order of the first meeting of the Commission after the said member's successor has been appointed."

AND THAT the City Clerk be authorized to prepare the necessary amending by-law. CARRIED.

MINUTES of a Public Hearing of the City Council held in the Second Floor Court Room of the Justice Administration Building on Tuesday, April 16th, 1974, at 7:30 P.M.

Mayor Reid called this Public Hearing to order at 7:33 P.M.

The City Clerk advised that this Public Hearing had been called for the purpose of considering an amendment to the "Zoning By-law, 1967", which would permit smaller lot sizes in onefamily residential areas of the City under certain circumstances and would apply generally throughout the City. He noted that reports from Staff, the Planning Consultants, and the Advisory Planning Commission had been received by Council members, as well as a letter from Mr. J.W. Black of North Shore Realty and Mr. A. Calli, dealing with this subject.

*Alderman Braithwaite entered the meeting at 7:35 P.M.

Mayor Reid asked anyone in the public gallery to speak if they felt their property would be affected by the proposed amendment to the Zoning By-law.

The Clerk then read a letter from Mr. and Mrs. J. Spence, of 223 East 28th Street. Mrs. Spence, present in the gallery, advised that she and her husband had originally owned two and one half lots, which had been consolidated into Lot "A", on which they had paid taxes and local improvement assessments since 1921. She stated that now, however, they were no longer able to look after the large lot and requested permission to sell a 33' portion of the property.

Mr. Derlago, who advised he owned property at 338 West 27th Street, stated this property prior to 1966 had been two 33' foot lots which had been consolidated, and he now wished to subdivide to create two lots as had originally been the case.

Mr. J.W. Black, of North Shore Realty, stated he had made recommendations to Council suggesting that rather than stipulating certain lot sizes, the by-law should be amended to require sideyards of a certain width, and he inquired why his suggestions had been rejected.

Mr. A. Calli, of 855 East 17th Street, felt that Council should consider approving the creation of 33' lot sizes.

Mr. J. Pensato, of 720 East 16th Street, advised he owned property at 348 West 19th Street, and felt that the approval of the creation of 33' lots would result in cheaper building sites, thereby permitting more people to own their own homes.

Mr. Black asked to hear the report of the City's Planning Consultants in connection with his letter suggesting that only sideyards be considered when approving lot sizes, and the Mayor read the report of Urban Programme Planners in this respect.

Mayor Reid then requested that Alderman Macdonald and Alderman

Taylor, the City's representatives on the Advisory Planning Commission, outline the Commission's reasons for rejecting the suggestions put forward by Mr. Black.

Alderman Macdonald advised he had voted against the Commission's motion of rejection, stating he was in favour of the recommendation of the Planning Consultants for a minimum frontage of 30' and a minimum lot area of 3600', this to apply to both newly created lots and existing lots.

Alderman Taylor said that the Commission was in favour of the recommendation of the City Administrator, i.e., 40' frontace with a square foot area of 4800', this to apply in limited situations, and felt that the permission of lots of a smaller area would not be compatible with the residential policy which had been recently adopted in principle by the Council. He stated the Commission felt also that this would lead eventually to row housing in single-family zones.

Moved by Alderman Marcino, seconded by Alderman Braithwaite that this Hearing recess for a meximum of five minutes. CARRIED.

Whereupon the Hearing recessed at 7:58 P.M., and reconvened at 7:59 P.M., with the same personnel present.

Mr. Black stated that the requirement of a five foot sideyard would allow for the same distance between houses as is now the case with 50' or 60' lots, and that a house could be aesthetically designed for a narrower lot and still permit a space of 5' on either side.

It was noted that permission for lots with a frontage of 30' could lead to developers purchasing three existing homes on 50' lots, demolishing the houses, and creating five 30' lots.

Mr. Calli stated that, with the exception of City-owned lots, every 33' lot in the City has been developed, and the houses constructed thereon have not proved to be detrimental to the neighbourhood.

Mr. Black noted that it would not be economically feasible for a developer to purchase three houses on 50' lots and subdivide the property into five 30' lots.

Mr. John Gardner stated he had requested about a year ago that Council permit smaller lot sizes, noting that in his case he owned 89' x 127', which, if subdivided, would be just short of the presently required 6,000' area.

Moved by Alderman Marcino, seconded by Alderman Howard, that this Public Hearing now adjourn. CARRIED.

REPORTS OF COMMITTEES, STAFF, AND COUNCIL REPRESENTATIVES

North and West Vancouver Temple 2. Society - re Mr. H.V. Chisamore -Report from City Administrator

Moved by Alderman Marcino, seconded by Alderman Howard that a letter be forwarded to the North and West Vancouver Temple Society advising that the City of North Vancouver absolves Mr. H.V. Chisamore of any personal financial / obligation which may have accrued with respect to his negotiations regarding the proposed development involving City property between 3rd and 2nd Streets, west of St. Georges Avenue.

CARRIED.

3. Municipal Social Services - Report from City Administrator

Moved by Alderman Marcino, seconded by Alderman Macdonald that

(a) the Minister be requested to advise of the Provincial Government's schedule of transition re the Social Service function for the City and District of North Vancouver, or if it is to be a Region, for the North Shore;

CARRIED.

Purchasing Management Association of 4. Canada - Annual Convention - Report from City Administrator

Moved by Alderman Marcino, seconded by Alderman Howard that Mr. G.H. Brewer, Purchasing Agent, be authorized to attend the 1974 Annual Conference of the Purchasing Management Association of Canada being held in Edmonton, Alberta, and that his registration fee and expenses be paid on the usual basis.

International Institute of Municipal Clerks - 1974 Conference - Report 5. from City Administrator

Moved by Alderman Taylor, seconded by Alderman Macdonald that Mr. A.S.J. Gibb, City Clerk, be authorized to attend the 1974 Annual Conference of the International Institute of $\gamma_{
m J}$ Municipal Clerks to be held in Norfolk, Virginia, May 10th to 14th, 1974, and that his registration fee and expenses be paid by the City on the usual basis.

Porte Realty - Application to Purchase 6. Portion of Grand Boulevard Road Allowance - Report from City Administrator

Moved by Alderman Marcino, seconded by Alderman Taylor that Porte Realty Ltd. be advised, in reply to their letter of March 18th, 1974, that the City is willing to sell a portion of the City road allowance located to the north of Lot 13, Block 15, D.L. 550, in accordance with the provisions contained in the report of the City Engineer dated April 10th, 1974, including the requirement that the owners of Lots 11 and 12 do likewise with respect to the surplus land north of their

B properties; SUBJECT TO the additional properties being consolidated with Lots 11, 12, and 13 respectively; AND THAT, should the above conditions be acceptable, the Land Agent be authorized to take all necessary action to facilitate these land sales, including the recommendation to Council of an appropriate sale price.

Fire Department Promotion Training 7. Policy - Report from City Administrator

Moved by Alderman Marcino, seconded by Alderman Taylor that Subsection (2) of Clause 2 of the City of North Vancouver Fire Department Promotion Training Policy be amended to read as follows:

"(2) Candidates for inclusion in the Officers' Eligibility Pool shall be drawn from those members of the Department possessing the rank of a Fifth Year Fireman, or higher, and who possess not less than ten (10) years' service at the date of application.

CARRIED.

Paving - Lonsdale Avenue at Upper 8. Levels Highway - Report from City Engineer

Moved by Alderman Howard, seconded by Alderman Braithwaite that

the Minister of Highways be advised of the problem faced by the City in connection with the paving of Lonsdale Avenue between 24th and 26th Streets in view of the fact that the plans of the Provincial Government with respect to the intersection of Lonsdale Avenue and the Trans-Canada Highway have not been made known; and that the Minister be advised that any major improvement to this intersection would require the widening of Lonsdale Avenue or grade changes into the block on either side, and for this reason the City would appreciate a decision from the Provincial Government as to what improvements are planned.

Moved by Alderman Marcino, seconded by Alderman Taylor that the motion be amended by adding: "and further, if the Province has no immediate plans for the improvement of this intersection, that they be requested to consider paying for the widening of Lonsdale Avenue between 24th and 26th Streets."

CARRIED.

The motion as amended was then put and CARRIED.

Newspaper Distribution - 258 East
 21st Street - Report from City Engineer

Moved by Alderman Braithwaite, seconded by Alderman Marcino that staff be instructed to meet with Mr. Len Churchill, Sun newspaper distributor, and the Sun newspaper representatives in order to consider other possible alternatives as to methods of distribution, and to report back to Council.

CARRIED.

10. Tape Recording of Council and Committee Minutes

The City Clerk stated that he had received notification from His Worship Mayor Reid that, pending receipt of a legal opinion from the City Solicitor, he was invoking Section 180 of the Municipal Act to return for reconsideration the resolution of Council in connection with the tape recording .] of Council and Committee meetings, and advised that a written opinion had not yet been received.

MOTIONS AND NOTICES OF MOTIONS

11. Moratorium re Approval of Strata Title Subdivision - Alderman Marcino

Moved by Alderman Marcino, seconded by Alderman Braithwaite THAT WHEREAS rental construction in North Vancouver has come to a slow down;

AND WHEREAS most apartment construction is being converted to strata title;

AND WHEREAS a public forum on this subject has been authorized by this Council;

THEREFORE BE IT RESOLVED THAT a one year moratorium on strata titles for housing be instituted effective immediately.

Moved by Alderman Howard, seconded by Alderman Macdonald that this meeting recess for the purpose of considering Item No. 18 on the agenda of the Policy Committee.

DEFEATED.

The motion with respect to the moratorium on Strata Title Subdivision approvals was then put and <u>DEFEATED</u>.

Alderman Marcino is recorded as voting in favour of the motion.

12. Foreign Ownership of Canadian Lands - Alderman Grimwood

Alderman Grimwood presented the following notice of motion:

"WHEREAS the City of North Vancouver presently has in excess of 75 acres of land which is foreign-owned, valued in excess of approximately \$20,000,000.00;

AND WHEREAS land is an asset of this nation;

THEREFORE BE IT RESOLVED THAT a resolution be submitted to the 1974 Conference of the Canadian Federation of Mayors and Municipalities to request that the Federal Government place a moratorium on the sale of land to foreigners and bring in the required legislation to control the disposition of Canadian land to foreigners henceforth."

Tape Recording of Council and Committee Meetings - Alderman Grimwood

Alderman Grimwood presented the following notice of motion for consideration at the next Council meeting:

"THAT the City Clerk be responsible for the tape recording of Council meetings and Committee meetings, with the exception of meetings held in camera, the original recordings / to be in the custody of the Clerk for safekeeping; AND THAT the said tapes be made available for perusal by any person; AND FURTHER that a copy of the said tapes be retained in the City of North Vancouver Public Library."

BY-LAWS

14. Reconsideration and Final Adoption

Moved by Alderman Marcino, seconded by Alderman Macdonald that "Highways Stopping Up and Closing By-law, 1974, No. 4664", (portion of 100 Block West 14th Street), be reconsidered.

CARRIED.

Moved by Alderman Marcino, seconded by Alderman Macdonald that "Highways Stopping Up and Closing By-law, 1974, No. 4664" be finally adopted, signed by the Mayor and City Clerk, and sealed with the Corporate Seal. CARRIED.

15. Introduction and First Readings

Moved by Alderman Marcino, seconded by Alderman Taylor that "Zoning By-law, 1967, Amendment By-law, 1974, No. 4661", (smaller lot sizes), be introduced and read a first time in short form, copies of same having been distributed to all Council members and read by them.

A polled vote was requested.

Voting in favour: Alderman Grimwood, Alderman Marcino, Alderman Taylor, Alderman Howard, and Mayor Reid.

Voting against: Alderman Macdonald and Alderman Braithwaite.

The motion was declared <u>CARRIED</u> with the necessary two-thirds majority.

Moved by Alderman Marcino, seconded by Alderman Howard that "Zoning By-law, 1967, Amendment By-law, 1974, No. 4661" be read a second time in short form.

The motion was declared <u>CARRIED</u> with the necessary two-thirds majority.

Alderman Braithwaite is recorded as voting against the motion.

Moved by Alderman Marcino, seconded by Alderman Taylor that "Zoning By-law, 1967, Amendment By-law, 1974, No. 4661" be read a third time in short form and passed subject to reconsideration.

The motion was declared $\underline{\text{CARRIED}}$ with the necessary two-thirds majority.

Alderman Braithwaite is recorded as voting against the motion.

Moved by Alderman Marcino, seconded by Alderman Taylor that "Land Sales By-law, 1974, No. 4665", (North and West Vancouver Temple Society - 2nd Street and St. Georges Avenue), be introduced and read a first time in short form, copies of same having been distributed to all Council members and read by them. CARRIED.

Moved by Alderman Marcino, seconded by Alderman Taylor that "Land Sales By-law, 1974, No. 4665" be read a second time in short form. CARRIED.

Moved by Alderman Marcino, seconded by Alderman Macdonald that "Land Sales By-law, 1974, No. 4665" be read a third time in short form and passed subject to reconsideration. CARRIED.

INQUIRIES

16. Closure of Safeway Store at Second Street and Lonsdale Avenue -Alderman Braithwaite

Alderman Braithwaite inquired if Mayor Reid had contacted the officials of the Safeway Store in connection with the closure of the store at Second Street and Lonsdale Avenue. He added that he had heard that the store would now be / converted to a cabaret or nightclub.

Mayor Reid advised he had contacted the Safeway store and had spoken to the individual who had given him the information that the store was not closing, and had informed him that he had passed this information on. He was told that they were sorry, but to continue operation of the store on a month to month basis would not have warranted the cost of renovations to the building. He said he had also been advised that they were very interested in establishing another store in the South Lonsdale area. He noted that he had no knowledge with respect to a proposed cararet in this location.

17. Park Tour - Alderman Braithwaite

Alderman Braithwaite inquired if a date had been set for the Council members to tour the ravine lots, and Mayor 2 Reid said he understood Council was going to make their

own arrangements, and that a date could be set after the meeting this evening.

18. Public Open Forum - Alderman Braithwaite

Alderman Braithwaite felt that the date of the next Public ∂_j Open Forum should be set by Council.

Mayor Reid felt that a date for this could be set tomorrow evening.

The City Administrator noted that the date for a public open forum would depend on the availability of a suitable hall, and possibly the Clerk's office should be instructed to recommend possible sites and dates to Council.

Location of Council Meetings -19. Alderman Grimwood

Alderman Grimwood inquired if it was possible to hold official Council meetings at the old City Hall, and Mayor Reid replied in the negative, stating that the Council Chamber was in the Justice Administration Building.

Resolution to Canadian Federation of Mayors 20. and Municipalities - Alderman Grimwood

Alderman Grimwood asked what the situation was with respect to his notice of motion to submit a resolution to the Canadian Federation of Mayors and Municipalities dealing with foreign ownership of Canadian lands, and Mayor Reid advised this would be included on the next Council agenda for consideration.

Alderman Grimwood requested that a special meeting be held tomorrow evening for this purpose, and Mayor Reid pointed out that the Council members were meeting at that time with the Fire Fighters as well as for the purpose of considering the Budget.

Qualifications of Election 21. Candidates - Alderman Marcino

Alderman Marcino felt there was a discrepancy in the Municipal Act with respect to qualifications of election candidates, noting that in one section it required the name of a candidate to appear on the list of electors in one year, whereas another section required the name to be on the list for two years. Staff were requested to report clarifying this matter.

Kiwanis Senior Citizens Homes 22. Ltd. - Previous Inquiry by Alderman Grimwood

The City Clerk noted that as requested by Alderman Grimwood last week, copies of the Memorandum of Association of Kiwanis Senior 3 Citizens Homes Ltd. had been distributed to Council members this evening.

12. (Cont'd) - Foreign Ownership of Canadian Lands

Moved by Alderman Grimwood, seconded by Alderman Braithwaite that the subject of foreign ownership of Canadian lands be placed on the agenda.

CARRIED.

Moved by Alderman Grimwood, seconded by Alderman Braithwaite THAT WHEREAS the City of North Vancouver presently has in excess of 75 acres of land which is foreign-owned, valued in excess of approximately \$20,000,000.00;

AND WHEREAS land is an asset of this nation;

THEREFORE BE IT RESOLVED THAT a resolution be submitted to the 1974 Conference of the Canadian Federation of Mayors and Municipalities to request that the Federal Government place a

moratorium on the sale of land to foreigners and bring in the required legislation to control the disposition of Canadian land to foreigners henceforth.

The City Administrator noted that the Province of Prince Edward Island had passed legislation prohibiting the sale of property to foreigners, and perhaps the City should check with Prince Edward Island prior to proceeding with this item. He added that in his opinion this was an item to go before the Union of B.C. Municipalities in September.

The motion was then put and CARRIED.

RECESS

The meeting recessed at 9:00 P.M., for the purpose of the public question period, and reconvened at 9:01 P.M., with the same personnel present.

Moved by Alderman Taylor, seconded by Alderman Marcino that this Council now adjourn to Committee of the whole for the purpose of considering a confidential report in camera.
