Mayor Reid called this Regular Meeting of Council to order.

1. MINUTES

Moved by Alderman Grimwood, seconded by Alderman Marcino that the Minutes of the Regular Meeting of Council held on June 24th, 1974, and of the Recessed Meeting of Council held on June 27th, 1974, be taken as read and adopted as circulated.

CARRIED.

DELEGATIONS

Vancouver Symphony Society re Grant

Mr. L.J. Merrell, Campaign Chairman for the Vancouver Symphony Society, asked that Council members reconsider their decision to refuse a grant to this organization. He stated that although it was called the "Vancouver" Symphony, it was actually the Symphony of the Lower Mainland, and that many of their members and subscribers lived in the City of North Vancouver. He felt also that there was a principle involved and that the Symphony should have the support of all municipalities even if the amount of the grant was not large.

Moved by Alderman Marcino, seconded by Alderman Macdonald that the application of the Vancouver Symphony Society for a grant for the year 1974 be referred to the next meeting of the Finance Committee for reconsideration.

CARRIED.

CORRESPONDENCE

 Skagit River Canoe-in and Picnic - Ross Committee

Moved by Alderman Taylor, seconded by Alderman Braithwaite that the letter dated June 28th, 1974, from the Coordinator of the Ross Committee, extending an invitation to Council members to participate in the Skagit River Canoe-in and Picnic on July 28th, 1974, be received and filed, and that inquiries be made as to whether or not any members of Council would be attending and the Ross Committee be advised accordingly.

CARRIED.

4. Additional Suite - 1549 St. Georges Avenue

Moved by Alderman Marcino, seconded by Alderman Macdonald that Council reaffirm its decision of June 17th, 1974, to refuse to grant approval for the installation of an additional suite in the basement area of the premises situated at 1549 St. Georges Avenue because of the number of non-conforming conditions in the existing building, and that Mr. Hershey Porte be so advised.

CARRIED.

5. B.C. Taxi Owners Association - re Taxi Fare Increases

Mayor Reid reported that he had met with Mayor Langley of West Vancouver, the Licence Inspectors of the City and West Vancouver and representatives of the taxi companies last week for the purpose of discussing the application for an increase in rates. He added that Mayor Langley had stated he would recommend to his Council the acceptance of the proposed tariff and he was now recommending the same increase to the City Council.

Moved by Alderman Howard, seconded by Alderman Marcino that in accordance with the recommendation of Mayor Reid the following increase in taxi fares be approved:

From \$0.65 Flag to \$0.85 Flag
From \$0.50 per mile to \$0.60 per mile
From \$6.00 per hour waiting to \$8.00 per hour waiting.

CARRIED.

6. Standing Committee on Waterfront and Environment re "Information Report #3"

Moved by Alderman Marcino, seconded by Alderman Braithwaite that the Chairman of the Standing Committee on Waterfront and Environment be advised, in response to his letter of June 26th, 1974, enclosing "Information Report #3" of the said Committee, that Council concurs with the 23 points outlined in the plan; and further that this Council appoint a Waterfront Ad Hoc Committee to work in liaison with the Vancouver Committee, subject to their acceptance; and further that the said Report #3 be referred to the Planning Consultants for their recommendation.

It was pointed out that the Waterfront Committee had requested a reply by July 22nd, but the next meeting of the Council would not be held until that date for consideration of the recommendations from the Planner, and it was agreed to advise the Committee to this effect and request that the date be extended.

The motion was then put and CARRIED.

7. Western Transportation Advisory Council - Invitation to Participate in Burrard North Shore Terminal Operators Working Committee 1+

Mr. Raymond gave a brief outline of-the function of the Western Transportation Advisory Council, stating that #WESTAC was comprised of industrial concerns and certain governmental concerns who deal with the supply of transportation.

Moved by Alderman Braithwaite, seconded by Alderman Marcino

that the City of North Vancouver participate as a member of the WESTAC Burrard North Shore Terminal Operators Working Committee, and that the City Engineer be appointed a member of the Committee as well as any other member of Council or staff whom the Mayor wishes to appoint.

Mayor Reid appointed Alderman Marcino to the said Committee, along with Mr. T.J. Scott, City Engineer.

The motion was then put and CARRIED.

8. North Vancouver Youth Band - re Grant

Moved by Alderman Macdonald, seconded by Alderman Howard that the North Vancouver Youth Band be advised, in response to their letter of June 20th, that their request for a 1974 municipal grant has been referred to the next meeting of the Finance Committee for reconsideration.

CARRIED.

REPORTS OF COMMITTEES, STAFF, AND COUNCIL REPRESENTATIVES

 Closure of Heywood Street - Report from City Engineer

Moved by Alderman Howard, seconded by Alderman Marcino that the item on the agenda dealing with the closure of Heywood Street be considered at this time.

CARRIED.

Alderman Braithwaite left the Council Chamber during the discussion of this subject because of a possible conflict of interest, returning immediately thereafter.

Moved by Alderman Marcino, seconded by Alderman Macdonald that the subject of the closure of Heywood Street and the suggested cul-de-saccing of the street be referred to an Ad Hoc Committee to be appointed for the purpose of conducting a study in this regard for the next two months, and that the said Committee report back to Council by September 9th, 1974.

DEFEATED.

Moved by Alderman Marcino, seconded by Alderman Macdonald that a Committee be struck for the purpose of studying all of the aspects of the traffic problem on Heywood Street for the next two months and report back to Council. DEFEATED.

Moved by Alderman Grimwood, seconded by Alderman Marcino that the subject of the closure of Heywood Street be tabled for two weeks.

DEFEATED.

Moved by Alderman Howard, seconded by Alderman Taylor that Heywood Street be left open to through traffic and that the R.C.M.P. be directed, starting tomorrow, to strictly enforce the speed limits on this street, if necessary posting signs that a radar check is taken on the street; and that the matter of the closure of the street be brought before Council again for consideration upon receipt of the report regarding the ravine lots and parks in the Heywood area.

A polled vote was requested.

The motion was declared CARRIED.

Voting in favour: Alderman Macdonald and Alderman Marcino.

Voting against: Alderman Grimwood, Alderman Taylor, Alderman Howard, and Mayor Reid.

The motion was declared DEFEATED.

10. Capilano College re Parking (Nor-Tax Building) - Reports from Parking Committee, Urban Programme Planners, and Advisory Planning Commission

The City Clerk noted that additional reports from the Planning Consultants and the Advisory Planning Commission dealing with this subject had been circulated to Council members this evening.

Moved by Alderman Marcino, seconded by Alderman Macdonald that the report dated June 21st, 1974, from the Chairman of the Parking Committee with reference to parking for the Capilano College, be received and filed.

CARRIED.

Moved by Alderman Macdonald, seconded by Alderman Marcino that, in accordance with the provisions of Section 1001 (2)(c), Subsection 1, of the Zoning By-law, the City in negotiating an Agreement with the developer for off-site parking spaces, stipulate in that Agreement that the off-site parking areas must be designated exclusively for Capilano College use; and further that a Public Hearing be held on August 19th, 1974, at 7:30 P.M. for the purpose of considering an amendment to the Zoning By-law to provide for a community college use in the C-1 Zone and to provide a parking ratio of 1 space per five students for community colleges and business and trade schools in the C-1 Zone.

CARRIED.

11. Zoning By-law Amendment re M-4
Zones - Report from City Administrator

Moved by Alderman Grimwood, seconded by Alderman Howard that a Public Hearing be held at 7:30 P.M. on Monday, August 19th, 1974, to consider an amendment to the Zoning By-law, 1967, to add the M-4 Zone to those zones listed in Section 1001(2)(c) of the said By-law.

CARRIED.

12. Locked-in Lots - Reports from Planning Consultants and Advisory Planning Commission

Moved by Alderman Braithwaite, seconded by Alderman Howard that Council reaffirm its resolution adopted on May 21st, 1974, to not intervene on behalf of Zedex Holdings Ltd. in their request for permission to develop 145 and 149 West 17th Street, and that the locked-in lots portion of the City's Zoning By-law remain as it is, and that Zedex Holdings Ltd. be advised accordingly.

13. Lonsdale Private Hospital Lease - Report from City Administrator

/Alderman Macdonald left the Council Chamber during the disò cussion of this matter, returning immediately thereafter. 3

Moved by Alderman Marcino, seconded by Alderman Braithwaite that the lease with Lonsdale Private Hospital be renewed for a further period of five years, in accordance with the recommendation of the City and District Land Agents; as follows:

- (a) That a new lease be offered for a term not exceeding five years commencing July 1st, 1974, at an increased rent of \$3,900.00 per annum, exclusive of taxes, payable in advance at a rate of \$325.00 per month, otherwise substantially on the same terms and conditions as heretofore, with the addition of a clause permitting termination upon six months' notice in the event that major items of expenditure on maintenance and repair appear likely;
- (b) that regular inspections of the structure be made and an annual report to both municipalities on the condition of the premises and the likelihood of major expenses occurring, either by the City Building Inspector or by an outside consultant, not later than April 30th each year;
- (c) that the oil-fired water heater installation be renewed at a cost not exceeding \$1,135.00 plus 10%, i.e. say, \$1,250.00.

CARRIED.

14. Proposed Land Exchange - (Emerald Park Lodge Site) - Report from City Administrator

Moved by Alderman Marcino, seconded by alderman Howard that the City Clerk be authorized to prepare the necessary by-law to remove the parks dedication from Lots 7, 8, 23, and 24, Block 153, D.L. 274, for three readings by Council, for submission to the Minister of Municipal Affairs for approval prior to reconsideration and final adoption by the Council; AND FURTHER THAT upon successful completion of the process as authorized herein, the Land Agent be authorized to prepare for execution the necessary notices and documentation in regard to the properties exchange; AND FURTHER THAT staff be authorized to accept a Land Use Contract application from 20th Century Properties Ltd. with respect to the four lots to be obtained by them in this negotiation for process in the normal manner, with a public hearing to be held, and the lands exchange only to be considered final upon the adoption by Council of the by-law enacting the said Land Use Contract, and the registration of same in the Land Registry Office; AND FURTHER THAT the City Clerk be instructed to prepare for Council consideration the appropriate Development Area By-law in order to enable a Land Use Contract on the said Lots 7, 8, 23, and 24, Block 153, D.L. 274.

15. Speculation - Strata Title Subdivisions -Report from City Solicitor

Moved by Alderman Marcino, seconded by Alderman Braithwaite that prior to granting approval for the subdivision of property under the Strata Titles Act, the Council require the developer in its application and in the "Terms of Sale and Forms of Contract" section of the prospectus to state:

"The strata lots will be sold only to persons who indicate their intention to reside in the condominium unit and no one person may purchase more than one unit."

Moved by Alderman Howard, seconded by Alderman Braithwaite that Mr. J.W. Black, who was present in the audience, be permitted to speak on this subject.

CARRIED.

Mr. Black felt that the word "intend" in the resolution should be given some thought, as a person could buy fifty condiminiums and state that he intended to reside therein but then change his mind.

The motion was then put and CARRIED.

16. Nor-Wes Building Supplies - Temporary Access to Hanes Avenue - Report from City Engineer

Moved by Alderman Marcino, seconded by Alderman Taylor that the Mayor and City Clerk be authorized to sign and seal with the Corporate Seal the Agreement document as prepared, between the City and Nor-Wes Building Supplies which protects the City and establishes the temporary nature of the access to Hanes Avenue.

17. Construction of Apartment Building 137 East 5th Street - Report from

AND WHEREAS it is the City Council's desire to avoid the further development of industries within the City's boundaries which contribute to pollution of the environment;

AND WHEREAS it is desirable to assure the development of the waterfront in the best interests of the community as a whole and to ensure compatibility of any development with the long range plan of the City presently in preparation;

IT IS RESOLVED THAT the City's Planning Consultants be hereby instructed to prepare the necessary amendments to the "Zoning By-law, 1967" which will have the effect of eliminating the development of noise and pollution producing industries within the City of North Vancouver, particularly the areas of the City west of Lonsdale Avenue and south of the railway tracks, up to the western boundary of the City;

IT IS FURTHER RESOLVED that the City staff be instructed that should, within the interim period, any person apply for a building permit within the above named area, such application must be referred to Council for approval prior to being processed or permit issued.

 - (b) Council authorize the issuance of a permit in favour of Mr. and Mrs. John Church of 819 East Third Street, to use and maintain a driveway from the southwest corner of Lot 2 west to the end of Queensbury Avenue, the cost of same to be borne by the City out of the 1974 Annual Budget under "Engineering Structures Lane Opening", such cost to be estimated at \$1,000.00, in accordance with the sketch attached to the report of the City Administrator dated July 11th, 1974;
 - (c) Mr. Ledbetter be required, in the development of his property, to access from Queensbury Avenue with the understanding that under no circumstances will direct access to Third Street be permitted.
- 31. Application to Purchase Lot 9, Block 159, D.L. 271 - Report from Land Agent

THAT the application dated November 24th, 1973, from North Shore Realty Ltd. to purchase Lot 9, Block 159, D.L. 271, Plan 750, on the south side of the 200 Block West Second Street, from the City, be tabled until November 30th, 1974, or when North Shore Realty Ltd. is in a position to finally purchase the said Lot 9, or exchange same for Lot 15, Block 159, D.L. 271, Plan 750, whichever is soonest; and that the property be reposted at a revised upset price.
