 Heald Industries Ltd., - Parking Access to property at 860 West 15th Street

Mr. Heald and his solicitor jointly made a presentation to Council with respect to a proposed cabaret at 860 West 15th Street, North Vancouver.

Mr. Heald stated he had written several letters to the Permits and Licence Department requesting information and guidance with

respect to the operation of a cabaret, parking requirements and any other pertinent information in this regard, as he wished to have this information before making a commitment with respect to a lease agreement. He said the premises were inspected by a City Inspector, and he was informed that it would be possible to accommodate 10 extra parking stalls in addition to the existing parking, and he subsequently had a parking lay-out prepared which provided 17 extra parking stalls perpendicular to the lane. Mr. Heald said he was told a cabaret would be an approved use in this zone, and that on the basis of one space per 125 sq. ft., the necessary parking would be 43 spaces for a total licensed floor area of 5,336.57 square feet. Mr. Heald said he signed a lease for a period of 5 years, ordered some material and engaged the services of an architect and builder. Mr. Heald said he was informed by telephone that it had been found the lane was not a legal lane because it was only 16 feet wide instead of the required 20 feet, and therefore parking would not be permitted off the lane. If he has to scale down the licensed floor area to meet the parking requirements, Mr. Heald said this would result in a loss of revenue calculated at \$11,000 net per month.

With respect to the noise factor, Mr. Heald said there should be very little noise because the building is of concrete and it is planned to use carpet extensively throughout, and further that it is planned to attract a good type of clientele. Mr. Heald said he would meet all the regulations of the Liquor Licence Act with respect to cabarets, as well as providing full meal service.

Alderman Braithwaite requested Mayor Reid to report to Council next week with respect to recent incidents involving the R.C.M.P. in North Vancouver, and said he has received reports of alleged police brutality, and that he understood that a petition is being circulated asking for our own police force.

Mayor Reid said that in the interim he could say that during his terms of office as Mayor of the City of North Vancouver he has not received one report of police brutality, nor is he aware of any discussions regarding changing the system of policing.

The Clerk also directed Council members to a memorandum from the Land Agent with reference to Lots 1 to 10, Block 14, D.L. 616, located on East 23rd Street at Queensbury Avenue, in which it was pointed out that these lots may have been prematurely included in this Public Hearing.

The City Administrator noted that the Land Agent had recommended that Council not deal with these lots this evening in view of the fact that Council on August 11th, 1975, had requested the Technical Planning Committee to report on the boundaries of Greenwood Park, and as the lots in question are directly adjacent he felt Council should defer any decision on these properties until the report from the Technical Planning Committee is received.

At the request of Mayor Reid the City Clerk then read the memorandum from the Land Agent for the benefit of the people in the public gallery.

Mayor Reid then requested anyone in the audience to speak if he or she felt their property would be affected by the proposed rezoning of Lots 1-10, Block 14, D.L. 616, located on East 23rd Street at Queensbury Avenue.

Mr. Craig, whose residence is adjacent to Lot 10, advised he was not in favour of the area being used for multiple density development, as suggested by the Land Agent in his report, in view of the fact these lots are indistinguishable from the portion of Greenwood Park known as the "quarry", adding that it had taken in the vicinity of 75 years for the growth of the vegetation thereon. He noted that there was literally no dense bush area left in the

City.

Mr. Abernathy, another resident in the area, felt that the citizens should know what kind of feasibility studies are done in connection with this property, and how much money it will cost to service it.

Mr. Monroe, another resident, felt there would be no purpose served in dumping a lot of houses into the area, and that at the present time the trees growing on these lots helped to alleviate the noise from the Trans-Canada Highway.

Mayor Reid then dealt individually with the following properties, requesting in each case that any residents speak if they felt their property would be affected by the proposed rezoning:

Lots 24 and W, Block 9, D.L. 272, located in the 900 Block Shavington Street and the 1000 Block Heywood Street.

Lots 21 and 22, Block 237, D.L. 546, located on the south side of the 200 Block East 28th Street.

Lots 12 and 13, Block 230A, D.L. 546, located on the south side of the 200 Block East 27th Street.

Lot 1, Block 15, D.L. 265, located on the southeast corner intersection of West 3rd Street and Fell Avenue.

Lot 3, B lock 10, D.L. 265, located on the north side of the 700 Block Marine Drive.

Lots 1 to 7, Block E, D.L. 265/552, located on the east side of the 1600 Block Fell Avenue.

The only comments made by members of the public in connection with the above properties came from Mr. Dan Ryan, of West 21st Street, who requested clarification of the term "reserved for municipal purposes."

Mayor Reid advised that in the event of a property being dedicated for park use it would take an Order-in-Council to remove the dedication, whereas if a property is reserved for municipal purposes Council has the power in the future to use the lands for either park or other purposes, including a residential use.

Moved by Alderman Marcino, seconded by Alderman Taylor that this Public Hearing now adjourn. CARRIED.

Whereupon the meeting adjourned at 7:55 P.M.

- (b) approve the guidelines for consideration of neighbourhood pubs as submitted;
- (c) consider the provision for parking as it affects neighbourhood pubs, and request the Planner to report on this subject for possible revision to the Zoning By-law;

 - (i) one member of Council;

- (e) approve the principle of conducting referendums within a four-block radius from the neighbourhood pub location at the cost of the applicant with a \$2,000 deposit;
- (f) approve the policy that will grant approval to an application for a neighbourhood pub only if the Neighbourhood Pub Committee has granted written approval and a referendum described in (f) preceding has an overall 50% majority with a 60% majority for those residents residing within a one-block radius of the proposed neighbourhood pub location.

Moved by Alderman Braithwaite, seconded by Alderman Macdonald that Mrs. Bertha Andreeff, who was present in the public gallery, be heard with respect to this subject. CARRIED.

Mrs. Andreef advised that they were the owners of a ten suite apartment building and a real estate office situated at 2027-29 Lonsdale Avenue, stating that the apartment building is non-conforming and that their taxes are based on a commercial use. She said it had been their intention to extend the front of the building out to the street, which would improve the appearance, and the operation of a neighbourhood pub would compensate for the taxes they are paying based on a commercial use.

THAT the salary of the City Administrator be increased to the third step of his salary scale, effective October 1st, 1975, and that it be recommended to the 1976 Council that the Administrator's salary be further increased to the top step of the scale effective January 1st, 1976.

16. Land Exchange - 20th Century Properties - Report from City Administrator

THAT Council reject any proposal for an apartment development in excess of eight storeys on the site of the lands involved in a land exchange between the City and 20th Centure Properties for the following reasons:

- (a) buildings limited to eight storeys are more aesthetically pleasing;
- 2 (b) the City's fire fighting equipment is not designed for buildings in excess of eight storeys;
 - (c) the Council previously made a commitment at the public hearing held in this regard to limit the height of any structures on this site to eight storeys.

THAT Council approve in principle, without commitment, the proposed exchange of properties as outlined in Proposal 2 and Proposal 3 attached to the report of the Director of Permits and Licences, and dated September 26th, 1975, and authorize staff to negotiate an exchange with 20th Century Properties Limited on the basis of either proposal.

CARRIED.

17. Self Service Gasoline Stations - Report from Director, Permits and Licences

Mayor Reid left the Council Chamber during consideration of this subject because of a possible conflict of interest, returning immediately thereafter.

 3 Alderman Braithwaite assumed the Chair.

Moved by Alderman Grimwood, seconded by Alderman Macdonald that the following recommendation of the Committee of the Whole be adopted:

THAT the Provincial Government be urged to research the matter of self serve gasoline retailing with a view to

instituting any required controls, and that the matter of controls over such facilities be referred to the City Solicitor for discussion in conjunction with City Staff and report back to Council.

CARRIED.

Mayor Reid returned to the meeting at this point and resumed the Chair.

Moved by Alderman Taylor, seconded by Alderman Braithwaite that this meeting now adjourn.

CARRIED.
