MINUTES of the Statutory Meeting of the City Council, held in the Council Chamber, City Hall, 141 West 14th Street, North Vancouver, B.C., on Monday, January 5th, 1976, at 7:35 P.M.

His Worship Mayor Reid called the meeting to order.

The City Clerk reported that the newly elected Council members, Mayor T.H. Reid, Alderman S.A. Dean, Alderman R.E. Hall and Alderman M.B. Howard, had been duly sworn in by Provincial Judge Wallace Craig.

Reverend Robert Allison of St. Andrews and St. Stephens Presbyterian Church then gave the invocation.

Moved by Alderman Marcino, seconded by Alderman Grimwood that a vote of appreciation be extended to Judge Wallace Craig for his participation in this 1976 Statutory Council meeting.

CARRIED.

Moved by Alderman Grimwood, seconded by Alderman Dean that the A Reverend Robert Allison be thanked for giving the invocation at this evening's Statutory Meeting.

CARRIED.

Moved by Alderman Marcino, seconded by Alderman Dean that a vote of appreciation be extended to the R.C.M.P. Detail for their participation in this 1976 Statutory Council meeting.

1. ADDRESS BY HIS WORSHIP, MAYOR T.H. REID

"Ladies and Gentlemen, Honoured Guests. For the seventh year it is my privilege to present to the people of the City of North Vancouver the Mayor's report and at this time I would like to thank the voters for giving me the opportunity to represent them as their Mayor for a fourth term.

It is a pleasure to extend my congratulations to those who were successful in the civic election and to welcome back to Council Alderman Marc Howard, former Alderman S. Dean who served five years on Council from 1969 - 1973 inclusive, and Ralph Hall who as Editor and Reporter for the Citizen brings with him a wealth of knowledge from his many years observing and commenting on City business. I sincerely feel that the City is fortunate to have the services of these people.

At this time I would like to thank Community 10 TV for its public service in filming and showing the Council meetings. From comments made to me by the general public regarding the Council meetings and the election coverage, this medium has proven most informative to people who would not normally attend the meetings. Therefore, through the efforts of Channel 10 this community is developing better informed citizens.

It is not proposed in this report to review 1975 on a statistical basis. In March the new Civic Centre was opened containing the first City Hall built by the City of North Vancouver, the Library, and the Mall. I would be remiss in not commenting on the Mall which has brought so much pleasure to the citizens having a place down town to relax and enjoy the pleasant days of summer.

Another link in the Lower Road was started with improvements to Esplanade from St. Andrews Avenue to Forbes Avenue. It is hoped that the total question of the Lower Road will be resolved by all phases of government in 1976.

The roads and services for the development of the Cedar Village subdivision are now approximately 60% completed and the lots will be made available for housing this year.

The 1975 Council approved and reserved \$100,000 toward the reconstruction of Third Street between Forbes Avenue and Bewicke Avenue. The total cost of this section of road to be completed in 1976 is approximately \$395,000.

In 1976 after the boundaries are established for Greenwood and Loutet Parks, the Council should have these parks dedicated. Also in 1976 the Council should prepare the plan for the advanced payment of City taxes to commence in 1977. With the recent installation of the computer in the Treasury Department, this program can be commenced with very little difficulty.

In my previous inaugural addresses emphasis has been on minimal tax increases and inflation, however these factors are more than ever apparent to Council as all Members of Council participated in the recent civic election and actively supported candidates of their choice, and I surmise, their policy, and candidates who stated they would like to see taxes cut or a holding of the tax line. I therefore request that the Council freeze taxes at the 1975 level. We have been able to maintain a high level of service and I feel that with the increase in assessments through development this coming year, we will still be able to maintain essential service at the 1975 level.

With regard to the Mayor, a question arises, what is expected of him - strength and leadership, or is he a figurehead who kowtows to the few selfish individuals with vested interests who only think of their own personal gain without regard to the welfare of the City or the residents as a whole. The Municipal Act, which dictates the rules of administration to the municipalities, is designed to give the Mayor the power to justly make a decision on a pertinent point by being guided by the laws therein.

It will be my policy in the future as it has been in the past to use the Act as an effective instrument to guide the Council. The minimum result of making the hard choice is usually unpleasantness, yet the effective Mayor knows he must make the hard choice. He knows he must consider not only the people involved but the effect now and tomorrow on all of the people.

He must anticipate the long run result and choose it over the short run gain, not personal comfort. As your Mayor it is also my duty to expect criticism with regard to the actions of your Council and Staff when it doesn't function the way the majority of the people wish it. It is also my duty to respect the wishes of the majority after they have been presented with the true facts.

In my opinion in 1976 Council should concentrate at least part of its efforts on those matters which the Union of

B.C. Municipalities and the Canadian Federation of Mayors and Municipalities has been striving to obtain for many years, and that is a more equitable sharing of the total tax dollar by the senior governments with municipalities. The tax dollar spent on the municipal scene is the most visible to the tax-payer. "

Moved by Alderman Dean, seconded by Alderman Hall that the inaugural address by His Worship be recorded in the Minutes.

Mrs. Arnaud noted that the proposal for the provision of occupational health servicing had been presented to the three North Shore Councils in 1969, but had at that time been rejected. She said they were now resubmitting it because it was felt that employees of the Corporation and the taxpayers were not receiving the benefits of a good preventive program which included health counselling and health assessment. She stated the nurse assigned would remain an employee of the V.O.N., and the City would not be responsible for any salary or fringe benefits.

*Alderman Howard entered the meeting at 7:40 P.M.

Mrs. Arnaud stated further that the nurse would also hold an industrial first aid certificate, but that the concept of their program was much broader than first aid, being more concerned with preventive services.

*Alderman Marcino entered the meeting at 7:45 P.M.

Moved by Alderman Braithwaite, seconded by Alderman Marcino that the Victorian Order of Nurses be advised in response to their letter of November 18th, 1975, that the City agrees with the concept of an Occupational Health Nursing Program, and further that the City Staff meet with the staff of the V.O.N. and submit a further report to Council providing the details related to the proposed program.

He added that reports from staff, the Planning Consultants, and the Advisory Planning Commission had been distributed to Council members, as well as copies of correspondence from Mr. Brian A. Hanson, Solicitor for the operator of the Dairy Queen, and Mr. and Mrs. G.M. Riste, owners of property in Block 19 which would be affected by the proposed amendment to the By-law.

The City Clerk noted further that the most recent report from the Planning Consultants recommended a modification of the by-law which had been prepared for consideration this evening and for this reason had suggested another Public Hearing be called to consider this subject generally.

Mr. R.E. Mann, Planning Consultant, stated that discussions had been held with City staff and developers after the preparation of the first draft of the by-law, and as a result it was found that several items therein should be changed, adding that the City Solicitor was of the opinion these changes would be considered of major importance, and therefore, under the provisions of the Municipal Act, would require another Public Hearing to be held.

Mr. Mann then outlined, with the use of slides, the intent of the legislation proposed, and stated that conclusions reached in the Lower Lonsdale/Waterfront Study which had been prepared early in 1975, were to endeavour to stay in harmony with the present character of the area, retaining the small shops, low rise, community type of development, with the area above 4th Street facing Lonsdale Avenue being residential, the development criteria taking into consideration view amenities, the slope of the land, sun and shade angles, and restricting building heights to six storeys or sixty feet. He added that the by-law, as redrafted, would eliminate required setbacks on floors above the third storey on the east and west elevations.

Moved by Alderman Howard, seconded by Alderman Marcino that this Public Hearing be recessed. CARRIED.

Whereupon the Hearing recessed at 7:29 P.M., and reconvened at 7:31 P.M. with the same personnel present.

Mayor Reid asked anyone present in the public gallery to speak if they felt their property would be affected by the proposed rezoning.

The City Clerk advised that further correspondence on this subject had been received at 4:30 P.M. today from Mr. R. Watson, and copies of this had been circulated to Council members this evening.

Mr. Brian Hanson, representing Mr. E.A. Strasman, the operator of the "Dairy Queen" located at the corner of 4th Street and Lonsdale Avenue, stated his client was purchasing the business from Mr. A.E. Walker, his father-in-law. He noted that the property is presently zoned CS-3, Special Commercial.

It was pointed out that the property had been rezoned to CS-3 from RH-1 in 1971 on the understanding that there would be improvements made by way of providing a modern type sit-in restaurant on the site, but the owner had so far not proceeded with these alterations.

Mr. Strasman stated that Mr. Walker, shortly after the property had been rezoned, had been struck with ill health, and it was for this reason he had operated the business for him since 1972 and had now entered into an agreement to purchase on the understanding the building would be remodeled. Mr. Strasman did not feel that the type of building which would be erected would hamper the view of other residents, and the change in zoning would prevent him from upgrading the building in view of the fact it would then be non-conforming.

Mr. R.W. Perrick stated he represented the owners of Lots 17, 18, and 19, Block 120, D.L. 274, one of which was Mr. R. Watson, the owner of Lot 17. Mr. Perrick said there were existing businesses on each of these properties, and it was his understanding from discussions with the owners that development under the by-law as proposed would not be economically feasible, and these owners wished to retain their properties in order to carry on their separate businesses.

Mr. Harold T.K. Ma stated he was part owner of property on the west side of Lonsdale between 4th and 5th Streets, and felt the proposed rezoning was contrary to the provisions of Section 702 of the Municipal Act based on land values. He displayed several sketches depicting designs of a building constructed in accordance with the design proposed in the by-law, noting that such a building would not be economical because it would require a great deal of reinforcement because of the compulsory setbacks above the third storey and would create difficulties insofar as the placement of stairwells and plumbing was concerned. In addition to this the design of the building would curtail the number of suites which could be contained therein, thereby requiring a developer to charge unrealistic prices.

Mr. Ma also displayed a sketch of a building situated diagonally on the site, which included a playground and commercial outlets as well as residential accommodation, and suggested that such an arrangement would be more feasible than that permitted under the proposed amending by-law.

Mayor Reid left the meeting briefly at this time.

Mr. G.M. Riste advised he owned property at the north-east corner of 5th and Lonsdale and had gone to considerable expense in preparing plans for the construction of a seven storey building on that location, which would not be permitted under the proposed regulations.

At the request of Mayor Reid the City Clerk read a letter submitted by Mr. and Mrs. Riste in this connection.

Alderman Howard left the meeting briefly during this period.

Mr. Riste noted that it was their intention to build rental units, but the by-law amendment would result in a reduction in the number of permissible suites from 32 to 9, and would increase the cost of land per suite, based on the assessed value, from \$3344 to \$11,880, in which case a developer would have to charge unreasonable rents, and under these circumstances would not be able to obtain a mortgage.

Mr. Fred Kranz, the owner of property on the east side of Lonsdale immediately south of 5th Street, displayed a sketch of the type of building required by the amending by-law as compared to the high rise type of construction previously permitted by the Zoning By-law, adding that the high-rise would require only 18% site coverage, whereas the other would need a site coverage of 50%, and that the cost of the necessary reinforcing because of the building design would make it economically impossible to contemplate, in view of the fact that the number of suites would be reduced from 48 to 23. He suggested a combination of residential and commercial should be considered.

Moved by Alderman Marcino, seconded by Alderman Braithwaite that it be recommended to Council that a Public Hearing be called for Monday, February 16th, 1976, at 7:00 P.M., to give consideration to development criteria and rezoning regulation amendments for the RH Zones of the City, including the proposed rezoning of properties fronting on Lonsdale Avenue between 4th and 6th Streets.

Moved by Alderman Marcino, seconded by Alderman Howard that this Public Hearing now adjourn.

Mayor Reid called this Public Hearing to order at 7:29 P.M.

The City Clerk advised this Public Hearing had been called for the purpose of considering an amendment to the "Zoning By-law, 1967" to provide that only licensed operators of service stations, or their employees, may dispense gasoline to the general public, thus preventing the further institution of self service gasoline stations, while making the existing self service gasoline stations a non-conforming use.

Moved by Alderman Howard, seconded by Alderman Marcino that this Public Hearing be recessed.

CARRIED.

Whereupon the Hearing recessed at 7:30 P.M., and reconvened at 9:30 P.M., with the same personnel present.

Mayor Reid asked anyone in the public gallery to speak if they felt the proposed amendment to the Zoning By-law would affect property owned or occupied by them.

Mrs. M. Kerr spoke on behalf of the Automotive Retailers Association, advising that the Association represented over 1500 automotive firms in B.C. She noted that the Association was in favour of the amendment, and was of the opinion that the proliferation of self service gasoline stations resulted in higher costs to the consumer inasmuch as the full-service operator must charge more for service to compensate for the lack of income formerly derived from the sale of gasoline. She also stated that because automobiles did not receive regular maintenance checks at self service stations, many vehicles are unsafe, with the motorist being unaware of the condition of his automobile.

Mr. S.A. Ruocco, of Imperial Oil Ltd., opposed the proposed amendment to the by-law, being of the opinion that such restrictions should not be imposed under a free enterprise system and that such legislation was discriminatory against the oil industry. He added that self-service stations resulted in lower gasoline prices, and objected to such outlets being placed in a non-conforming category, noting that this would preclude an operator, who may be facing some difficulty due to health or other reasons, from closing such a facility for a period in excess of thirty days, as after that time he would have lost non-conforming status. He said further that his firm would eliminate service bays only where they were not necessary, but would add them where required.

Mr. S.T. Dawes, representing Shell Canada Ltd., stated that his firm object to the proposed amending by-law because

it was felt to be a restriction on the marketing of gasoline. He said self service stations were the most efficient method of keeping gasoline costs down, noting that they had expended \$50,000 in 1974 on the conversion of their service station at 18th and Lonsdale, having obtained the necessary permit to do so, yet now the City was attempting to make their operation illegal. He said that if any improvements to their building were contemplated, it would be necessary to convert back to full service, and if they wished to add a service bay they would have to cancel the self service operation.

It was noted that insofar as alteration to the design of the structure was concerned, his firm would be able to appeal to the Board of Variance, but that installation of underground tanks would require a permit from the Fire Marshal.

Mr. Dawes felt that if this type of service was restricted in the City the public would go elsewhere to obtain it.

Mr. O'Callahan, representing Gulf Oil Ltd., stated the Automotive Retailers Association was concerned for the most part with unemployment and control by the large oil companies. He stated the safety record in connection with self service stations has been outstanding, and there is no surplus of qualified personnel. He said his firm has commenced a program of leasing self service retail outlets, currently leasing 28% of their stations in B.C., which will increase to 40% at the end of the year, and that the Vancouver motorist was enjoying some of the lowest gasoline prices in Canada because of self service stations. He noted also that the motorist has a choice of the type of station from which to purchase his gasoline requirements.

Mr. W.J. Walmsley, representing Standard Oil Company of British Columbia, stated his firm was opposed to the proposed amendment to the by-law, being of the opinion it was discriminatory in nature inasmuch as the legislation is directed at controlling the method of operation of a business rather than the principle of land use. He said the safety standards are in line with the regulations issued by the Fire Marshal for this type of service. He stated also that it was not the intention of his firm to convert all their stations to self service. Mr. Walmsley objected further to the resulting non-conformity of such facilities, noting that this would prevent future modifications to these stations, and would result in the deterioration of a property.

Mr. R. Hollingsworth, operator of the Lynn Valley Esso Station, stated that in a self service gasoline station the operator can no longer set the price for gasoline, but becomes a commissioned agent, with the oil companies fixing the price, thus the operator loses the cash flow from gasoline sales.

The representative of Gulf Oil Ltd. stated this was not the way his firm operated, but that they leased self service stations on a business opportunity basis, with the dealer participating in the enterprise.

The operator of the North Vancouver Shell Station stated that in the past year there have been two near disasters as a result of self service operations, and added that customers at these stations frequently neglect to replace the caps on their gas tanks.

Moved by Alderman Marcino, seconded by Alderman Hall that this Public Hearing now adjourn. CARRIED.
