The City Clerk advised that this Public Hearing had been called for the purpose of considering the rezoning of Lot "B", Block 52, D.L. 550, located on the north side of 14th Street, between St. Andrews and Ridgeway Avenues, from RS - Single Family Zone to RT - Two-Family Residential Zone.

Mr. Gibb added that Council members had previously received reports from staff and the Advisory Planning Commission with regard to this application for rezoning, and stated that his office had received no representations in person or by telephone either for or against the application. He stated further that he had received copies of photographs of a duplex which he understood was a duplicate of that proposed to be constructed at this location should the application be granted, and these were circulated to Council members for their viewing.

Mayor Reid asked anyone present in the public gallery to speak if he or she felt their property would be affected by the proposed rezoning.

Mrs. Carrie Cates advised she was a member of the Lions Gate Hospital Board and said she was of the opinion this was a blatant case of spot zoning. She later added that the Hospital had applied for the rezoning of property in the same block and the application had been turned down by the Council.

The City Administrator noted that the Community Plan which Council has approved in principle had designated this area to accommodate eight to twelve dwelling units per acre, and the same densities could be extended to other lots in the area subject to applications being made.

Mr. David Grubbe, of 815 West 20th Street, expressed the fear that should this application be granted, the increased densities would encroach upon other single family areas in the City.

It was pointed out that areas designated in the Community Plan for single family use would remain so, and the increased density zones would not be extended into the single family areas.

It was also noted that the application of the Lions Gate Hospital was to have their property rezoned for a parking lot, and Mrs. Cates stated that the parking lot would have been only a temporary use and that it was slated for future expansion of health services.

Moved by Alderman Dean, seconded by Alderman Hall that this Public Hearing now adjourn.

He further noted that if the City extended shopping hours for December it would not make for uniform shopping hours on the North Shore, unless the municipalities of North and West Vancouver adopted a similar policy.

A number of merchants in the gallery also spoke against any extension of Christmas shopping hours.

Mr. Bruce Ferguson, Manager of the Capilano Mall Shopping Centre, and a representative of Mr. Mike's Restaurant spoke in favour of extended Christmas shopping hours. The motion was then put and CARRIED.

3. Motion in the Name of Alderman Hall re Amendment to Shops Regulation By-law

 - "4. For the local convenience and well being of the residents of this City all shops of all classes are exempted from the provisions of Section 859 of the Municipal Act."; and
- (b) renumbering Section 10 as Section 5.

AND THAT Woods, Gordon & Co., submit a report, with recommendations, by January 31st, 1977.

THAT Council meet with Woods, Gordon & Co. before the study is commenced, to determine the cost of said study and discuss the guidelines.

WHEREAS the motion adopted by Council on February 12, 1974, authorizing the recompensing of Council members at the per diem rate of \$60.00 for expenses re functions attended in the Greater Vancouver Regional District, is an exorbitant amount;

AND WHEREAS the wording of the said motion can lend the policy stated therein to abuse;

THEREFORE BE IT RESOLVED THAT the resolution of Council adopted on February 12, 1974, and reading as follows, be reconsidered:

"THAT any Council member required to attend any function authorized or required by the Council, held in the Greater Vancouver Regional District, and extending for more than half a working day shall be recompensed at the rate of \$60.00 per diem inclusive of out-of-pocket expenses and travel expenses, but not including registration fees; from this per diem rate shall be deducted any remuneration paid by the Greater Vancouver Regional District or Greater Vancouver Regional District and the net amount then paid to the said member. This compensation shall not be in addition to any per diem rate payable in connection with the Council policy for travel expense allowances for functions outside the Greater Vancouver Regional boundary."

That this resolution be rescinded, and that it be FURTHER RESOLVED THAT effective immediately the members of Council and Staff be reimbursed on the basis of actual costs for which receipts are supplied in the matter of attending on behalf of or representing the City at functions in the Greater Vancouver Regional District area.

Mayor Reid read aloud a legal opinion received from the City Solicitor on this date with respect to this matter.

At this point Alderman Dean took her seat at the Council table and Mayor Reid resumed the Chair.
