Alderman Payne commented on the recent publicity with respect to entering property of a private citizen, in this instance the home of Mrs. Doris Orr. He asked that a staff report be submitted in connection with this matter, and Mayor Loucks advised this information would be provided.

(b) Clean up of Back Yards and Lanes -Inquiry by Alderman Payne

Alderman Payne noted that some months ago he had requested a complete report on the action which the City is taking or can take with respect to the cleaning up of debris in lanes and back yards in the City.

Mr. Raymond said he would check this out.

(c) Kiwanis Arts and Crafts Fair -Inquiry by Alderman Marcino

Alderman Marcino asked that the subject of the request of the Kiwanis Club to hold an Arts and Crafts Fair be placed on the agenda of the next Regular Meeting of Council.

(d) Doris Orr - Inquiry by Alderman Marcino

Alderman Marcino asked that consideration of the Doris Orr incident be included on the agenda of the next Council Meeting.

(e) Condition of Boulevard - 300 Block East 3rd Street - Inquiry by Alderman Colcleugh

Alderman Colcleugh advised that he had received a telephone call from a gentleman owning property in the 300 Block East 3rd Street who is concerned about the condition of the boulevard opposite the B.C. Hydro installation. He said it was his understanding that although the City can enforce the 'clean up of private property it can do nothing to force the owners of property to clean up the boulevards fronting their homes. He felt that the City should either accept this responsibility or get an enforceable by-law to ensure cleanup by owners.

(f) Untidy Sidewalks - Lonsdale Avenue between 14th and 17th Streets -Inquiry by Alderman Colcleugh

Alderman Colcleugh remarked on the untidy condition of Lonsdale Avenue between 14th and 17th Streets, and suggested that either the City should have an enforceable by-law to require the merchants abutting on main streets to keep the sidewalks clean or arrange for the City to do it. He asked that staff reports be provided with respect to this subject, as well as the cleanup of boulevards.

Mayor Loucks was of the opinion that both these items should be dealt with by the Council.
