The invocation was then given by the Rev. A.H. Mundy of St. Andrews United Church.

The meeting was then called to order at 8:20 P.M.

1. INAUGURAL ADDRESS BY HIS WORSHIP MAYOR J.E. LOUCKS

"Honoured guests, Members of Council, Ladies and Gentlemen, for the third year it is my privilege to present the Mayor's Report to the people of North Vancouver City. Before beginning the main part of this address I would like to take the liberty of thanking the citizens for giving me the opportunity to serve as their Mayor for a second term.

I would also like to congratulate the Aldermen on their election to office. Frank Marcino - who is beginning his eighth consecutive year on Council, Gordon Cross, Elko Kroon, and Gary Payne who are each beginning their second term, Stella Jo Dean, who is returning to Council after a two year absence and who has seven years of service on previous Councils, and Bill Sorenson who is beginning his first term on Council but has served the Community in many ways for several years.

I am looking forward to working with them and staff over the next two years on behalf of the citizens of North Vancouver City.

We are indebted to Judge Wallace Craig for performing the Swearing In Ceremony, Reverend A.H. Mundy for the Invocation, and Constables H. Schmolke and L.W. Hay of the Royal Canadian Mounted Police for their attendance this evening.

At this time I would also like to thank members of the media for their coverage of Council Meetings during the past year. Comments made by many residents indicate that they have a keen interest in the actions of this municipal Council and depend upon the media to help keep them informed.

In discussions of the major events of 1979, there is unanimous agreement that the highlight of the year was the public announcement by Premier Bennett of the Lonsdale Quay Development. This proposed 70 million dollar waterfront development project, which includes a six acre waterfront park, the Marine Training Institute of B.C., the headquarters for I.C.B.C., specialty boutique-like stores, restaurants, and 300 residential units of varying types will act as a catalyst for the development of Lower Lonsdale and provide tremendous revenue benefits not only for the City of North Vancouver but also for other parts of the North Shore.

While this proposal is an exciting preview of things to come it is important at this time to review a few of the major accomplishments that took place during 1979 and are of great importance to this community.

Estimates by our Permits & Licences Department indicate that by the end of December the total value of building permits issued for 1979 will reach \$32,000,000. This will be the third year in a row that we will have reached or surpassed our forecasts of development. Based on experience of past years some of these projects will have an effect upon 1980's assessment and taxes but the bulk of them will not truly affect our tax base until 1981.

Using the Ten Year Plan as a guide the Engineering Department carried out its second successful year of implementing many projects necessary for the improvement of City services. Over \$1,500,000 has been spent so far this year on improvements to our streets, water system, sewer system, sidewalks, lanes and parks. A major project has been the improvement of Keith Road from Bewicke to Mahon Avenue. This involved the installation of a large storm sewer, curbing the centre boulevard to provide two roadways, repaving, and improvement to the sidewalks on both the north and south sides. When this project is completed it will make a major improvement to the flow of traffic to and from Marine Drive. Thanks to the City taking advantage of a Provincial Cost Sharing Program there will be no charge to the fronting owners.

The major park improvements have been the rebuilding of Mahon Park Grandstand which had been destroyed by fire, the construction of a double tennis court with lighting for night playing at Derek Inman Park and the installation of an underground sprinkler system at Boulevard Park. The insurance from the old grandstand and a grant from the Provincial Recreation Facilities Assistance Program did much to lower the cost for City taxpayers.

In negotiations involving the City, the British Columbia Buildings Corporation, and the North Vancouver School Board, agreement was finally reached which will result in the building of a new court house on the western section of the North Vancouver Secondary School site and the retention of the school gymnasium for the use of citizens of North Vancouver. Through a ten year agreement of sale the City is purchasing the site and the building for the cost of the land alone.

In looking forward to 1980 I can see some important issues facing Council.

First and foremost is the provision of necessary services at the lowest cost to the taxpayers. To keep tax increases to a minimum I would recommend to Council that the mill rate be frozen at its present level or decreased, if possible. I feel that if this is done an increase in assessments through new developmens and the judicious use of funds from the sale of City lands will enable us to maintain the present level of essential services and carry on the implementation of improvements recommended in the next step of our Ten Year Plan.

The revitalization of Lower Lonsdale has begun with the near completion of the first part of Esplanade Centre. As indicated earlier the Provincial Government's plans for the Sea Bus site will encourage further development in the area. Council and staff must make certain that all proposed projects conform to the guidelines laid down in our Community Plan.

Within the next few months the City will obtain ownership of the land for our long awaited waterfront park. Since development of this park will be very costly, one of the first steps the Council must take is to have staff or consultants prepare a plan which will recommend the short term and long term objectives and suggest ways and means of achieving these objectives.

In my opinion an agreement on the Low Level Road, which has been discussed for years, is closer to being realized than it has ever been in the past. Negotiations carried on during the past two years with the Squamish Band, other North Shore Municipalities and the Provincial Government have prepared the way for the City to achieve an important breakthrough on the development of this very necessary arterial road. A major task of this Council is to see that we achieve this break-through by reaching an agreement with the Squamish Indian Band for a route through their lands.

In conclusion I would like to pay tribute to Jim Warne and Murray Colcleugh for their contributions to the City during the past two years. Jim has served on City Council for a total of seven years. I know that he will continue to serve the community in many different ways. Murray has moved to Penticton, but I know that he will continue to have an interest in our community.

I would also like to express my thanks to the staff of the City who are often taken for granted but whose efforts and dedication make it possible for Councils to achieve the improvements they feel are needed in our community."

By-law No. 5230

The Acting City Clerk advised that this by-law was for the purpose of rezoning Lot 22, Block 130, D.L. 274, located on the north side of the 300 Block East Third Street from Medium Density Apartment Zone to Comprehensive Development Zone to permit construction of a four-unit apartment building on the site. The applicant is R & R Western Estates Ltd.

Mr. Morris displayed plans of the proposed development and advised that a similar proposal had previously been approved by Council and registered as a land use contract but had not been acted upon by the developer in the time permitted. He said the reason that the application is for a Comprehensive Development Zone is because of a locked-in lot situation, and he outlined the situation with respect to the sale of the Fraser Block and the loss of its parking on the vacant lot, which is the subject lot in this application. Reference was made to metal flues for chimneys shown on the plans. Mr. Morris advised that his Department has been in touch with the Fire Marshal's office and will seek clarification on the ruling on the matter of metal flues.

By-law No. 5231

The Acting City Clerk advised that this by-law would have the effect of amending the text of the "Zoning By-law, 1967" to regulate an off-street parking use or an accessory off-street parking use accessory to other than a one-family or two-family residential use, and to require such off-street parking use to be provided on a 24-hour per day basis; and to define the terms pertinent to the provision of off-site parking spaces in certain commercial and industrial zones.

Mr. Morris noted that revised copies of By-law No. 5231 had been circulated to all Council members prior to this meeting.

Mr. Morris stated that the proposed amending by-law was the result of a request by Council to staff to provide an amendment to the Zoning By-law stipulating that the City's parking requirements are on a twenty-four hour basis. He said the City has always contended that parking must be provided on a twenty-four hour basis but that recently the City was challenged on this point. He noted that By-law No. 5231 also provides dimensions for parking to conform with graphic standards.

Mayor Loucks recessed the meeting at 7:50 P.M. to call the Council meeting to order, and the Public Hearing then reconvened at 7:51 P.M., with the same personnel present.

Mr. Morris then reviewed each clause of By-law No. 5231.
