*Alderman Payne entered the meeting at 7:32 P.M.

1. ADOPTION OF MINUTES

Moved by Alderman Dean, seconded by Alderman Sorenson that the Minutes of the Regular Meeting of Council held on October 27, 1980, be taken as read and adopted as circulated.

CARRIED.

2. DELEGATIONS

(a) G.V.R.D. - Director of Planning. Re: Livable Region Program.

Mr. K. Cameron and Mr. G.F. Farry of the G.V.R.D. Planning Committee displayed slides depicting "The Livable Region: From the 70's to the 80's". The presentation summarized the purpose of the program, the progress which has been achieved to the present time, and the problems and opportunities for the 1980's with respect to residential settlements, the balance of jobs to the population in each part of the region, the regional economy, accessibility, agricultural viability, and open space.

Mr. Farry and Mr. Cameron then responded to the questions of Council members, and urged them, if possible, to attend the seminar on the subject which will be held in January of 1981.

Mayor Loucks then thanked the delegation for their presentation.

(b) Capilano Mall. Re: Christmas Shopping Hours

Mr. Frank Leahy, General Manager of the Capilano Mall Shopping Centre, advised he and other merchants in the Mall were somewhat disturbed to hear that Council is contemplating a change in the Christmas shopping hours as established for the City last year. He indicated that additional merchandise has been ordered to provide for the late shopping hours during the month of December prior to Christmas Eve and arrangements have been made for the employment of the necessary staff. He added that a reduction in the late shopping hours during the first week of December would result in a loss of jobs and salaries for a number of individuals who would otherwise have the opportunity to be gainfully employed.

Mr. Leahy then answered several queries from the Council members regarding the number of employees involved and the amount of the payroll for the additional hours during this one week.

Moved by Alderman Dean, seconded by Alderman Cross that no amendment be made to the City's Shops Regulation By-law as it now stands with respect to Christmas shopping hours; and that Mr. F. Leahy, General Manager of Capilano Mall and the Districts of North and West Vancouver be so advised. CARRIED.

(a) Personnel - North Shore Neighbourhood House. (Alderman Kroon)

Alderman Kroon noted that Mr. Braithwaite was no longer associated with North Shore Neighbourhood House and asked as to the line of command at the present time, in view of the fact that this organization provides an important service to the community.

Alderman Sorenson, the City's representative on the Board of Directors of North Shore Neighbourhood House indicated he would bring Alderman Kroon up to date on the matter.

Alderman Dean referred to an item which had been circulated to Council members for information from the Ministry of the Attorney General with regard to the Counterattack Program. She asked that the subject be referred to the Police Liaison Committee for a report as to the possibility of organizing such a program in the City.

Alderman Kroon, Chairman of the Police Liaison Committee, advised that the matter of this program was being dealt with by the R.C.M.P., and that he would make the necessary arrangements to have the item considered by the Committee.

(d) Vocational Unit, North Vancouver Secondary School. (Alderman Dean). 4

Alderman Dean referred to an item in the minutes of the October 16, 1980, meeting of the North Vancouver Recreation Commission which indicates that the School Board is prepared to allow the Commission to utilize free of charge the former vocational unit of the North Vancouver Senior Secondary School as an arts and crafts centre subject to certain conditions whereby the Commission would be responsible for maintenance and renovation, at a capital cost of \$6000 to \$9000. She inquired if the Commission can legally expend funds for this purpose.

Alderman Payne, the Council's representative on the Recreation Commission, advised the Councils of the City and District must approve both the operational and capital budget of the Commission and operation of an additional facility would require an amendment to the By-law.

(e) Rental Fee for Use of Playing Fields. (Alderman Dean)

Alderman Dean noted that in the minutes of the Recreation
Advisory Committee meeting held on September 25, 1980, it was suggested that a rental be charged for the use of playing fields, and she noted that the Commission is also suggesting a budgetary cost of \$20,000 for administration of the playing

fields, which are municipally maintained. She felt that a user fee would be appropriate but the revenue from this source should go to the municipalities for the upkeep of the fields, and she questioned the legality of the Commission including in its budget an additional cost for administration.

Alderman Payne noted that the Commission regulates the use of these facilities at a substantial cost and the user fee has the effect of reducing the subsidy required from the municipalities an administration charge is included in the budget, but there is no user fee for the playing fields.
