The Hearing was called to order at 7:30 P.M.

BY-LAW NO. 5640

Mr. Hawkshaw advised this by-law will have the effect of amending the text of the Zoning By-law insofar as it pertains to the Comprehensive Development 63 Zone, so as to allow a maximum of three driveways to the property located at 245, 247, and 249 West 17th Street, legally described as Lot "H", Resub. 6, Block 29, D.L. 548, Plan 2481, (Strata Lots 1, 2, and 3 - Strata Plan VR 1432). He stated the applicant for this by-law amendment is Barod Developments Ltd.

Mr. White noted that the initial application for the rezoning of this property to CD-63 had been considered and approved by Council some time ago, which by-law permitted three dwelling units on the site. However, at that time the site planning for the project had not been completed and the by-law restricted access to the property to a maximum of two driveways. In view of the fact that three dwelling units have been constructed, the applicant has requested permission for an additional driveway.

Mr. White advised that the Engineering Department have indicated that they have no major concerns with the installation of a third driveway.

Acting Mayor Braithwaite asked anyone in the the public gallery to comment if they felt their property would be affected by the proposed amendment to the Zoning By-law, and no one did so.

BY-LAW NO. 5641

Mr. Hawkshaw advised that this By-law was for the purpose of rezoning Lot 14, Block 118, D.L. 274, Plan 878, located at 269 East Sixth Street, from RT-1 Two-family Residential 1 Zone to RT-2 Two-family Residential 2 Zone, to permit construction of two dwelling units on the site, in accordance with the regulations in the Zoning By-law pertaining to the He stated that the applicant is Mrs. Emma Conto.

Mr. White explained that the RT-2 Zone allows for a structure of larger dimensions than that permitted in the RT-1 Zone, however, the applicant will be required to provide a covenant to limit density to two dwelling units.

Mr. White then outlined the details of the draft by-law with respect to lot size, floor space, building height and setbacks, off-street parking requirements, the location of refuse containers, and the exterior finishes. He noted that the density is well within that designated in the Official Community Plan and that the project complies with the Community Plan with respect to open space criteria.

Mr. White stated that the City Solicitor had recommended rewording of Section 3 of the draft amending by-law, and it is therefore proposed to revise that by-law by deleting the said Section 3 and substituting the following:

- "3. Pursuant to Section 306(1) of the Municipal Act of British Columbia, this By-law shall take effect on the earlier of the following dates:
 - (a) The date the owner, their successors or assigns, registers as a first charge against the Title of Lot 14, Block 118, District Lot 274, Plan 878, a Section 215 Land Title Act Covenant in favour of the Crown or a municipality in respect of confining the use of that land, or the use of the building on, or to be erected on that land, to a two family residential use.
 - (b) August 1, 1985."

Acting Mayor Braithwaite invited anyone in the public gallery to speak if they were concerned that the proposed amendment to the Zoning By-law would affect their property, and no one did so.

Moved by Alderman Dean, seconded by Alderman Clark that the Hearing adjourn.
